POLICY QUESTION:

Does city council support the 2016 Arapahoe County Community Development Block Grant (CDBG) Program Subgrantee Agreement for the Littleton Sidewalk Improvements Project?

BACKGROUND:

In 1992, the City of Littleton began participating with Arapahoe County in the Urban Counties Community Development Block Grant (CDBG) Program. A summary is attached.

The city's allocation was reduced from \$150,000 to \$135,000, starting with this 2016 grant cycle. Delays in the federal funding process pushed this 2016 grant agreement completion to 2017.

In October 2015, the city submitted 2016 CDBG grant applications for \$135,000 as follows:

PRENTICE AVENUE SIDEWALK (\$114,750)

This is a continuation of an on-going program to replace narrow and deteriorated sidewalks in the northeast neighborhoods of Littleton. The 2016 grant will fund installation of new sidewalk and curb ramps on one side of West Prentice Avenue between South Hickory and South Delaware Streets. This sidewalk is more than 50 years old with "Hollywood" style rollover curbs. The existing 31" wide (non-ADA compliant) sidewalk will be widened to 60". The contract with Arapahoe County requires a minimum of 1,800 linear feet of new sidewalk.

CONNECTION TO COVERAGE AND HEALTH CARE (\$20,250) Doctor's Care requested \$20,250 to support its Connection to Coverage and Health Care project. This project was originally funded as the Integrated Health Care Initiative with \$22,500 from the city's 2005 CDBG allocation and continued in this amount through 2015. As a Certified Assistance Site for Connect for Health Colorado, Doctors Care will provide a new level of access to low income individuals in Littleton. By providing access to integrated care, along with "wrap around" services for patients with higher levels of psychosocial needs, this program offers complete integration of services necessary for medical and emotional health of members of the community. This \$20,250 application has been approved, and the county will contract directly with Doctor's Care who will be responsible for all documentation and reporting per the county CDBG guidelines.

STAFF ANALYSIS:

Housing and Urban Development and Arapahoe County approved the Sidewalk Project grant application. With adoption of this resolution and subsequent contract signatures, the project needs only a final award letter and Notice to Proceed from the county in order to move forward. The project will be bid, contracted and completed this summer.

FISCAL IMPACTS:

The 2017 budget includes \$114,750 for the 2016 CDBG Program so no additional appropriation is required.

STAFF RECOMMENDATION:

Staff recommends approval of this resolution to continue the CDBG program.

SUBGRANTEE AGREEMENT FOR ARAPAHOE COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS

SUBGRANTEE: City of Littleton PROJECT NAME: Littleton Sidewalk Improvements PROJECT NUMBER: LTPF1608

This Agreement is made by and between the Board of County Commissioners of the County of Arapahoe, State of Colorado, for the Community Development Block Grant Program in the Community Resources Department (hereinafter referred to as the County) and **City of Littleton** (hereinafter referred to as the SubGrantee) for the conduct of a Community Development Block Grant (CDBG) Project.

I. PURPOSE

The primary objective of Title I of the Housing and Community Development Act of 1974, as amended, and of the Community Development Block Grant (CDBG) Program under this Title is the development of viable urban communities, by providing decent housing, a suitable living environment and expanding economic opportunities, principally for low and moderate income persons.

The project by the SubGrantee known as **Littleton Sidewalk Improvements** (Project) will be carried out in accordance with the Scope of Services, attached to, and incorporated herein as Exhibit A.

The SubGrantee may proceed to incur costs for the Project upon receipt of an official "Notice to Proceed" from the County.

II. WORK TO BE COMPLETED BY THE SUBGRANTEE

The grant funds are to be used only to provide services to Arapahoe County residents, excluding residents of the city of Aurora, per County CDBG guidelines.

A. Payment

It is expressly agreed and understood that the total amount to be paid by the County under this contract shall not exceed **\$114,750**. Drawdowns for the payment of eligible expenses shall be made against the line item budgets specified in the Project Budget and in accordance with performance criteria established in Exhibit A Scope of Services. The parties expressly recognize that the SubGrantee is to be paid with CDBG funds received from the federal government, and that the obligation of the County to make payment to SubGrantee is contingent upon receipt of such funds. In the event that said funds, or any part thereof, are, or become, unavailable, then the County may immediately terminate or, amend this agreement. To the extent C.R.S. § 29-1-110 is applicable, any financial

obligation of the County to the SubGrantee beyond the current fiscal year is also contingent upon adequate funds being appropriated, budgeted and otherwise available.

Upon expiration of this Agreement, as identified by the Agreement Date and Project Deadline (Deadline) in Exhibit A, the SubGrantee shall transfer to the County any CDBG funds on hand at the time of expiration and any accounts receivable attributable to the use of CDBG funds. These transferred funds shall revert to the County and be utilized for other purposes.

B. Timeline

All Project activities shall be completed and draw requests submitted by the Deadline unless the Subgrantee notifies the County in writing thirty (30) days prior to the Deadline that the funds cannot be disbursed. An extension may be granted, in writing, in which all draw requests be submitted and Project activities shall be completed by thirty (30) days following the Deadline. In the event that the completion deadline falls on a weekend or holiday, the Deadline will be considered the work day prior to the scheduled completion date. If the project requires additional time past the extended Deadline, the Agreement must be modified by mutual agreement of the County and the SubGrantee.

C. Performance Criteria

In accordance with the funding application submitted by the SubGrantee for the Project, the criteria listed below are to be met during the execution of the Project as identified in Exhibit A Scope of Services.

- 1. Quantifiable Goals
- 2. Community Impact
- 3. Monthly Performance Standards

D. Reporting Requirements

- 1. Project reports will be due within twenty (20) days following the end of each reporting period as specified in Exhibit A Scope of Services until the Project is completed.
- 2. The official annual audit and/or Financial Statements for the SubGrantee in which both revenues and expenditures for the CDBG Projects described herein are detailed are due annually. The last completed official annual audit report and/or Financial Statements shall be due on May 31, and for four (4) years thereafter on May 31.
- 3. Non-profit organizations that expend \$750,000 or more annually in federal funds shall comply with the Single Audit Act of 1984, as amended, as implemented in OMB Uniform Guidance \$200.501, and other applicable federal regulations.

III. RESPONSIBILITIES OF THE SUBGRANTEE

A. Federal Compliance

The SubGrantee shall comply with all applicable federal laws, regulations and requirements, and all provisions of the grant agreements received from the U.S. Department of Housing and Urban Development (HUD) by the County. These include but are not limited to compliance with the provisions of the Housing and Community Development Act of 1974 and all rules, regulations, guidelines and circulars promulgated by the various federal departments, agencies, administrations and commissions relating to the CDBG Program. A listing of some of the applicable laws and regulations are as follows:

- 1. 24 CFR Part 570;
- 2. 24 CFR Parts 84 and 85 as applicable per 24 CFR 570.502;
- 3. Title VI of the Civil Rights Act of 1964;
- 4. Title VIII of the Civil Rights Act of 1968;
- 5. Sections 104(b) and 109 of the Housing and Community Development Act of 1974;
- 6. Fair housing regulations established in the Fair Housing Act, Public Law 90-284, and Executive Order 11063;
- 7. Section 504 of the Rehabilitation Act of 1973;
- 8. Asbestos guidelines established in CPD Notice 90-44;
- The Energy Policy and Conservation Act (Public Law 94-163) and 24 CFR Part 39;
- 10. Non-discrimination in employment, established by Executive Order 11246;
- 11. Equal employment opportunity and minority business enterprise regulations established in 24 CFR part 570.904;
- 12. Section 3 of the Housing and Urban Development Act of 1968;

The purpose of section 3 is to ensure that employment and other economic opportunities generated by certain HUD financial assistance

shall, to the greatest extent feasible, and consistent with existing Federal, State and local laws and regulations, be directed to low- and very low income persons, particularly those who are recipients of government assistance for housing, and to business concerns which provide economic opportunities to low- and very low-income persons.

- 13. Federal procurement rules when purchasing services, supplies, materials, or equipment. The applicable federal regulations are contained in: 24 CFR Part 85 or through 24 CFR Part 84, as applicable;
- 14. Lead Based Paint regulations established in 24 CFR Parts 35 and 570.608;
- 15. Audit Requirements established in OMB Uniform Guidance §200.501; and
- 16. Cost principles established in OMB Uniform Guidance §200.430 and §200.431 as applicable per 24 CFR 570.502;
- 17. Conflict of Interest:
 - *a) Applicability.*

(1) In the procurement of supplies, equipment, construction, and services by the County and by the SubGrantee, the conflict of interest provisions in 24 CFR 85.36 and 24 CFR 84.42, respectively shall apply.

(2) In all cases not governed by 24 CFR 85.36 and 84.42, the provisions of 24 CFR 570.611 (2) shall apply. Such cases include the acquisition and disposition of real property and the provision of assistance by the County or by its SubGrantees to individuals, businesses, and other private entities under eligible activities that authorize such assistance (e.g., rehabilitation, preservation, and other improvements of private properties or facilities pursuant to 24 CFR 570.202; or grants, loans, and other assistance to businesses, individuals, and other private entities pursuant to 24 CFR 570.203, 570.204, 570.455, or 570.703 (i)).

b) Conflicts prohibited. The general rule is that persons described in paragraph (c) of this section who exercise or have exercised any functions or responsibilities with respect to CDBG activities assisted under this part, or who are in a position to participate in a decision-making process or gain inside information with regard to such activities, may not obtain a financial interest or benefit from a CDBG-assisted activity, either for themselves or those with whom they have business or immediate family ties, during their tenure or for one year thereafter.

- *Persons covered.* The conflict of interest provisions of paragraph
 (b) of this section apply to any person who is an employee, agent, consultant, officer, or elected official or appointed official of the County, or any designated public agencies, or of the SubGrantee that are receiving funds under this part.
- d) *Exceptions.* Upon the written request of the County, HUD may grant an exception to the provisions of paragraph (b) of this section on a case-by-case basis when it has satisfactorily met the threshold requirements of (d)(1) of this section, taking into account the cumulative effects of paragraph (d)(2) of this section.

(1) *Threshold requirements.* HUD will consider an exception only after the County has provided the following documentation:

- i. A disclosure of the nature of the conflict, accompanied by an assurance that there has been public disclosure of the conflict and a description of how the public disclosure was made; and
- ii. An opinion of the County's attorney that the interest for which the exemption is sought would not violate State or local law.

(2) Factors to be considered for exceptions. In determining whether to grant a requested exception after the County has satisfactorily met the requirements of paragraph (d)(1) of this section, HUD shall conclude that such an exception will serve to further the

purposes of the Act and the effective and efficient administration of the County's program or project, taking into account the following factors, as applicable:

- i. Whether the exception would provide a significant cost benefit or an essential degree of expertise to the program or project that would otherwise not be available;
- ii. Whether an opportunity was provided for open competitive bidding or negotiation;
- iii. Whether the person affected is a member of a group or class of low- or moderate-income persons intended to be the beneficiaries of the assisted activity, and the exception will permit such person to receive generally the same interests or benefits as are being made available or provided to the group or class;
- iv. Whether the affected person has withdrawn from his or her functions or responsibilities, or the decision making process with respect to the specific assisted activity in question;
- v. Whether the interest or benefit was present before the affected person was in a position as described in paragraph (b) of this section;
- vi. Whether undue hardship will result either to the County or the person affected when weighed against the public interest served by avoiding the prohibited conflict; and
- vii. Any other relevant considerations.
- 18. The SubGrantee cannot engage in a federally funded contract with any entity registered in the Lists of Parties Excluded From Federal Procurement or Nonprocurement Programs.
- 19. Labor Standards (Davis-Bacon)

Except for the rehabilitation of residential property that contains less than eight (8) units, the SubGrantee, and its contractor and all subcontractors shall comply with the Davis-Bacon Act, 40 U.S.C. 276a to 276a-7, and applicable regulations of the Department of Labor under 29 C.F.R. Part 5, requiring the payment of wages at rates of not less than those prevailing on similar construction in the locality as determined by the Secretary of Labor, when the project costs total \$2,000 or more and the work is financed in whole or in part with assistance provided under this Agreement. The applicable Davis-Bacon wage rate schedule must be included in all bid and contract documents, as well as the "Federal Labor Standards Provisions", Form HUD-4010.

20. Lead Based Paint Regulations

If the Project involves acquisition, construction, demolition, rehabilitation, or any other activity related to residential housing, and the building was built prior to 1978, Lead Based Paint Laws and Regulations apply, as established in 24 CFR Parts 35 and 24 CFR

570.608. Further, all applicable federal and state laws relating to lead-based paint must be followed, including such regulations promulgated by the U.S. Environmental Protection Agency and the State Department of Public Health and Environment, including regulations for non-housing buildings. If the SubGrantee does not follow and document lead based paint laws and regulation compliance, the SubGrantee will not be eligible for reimbursement.

21. Environmental Review

Notwithstanding any provision of this Agreement, the parties hereto agree and acknowledge that this Agreement does not constitute a commitment of funds or site approval, and that such commitment of funds or approval may occur only upon satisfactory completion of environmental review and, if required, receipt by Arapahoe County of a release of funds from the U.S. Department of Housing and Urban Development under 24 CFR Part 58. The parties further agree that the provision of any funds to the project is conditioned on Arapahoe County's determination to proceed with, modify, or cancel the project based on the results of a subsequent environmental review.

22. Uniform Relocation Act (URA)

The Project is subject to the relocation and acquisition requirements of the Uniform Relocation Act of 1970, as amended, and implemented at 49 CFR Part 24; Section 104(d) of the Housing & Community Development Act, as amended, and implemented at 24 CFR Part 42; and Displacement, Relocation, Acquisition, and Replacement of Housing implemented at 24 CFR 570.606. The SubGrantee must comply with the County's Anti Displacement and Relocation Assistance Plan on file and must pay all relocation expenses as applicable under the Act. Relocation payment calculations, records of Relocation payments and all other Relocation records are subject to County or federal review and monitoring. The SubGrantee agrees that it will pay any relocation expenses required by the Act and will reimburse the County for any relocation payments the County paid as a result of monitoring review by the County or any federal agency, as required by the Act.

B. Non-Appropriations Clause

The SubGrantee agrees that it will include in every contract it enters, which relies upon CDBG monies for funding, a non-appropriation clause that will protect itself, and the County from any liability or responsibility or any suit which might result from the discontinuance of CDBG funding for any reason. Because this SubGrantee Agreement involves funds from a federal grant, to the extent there is a conflict the funding provisions of this SubGrantee Agreement, the federal grant and the federal statutes control rather than the provisions of Section 24-91-103.6, C.R.S. with regard to any public work projects.

C. Expenditure Restrictions

All CDBG funds that are approved by HUD for expenditure under the County's grant agreement, including those that are identified for the SubGrantee's Projects and activities, shall be allocated to the specific projects and activities described and listed in the grant agreements. The allocated funds shall be used and expended only for the projects and activities for which the funds are identified.

D. Agreement Changes

No projects or activities, nor the amount allocated therefore, may be changed without approval by the County and acceptance of the revised Final Statement and/or Consolidated Plan by HUD, if required. Changes must be requested in writing and may not begin until a modification to this Agreement is fully executed.

E. Direct Project Supervision and Administration

The SubGrantee shall be responsible for the direct supervision and administration of its respective projects or activities. This task shall be accomplished through the use of the SubGrantee's staff, agency and employees. The SubGrantee shall be responsible for any injury to persons or damage to property resulting from the negligent acts or errors and omissions of its staff, agents and employees. Because the SubGrantee is responsible for the direct supervision and administration of its projects or activities, the County shall not be liable or responsible for cost overruns by the SubGrantee on any projects or activities. The County shall have no duty or obligation to provide any additional funding to the SubGrantee if its projects or activities cannot be completed with the funds allocated by the County to the SubGrantee. Any cost overruns shall be the sole responsibility of the SubGrantee.

- 1. The SubGrantee agrees that all funds allocated to it for approved projects or activities shall be used solely for the purposes approved by the County. Said funds shall not be used for any non-approved purposes.
- 2. The SubGrantee agrees that the funds allocated for any approved projects or activities shall be sufficient to complete said projects or activities without any additional CDBG funding.

F. Indemnity

To the extent allowed by law, the SubGrantee shall indemnify and hold harmless the County and its elected and appointed officials, officers, employees and agents from and against any and all losses, damages, liabilities, claims, suits, actions or costs, including attorney's fees, made, asserted or incurred as a result of any damage or alleged damage to person or property occasioned by the acts or omissions of SubGrantee, its officers, employees, agents, contractors or subcontractors, arising out of or in any way connected with the Project or the performance of this contract.

G. Bonding and Insurance

If the SubGrantee's projects involve construction activities, any Contractor it uses for said activities shall be required to provide and maintain, until final acceptance by the SubGrantee of all work by such Contractor, the kinds and minimum amounts of insurance as follows:

- 1. Comprehensive General Liability: In the amount of not less than \$1,000,000 combined single limit. Coverage to include:
 - a. Premises Operations
 - b. Products/Completed Operations
 - c. Broad Form Contractual Liability
 - d. Independent Contractors
 - e. Broad Form Property Damage
 - f. Employees as Additional Insured
 - g. Personal Injury
 - h. Arapahoe County and the SubGrantee as Additional Named Insured
 - i. Waiver of Subrogation
- 2. Comprehensive Automobile Liability: In the amount of not less than \$1,000,000 combined single limit for bodily injury and property damage. Coverage to include:
 - a. Arapahoe County and the SubGrantee as additional Named Insured
 - b. Waiver of Subrogation
- 3. Employers Liability and Workers Compensation: The Contractor shall secure and maintain employer's liability and Worker's Compensation Insurance that will protect it against any and all claims resulting from injuries to and death of workers engaged in work under any contract funded pursuant to this agreement. Coverage to include Waiver of Subrogation.
- 4. All referenced insurance policies and/or certificates of insurance shall be subject to the following stipulations:
 - a. Underwriters shall have no rights of recovery subrogation against Arapahoe County or the SubGrantee; it being the intent of the parties that the insurance policies so effected shall protect the parties and be primary coverage for any and all losses covered by the described insurance.
 - b. The clause entitled "Other Insurance Provisions" contained in any policy including Arapahoe County as an additional named insured shall not apply to Arapahoe County, or the SubGrantee.
 - c. The insurance companies issuing the policy or policies shall have no recourse against Arapahoe County, or the SubGrantee for payment of

any premiums due or for any assessments under any form of any policy.

- d. Any and all deductibles contained in any insurance policy shall be assumed by and at the sole risk of the Contractor.
- 5. Certificate of Insurance: The Contractor shall not commence work under any contract funded pursuant to this Agreement until he has submitted to the SubGrantee, received approval thereof, certificates of insurance showing that he has complied with the foregoing insurance requirements. The SubGrantee shall also submit a copy of the Contractor's certificates of insurance to the County.
- 6. Notwithstanding the provisions contained in this paragraph (H) set forth hereinabove, the County reserves the right to modify or waive said provisions for projects or activities for which these provisions would prove prohibitive. The SubGrantee understands, however, that the decision to waive or modify those provisions is fully within the discretion of the County.

In accordance with 24 CFR parts 84 and 85, the following bonding requirements shall apply to all projects exceeding the simplified acquisition threshold (currently \$150,000):

- 1. A bid guarantee from each bidder equivalent to 5% of the bid price;
- 2. A performance bond on the part of the contractor for 100% of the contract price; and
- 3. A payment bond on the part of the contractor for 100% of the contract price.

H. Records

The SubGrantee shall maintain a complete set of books and records documenting its use of CDBG funds and its supervision and administration of the Project. Records are to include documentation verifying Project eligibility and national objective compliance, as well as financial and other administrative aspects involved in performing the Project. The SubGrantee shall provide full access to these books and records to the County, the Secretary of HUD or his designee, the Office of the Inspector General, and the General Accounting Office so that compliance with Federal laws and regulations may be confirmed. The SubGrantee further agrees to provide to the County upon request, a copy of any audit reports pertaining to the SubGrantee's financial operations during the term of this Agreement. All records pertaining to the Project are to be maintained for a minimum of five years following close-out of the Project.

I. Reporting

The SubGrantee shall file all reports and other information necessary to comply with applicable Federal laws and regulations as required by the County and HUD. This shall include providing to the County the information necessary to complete annual Performance Reports in a timely fashion.

J. Timeliness

The SubGrantee shall comply with the performance standards established in Exhibit A of this Agreement. The SubGrantee understands that failure to comply with the established standards may lead to a cancellation of the Project and a loss of all unexpended funds.

K. Reimbursement for Expenses

The SubGrantee agrees that before the County can distribute any CDBG funds to it, the SubGrantee must submit to the County's Housing and Community Development Services Division documentation in the form required by that Division which properly and fully identifies the amount which the SubGrantee is requesting at that time. The County shall have ten (10) working days to review the request. Upon approval of the request, the County will distribute the requested funds to the SubGrantee as soon as possible.

L. Program Income

All program income directly derived from the Arapahoe County Community Development Block Grant Program received by the SubGrantee will be returned to the County unless authorized in Exhibit A Scope of Services to be retained by the SubGrantee and dispersed for its approved CDBG Project activities. If the retention and re-use of Program Income is Authorized, it must be dispersed for its approved CDBG Project activities before additional CDBG funds are requested from the County. Following completion of the SubGrantee's Arapahoe County CDBG Projects, all program income directly generated from the use of CDBG funds will be remitted to the County.

M. Real Property

Real property acquired in whole or in part with CDBG funds shall be utilized in accordance with the scope and goals identified in Exhibit A Scope of Services attached to and made a part of this Agreement. Should the property in question be sold or otherwise disposed of, or the approved property usage discontinued, the SubGrantee shall adhere to the requirements of 24 CFR Parts 84 or 85 (as applicable) regarding the use and disposition of real property.

N. State and County Law Compliance

All responsibilities of the SubGrantee enumerated herein shall be subject to applicable State of Colorado statutes and County ordinances, resolutions, rules, and regulations.

O. Subcontracts

If subcontracts are used on the Project, the SubGrantee agrees that the provisions of this Agreement shall apply to any subcontract.

P. Suspension or Termination

This Agreement may be immediately suspended or terminated upon written notification from the County if the SubGrantee materially fails to comply with any term of this Agreement. This Agreement may also be terminated for convenience by mutual agreement of the County and the SubGrantee.

Q. Urban County Designation

In the event that the Unit of General Local Government should withdraw from the County's "Urban County" designation, this Agreement shall terminate as of the termination date of the County's CDBG grant Agreement with HUD.

R. Certification

The SubGrantee certifies that to the best of its knowledge and belief:

- 1. No Federal appropriated funds have been paid or will be paid, by or on behalf of it, to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement; and,
- 2. If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, it will complete and submit Standard Form-LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.

S. Disallowance

If it is determined by HUD or other federal agency that the expenditure, in whole or in part, for the SubGrantee's Project or activity was improper, inappropriate or ineligible for reimbursement, then the SubGrantee shall reimburse the County to the full extent of the disallowance.

T. Reversion of Assets

Upon expiration of this Agreement, the SubGrantee shall transfer to the County any CDBG funds on hand at the time of expiration and any accounts receivable attributable to the use of CDBG funds. Any real property under the SubGrantee's control that was acquired or improved in whole or in part with CDBG funds (including CDBG funds provided to the SubGrantee in the form of a loan) in excess of \$25,000 is either:

(i) Used to meet one of the national objectives in §570.208 (formerly §570.901) until five years after expiration of the agreement, or for such longer period of time as determined to be appropriate by the County and specified in Exhibit A Scope of Services; or

(ii) Not used in accordance with national objectives in §570.208 (formerly §570.901), in which event the SubGrantee shall pay to the County an amount equal to the current market value of the property less any portion of the value attributable to expenditures of non-CDBG funds for the acquisition of, or improvement to, the property.

IV. RESPONSIBILITIES OF THE COUNTY

A. Administrative Control

The Parties recognize and understand that the County will be the governmental entity required to execute all grant agreements received from HUD pursuant to the County's requests for CDBG funds. Accordingly, the SubGrantee agrees that as to its projects or activities performed or conducted under any CDBG agreement, the County shall have the necessary administrative control required to meet HUD requirements.

B. Performance and Compliance Monitoring

The County's administrative obligations to the SubGrantee pursuant to paragraph A above shall be limited to the performance of the administrative tasks necessary to make CDBG funds available to the SubGrantee and to provide Housing and Community Development Services staff whose job it will be to monitor the various projects funded with CDBG monies to monitor compliance with applicable Federal laws and regulations.

C. Reporting to HUD

The County will be responsible for seeing that all necessary reports and information required of the County are filed with HUD and other applicable Federal agencies in a timely fashion.

V. EXTENT OF THE AGREEMENT

This agreement, including any documents attached as exhibits which are hereby incorporated herein by reference, represents the entire and integrated agreement between the County, and SubGrantee and supersedes all prior negotiations, representations or agreements, either written or oral. Any amendments to this agreement must be in writing and signed by both the County, and SubGrantee. If any portion of this agreement is found by a court of competent jurisdiction to be void and/or unenforceable, it is the intent of the parties that the remaining portions of this agreement shall be of full force and effect.

2. ACTIVITY DESCRIPTION/PERFORMANCE GOALS

a. Purpose (short description of program purpose)

The purpose of this project is to improve the city's pedestrian infrastructure, particularly in the city's lower income neighborhoods; thereby, providing residents with safe access to community resources, in this case, Cornerstone and Progress Park. The improvements will provide all residents with sidewalks and curb ramps that meet ADA standards.

b. Goals and Community Impact

The goal of this project is to successfully install five feet wide sidewalks and curb ramps that meet ADA standards, along W. Prentice Avenue from South Hickory Street to South Delaware Street. Thereby improving the pedestrian infrastructure surrounding Cornerstone and Progress Park. If feasible, based on contractor bids, this project will install roughly 1,200 linear feet of sidewalk.

c. Project Address

The video recordings of meetings shall be kept in perpetuity to provide clarification of action minutes when needed. The amendment has been added to the ordinance for second reading.

POLICY QUESTION:

Does city council support accepting ownership of the Roxborough gravity interceptor sewer, terminating easements and granting an access easement to Roxborough Water and Sanitation District (RW&S)?

BACKGROUND:

In 2005, RW&S constructed a lift station, force main and gravity sewer to convey wastewater from its customers to a connection with the city's sewer collection system. The gravity sewer begins near the intersection of C-470 and South Platte Canyon Road and extends north to connect to Littleton sewer near the intersection of West Belleview Avenue and South Santa Fe Drive. Near West Bowles Avenue, another sewer owned by the Platte Canyon Water and Sanitation District (PCW&S) was connected to the RW&S sewer, to eliminate the PCW&S lift station. Both systems are shown on Exhibits B and C.

The PCW&S sewer had a series of problems over the years and was expensive to maintain and repair. The PCW&S sewer also serves part of the City of Littleton located west of the South Platte River and south of West Berry Avenue. To address these problems, the city, RW&S and PCW&S agreed to share the cost of the sewer pipeline via a 2006 agreement (Exhibit D). This agreement (section 9, page 6) waived any financial contribution of the city in the shared pipeline, with the understanding the city would assume the ownership of the entire gravity sewer. Supporting the discussion is a September 9, 2006 Staff Communication to council (Exhibit E).

In January 2015, work began to execute the 2006 agreement and convey the ownership of the gravity line to the City of Littleton. During this time, a significant issue was encountered concerning the transfer of ownership to the city across property owned by the United States Army Corps of Engineers (COE) and its insistence the city hold the COE harmless of liability. State law prohibits the city from indemnifying other parties and the ownership transfer was renegotiated to exclude this section from city ownership (i.e. RW&S will retain ownership as shown in purple - see Exhibit F).

In order to transfer ownership of the gravity line to the city, a series of easements must be granted to the city, as

identified in Exhibit G. Several easements will be voided across property the city already owns, as identified in Exhibit H. In some cases, a "License Agreement" would be granted to the city where the gravity line crosses property owned by Denver Water, Xcel Energy, the Nevada Ditch and Columbine Country Club. Those easements are identified in Exhibit I.

STAFF ANALYSIS:

The city has a standard sewer service agreement to provide wastewater treatment to all eight sanitation districts it serves, including PCW&S and RW&S. Agreements state each district will operate its collection system to a point of connection with the city's collection system. Littleton ownership of the RW&S gravity sewer will have the city as the sole owner, which is more in alignment with the other district agreements.

PCW&S previously approved a prior version of the Interceptor Transfer Agreement in May identified as Exhibit K. The agreement has since been revised, and PCW&S will take the revised agreement to its board for approval.

Operation and maintenance of the gravity sewer will become the responsibility of the city. New interceptor sewers of this type require relatively little routine maintenance. Staff believes the maintenance of the gravity sewer can be completed with present staff and equipment. The gravity sewer is less than ten years old and was constructed with modern corrosion resistant materials. It is not anticipated any major replacement or rehabilitation will be required for many years.

Odor from the gravity sewer has occasionally been an issue. RW&S has installed odor control facilities on the lift station and force main, which RW&S will continue to own, operate and maintain on COE property. Maintenance access will be across park space owned by the city and maintained by South Suburban Park & Recreation District as identified in Exhibit J. Routine maintenance access should not negatively affect use of the park. In the event heavy construction is needed at some point in the future, additional temporary construction easements may be required.

FISCAL IMPACTS:

Transfer of the RW&S gravity sewer to Littleton is proposed at no cost to either party. RW&S has paid all its obligations under its Loan Agreement dated May 1, 2005 with the Colorado Water Resources and Power Development Authority which was a requirement of the 2006 agreement. RW&S has obtained consent to release the confirmation letter from the state (Exhibit A).

Terminating the easements by the city is proposed at no cost to RW&S.

STAFF RECOMMENDATION:

Staff recommends approval.

Section 3: The City of Littleton, Colorado does hereby approve granting an

INTERCEPTOR TRANSFER AGREEMENT

This INTERCEPTOR TRANSFER AGREEMENT is entered into on this _____ day of ______, 2017, by and between the ROXBOROUGH WATER AND SANITATION DISTRICT (the "District") and the CITY OF LITTLETON, COLORADO SEWER UTILITY ENTERPRISE, a water activity enterprise of the State of Colorado (the "City"), collectively referred to herein as the "Parties."

RECITALS

WHEREAS, the District is empowered by § 32-1-1004, C.R.S., to provide water and wastewater service within its boundaries; and

WHEREAS, the District constructed a regional sanitary sewer pipeline (the "Pipeline") for the purpose of transporting wastewater from the District's existing facilities to the Englewood/Littleton Wastewater Treatment Plant; and

WHEREAS, the southernmost portion of the Pipeline consists of a force main pipeline ("Force Main Pipe"), extending north from the District's existing wastewater treatment facility to the District's transition vault ("Transition Vault") located north of C-470 and east of South Platte Canyon Road; and

WHEREAS, the northernmost portion of the Pipeline consists of a gravity-flow line extending north from the Transition Vault to the tie-in at the City's sanitary interceptor which terminates at the Englewood/Littleton Wastewater Treatment Plant and is located west of the intersection of Belleview Avenue and Santa Fe Drive (the "Gravity Flow Pipe"); and

WHEREAS, a portion of the Gravity Flow Pipe is also accessed and used by Platte Canyon Water and Sanitation District, a quasi-municipal corporation and political subdivision of the State of Colorado ("Platte Canyon") and the City (the "Shared Pipe"), and was constructed to provide sufficient wastewater flow capacity for the District, Platte Canyon and the City. The Shared Pipe is more particularly depicted on <u>Exhibit C</u> attached hereto and incorporated herein by reference; and

WHEREAS, on October 27, 2006, the District, Platte Canyon and the City entered into that certain "Intergovernmental Agreement Regarding Cost Sharing for Use of Shared Pipe" for purposes of allocating each party's respective capacity in the Shared Pipe as well as to set forth their respective payment obligations for the costs of constructing and maintaining the Shared Pipe (the "Cost Sharing IGA"); and

WHEREAS, the Cost Sharing IGA contemplated the future conveyance of the Gravity Flow Pipe, including the Shared Pipe, from the District to the City, and pursuant to Paragraph 13 of the Cost Sharing IGA, the parties thereto acknowledged and consented to the conveyance of the Shared Pipe, together with all maintenance and operations responsibilities thereto, from the District to the City, upon such terms as may be mutually agreed upon by the District and the City, and consented to by Platte Canyon, such consent not to be unreasonably withheld; and WHEREAS, the Cost Sharing IGA further provides that the City would accept ownership of the Gravity Flow Pipe from the District at such time that the District satisfied its repayment obligations pursuant to that certain Loan Agreement entered into between the District and the Colorado Water Resources and Power Development Authority ("CWRPDA"), dated May 1, 2005 ("2005 Loan"), or at such earlier time as the District may be permitted to transfer ownership of the Gravity Flow Pipe pursuant to the 2005 Loan; and

WHEREAS, the District desires to transfer ownership, including operations and maintenance responsibilities, of the Gravity Flow Pipe depicted in <u>Exhibit B</u> attached hereto and incorporated herein by reference, to the City, excepting from the transfer that portion of the Gravity Flow Pipe located on certain real property owned by the Department of the Army ("Army Flow Pipe"), which shall remain owned, operated and maintained by the District, and the City is willing to accept ownership and related operation and maintenance responsibilities of the Gravity Flow Pipe, subject to the terms and conditions set forth in this Agreement; and

WHEREAS, CWRPDA has provided its consent to the District's conveyance of the Gravity Flow Pipe to the City as evidenced by CWRPDA's letter, dated May 5, 2016, attached hereto as <u>Exhibit A</u> and incorporated herein by reference; and

WHEREAS, the Parties have negotiated this Interceptor Transfer Agreement (the "Agreement") for the purpose of setting forth the terms and conditions for the District to transfer ownership of the Gravity Flow Pipe, and all operation and maintenance responsibilities related thereto, to the City.

NOW, THEREFORE, in consideration of the promises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties mutually agree as follows:

AGREEMENT

1. <u>Conveyance of Gravity Flow Pipe</u>. Subject to the terms and conditions set forth herein, the District hereby sells, conveys, transfers and delivers to the City that portion of the Gravity Flow Pipe commencing at and including Manhole 249 and extending north to the tie-in at the City's sanitary interceptor which terminates at the Englewood/Littleton Wastewater Treatment Plant, as more particularly depicted on <u>Exhibit B</u> attached hereto. Such conveyance is inclusive of the Shared Pipe depicted on <u>Exhibit C</u> attached hereto. The City hereby accepts said conveyance and transfer from the District of that portion of the Gravity Flow Pipe described in this Paragraph 1 and depicted on <u>Exhibit B</u> attached hereto. The District shall execute a "Bill of Sale," as attached hereto as <u>Exhibit D</u> and incorporated herein by reference, to convey the Gravity Flow Pipe to the City. The conveyance of the Gravity Flow Pipe shall be deemed effective upon the occurrence of the following ("Effective Date"): (1) the delivery of a Bill of Sale from the District to the City; (2) the execution and, as applicable, recording of the Assignments and New Licenses, as such terms are defined and further described in Paragraph 5 hereof; and (3) the execution and recording of the Manhole 249 Easement as further described in Paragraph 8 hereof.

2. <u>Army Flow Pipe</u>. The Parties acknowledge that the District has installed certain odor control beds between the Transition Vault and Manhole 262 located on that portion of the Gravity Flow Pipe referred to herein as the Army Flow Pipe, and that proper maintenance of the odor control beds is essential to the integrity of the entire Pipeline. The Parties further acknowledge and agree that the District shall retain ownership of the Army Flow Pipe to allow the District to access and maintain the odor control beds and related components.

3. <u>Manhole 227 – Air Vent</u>. As part of the District's construction of the Gravity Flow Pipe, an air vent was installed on Manhole 227, which is located on property owned by the City and is an integral part to the District's operation of its Transition Vault. The Parties agree that the District shall be responsible for the ongoing operations and maintenance of the air vent on Manhole 227. Utilizing the license granted by the City to the District pursuant to Paragraph 7 hereof, the District shall have the right of ingress and egress in, to, through, over, under, and across the City's property as is necessary for the District to access Manhole 227 for purposes of operating, maintaining, repairing, and/or replacing the air vent and any related components thereto. The City shall ensure that the immediate area on and surrounding Manhole 227 is kept clear of any and all plants or other shrubbery, rubbish or any other structure or fixture, and that Manhole 227 is damaged due to the City's direct or indirect activities conducted on or in association with the Gravity Flow Pipe, the City shall be responsible for all costs associated with the District's repair or replacement of the air vent on Manhole 227.

4. <u>Reserved Capacity in Gravity Flow Pipe</u>. The Parties acknowledge that the Shared Pipe was constructed at 36 inches in diameter to provide sufficient wastewater flow capacity in the Shared Pipe for the District, the City, and Platte Canyon, and all of the Gravity Flow Pipe located south of the Shared Pipe was constructed at 24 inches (24") in diameter. The District hereby reserves for itself 6.006 million gallons per day of capacity in the entire Gravity Flow Pipe, including the 24" portion and the Shared Pipe. The City hereby agrees and acknowledges such reservation of capacity by the District and shall take no action to impair the District's access to and use of said capacity in the Gravity Flow Pipe.

5. <u>Assignment of Easements and Licenses</u>. Except as other provided herein, the District shall assign to the City all of the District's right, title and interest in such easements and licenses that the District obtained to construct, operate and maintain the Gravity Flow Pipe. A list of the easements and licenses to be assigned to the City is attached hereto as <u>Exhibit E</u> and incorporated herein by reference (the "Assignments").

a. <u>New Licenses</u>. Certain property owners that previously granted the District licenses for the Gravity Flow Pipe have requested that the City enter into new license agreements with the property owners upon the conveyance of the Gravity Flow Pipe. The City hereby agrees to enter into license agreements with the City and County of Denver, acting by and through its Board of Water Commissioners and with the Public Service Company of Colorado (collectively, the "New Licenses").

b. <u>CDOT Permit</u>. The Parties acknowledge that portions of the Gravity Flow Pipe cross certain rights of ways owned by the Colorado Department of Transportation ("CDOT"). The

District obtained a CDOT permit ("Permit") to construct, operate and maintain the Gravity Flow Pipe in such rights of way, which Permit is not transferable. In the event the City must conduct future work on that portion of the Gravity Flow Pipe located in CDOT's rights of way, the City shall be required to obtain a new permit from CDOT.

c. <u>Termination of City Easements</u>. As part of the District's construction, installation, operation and maintenance of the Gravity Flow Pipe, the City and the District entered into that certain Easement Deed, dated September 26, 2006, as recorded in the records of the Douglas County Clerk and Recorder on October 6, 2006, at Reception No. B6143901 (Easement No. 1), and that certain Permanent Sanitary Sewer Easement, dated September 26, 2006, as recorded in the records of the Douglas County Clerk and Recorder on October 6, 2006, at Reception No. B6143901 (Easement No. 1), and that certain Permanent Sanitary Sewer Easement, dated September 26, 2006, as recorded in the records of the Douglas County Clerk and Recorder on October 6, 2006, at Reception No. B6143904 (Easement No. 2) pursuant to which the City granted the District permanent easements to construct, operate and maintain that portion of the Gravity Flow Pipe located on the City's property. Upon the Effective Date of the conveyance of the Gravity Flow Pipe to the City, the District and the City shall extinguish Easement No. 1 and Easement No. 2 via separate instrument executed by the District and the City, as required pursuant to Paragraph 23 of Easement No. 1 and Paragraph 17 of Easement No. 2.

6. <u>Operations and Maintenance</u>. Upon the Effective Date of the conveyance of the Gravity Flow Pipe to the City, the City shall own the Gravity Flow Pipe, excepting from said conveyance the Army Flow Pipe section as provided in Paragraphs 1 and 2 herein, and the City shall assume all responsibility for the proper operation and maintenance of the Gravity Flow Pipe, except as otherwise provided in Paragraphs 3 and 7 hereof. With the exception of the Shared Pipe and as otherwise provided in this Agreement, the City assumes all costs, expenses and other responsibilities related to the maintenance of the Gravity Flow Pipe and the District shall have no further responsibilities to operate and maintain the Gravity Flow Pipe or to pay any costs related thereto including, but not limited to, costs for repairs or replacement of the Gravity Flow Pipe. For the Shared Pipe, the City shall perform all routine and emergency maintenance on the Shared Pipe, as further provided in and in accordance with Paragraph 9 of the Cost Sharing IGA, with the costs of such routine and/or emergency maintenance being allocated among the City, the District and Platte Canyon pursuant to the percentages established in Paragraph 5.4 of the Cost Sharing IGA.

7. <u>License Agreement</u>. The City hereby grants to the District a non-revocable, nonexclusive license to access and inspect the Gravity Flow Pipe at any time for any purpose necessary and appropriate to ensure the integrity of the entire Pipeline including, but not limited to, the air vents installed on Manhole 227 as further provided in Paragraph 3 hereof. Except as otherwise provided in this Agreement, if the District determines that maintenance of the Gravity Flow Pipe transferred to the City herein, including repairs and replacement thereof, is required to ensure the integrity of the Pipeline, the District shall provide notice to the City and the City hereby agrees to conduct such maintenance requested by the District at the City's expense. In the event the City considers the District's maintenance request to be unnecessary or believes alternative maintenance methods should be pursued, the City shall provide written notice of its determination to the District within ten (10) days of receiving a maintenance request from the District ("City Determination Letter"). Within ten (10) days of receiving the City Determination. In the event the District rejects the City Determination Letter, the Parties shall work together to attempt to reach a solution acceptable to both Parties. If the Parties fail to reach an agreement, the District may take any action it deems necessary to ensure the integrity of the Pipeline, including but not limited to, court action.

8. <u>Manhole 249 Easement</u>. As set forth in Paragraph 1 hereof, the District's conveyance to the City of the Gravity Flow Pipe shall commence at and include Manhole 249 which is situated at the southernmost point of the Gravity Flow Pipe on the City's property. The Parties acknowledge that the District will require access to the Army Flow Pipe and the District's Force Main Pipe via Manhole 249. Concurrently with the District's conveyance of the Gravity Flow Pipe to the City, the City shall grant to the District a perpetual nonexclusive access easement in, to, through, over, under and across Manhole 249, such Manhole 249 to be used by the District to gain access to, inspect and service the Army Flow Pipe and the Force Main Pipe ("Manhole 249 Easement").

9. <u>Additional Instruments</u>. The District and the City agree to prepare and execute any other documents or instruments necessary to effectuate the conveyance of the Gravity Flow Pipe from the District to the City.

10. <u>No Warranties.</u> The District does not warrant that the Gravity Flow Pipe will be free from interruption caused by accidents or repairs. No such interruptions shall render the District liable for any damages and the City hereby expressly waives and releases all claims against the District for any damages resulting from the stoppage or interruption of service, including any damage to private property, except as may be caused by the negligent or willful misconduct of the District or its officers, agents or employees.

11. <u>Notices</u>. Any notices, demands, or other communications required or permitted to be given by any provision of this Agreement shall be given in writing and shall be delivered in person, by certified mail, postage prepaid, return receipt requested, by a commercial overnight courier that guarantees next day delivery and provides a receipt, or by electronic mail communications ("E-Mail"), and such notices shall be addressed to the Parties below or to such other address as either Party may from time to time specify in writing to the other party. Notice shall be considered delivered upon delivery by certified mail, overnight courier, E-Mail or upon hand delivery. When using E-Mail to provide notice, the receiving party must respond via "reply" acknowledging receipt of the E-Mail notification. If the sending party fails to receive acknowledgement of such receipt, an alternative form of notification must be used.

12. <u>Amendment.</u> This Agreement may not be amended, modified, or changed, in whole or in part, without a written agreement executed by the Parties.

13. <u>Assignment.</u> No assignment of any right or obligation contained in this Agreement shall be permitted without the prior written consent of the non-assigning Party, which consent shall not be unreasonably withheld.

14. <u>Governmental Immunity.</u> Nothing in this Agreement shall be construed to be a waiver, in whole or in part, of any right, privilege, or protection afforded either of the Parties pursuant to the Colorado Governmental Immunity Act, Section 24-10-101, *et seq.*, C.R.S.

15. <u>Enforcement.</u> The Parties agree that this Agreement may be enforced in law or equity, for specific performance, injunctive or other appropriate relief, including damages, as may be available according to the laws and statutes of the State of Colorado.

16. <u>Governing Law.</u> This Agreement shall be governed by and construed in accordance with the laws of the State of Colorado.

17. <u>Severance Clause.</u> If any provision of this Agreement is declared by any court of competent jurisdiction to be invalid for any reason, such invalidity shall not affect the remaining provisions; such remaining provisions shall be fully severable and this Agreement shall be construed and enforced as if such invalid provisions had never been inserted in this Agreement.

18. <u>No Third Party Beneficiaries.</u> Nothing in this Agreement shall be interpreted or construed to create any third party beneficiaries of this Agreement. The Parties expressly acknowledge that it is their intent that no third party beneficiaries be created by this Agreement or any interpretation or construction thereof.

19. <u>No Agency, Partnership, or Joint Venture</u>. Nothing in this Agreement shall be interpreted or construed to create any agency, partnership, or joint venture relationship between the Parties. The Parties expressly acknowledge that it is their intent that no agency, partnership,

or joint venture relationship be created between them by this Agreement or any interpretation or construction thereof.

20. <u>Successors and Assigns.</u> This Agreement shall be binding upon the Parties and their respective successors and assigns.

21. <u>Captions.</u> The headings of sections and paragraphs are included solely for convenience and reference. If any conflict between any heading and the text of this Agreement exists, the text shall control.

22. <u>Counterparts.</u> This Agreement may be executed in counterparts, each of which shall be an original, but all of which together shall constitute one and the same Agreement.

23. <u>Entire Agreement.</u> This Agreement constitutes the entire agreement among the Parties with respect to conveyance of the Gravity Flow Pipe, and sets forth the rights, duties, and obligations of the Parties with respect to the Gravity Flow Pipe. Any prior agreements, promises, negotiations, or representations relating to the conveyance of the Gravity Flow Pipe and not expressly set forth in this Agreement shall have no force and effect.

24. <u>Platt Canyon Consent.</u> By signature attached hereto, Platte Canyon consents to the terms and conditions of this Agreement related to the transfer of the Shared Pipe, together with maintenance and operations responsibilities, from the District to the City.

DEPICTION OF GRAVITY FLOW PIPE

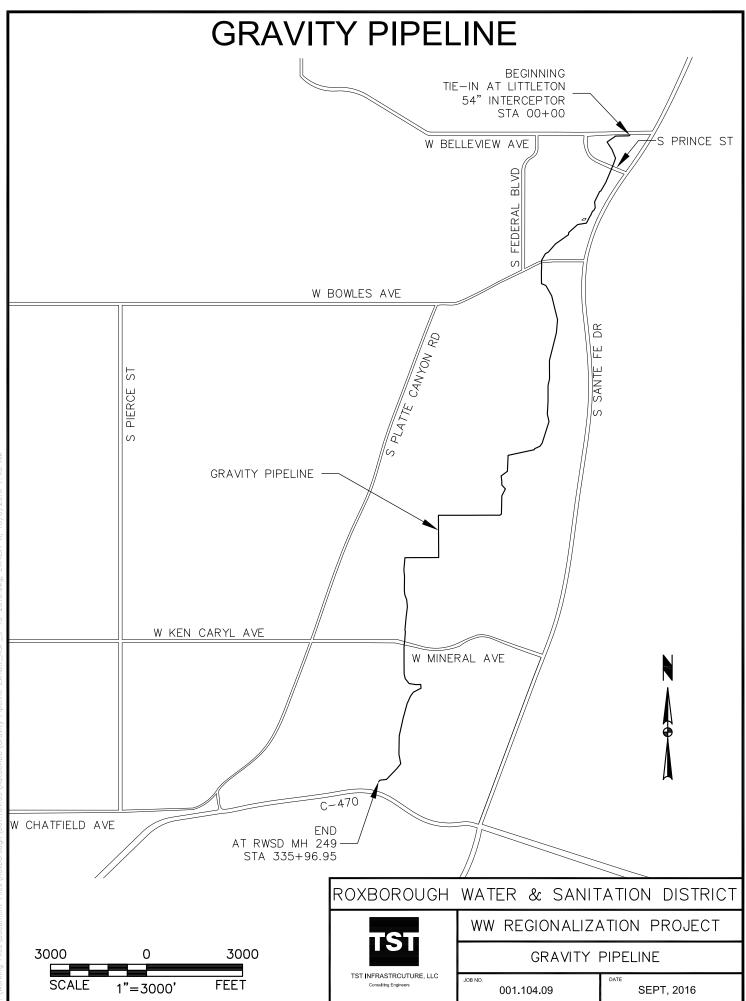

DEPICTION OF SHARED PIPE



DEPICTION OF GRAVITY FLOW PIPE

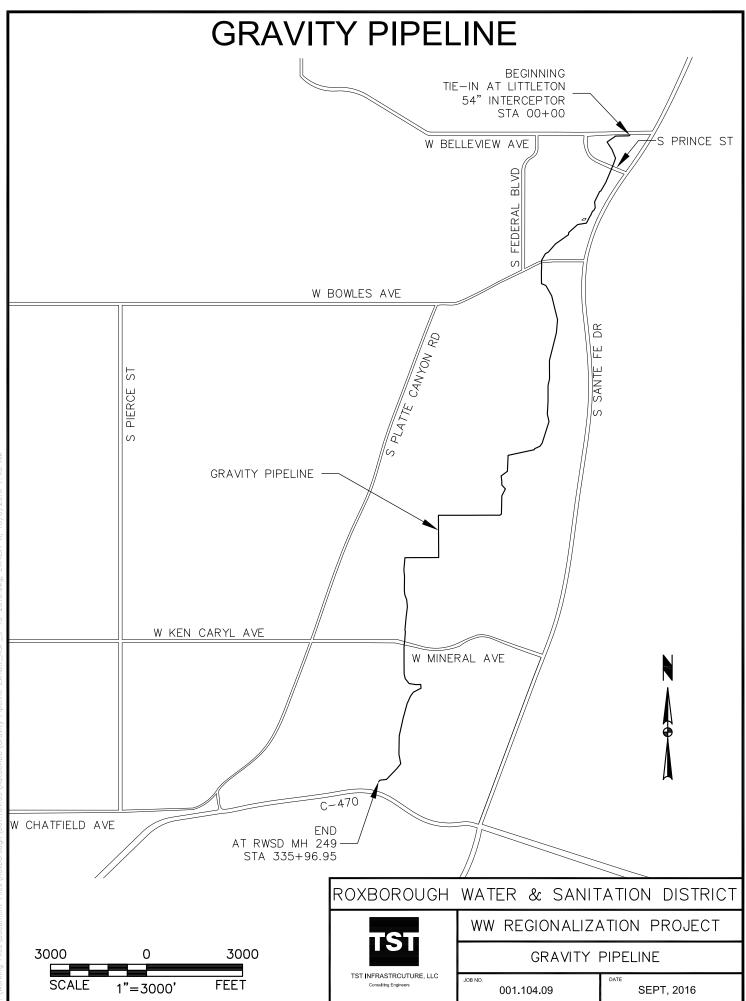



Shared Gravity Pipeline



Intergovernmental Agreement Regarding Cost Sharing for Use of Shared Pipe

INTERGOVERNMENTAL AGREEMENT REGARDING COST SHARING FOR USE OF SHARED PIPE

This Intergovernmental Agreement ("Agreement") is made and entered into this <u>27th</u> day of <u>October</u>, 2006 by and among the City of Littleton, Colorado Sewer Utility Enterprise, a water activity enterprise of the State of Colorado (the "City"), the Platte Canyon Water and Sanitation District, a quasi-municipal corporation and political subdivision of the State of Colorado ("Platte Canyon") and the Roxborough Water and Sanitation District (formerly Roxborough Park Metropolitan District), a quasi-municipal corporation and political subdivision of the State of Colorado ("Roxborough"), collectively referred to herein as the "Parties."

RECITALS

WHEREAS, Roxborough is constructing a pipeline (the "Pipeline") for the purpose of transporting wastewater from Roxborough's existing facilities to the Littleton-Englewood Wastewater Treatment Facility; and

WHEREAS, the southernmost portion of the Pipeline will consist of a force main pipeline, extending from Roxborough's existing wastewater treatment facility north generally to C-470; and

WHEREAS, the northernmost portion of the Pipeline will consist of a gravity-flow line extending from the connection to the proposed force main, located north of C-470 and east of South Platte Canyon Road, north to the tie-in at the existing City of Littleton 54-inch sanitary interceptor located west of the intersection of Belleview Avenue and Santa Fe Drive (the "Gravity Flow Pipe"). The Gravity Flow Pipe is more particularly described on Exhibit A, attached hereto and incorporated herein by this reference; and

WHEREAS, a portion of the Gravity Flow Pipe will be accessed and used by Platte Canyon and the City (the "Shared Pipe"). The Shared Pipe will have capacity for the wastewater flow of Roxborough, Platte Canyon and the City. The Shared Pipe is more particularly described on Exhibit B, attached hereto and incorporated herein by this reference; and

WHEREAS, Platte Canyon utilizes a lift station located generally between Bowles Avenue and Prince Street (the "Platte Canyon Lift Station") and;

WHEREAS, Platte Canyon desires to abandon its connection to the Platte Canyon Lift Station and connect to the Shared Pipe through a Platte Canyon owned gravity flow pipeline at the Point of Connection as defined in Paragraph 8; and

WHEREAS, the Shared Pipe can be constructed to accommodate the current and projected flows which would otherwise be served by the Platte Canyon Lift Station; and

WHEREAS, Roxborough is willing to construct the Shared Pipe to accommodate the current and projected flows which would otherwise be served by the Platte Canyon Lift Station provided Platte Canyon and/or the City are willing to pay their proportionate share of operation and maintenance costs for the Shared Pipe along with their proportionate shares of the total project costs associated with constructing the Shared Pipe, which respective shares shall be the same as each Party's respective required percentage of capacity in the Shared Pipe.

WHEREAS, the Parties desire to enter into this Agreement to allocate their respective capacity in the Shared Pipe as well as to set forth their respective payment obligations for the costs of constructing the Shared Pipe; and

WHEREAS, the Parties are governmental entities and a further purpose of this Agreement is to promote the public health, welfare and safety of the inhabitants of both Districts and the City, and

WHEREAS, this Agreement shall be construed in light of the public nature of the contracting Parties and their powers, purposes and limitations and shall at all times conform with such powers and limitations.

NOW, THEREFORE, in consideration of the promises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties mutually agree as follows:

1. <u>Conditions Precedent.</u> The Parties acknowledge that Roxborough's construction of the Shared Pipe requires the approval of the State of Colorado Department of Public Health and Environment, and may require the approval of other governmental entities having jurisdiction over or with respect to the Shared Pipe, including but not limited to, the Denver Regional Council of Governments. In the event such approvals are not obtained and the Shared Pipe is not constructed, Roxborough shall return any payments made by Platte Canyon or the City pursuant to Paragraph 6 of this Agreement. Such payments shall be returned within 30 days of written notice from Roxborough that the required governmental approvals have not been obtained and that the Sbared Pipe will not be constructed.

2. <u>Construction and Design</u>. Except as otherwise agreed in writing by the Parties, all matters relating to the design and construction of the Pipeline, including the Shared Pipe, shall be under the reasonable control and at the reasonable discretion of Roxborough.

Roxborough understands that Platte Canyon intends to connect a gravity flow pipeline to the Shared Pipe in order to bypass Platte Canyon's existing sewage lift station. In finalizing the design of and in constructing the Shared Pipe, Roxborough shall not act or fail to act in any way that would unreasonably or adversely interfere with Platte Canyon's ability to connect to and thereafter utilize the Shared Pipe through a gravity flow connecting pipeline.

2.1 <u>Sharing of Information</u>. As part of the final design of the Shared Pipe, Roxborough has provided the City and Platte Canyon with copies of the final design plans and specifications. All matters relating to the design and construction of the Shared Pipe shall remain in Roxborough's control, pursuant to Paragraph 2 of this Agreement.

If for any reason Platte Canyon cannot connect by gravity into the Shared Pipe, Platte Canyon and/or the City shall have the right to terminate this Agreement. Upon termination, Platte Canyon and the City shall receive a refund of whatever monies have been paid to Roxborough and not expended as of the date of such termination and each Party shall thereafter be relieved of any further obligations under this Agreement.

Change Orders. Except as otherwise provided in this Agreement or hereinafter 3. agreed to in writing by the Parties, Roxborough shall have the sole responsibility, in the reasonable exercise of its discretion, for approving all change orders required for the construction of the Pipeline, including the Shared Pipe. All change orders approved by Roxborough shall require the Parties to pay their allocated percentage of the cost of the change order, as such percentage is defined in Paragraph 5.4 of this Agreement. Roxborough shall notify Platte Canyon and City of the need for any change order at such time as a change order is requested by either the contractor or Roxborough. In the event, any individual change order exceeds 5% of the initial contract price for the Shared Pipe, as reflected in the awarded construction contract, Platte Canyon and City shall be provided three (3) business days in which to approve or disapprove the proposed change order. If Platte Canyon and/or City disapproves the proposed change order and Roxborough determines that the proposed change order should be executed despite such disapproval, then the provisions of Paragraph 3.1, below, shall apply. Further, in the event the total of all change orders for the Shared Pipe exceed 15% of the initial contract price for the Shared Pipe, as reflected in the awarded construction contract, and Platte Canyon and/or City disapprove of the same upon three (3) business days notice from Roxborough of the total amount of all change orders for the Shared Pipe, the provisions of Paragraph 3.1, below, shall apply. All notices related to change orders required by this Paragraph 3 shall be sent via email to the individuals listed in Paragraph 10.

3.1 <u>Dispute Resolution Procedure</u>. If the events described in Paragraph 3, above, occur during construction of the Shared Pipe, the dispute resolution procedures set forth in this subparagraph shall be utilized after construction has been completed, but before the final billing adjustment required by Paragraph 6.1, below. A committee composed of two (2) representatives from each of the Parties shall convene to evaluate the cause(s) of the change orders, and whether the change order or orders should be considered Shared Pipe Construction Costs, chargeable to the Parties generally, or whether those costs should be chargeable only to Roxborough or one of the other Parties.

If the Parties can not agree on an allocation of change order costs, then the dispute shall be submitted to an independent Arbiter to be selected by the Parties. If the Parties can not agree on a person to serve as an independent Arbiter, then the immediate Past-President of the Colorado Chapter of the American Consulting Engineer's Council shall select the names of seven (7) Registered Professional Engineers qualified to act as Arbiter of such a dispute. Each Party shall strike two (2) names from the list within ten (10) working days from the date the list is presented. The remaining person shall act as Arbiter. The Arbiter shall allow as Shared Pipeline construction costs, any change orders or order or portions thereof that the Arbiter finds to be reasonable under the circumstances. The Arbiter shall also allocate those costs between and among the Parties as the Arbiter determines appropriate. The Arbiter's decision shall be binding on the Parties.

4. <u>Phasing of Construction</u>. Notwithstanding any other provision contained in this Agreement to the contrary, Roxborough shall have the right to construct the Pipeline in such phases as Roxborough determines appropriate; provided, however, that once construction of the Shared Pipe is commenced, it shall be prosecuted diligently to completion. Further, before construction of the Pipeline or any portion thereof commences, Roxborough shall provide the City and Platte Canyon with a construction schedule for the Shared Pipe, so that Platte Canyon and the City can determine when the Shared Pipe shall be constructed, and when it is reasonable to anticipate that Platte Canyon's lift station can be taken out of service.

5. <u>Construction Cost Payment Obligations.</u> Subject to the requirements of Paragraph 30, below, each Party shall pay their proportionate share of the Shared Pipe Construction Costs as set forth in Paragraph 5.4, below. Subject to the requirements of Paragraph 30, below, Platte Canyon and City shall pay their proportionate share of Related Costs as set forth in Paragraph 5.3, below.

5.1 <u>Shared Pipe Construction Costs</u>. Shared Pipe Construction Costs shall mean all direct charges incurred by Roxborough in constructing the Shared Pipe, but shall not include any Related Costs, as that term is defined in Paragraph 5.2, below. Shared Pipe Construction Costs shall include the direct purchase costs of contracted or Roxborough-furnished materials, construction contract payments, and payments made directly by Roxborough to third-parties for easements or rights of way for the Shared Pipeline. The estimated Shared Pipe Construction Costs are \$ 1,750,000.

5.2. <u>Related Costs</u>. Rolated Costs shall mean all internal and overhead costs incurred by Roxborough in constructing the Shared Pipe, including but not limited to the costs of design and other consultants retained by Roxborough for constructing the Shared Pipe, and shall include, but not be limited to all of the services if provided for or contracted by Roxborough: contract administration, design, review, survey, inspection, materials testing, legal fees, publication costs and costs of posting all applicable notices. Related Costs shall be calculated as a percentage of Shared Pipe Construction Costs.

5.3 <u>Calculation of Related Cost</u>. Related Costs for the Shared Pipe, shall be 23% of the actual Shared Pipe Construction Costs. Platte Canyon's share of Related Costs shall be 46.2%, the City's share of Related Costs shall be 7.4%, and Roxborough's Share of Related Costs shall be 46.4%.

5.4 <u>Each Party's share of Shared Pipe Construction Cost</u>. Each Party shall be responsible for paying a percentage of the Shared Pipe Construction Cost, which percentage shall be equivalent to each Party's relative percentage of the total capacity of the Shared Pipe, as calculated based upon the expected peak flows set forth in Paragraph 7, below. The Parties agree, based upon their respective capacity demands as set forth in Paragraph 7, below, that the City shall be responsible for payment to Roxborough of 7.4% of the Shared Pipe Construction Cost, Platte Canyon shall be responsible for payment to Roxborough of 46.2% of the Shared Pipe Construction Cost, and Roxborough shall be responsible for payment of 46.4% of the

Shared Pipe Construction Cost. Payments from the City and Platte Canyon shall be made as provided in Paragraph 6, below, of this Agreement.

6. <u>Payment of Shared-Pipe Construction Cost and Related Costs.</u> Subject to the requirements of Paragraph 30, below, the City and Platte Canyon shall pay to Roxborough their respective proportionate shares of the Shared Pipe Construction Cost and Related Costs according to the following schedule:

a) one-third (1/3) of each Party's proportionate share of the estimated Shared Pipe Construction Costs and Related Costs, shall be paid at such time as the contractor is on site and starts construction of the Shared Pipe; and

b) one-third (1/3) of each Party's proportionate share of the estimated Shared Pipe Construction Costs and Related Costs shall be paid within thirty (30) days after Platte Canyon and the City receive notification from Roxborough that Roxborough has expended 50% of the total estimated Shared Pipe Construction Costs and Related Costs; and

c) one-third (1/3) of each Party's proportionate share of the estimated Shared Pipe Construction Costs and Related Costs shall be paid within thirty (30) days of notification of the completion and acceptance by Roxborough of the Shared Pipe.

6.1 <u>Final Billing Adjustment.</u> Within ninety (90) days after the Shared Pipe has been constructed and accepted by Roxborough, Roxborough shall prepare a final billing adjustment, showing all actual Shared Pipe Construction Costs and Related Costs incurred by Roxborough for the construction of the Shared Pipe. Based upon such actual cost, Roxborough shall then issue a billing adjustment to Platte Canyon and the City. If payments made by Platte Canyon or the City for the Shared Pipe are greater than the amount owed by said Parties under this Agreement, (each Party's share of Shared Pipe Construction Cost plus each Parties' percentage share of Related Costs), Roxborough will refund to the overpaying Party, the difference between the amount paid and the amount owed. Conversely, if the payments made by either Platte Canyon or the City are less than the amounts owed by such Parties, Roxborough will bill the underpaying Party for the difference. This amount shall be paid within 30 days of the billing date.

7. <u>Capacity in Shared Pipe.</u> Based upon peak flows, Roxborough will require 4.766 million gallons per day of capacity in the Shared Pipe, the City will require 0.755 million gallons per day of capacity in the Shared Pipe and Platte Canyon will require 4.747 million gallons per day of capacity in the Shared Pipe. The resulting total combined capacity needed in the Shared Pipe, based upon the Parties' stated peak flow requirements will be 10.268 million gallons per day, which will necessitate the Shared Pipe being sized at 36 inches in diameter. By constructing the Shared Pipe at 36 inches in diameter, it is anticipated that approximately 12.943 million gallons per day of capacity will exist in the Shared Pipe, thus creating approximately 2.675 million gallons per day of additional capacity in the Shared Pipe over and above the flow requirements stated herein. The additional capacity in the Shared Pipe shall be allocated among the Parties as follows: Platte Canyon—1.24 million gallons per day; Roxborough—1.24 million gallons per day; the City—0.20 million gallons per day. The Parties expressly acknowledge that

exceeding the flow capacities established in this Agreement, which flow capacities shall include any additional capacity to which the Parties may be entitled as set forth above, shall constitute a breach of this Agreement, and shall entitle the non-breaching Parties to enforce this Agreement and shall entitle the non-breaching Party or Parties to any and all remedies available at law or in equity, including but not limited to specific performance.

8. <u>Point of Connection.</u> The point of connection to the Shared Pipe for Platte Canyon and the City will be located near the Platte Canyon Lift Station (the "Point of Connection"), as determined by Platte Canyon and approved by Roxborough, which approval shall not be unreasonably withheld, conditioned, or delayed. All costs associated with connecting the Platte Canyon Lift Station to the Shared Pipe shall be the sole responsibility of Platte Canyon and the City, as may be more specifically allocated and agreed to by Platte Canyon and the City. Roxborough covenants and agrees that it shall cause the contractor constructing the Shared Pipe to cooperate and coordinate with Platte Canyon's contractor so that the Point of Connection can be constructed as efficiently and economically as is reasonably practical.

Maintenance. For so long as Roxborough remains the owner of the Shared Pipe, Roxborough shall perform all routine and emergency maintenance on the Shared Pipe, with the costs of such routine and/or emergency maintenance being allocated among the Parties in the percentages established in Paragraph 5.4 above. At such time as the City becomes the owner of the Shared Pipe, the City shall perform all routine and emergency maintenance on the Shared Pipe, with the costs of such routine and/or emergency maintenance being allocated among the Parties in the percentages established in Paragraph 5.4 above. For purposes of this Agreement, routine maintenance shall consist of periodic inspections, periodic cleaning, jetting and videotaping, and shall not include any repair or maintenance that involves excavating or replacing any reach or reaches of the Shared Pipe or replacing any manhole or other physical component thereof. Maintenance that is due to circumstances beyond the reasonable control of Roxborough and that for public health and safety reasons requires the immediate excavation or replacement of any reach or reaches of the Shared Pipe or the immediate replacement of any manhole or other physical component thereof shall be deemed emergency maintenance, the costs of which shall be allocated among the Parties as established in Paragraph 5.4 above. Prior to incurring any maintenance expense (other than emergency maintenance expense) in excess of \$25,000.00, the then owner of the Shared Pipe shall provide the other Parties with copies of the bids for such work, and shall give the other Parties the opportunity to provide reasonable comment and input with regard to the nature and extent and necessity for the routine maintenance.

10. <u>Notices and Place for Payments.</u> Any notices, demands, or other communications required or permitted to be given by any provision of this Agreement shall be given in writing, delivered personally, sent by facsimile or e-mail, with a hard copy sent immediately thereafter via First Class U.S. Postal Service, or sent via First Class U.S. Postal Service, postage prepaid and return receipt requested, and addressed to the parties at the information set forth below. Notice shall be considered given when delivered personally and sent by facsimile or e-mail with a hard copy sent immediately thereafter via First Class U.S. Postal Service, and shall be considered received on the earlier of the day on which such notice is

actually received by the party to whom it is addressed, or the third day after such notice is mailed.

12. <u>Amendment.</u> This Agreement, and each and every of its terms and conditions, may be added to or amended only by the mutual written agreement of the Parties, which agreement shall

be executed with the same formalities as this original Agreement. Special terms and conditions, if any, which are agreed upon by the Parties at the time this Agreement is executed shall be reduced to writing in accordance with this paragraph and appended to this Agreement. Any amendments or modifications not made in accordance with this Paragraph 12 shall be mull and void and of no legal force or effect.

13. <u>Assignment</u> No assignment of any right or obligation contained in this Agreement shall be permitted without the prior written consent of all Parties hereto, which consent shall not be unreasonably withheld. Notwithstanding the foregoing, the Parties acknowledge and consent to the conveyance of the Shared Pipe, together with all maintenance and operations responsibilities thereto, from Roxborough to the City, upon such terms as may be mutually agreed upon by Roxborough and the City, and consented to by Platte Canyon, such consent not to be unreasonably withheld. Nothing herein contained shall preclude Platte Canyon from transferring its rights and obligations under this Agreement to any entity that by reason of any consolidation or dissolution of Platte Canyon, becomes the successor-in-interest to Platte Canyon's sanitary sewer collection system.

14. <u>Enforcement.</u> The parties agree that this Agreement may be enforced in law or equity, for specific performance, injunctive or other appropriate relief, including damages, as may be available according to the laws and statutes of the State of Colorado.

15. <u>Entire Agreement</u>. This Agreement constitutes the entire agreement among the Parties with respect to, and only with respect to, the Shared Pipe, including but not limited to the payment of fees, and sets forth the rights, duties, and obligations of each to the other as of the date hereof with respect to the Shared Pipe. Any prior agreements, promises, negotiations, or representations relating to the Shared Pipe and not expressly set forth in this Agreement shall have no force and effect.

16. <u>Governing Law.</u> This Agreement shall be governed by and construed in accordance with the laws of the State of Colorado.

17. <u>No Warranties.</u> Roxborough does not warrant that the Gravity Flow Pipe will be free from interruption caused by accidents or repairs or causes beyond its control. No such interruptions shall render Roxborough liable for damages and the City and Platte Canyon hereby expressly waive and release all claims against Roxborough for damage for stoppages or interruptions of service except as may be caused by the negligent or willful misconduct of Roxborough or its officers, agents or employees. Notwithstanding the foregoing, Roxborough understands that Platte Canyon is contributing to the cost of the Shared Pipe for the express purpose of being able to decommission its sewage lift station and transport sewage by gravity flow into the Shared Pipe. In connection therewith, Platte Canyon is redesigning the line leading into its sewage lift station, and relocating the same for connection to the Shared Pipe. Roxborough covenants and agrees that it will do nothing during construction that would frustrate or make it impossible for Platte Canyon to complete its connection to the Shared Pipe as presently contemplated. 18. <u>Successors and Assigns.</u> This Agreement shall be binding upon the Parties and their respective successors and assigns.

19. <u>Captions.</u> The headings of sections and paragraphs are included solely for convenience and reference. If any conflict between any heading and the text of this Agreement exists, the text shall control.

20. <u>Severance Clause.</u> If any provision of this Agreement is declared by any court of competent jurisdiction to be invalid for any reason, such invalidity shall not affect the remaining provisions; such remaining provisions shall be fully severable and this Agreement shall be construed and enforced as if such invalid provisions had never been inserted in this Agreement.

21. <u>Duplicate Originals.</u> This Agreement may be executed in several counterparts, each of which shall be an original, but all of which together shall constitute one and the same Agreement.

22. <u>Governmental Immunity.</u> Nothing in this Agreement shall be construed to be a waiver, in whole or in part, of any right, privilege, or protection afforded any of the Parties pursuant to the Colorado Governmental Immunity Act, Section 24-10-101, et seq., C.R.S.

23. <u>Time of Essence</u>. Time is of the essence in the performance of each and every obligation contemplated herein.

24. <u>Force Majeure</u>. A Party hereto shall not be liable for any failure to perform as required by this Agreement, to the extent such failure to perform is caused by any reasons beyond the control of such Party, or by reasons of any of the following occurrences, whether or not caused by such Party: strikes, labor disturbances or labor disputes of any character, accidents, failure of any governmental approval required for full performance, riots, civil disorder or commotion, war, actions of aggression, floods, earthquakes, acts of God, explosion or similar occurrences, provided that such Party shall exercise its best efforts to provide the best possible alternative performance and to prevent the foregoing occurrences from obstructing the full performance. Such occurrences shall not terminate this Agreement and shall not affect this Agreement except as provided in this section.

25. <u>Exhibits.</u> All exhibits referenced herein are attached hereto and incorporated by this reference.

26. <u>Insurance/Payment and Performance Bonds.</u> Roxborough shall require its contractor for the Shared Pipe to obtain appropriate insurance coverage and payment and performance bonds related to the construction of the Shared Pipe. Roxborough shall require its contractor to name the City and Platte Canyon as additional insureds on all such policies of insurance and shall require its contractor to name the City and Platte Canyon as additional obligees on all such payment and performance bonds. The City and Platte Canyon shall be named third party beneficiaries as to that portion of the construction contract which is for the Shared Pipe.

27. <u>No Third Party Beneficiaries.</u> Nothing in this Agreement shall be interpreted or construed to create any third party beneficiaries of this Agreement. The Parties expressly

acknowledge that it is their intent that no third party beneficiaries be created by this Agreement or any interpretation or construction thereof.

28. <u>No Agency, Partnership, or Joint Venture</u>. Nothing in this Agreement shall be interpreted or construed to create any agency, partnership, or joint venture relationship among the Parties. The Parties expressly acknowledge that it is their intent that no agency, partnership, or joint venture relationship be created among them by this Agreement or any interpretation or construction thereof.

29. <u>Conveyance of Gravity Flow Pipe.</u> The Parties acknowledge and agree that in consideration of the payment of the City's costs associated with this Agreement, as provided in Paragraph 30, that the City agrees to accept ownership of the Gravity Flow Pipe from Roxborough at such time as Roxborough has satisfied its repayment obligations under that certain Loan Agreement entered into between Roxborough and the Colorado Water Resources and Power Development Authority dated May 1, 2005, or at such earlier time as Roxborough may be permitted to transfer ownership of the Gravity Flow Pipe, Roxborough may be permitted to transfer ownership of the Gravity Flow Pipe, Roxborough shall deliver to the City, in a form acceptable to the City, instruments granting to the City all of Roxborough's right, title, and interest in the real property upon which the Gravity Flow Pipe is located.

30. <u>Payment of City's Costs by Roxborough.</u> In consideration of the City's agreement to accept conveyance of the Gravity Flow Pipe, as set forth in Paragraph 29, Roxborough agrees to pay all costs chargeable to the City pursuant to this Agreement, other than the City's share of ongoing routine and emergency maintenance costs as set forth in Paragraph 9 herein.







INTRODUCTION

The purpose of this communication is to present to city council a resolution authorizing an Intergovernmental Agreement (IGA) between the City of Littleton, Colorado Sewer Utility Enterprise, acting through City Council as its' governing body (city), the Platte Canyon Water and Sanitation District (Platte Canyon) and the Roxborough Water and Sanitation District (Roxborough) to provide funding for construction and establish ownership of a sanitary sewer interceptor along the west side of the South Platte River. The resolution also authorizes a Facilities Conveyance Agreement for a public storm sewer installed by Roxborough within the city.

HISTORY AND FACTS

The city provides wastewater service to properties within eight sanitation districts located outside the city limits. Sewer service to those districts is authorized by a Sewer Service Agreement with the city. Each agreement stipulates the city will accept wastewater from the district into an interceptor sewer that is owned and operated by the city. The interceptor sewer conveys wastewater to the Littleton/Englewood Wastewater Treatment Plant for required treatment. The city presently accepts wastewater from Platte Canyon into our sewer interceptor on the east side of the South Platte River, near West Crestline Avenue. Platte Canyon owns and operates a sewage lift station on the west side of the river, which pumps wastewater beneath the river and up into the city's sewer interceptor. The area of Littleton west of the river is generally north of Bowles Avenue to Berry Avenue and west of the River to Lowell Boulevard which is not served by the Platte Canyon Water and Sanitation District. The Platte Canyon sewer connects to their lift station, as authorized by Platte Canyon's Sewer Service Agreement. Littleton makes an annual payment to Platte Canyon for operation, maintenance and the future replacement of the lift station, based on it's percentage of flow through the facility.

On September 7, 2004, the city signed a Sewer Service Agreement with Roxborough to provide conveyance and treatment of that district's wastewater. Roxborough Park community is located south of the Chatfield Reservoir and east of the South Platte River. This fall, Roxborough is scheduled to begin construction of a new gravity sewer line along the west side of the South Platte River, from State Highway C-470 and eventually connect to the city's 54" interceptor sewer located just west of Santa Fe Drive at Zuni Street. The Roxborough sewer line will cross under the river to the west side then proceed south to the Roxborough Park. This gravity flow sewer will pass by Platte Canyon's sewage lift station.

Platte Canyon and the city asked Roxborough to consider allowing the inflow sewer to the lift station to be connected to the proposed Roxborough gravity sewer. In order to do so, the Roxborough sewer needed to be enlarged from the lift station north to the city's interceptor. By making this connection, the lift station will no longer be necessary and could be removed by Platte Canyon.

This proposed IGA will establish each party's cost share for design and construction of an enlarged Roxborough sewer and designate ownership of the sewer line in Littleton.

This past summer, Roxborough relocated the existing storm sewer in the Belleview Avenue / Zuni Street intersection, to eliminate a conflict with Roxborough's proposed gravity sewer. The storm sewer provides drainage runoff control of the frontage road and the business properties south of Belleview Avenue and west of Santa Fe Drive to the river. This storm sewer should be owned and operated by the city as the public street drains to the river via this storm sewer. Appropriate drainage easements have been or will be dedicated to the city. The Facilities Conveyance Agreement will establish the city's ownership of the existing storm sewer.

FINANCIAL DETAILS

The cost of Roxborough's enlarged pipeline, from Platte Canyon's lift station sewer to the connection with the city's 54" sewer interceptor, is to be shared by Roxborough, Platte Canyon and the city based on the percentage of flow generated by properties within the boundary of each entity. The percentages break down is as follows:

Roxborough	46.4%
Platte Canyon	46.2%
Littleton	7.4%
TOTAL	100%

Littleton makes an annual operations and maintenance payment to Platte Canyon for our share of the costs of operating the existing lift station. Those annual payments from 1977 through 2005, for the years where documentation could be found, total \$97,635. Converting this total to an equivalent amount in 2005 dollars (based on 3% annual inflation), it yields a total of \$157,170 which converts to an annual payment of \$6,287 (in 2005 dollars).

Roxborough has paid for the entire \$171,622 cost to relocate the city's storm sewer at West Belleview Avenue and South Zuni Street, to be covered under the Facilities Conveyance Agreement.

LEGAL OPINION

The City Attorney has reviewed the IGA, Facilities Conveyance Agreement and the Resolution and all have been approved as to form.

CONFLICTS AND/OR COMPLICATIONS

The standard Sewer Service Agreement executed with each district states the city will accept untreated sewage from the district properties. The Sewer Service Agreement also designates a point of connection for each district. Compliance with this provision does not allow Platte Canyon to connect their sewer to the Roxborough sewer, but requires the point of connection to be a line owned and operated by the city. Under the proposed IGA, the city will accept ownership of the sewer to be constructed by Roxborough, once all bonds and financing costs have been paid by Roxborough. To facilitate possible additional, future connections to the sewer, the city will ultimately accept ownership of the gravity sewer to be constructed by Roxborough north of C-470.

In return for the city assuming future costs of operation and maintenance of that sewer, Roxborough has agreed to pay the entire amount of Littleton's initial share of gravity flow sewer construction costs, estimated to be approximately \$129,500. So the city's cost as a result of entering into this IGA, will be zero. Littleton has been paying an average of \$6,287 each year to Platte Canyon for the city's share of the lift station O&M costs. Once the Platte Canyon sewer bypasses their lift station and connects to the Roxborough sewer, this annual fee payment will be reduced to zero. The cost of maintaining the Roxborough gravity sewer is estimated to be less than the current amount paid by the city for the Platte Canyon lift station.

The existing Platte Canyon lift station is about 28 years old. It is approaching the end of it's service life, and in the near future may need to be completely replaced. The existing Scwer Service Agreement would require the city to pay a portion of the cost to replace the lift station. If Platte Canyon sewer connection to the Roxborough sewer is not made, Platte Canyon will eventually have to proceed with the replacement of the lift station facility. Littleton's cost share for that work could exceed \$50,000. This amount would be in addition to normal lift station O&M costs.

CONCLUSION AND RECOMMENDATIONS

Staff recommends approval of both Agreements.

Gravity Interceptor Sewer Right-of-Way Map



RECITALS

WHEREAS, James and Kathleen Ackerman ("Grantor") and the District (formerly known as Roxborough Park Metropolitan District) entered into that certain Easement Agreement, dated December 30, 2005, and recorded in the Arapahoe County Clerk and Recorder's Office on March 24, 2006, at Reception No. B6045832, a copy of which is attached hereto as <u>Exhibit A</u> ("Easement Agreement"); and

WHEREAS, pursuant to the Easement Agreement, Grantor granted, bargained, sold, and conveyed to the District, its successors and permitted assigns, a perpetual non-exclusive easement ("Easement") to construct, reconstruct, operate, use, maintain, repair, replace and/or remove certain sanitary sewer lines, pipes, buried or underground water and sanitary sewer improvements and related facilities and appurtenances thereto including underground utilities to serve same (the "Improvements"), in, to, through, over, under and across certain parcels of real property located in Arapahoe County, Colorado, as described therein; and

EASEMENT AGREEMENT

(Littleton Pipeline Extension Parcels Nos. 1 and 3)

For and in consideration of the compensating amount described in Paragraph 9 herein, and for other good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, James and Kathleen Ackerman, having an address of 2410 West Belleview Avenue, Lot 2, Littleton, Colorado 80120 (the "Grantor"), hereby grants, bargains, sells and conveys to ROXBOROUGH PARK METROPOLITAN DISTRICT, a quasi-municipal corporation and political subdivision of the State of Colorado, whose address is 6222 North Roxborough Park Road Littleton, CO 80125 (the "District"), its successors and permitted assigns, a perpetual non-exclusive easement (the "Easement") to construct, reconstruct, operate, use, maintain, repair, replace and/or remove certain sanitary sewer lines, pipes, buried or underground water and sanitary sewer improvements and related facilities and appurtenances thereto including underground utilities to serve same (the "Improvements"), in, to, through, over, under and across certain parcels of real property located in Arapahoe County, Colorado, as more particularly described and shown in Exhibits 1 and 2 attached hereto and incorporated hercin by this reference (the area contained within the Easement being referred to herein as the "Premises"). Such Easement is granted by Grantor and is accepted by District pursuant to the following terms and conditions:

1. The District, its agents, successors and permitted assigns, shall have and exercise the right of ingress and egress in, to, through, over, under and across the Premises for any purpose necessary for the construction, reconstruction, operation, use, maintenance, repair, replacement and/or removal of the Improvements. The District may further use existing roadways and parking areas owned by Grantor to access the Premises.

2. The Grantor shall not construct or place any structure or building, street light, power pole, yard light, mailbox or sign, whether temporary or permanent, or plant any shrub, tree, woody plant, nursery stock, garden or other landscaping design feature on any part of the Premises without prior written approval from the District; however,

such limitation shall not preclude the planting of grass on the Premises. Any structure or building, street light, power pole, yard light, mailbox or sign, whether temporary or permanent, or any shrub, tree, woody plant, nursery stock, garden or other landscaping design feature of any kind situated on the Premises as of the date of this Easement Agreement may be removed by the District at the sole expense of the District without liability therefore. Any structure or building, street light, power pole, yard light, mailbox or sign, whether temporary or permanent, or any shrub, tree, woody plant, nursery stock, garden or other landscaping design feature of any kind placed on the Premises by Grantor subsequent to the date hereof without the District's consent may be removed by the District without liability to the District.

3. With the exception of removal of those things enumerated or contemplated in paragraph 2 above, upon completion of its activities, the District, to the extent practicable, shall restore the Premises to its original state as nearly as reasonably possible, including the surface of the ground and all permitted landscaping, to the condition it was in immediately prior to the date of this Easement Agreement, except as necessarily modified to accommodate the Improvements or as necessarily modified to accommodate changes to the surface of the ground and all permitted landscaping made by Grantor subsequent to the date of this Easement Agreement.

4. The District shall have the right, upon reasonable notice, to use so much of the adjoining premises of the Grantor during surveying, construction, reconstruction, use, maintenance, repair, replacement and/or removal of the Improvements as may be reasonably required; provided, however, that such activities shall not interfere unreasonably with Grantor's use and enjoyment of such adjoining premise.

5. The District shall have and exercise the right of subjacent and lateral support to whatever extent is necessary for the operation and maintenance of the Improvements. It is specifically agreed between and among the parties that, except as provided in this Easement Agreement, the Grantor shall not take any action, which would impair the lateral or subjacent support for the Improvements.

6. It is expressly acknowledged and agreed that the District shall have the right and authority to assign the Easement or grant licenses therein to any appropriate local governmental entity or to any public utility provider, including but not limited to all

rights to use, and all obligations associated with, the Easements as are granted to and assumed by the District herein. In addition, the District shall have the right and authority to grant temporary non-exclusive construction easements or license agreements to any appropriate local governmental entity or public utility provider for purposes of construction, reconstruction, operation, use, maintenance, repair, replacement and/or removal of the Improvements consistent herewith.

7. The District agrees that at such time and in the event that the Improvements and/or Easement described herein are abandoned by the District by written notice to Grantor, such Easement shall terminate and the real property interest represented by such Easement shall revert to the Grantor, its heirs, successors and/or assigns.

8. The Grantor warrants, covenants, grants, bargains and agrees to and with the District that the Grantor is well seized of the Premises above conveyed and has good, sure, perfect, absolute and indefeasible estate of inheritance, in law, in fee simple and has good right, full power and lawful authority to grant, bargain, sell and convey the same in manner and form as aforesaid, and that the same are free and clear from all former and other grants, bargains, sales, liens, taxes, assessments, encumbrances and restrictions of whatever kind of nature except those of record.

9. In consideration for Grantor's interest of the Easement, the District agrees to pay Grantor an amount of Nineteen Thousand Nine Hundred Twenty-Four Dollars and thirty-two cents (\$19,924.32).

10. Each and every one of the benefits and burdens of this Easement shall incur to and be binding upon the respective legal representatives, administrators, successors and permitted assigns of the Grantor and the District.

11. The Grantor reserves the right to grant further easement interests in the Premises to other third parties so long as such interests and uses are not inconsistent with, and do not unreasonably interfere with, the use of the Premises and benefits of this Easement by the District, its successors and permitted assigns, as described herein, such determination to be made by the District in its reasonable discretion.

12. The District shall be the owner of the Improvements and as such, the District agrees to assume all costs, expenses, and other responsibility for the

maintenance, repair and replacement of the pipeline and any other improvements on the Premises permitted under this Easement Agreement. The District reserves the right to assign or contract with a third party for the operation and maintenance and repair of the Improvements. Furthermore, the District reserves the right to assign the maintenance to another governmental entity after completion of the Improvements. District agrees that for a period of one (1) year following construction which involves disturbance of the surface of the ground of the Premises directly above the constructed pipeline, the District will maintain the surface elevation and quality of the soil and/or asphalt by correcting any settling or subsiding that may occur as a result of the work done by District.

13. The rights and responsibilities set forth in this Easement Agreement are intended to be covenants on the Premises and are to run with the land until this Easement is abandoned or terminated pursuant to the terms set forth herein.

14. Nothing in this Easement Agreement shall be construed as a waiver in whole or in part of any governmental immunity granted to the District in Section 24-10-101 et seq., C.R.S., as it currently exists, or may hereafter be amended.





ASSIGNMENT OF EASEMENT AGREEMENT

This ASSIGNMENT OF EASEMENT AGREEMENT (the "Assignment") is made and entered into this _____ day of _____, 20___, by and between ROXBOROUGH WATER AND SANITATION DISTRICT, a quasi-municipal corporation and political subdivision of the State of Colorado (the "District" or "Assignor"), and CITY OF LITTLETON, COLORADO, a municipal corporation of the State of Colorado (the "City" or "Assignee") (collectively, the "Parties").

RECITALS

WHEREAS, the State of Colorado, acting by and through the Department of Natural Resources, Colorado Water Conservation Board ("Grantor") and the District (formerly known as Roxborough Park Metropolitan District) entered into that certain Easement Agreement, dated March 30, 2006, and recorded in the Arapahoe County Clerk and Recorder's Office on April 7, 2006, at Reception No. B6054374, a copy of which is attached hereto as <u>Exhibit A</u> ("Easement Agreement"); and

WHEREAS, the Easement Agreement provides the District with a nonexclusive easement ("Easement") upon certain real property located in the County of Arapahoe, State of Colorado, as more specifically described therein (the "Property"), for the construction, operation and maintenance by the District of a waste water pipeline (the "Improvements") for a period of twenty-five years on Grantor's Property; and

WHEREAS, subsequent to the execution and recording of the Easement Agreement, the alignment of the pipeline to be constructed on certain parcels described in the Easement Agreement was modified and the parties executed an "Amendment to Easement Agreement", dated November 18, 2007, and recorded in the Arapahoe County Clerk and Recorder's Office on December 4, 2007, at Reception No. B7152234, to correct the map and legal description contained in the Easement Agreement to account for the realignment of the pipeline on the Property, a copy of which is attached hereto as **Exhibit B** ("Amendment to Easement Agreement"); and

WHEREAS, the District has conveyed, or intends to convey, the Improvements installed and constructed within the Easement area to the City; and

WHEREAS, pursuant to Paragraph 16 of the Easement Agreement, Grantor and the District understood and agreed that the District intended to assign its easement interest in the Property to the City, and the District agreed to provide written notice to Grantor of said assignment; and

WHEREAS, the District desires to assign and transfer all its right, title, obligation, and interest in, to and under the Easement Agreement and Amendment to Easement Agreement to the City; and

WHEREAS, the City is willing to accept said assignment of the District's right, title, obligation, and interest in, to and under the Easement Agreement and Amendment to Easement Agreement from the District.

NOW, THEREFORE, in consideration of the promises and mutual covenants herein contained, and for other good and valuable consideration, the legal sufficiency and receipt of which are hereby mutually acknowledged, the Parties hereby agree as follows:

1. The District hereby assigns to the City all of the District's right, title, obligation, and interest in, to and under that certain Easement Agreement attached hereto as Exhibit A, and as amended in that certain Amendment to Easement Agreement attached hereto as Exhibit B.

2. The City hereby accepts from the District the assignment of the District's right, title, obligation, and interest in, to and under the Easement Agreement and Amendment to Easement Agreement.

3. Upon execution of this Assignment, the District shall have no further right, title, obligation or interest in, to and under the Easement Agreement and Amendment to Easement Agreement.

4. Upon the recording of this Assignment in the Arapahoe County Clerk and Recorder's Office, the District shall provide written notice to Grantor of this Assignment.

5. This Assignment and the provisions hereof shall be governed by, and construed in accordance with, the laws of the State of Colorado.

6. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and assigns.

THIS EASEMENT AGREEMENT is made and entered into this $\frac{2p}{2}$ day of $\frac{N}{2}$, 2006 by and between the STATE OF COLORADO, acting by and through the Department of Natural Resources, Colorado Water Conservation Board whose address is 1313 Sherman Street, Denver, CO 80203, (hereinafter, the "Grantor"), and Roxborough Park Metropolitan District, a quasi-municipal corporation and political subdivision of the State of Colorado, whose address is 6222 North Roxborough Park Road, Littleton, CO, 80125 (hereinafter, the "Grantee").

WHEREAS, the Grantor is an agency of the State of Colorado created and controlled by Title 37, Article 60, C.R.S., which functions for the welfare and benefit of the State of Colorado and its in habitants; and

WHERBAS, the United States Army Corps of Engineers ("Corps") has constructed improvements to the flow of water in the channel of the South Platte River in Arapahoe County, State of Colorado, with said improvements known as the Chatfield Downstream Channel Improvement Project ("Improvement Project"); and

WHEREAS, the primary purpose of the Improvement Project is to provide drainage, flood control and water flow regulation; and

WHEREAS, the Corps and the Grantor entered into two agreements which gave the Grantor the responsibility of acquiring land, easements, and rights-of-way for the Improvement Project and the duty of maintaining and operating the Improvement Project; and

WHEREAS, the Grantor has acquired certain fee title interests, rights-of-way and easements within the Improvement Project right-of-way for the purposes of constructing and maintaining the Improvement Project; and

WHEREAS, the Grantee wishes to acquire and the Grantor is willing to grant a twenty-foot (20°) wide non-exclusive easement for the construction, operation and maintenance of a waste water pipeline on the Grantor's property within the Improvement Project; and

WHEREAS, the Grantor approved granting such an easement to the Grantee at the Grantor's March 2005 meeting.

WITNESSETH:

That, for and in consideration of a one-time payment of fifty thousand dollars (\$50,000) and other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, and the keeping and the performance of the covenants and agreements hereinafter expressed, Grantor grants to Grantee a nonexclusive easement upon the following property (hereinafter, the "Property") located in the County of Arapahoe, State of Colorado, to wit:

DRAWINGS AND LEGAL DESCRIPTIONS OF THE EASEMENTS' AREAS ARE ATTACHED HERETO AND INCORPORATED HEREIN AS PARCEL 1, SANITARY SEWER EASEMENT, PARCEL 2, SANITARY SEWER EASEMENT, PARCEL 3, SANITARY SEWER EASEMENT, PARCEL 4, SANITARY SEWER EASEMENT, AND PARCEL 5, SANITARY SEWER EASEMENT (CONSISTING OF A TOTAL OF THIRTEEN (13) PAGES).

TO HAVE AND TO HOLD, subject to the covenants and agreements hereinafter expressed, for the purpose of using the Property for a waste water pipeline for a period of twenty-five (25) years, to commence upon execution of this Basement Agreement.

GRANTOR AND GRANTEE MUTUALLY EXPRESSLY COVENANT AND AGREE:

1. If at any time during the term of this Easement Agreement Grantee does not for a period of 366 consecutive days make use of this easement for the purpose aforesaid, Grantor may in its sole discretion immediately declare such easement

abandoned and shall so notify Grantee by certified mail with return receipt requested. In the event of such abandonment the consideration shall be forfeited.

This easement is non-exclusive and the grant of easement is subject to and subordinate to any and all previously granted easements, rights-of-way, licenses and conveyances, recorded or unrecorded. It is Grantee's sole responsibility to determine the existence of any rights, uses or installations conflicting with Grantee's use of the Property hereunder. Grantee agrees to not interfere with any use in the easement area by any other party under a previous grant, whether granted by Grantor or previous owner. Grantee understands and agrees that Grantor makes no representations concerning ownership of nor warrants title to any of the Property. To the extent that this grant of easement may encroach on lands not owned or controlled by Grantor, Grantee assumes all responsibility for any such encroachment.

3. During the term of the Easement Agreement, the Grantor shall have the right to dispose of the Property or to use the same for other purposes subject to the rights and privileges herein granted to the Grantee. Grantor reserves the right to grant additional easements to third parties, provided that said easements do not materially interfere with the easement granted herein.

4. The terms and conditions of the easement granted herein shall be in compliance with and subordinate to the terms of the September 7, 1977 and January 29, 1980 Agreements between the United States Army Corps of Engineers and the Colorado Water Conservation Board ("Agreements"), which are incorporated herein by reference. This covenant and agreement includes but is not limited to the maintenance and operational requirements on the Grantor and its designees under those Agreements and the requirement that Grantor and its designees have unlimited access to the lands covered by this Easement to perform all necessary activities. The Grantee shall cooperate with the Grantor and its designees in the performance of its maintenance and operational requirements. Noncompliance by the Grantee with this provision shall be grounds for immediate termination of this Easement Agreement by the Grantor.

5. The signatories aver that to their knowledge, no State employee has any personal or beneficial interest whatsoever in the Property.

6. If this easement is granted pursuant to §24-82-201 C.R.S., as amended, this Easement Agreement shall not be deemed valid unless and until approved by the officials and officers of the State of Colorado as required by §24-82-202 C.R.S., as amended, or such assistants as they may designate.

7. The provisions hereof shall inure to the benefit of and bind the successors and assigns of the respective parties hereto and all covenants shall apply to and run with the land unless otherwise specifically noted.

8. The signatories aver that they are familiar with § 18-8-301, C.R.S. et. seq., (Bribery and Corrupt Influences) and § 18-8-401, C.R.S. et. seq., (Abuse of Public Office), and that no violation of such provisions is present.

9. This Easement Agreement including all exhibits, supersedes any and all prior written or oral agreements, and there are no covenants or agreements between the parties except as set forth herein with respect to the use of the Property by Grantee. No prior or contemporaneous addition, deletion, or other amendment hereto shall have any force or effect whatsoever unless embodied herein in writing. No subsequent amendment hereto shall have any force or effect unless embodied in a written agreement executed and approved by the officials and officers of the State of Colorado as required by the Colorado Revised Statutes, as amended, or such assistants as they may designate.

10. Grantee shall be responsible for recording this Easement Agreement with the Clerk and Recorder's Office in the county or counties in which the Property is located. Grantee shall provide Grantor with a conformed copy of the recorded easement.

11. Any notice required or permitted by this Easement Agreement may be delivered in person or sent by registered or certified mail, return receipt requested, to the party at the address as hereinafter provided, and if sent by mail it shall be effective when posted in the U.S. Mail Depository with sufficient postage attached thereto:

- 12. Grantor reserves all rights to any and all metallic and non-metallic minerals, ores and metals of any kind and character, including but not limited to coal, asphaltum, oil and gas in or under said easement.
- 13. If any part of this Easement Agreement is found, decreed or held to be void or unenforceable, the remainder of the provisions of this Easement Agreement shall not be affected thereby and shall remain in full force and effect.
- 14. This Easement Agreement shall be governed by the laws of the State of Colorado.
- 15. The parties hereto understand and agree that liability for claims for injuries to persons or property arising out of the negligence of either party, its departments, institutions, agencies, enterprises, boards, officials, and employees is controlled and limited by the provisions of the Colorado Governmental Immunity Act, §24-10-101, et seq. C.R.S. and §24-30-1501, et seq. C.R.S. Any provision of this Basement Agreement, whether or not incorporated herein by reference, shall be controlled, limited and otherwise modified so as to limit any liability of the Grantor and the Grantee to the above cited laws.

16. The parties hereto understand and agree that it is the intent of Grantee to assign its easement interest in the Property to the City of Littleton, Colorado. All provisions of this agreement apply to the City of Littleton, or any other successors or assigns, upon assignment of the casement. In the future, when the Grantee desires to assign this Easement to the City of Littleton, Colorado, the District agrees to provide written notice to the Grantor of this assignment. Furthermore, Grantee agrees to record the Assignment of Easement in the records of the Arapahoe County Clerk and Recorder, Colorado. Any additional other assignments of this Easement shall not be made in whole or in part, by either Party without the prior written consent of the other Party.

GRANTOR EXPRESSLY COVENANTS:

1. Grantee and Grantee's agents, assigns and successors shall have access at all times, subject to Grantor's security policies and procedures, to the Property for construction and maintenance of the waste water pipeline. Upon non-renewal, abandonment or termination of any of the Grantee's rights or privileges under this Easement Agreement, the Grantee's rights to access shall terminate.

GRANTEE EXPRESSLY COVENANTS

- 1. Grantor shall have, during the continuance of this easement, the right to dispose of the Property and to use the Property for other purposes provided such use does not materially interfere with the easement granted herein. In the event Grantor shall, in the future, wish to grant additional easements or rights-of-way which encroach upon the easement granted herein, Grantee expressly agrees and covenants it will consent to share the Property, provided the proposed additional easements or rights-of-way do not materially interfere with the purposes for which this easement is granted.
- 2. In the event of termination, Grantee, at its expense, shall, upon written request by Grantor, remove all improvements constructed by Grantee from the Property within ninety (90) days of termination and restore the Property as nearly as is practicable to the condition of the land existing immediately prior to Grantee's first use. In the event that Grantee does not remove the improvements within such 90-day period, Grantor shall have the option to either 1) remove the improvements and restore the Property to its prior condition and bill the Grantee for the cost of removal and restoration, or 2) consider such improvements abandoned and the improvements shall become the property of Grantor. Except as otherwise provided herein, termination of this Easement Agreement shall be by operation of law. If this Easement Agreement is so terminated, consideration paid shall be forfeited.
- 3. Grantee may not use this grant of easement for any purpose other than that which is specifically described herein. If the Property is used by Grantee for any purpose other than stated herein, the easement is automatically terminated, and all of the right, title and interest of Grantee (and Grantee's successors or assigns) in and to the Property become null and void, and the Property shall absolutely revert to and revest in Grantor as fully and completely as if this instrument had not been executed, without the necessity for suit or re-entry and Grantee shall remove improvements as provided

above. No act or omission on the part of any beneficiary of this paragraph shall be a waiver of the operation or enforcement of the paragraph.

- 4. It shall be the sole responsibility of the Grantee to obtain all necessary and applicable local, state and federal approvals and permits for the purposes set forth herein. Grantee agrees to comply with all rules, regulations and policies authoritatively promulgated pertaining to the use of the easement lands, including but not limited to local, state and federal flood plain regulations. Noncompliance by the Grantee with this paragraph and/or any such permit, rule regulation, or policy shall be grounds for immediate termination of this Easement Agreement by the Grantor.
- 5. Grantee agrees to indemnify, defend and hold harmless the Grantor against all liability, loss and expense and against all claims and actions based upon or arising out of injury or death to persons or damage to property, caused by any acts or omissions of Grantee, its successors, assigns, agents or contractors or arising out of Grantee's use of the Property. In the event that Grantee contracts for any work to be performed on the Property, Grantee shall require its contractors and subcontractors, except the Corps, to indemnify, defend and hold harmless Grantor, its employees and agents, and the Corps from any and all claims, damages and liabilities whatsoever for injury or death to persons or damage to property arising from the contractors' and/or subcontractors' actions or inactions. All contractors and subcontractors shall be required to abide by and follow the provisions of this Easement Agreement.
- 6. Grantee warrants that, throughout the term of this Easement Agreement, Grantee shall maintain continual commercial general liability insurance covering its use of the easement, with said insurance policy naming Granter as an additional insured. Copies of the current Acord Form 25 evidencing said insurance and additional insured endorsement(s) are attached to this Easement Agreement as Exhibit B and incorporated herein. Notices of renewal of this insurance shall be provided to Grantor on an annual basis. Said policy shall provide coverage in the amounts established by the Colorado Governmental Immunity Act (Article 10, Title 24, C.R.S.), both now and as hereafter amended.
- Grantee agrees that all excavations or other temporary removal of soil as required for Grantee's use of the Property for 7. the purposes set forth herein shall be properly replaced, and Grantee shall seed, restore and revegetate the surface to substantially its condition existing prior to the disturbance as reasonably possible. Grantee shall be responsible at all times for the immediate repair or replacement of, or reimbursement for any damage to the Property due to Grantee's use of the Property for the purposes set forth herein. Routes of ingress and egress for construction or for maintenance are to be limited to the minimum necessary locations, and all work areas created must be obliterated, protected against erosion, and restored to the former condition of the land, as nearly as possible by Grantee. Prior to restoring the property, Grantee shall submit a reclamation plan to Grantor for review and approval to ensure Grantor's property shall be restored as closely as possible to the original condition after construction of the project by the Grantee. Grantor shall determine, in its sole discretion, whether Grantee's restoration complies with this paragraph. In the event Grantee fails to perform the restorative or revegetative work required by this paragraph to the sole satisfaction of Grantor, and after thirty (30) days prior written notice specifying with particularity the failure and indicating the remedial steps needed to cure same, Grantor shall be allowed to perform said work, and Grantee shall pay within thirty (30) days all direct and indirect costs incurred by Grantor for restorative or revegetative work including, but not limited to, regrading, filling, revegetation, erosion control, and replacing of soil.
- 8. Grantee shall provide Grantor with as-built drawings prepared and signed by a licensed Colorado professional engineer showing the location of any improvements constructed on the Property (including location and depth of any improvements located underground) within thirty (30) days after completion of construction of such improvements.
- 9. The Grantor may, in its sole discretion, require the Grantee to relocate a portion or portions of improvements on the property by giving the Grantee at least ninety (90) days prior written notice of such requirement. All relocation costs shall be paid by the Grantee. In the event that Grantee does not remove the improvements within such 90-day period, Grantor shall have the option to either 1) remove the improvements and restore the Property to its prior condition and bill the Grantee for the cost of removal and restoration, or 2) consider such improvements abandoned and the improvements shall become the property of Grantor.
- 10. The Grantee understands and agrees that its facilities are subject to damage and total loss without liability accruing to the Grantor as a result of flooding, as the result of maintenance and operation of the Chatfield Downstream Channel Improvement Project by the Grantor, the Grantor's designees, or the Corps.
- 11. All proposed facilities to be constructed, owned, operated, and maintained by Grantee within the Improvement Project right-of-way or within any identified major drainage shall be reviewed and approved for construction by the Urban Drainage and Flood Control District ("UDFCD"). Any facilities that can qualify for UDFCD maintenance eligibility shall be done in accordance with UDFCD Guidelines for Maintenance Eligibility of Flood Control Facilities

Constructed by Others, September 2000, or as hereafter amended, and the Urban Storm Drainage Criteria Manual (USDCM).

12. The construction, storage and movement of vehicles, trucks and machinery shall be conducted at all times so as to minimize any disruption to recreational trails and paths while maximizing public safety. At all times during construction and maintenance activities, all of the recreation trails and paths shall remain open, unless adequate detours including signage and fencing are provided by the Grantec.

This ASSIGNMENT OF EASEMENT AGREEMENT (the "Assignment") is made and entered into this _____ day of _____, 20___, by and between ROXBOROUGH WATER AND SANITATION DISTRICT, a quasi-municipal corporation and political subdivision of the State of Colorado (the "District" or "Assignor"), and CITY OF LITTLETON, COLORADO, a municipal corporation of the State of Colorado (the "City" or "Assignee") (collectively, the "Parties").

RECITALS

WHEREAS, Robert J. Reindl ("Grantor") and the District (formerly known as Roxborough Park Metropolitan District) entered into that certain Easement Agreement, dated April 20, 2006, and recorded in the Arapahoe County Clerk and Recorder's Office on May 2, 2006, at Reception No. B6066824, a copy of which is attached hereto as <u>Exhibit A</u> ("Easement Agreement"); and

WHEREAS, pursuant to the Easement Agreement, Grantor granted, bargained, sold, and conveyed to the District, its successors and permitted assigns, a perpetual non-exclusive easement ("Easement") to construct, reconstruct, operate, use, maintain, repair, replace and/or remove certain sewer line, buried or underground improvements and related facilities and appurtenances thereto including underground utilities to serve same (the "Improvements") in, to, through, over, under and across certain parcels of real property described therein; and

EASEMENT AGREEMENT

(Sewer Line Parcel No. 1b)

For and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, including but not limited to the consideration described in the Temporary Construction Easement Agreement for the Sewer Line for Parcel No. 1b, recorded simultaneously herewith, the sufficiency and receipt of which are hereby acknowledged, Robert J. Reindl, having an address of 2357 S. Youngfield Way, Lakewood, Colorado 80228 (collectively, the "Grantor"), hereby grants, bargains, sells and conveys to ROXBOROUGH PARK METROPOLITAN DISTRICT, a quasi-municipal corporation and political subdivision of the State of Colorado, whose address is 6222 North Roxborough Park Road, Littleton, CO 80125 (the "District"), its successors and permitted assigns, a perpetual nonexclusive easement (the "Easement") to construct, reconstruct, operate, use, maintain, repair, replace and/or remove certain sewer line, buried or underground improvements and related facilities and appurtenances thereto including underground utilities to serve same (the "Improvements"), in, to, through, over, under and across certain parcels of real property located in Arapahoe County, Colorado, as more particularly described and shown in Parcel 1, consisting of two (2) pages, attached hereto and incorporated herein by this reference (the area contained within the Easement being referred to herein as the "Premises").

The purpose of this Easement Agreement is for construction of a sewer line and related facilities, improvements and appurtenances. Such Easement is granted by the Grantor and accepted by the District pursuant to the following terms and conditions:

1. The District, its agents, successors and permitted assigns, shall have and exercise the right of ingress and egress in, to, through, over, under and across the Premises for any purpose necessary for the construction, reconstruction, operation, use, maintenance, repair, replacement and/or removal of the Improvements. The District may further use existing roadways and parking areas owned by Grantor to access the Premises.

2. The Grantor shall not construct or place any structure or building, street light, power pole, yard light, mailbox or sign, whether temporary or permanent, or plant any shrub, tree, woody plant, nursery stock, garden or other landscaping design feature on any part of the Premises without prior written approval from the District; however, such limitation shall not preclude the planting of grass on the Premises. Any structure or building, street light, power pole, yard light, mailbox or sign, whether temporary or permanent, or any shrub, tree, woody plant, nursery stock, garden or other landscaping design feature of any kind situated on the Premises as of the date of this Easement Agreement may be removed by the District at the sole expense of the District without liability therefore. Any structure or building, street light, power pole, yard light, mailbox or sign, whether temporary or permanent, or any shrub, tree, woody plant, nursery stock, garden or other landscaping design feature of by the District at the sole expense of the District without liability therefore. Any structure or building, street light, power pole, yard light, mailbox or sign, whether temporary or permanent, or any shrub, tree, woody plant, nursery stock, garden or other landscaping design feature of any kind placed on the Premises by Grantor subsequent to the date hereof without the District's consent may be removed by the District at the expense of Grantor without liability to the District. 3. With the exception of removal of those things enumerated or contemplated in paragraph 2 above, upon completion of its activities, the District, to the extent practicable, shall restore the Premises to its original state as nearly as reasonably possible, including the surface of the ground and all permitted landscaping, to the condition it was in immediately prior to the date of this Easement Agreement, except as necessarily modified to accommodate the Improvements or as necessarily modified to accommodate changes to the surface of the ground and all permitted landscaping made by Grantor subsequent to the date of this Easement Agreement.



EASEMENT AGREEMENT

(Sewer Line Parcel No. 2)

For and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, including but not limited to the consideration described in the Temporary Construction Easement Agreement for Storm Pipeline for Parcel No. 1e, recorded simultaneously herewith, the sufficiency and receipt of which are hereby acknowledged, IRA SEALY AND SUSAN SEALY, having an address of 5221 South Santa Fe Drive, Littleton, CO 80120 (collectively, the "Grantor"), hereby grants, bargains, sells and conveys to **ROXBOROUGH PARK METROPOLITAN DISTRICT**, a quasi-municipal corporation and political subdivision of the State of Colorado, whose address is 6222 North Roxborough Park Road, Littleton, CO 80125 (the "District"), its successors and permitted assigns, a perpetual nonexclusive easement (the "Easement") to construct, reconstruct, operate, use, maintain, repair, replace and/or remove certain sanitary sewer lines, pipes, buried or underground water and sanitary sewer improvements and related facilities and appurtenances thereto including underground utilities to serve same (the "Improvements"), in, to, through, over, under and across certain parcels of real property located in Arapahoe County, Colorado, as more particularly described and shown in Parcel 1, consisting of two (2) pages, attached hereto and incorporated herein by this reference (the area contained within the Easement being referred to herein as the "Premises").

The purpose of this Easement is for construction of a sanitary sewer pipeline and related facilities, improvements and appurtenances. Such Easement is granted by Grantor and accepted by the District pursuant to the following terms and conditions:

1. The District, its agents, successors and permitted assigns, shall have and exercise the right of ingress and egress in, to, through, over, under and across the Premises for any purpose necessary for the construction, reconstruction, operation, use, maintenance, repair, replacement and/or removal of the Improvements. 2. Any structure or building, street light, power pole, yard light, mailbox or sign, whether temporary or permanent, or any shrub, tree, woody plant, nursery stock, garden or other landscaping design feature of any kind situated on the Premises as of the date of this Easement Agreement may be removed by the District at the sole expense of the District without liability therefore. Any structure or building, street light, power pole, yard light, mailbox or sign, whether temporary or permanent, or any shrub, tree, woody plant, nursery stock, garden or other landscaping design feature of any kind situated on the Premises as of the District without liability therefore. Any structure or building, street light, power pole, yard light, mailbox or sign, whether temporary or permanent, or any shrub, tree, woody plant, nursery stock, garden or other landscaping design feature of any kind placed on the Premises by Grantor subsequent to the date hereof without the District's consent may be removed by the District at the expense of Grantor without liability to the District. 3. 



WITNESSETH:

WHEREAS, Grantor, without warranting title or interest, believes that it owns either fee title or some other interest, such as an easement, in and to the four parcels of real property described below (hereinafter referred to as "Grantor's Property"); and

WHEREAS, Grantee desires to construct and thereafter operate, maintain, repair and replace, a subsurface sanitary sewer pipeline and related appurtenances within Grantor's Property.

NOW, THEREFORE, in consideration of the sum of SEVENTY-EIGHT THOUSAND, SEVEN HUNDRED TWENTY-ONE DOLLARS AND THIRTY-EIGHT CENTS (\$78,721.38) and other good and valuable consideration, paid by Grantee, the receipt of which is hereby acknowledged, Grantor hereby sells and quitclaims to Grantee, its successors and assigns, a non-exclusive easement (the "Easement") for the purpose of constructing, laying, operating, maintaining, repairing, replacing and removing a subsurface sanitary sewer pipeline of such size as is desired by Grantee ("Sanitary Sewer Pipeline"), in, through, under and across Grantor's Property more particularly described as follows:

> Four parcels of land located in the County of Arapahoe, State of Colorado, and identified herein as Parcel Nos. 1, 2, 3 and 4, and generally depicted on the Vicinity Map attached hereto as Exhibit A and incorporated herein by this reference. Parcel Nos. 1, 2, 3 and 4 are more particularly described and depicted on Exhibit B as attached hereto and incorporated herein by this reference (consisting of two pages for Parcel No. 1, two pages for Parcel No. 2, two pages for Parcel No. 3, and two pages for Parcel No. 4).

It is mutually covenanted and agreed by and between the Parties hereto as follows:

1. The term Sanitary Sewer Pipeline as used herein refers to one sanitary sewer pipeline, and all related facilities and surface appurtenances thereto; provided, however, that in no event shall the Sanitary Sewer Pipeline or any appurtenance thereto, including manholes, extend above the surface of the ground without the prior written consent of Grantor, which consent shall not be unreasonably withheld, conditioned or delayed. Notwithstanding the foregoing, no manhole or other surface appurtenance of any kind shall be located within the fairway of Grantor's golf course; provided, however, that manholes will be located adjacent to the fairway of Grantor's golf course in areas which are not paved. Such manholes shall extend above the surface of the ground in a distance not to exceed 8-inches and shall be installed in accordance with plans and specifications as approved by Grantor.

2. Grantee shall have and exercise the right of ingress and egress in, over, through and across Grantor's Property for any purpose reasonably necessary for the full enjoyment of the rights granted herein. The construction, storage and movement of vehicles, trucks and machinery shall be conducted at all times so as to minimize any disruption of play on the golf course, which shall remain open during all construction and maintenance activities. All construction and maintenance activity which occurs on Grantor's golf course shall be coordinated with Grantor's ground superintendent, who shall have the authority to route the movement of equipment and designate storage areas for materials and equipment as deemed necessary by Grantor. Further, at all times during construction and maintenance activities, all of Grantor's recreation trails and paths shall remain open, unless adequate detours are provided by Grantee, the location and routing of which shall be approved in advance by Grantor, which approval shall not be unreasonably withheld, conditioned or delayed.

3. Except in emergency situations, all routine and non-routine maintenance on and repair of that portion of the Sanitary Sewer Pipeline located within Grantor's Golf Course, shall be performed only during the month of November or such other winter months as approved in advance by Grantor in writing, so as to minimize the adverse affects on Grantor's Golf Course operation.

4. Grantee's use of Grantor's Property shall be non-exclusive, and Grantor, and Grantor's successors and assigns shall have an equal right to the use of Grantor's Property for all the same purposes and to the same extent as herein granted to Grantee or for any other purpose to the full extent permitted by law, but without unreasonably interfering with Grantee's use thereof. By way of explanation and not limitation, and subject to the provisions of paragraph 5 below, Grantor reserves the right unto itself, in common with Grantee, to use the surface and subsurface of Grantor's Property for any and all purposes, including, without limitation, golf course, trail, and other park and recreation purposes, including the installation of fencing, landscaping and other improvements. Further, Grantor shall have the right to grant additional subordinate easements, licenses and rights-of-way, in, through, over and across Grantor's Property for any and all purposes, including, without limitation, roads, streets, walks, utilities, including, without limitation, water, storm sewer, sanitary sewer, telephone, cable television, internet, fiber optic, gas and electrical utilities and equipment, and the installation, maintenance, construction, reconstruction, enlargement, relocation and operation thereof.

5. Grantor shall not plant any trees, woody plants or shrubs within the Easement without the prior written approval of Grantee, which approval shall not unreasonably be withheld. In addition, Grantor shall not place any street light, power pole, yard light, mailbox, or sign, whether temporary or permanent within the Easement without the prior

written approval of Grantee, which written approval shall not unreasonably be withheld. Nothing herein contained shall preclude the Grantor from using that portion of Grantor's Property that is paved parking area, for the parking of motor vehicles, except when the Grantee may be constructing or repairing the Sanitary Sewer Pipeline within the affected parking area. Any structure or building, street light power pole, yard light, mailbox or sign, whether temporary or permanent, or any tree, woody plant, or shrub, placed by Grantor within the Easement, without the prior written approval of Grantee, may be removed by Grantee at Grantor's expense and without liability to Grantee.

6. Grantee shall maintain the Sanitary Sewer Pipeline in good repair and condition and shall at all times operate the same in accordance with all applicable federal and state laws. After construction of the Sanitary Sewer Pipeline, or any other exercise of Grantee's rights hereunder that disturbs or damages the surface of Grantor's Property (including any adjacent property) or any improvement located thereon, including but not limited to, sod, landscaping, parking or trail surfaces, Grantee shall replace the same to Grantor's reasonable satisfaction, in accordance with an approved reclamation plan as set forth in paragraph 13 below.

7. Grantor covenants and agrees that Grantee shall have the right of subjacent and lateral support for Grantor's Property, to whatever extent is necessary or desirable for the full, complete and undisturbed enjoyment of the rights of Grantee hereunder. It is specifically agreed that Grantor shall take no action that will materially increase or otherwise adversely impair the earth cover over, or the lateral or subjacent support for the Sanitary Sewer Pipeline and appurtenances within the Grantor's Property without the prior written consent of Grantee, which consent shall not be unreasonably withheld, conditioned or delayed.

8. Grantor enters into this Easement Deed and License Agreement upon the expressed condition that the Easement and License herein granted shall last only so long as the Grantee utilizes Grantor's Property for the sole purpose of operating, maintaining, replacing and repairing the Sanitary Sewer Pipeline and related facilities. In the event Grantee utilizes Grantor's Property for any purpose other than the specific purpose identified herein, all of the Grantee's right, title and interest in and to Grantor's Property shall become null and void and the rights herein granted to Grantee shall absolutely revert to and vest in Grantor as fully and completely as if this instrument had not been executed, without the necessity for suit or reentry; and no act or omission on the part of Grantor shall be a waiver of the operation and enforcement of this clause.

9. Grantee expressly covenants and agrees that in the event of the termination of this Easement Deed and License for any reason, including Grantee's abandonment of its rights herein contained, Grantor, in the reasonable exercise of its discretion, may require the removal, at Grantee's sole expense of the Sanitary Sewer Pipeline and all related appurtenances from Grantor's Property and require the Grantee to restore the surface of Grantor's Property and any improvements located thereon, as nearly as possible, to the condition that existed as of the date of such termination.

10. Grantee expressly covenants and agrees that its use of Grantor's Property shall at all times be in compliance with and subordinate to the terms and provisions of any and all prior agreements that affect or in any way relate to Grantor's Property under any prior recorded agreements. This covenant includes, but is not limited to, the operational and maintenance requirements imposed upon the Grantor and its designees under any prior recorded agreements entered into between the Grantor and the Colorado Water Conservation Board. Grantee further understands that any violation of this provision shall entitle Grantor to any and all available remedies at law or in equity, except that a violation of this provision by Grantee shall not be grounds for termination this Easement Deed. Copies of the foregoing operational and maintenance requirements shall be provided by Grantor upon execution of this Easement Deed, to the extent the same cannot be obtained by Grantee through a search of the records of the Arapahoe County Clerk and Recorder's Office.

11. Each and everyone of the benefits and burdens of this Easement Deed and License Agreement shall inure to and be binding upon the respective legal representatives, heirs, executors, administrators, successors and assigns of the Parties hereto.

12. In addition to the permanent easement described above, Grantor hereby grants to the Grantee a Temporary Construction Easement for the purpose of constructing the Sanitary Sewer Pipeline. Said Temporary Construction Easement is for Parcels T1, T2, T3, and T4 as more particularly described and depicted on Exhibit C as attached hereto and incorporated herein by this reference (consisting of two (2) pages for Parcel No. T1, two (2) pages for Parcel No. T2, two (2) pages for Parcel No. T3, and two (2) pages for Parcel No. T4). Said Temporary Construction Easement shall expire and be of no further force or effect nine (9) months from the date construction of the Sanitary Sewer Pipeline commences on Grantor's property. Grantee shall provide written notice to Grantor of the date upon which construction of the Sanitary Sewer Pipeline commences on Grantor's property to permit calculating the date upon which the Temporary Construction Easement shall terminate. During the term of the Temporary Construction Easement, Grantee shall not erect or construct or allow to be erected or constructed any building or other structures within the Temporary Construction Easement Area other than those as may be required by any applicable State or Federal regulation (by way of example, portable restroom facilities).

13. Grantee covenants and agrees to restore, to Grantor's reasonable satisfaction, all lands and improvements located within the Temporary Construction Easement and Grantor's Property that are damaged or disturbed by Grantee's activities thereon. By way of explanation and not limitation, in connection with Grantee's use of Grantor's Property and Parcels T1, T2, T3, and T4, Grantee, prior to entry thereon, shall provide to Grantor for Grantor's approval, a reclamation plan to ensure that the area and improvements located within Grantor's Property and Parcels T1, T2, T3, and T4, Grantee, prior to entry thereon, shall provide to Grantor for Grantor's approval, a reclamation plan to ensure that the area and improvements located within Grantor's Property and Parcels T1, T2, T3, and T4 shall be restored as nearly as is reasonably possible to the condition that existed prior to Grantee's entry. The reclamation plan shall set forth a time schedule within which all reclamation activities shall be completed. Time is of the essence in the performance of all reclamation activities. In the event Grantee fails to restore the improvements to Grantor's reasonable satisfaction within the approved time, Grantee shall pay to Grantor liquidated damages in the amount of Two Hundred Dollars (\$200.00) per day, until such time as the improvements are restored per the

approved reclamation plan. The Parties agree that it would be difficult to determine actual damages Grantor may sustain in the event Grantee fails to timely reclaim any area disturbed as a result of Grantee's construction activities. The Parties further agree that said Two Hundred Dollars (\$200.00) per day is a reasonable measure of said damages in light of such difficulty.

14. To the fullest extent permitted by law, Grantee covenants and agrees to at all times protect, indemnify and hold harmless Grantor, its directors, officers, agents, employees, successors and assigns from and against any and all claims, costs, liabilities or expense of whatsoever kind or nature arising from, alleged to arise from, or that relate in any way to this Easement Deed and License Agreement or the construction, existence, maintenance, operation, repair, inspection, removal, or replacement of the Sanitary Sewer Pipeline and related appurtenances.

15. All costs associated with this Easement Deed, including surveying, construction, repair, and maintenance of any of Grantee's facilities shall be borne by Grantee; and Grantee shall and does hereby agree to indemnify and save harmless Grantor from all claims for damages or liens arising from the surveying, construction, repair, and maintenance of any of Grantee's facilities located within the District Property.

16. Nothing in this Easement Deed shall be constructed as a waiver, in whole or in part, or either party's rights, protections, and privileges as granted by the Colorado Governmental Immunity Act, § 24-10-101, *et seq.*, C.R.S.

17. Notwithstanding any other provision contained herein or in any attached Exhibit to the contrary, Grantor makes no representation or warranty regarding the use of Grantor's Property, hereby transferring to Grantee only such rights of use, if any, as Grantor itself may have, subject to Grantor's continuing right to use Grantor's Property as more particularly set forth in paragraph 4 above and subject to any and all prior liens, encumbrances, easements, restrictions, reservations and rights-of-way which may affect Grantor's Property.

18. This Easement Deed and the terms, conditions and provisions hereof may be enforced by either of the parties hereto and their successors and assigns; and in the event legal or administrative suits or proceedings are brought against any party for the purpose of such enforcement, the prevailing party shall recover from the non-prevailing party all costs associated therewith, including but not limited to reasonable attorney's fees.

19. This Easement Deed shall be subject to the South Suburban Park and Recreation District Easement Covenants, which are attached hereto and incorporated herein as Exhibit D. In the event of a conflict between the terms and provisions of the Easement Deed and the Easement Covenants, the Easement Covenants shall control.

20. It is expressly acknowledged that at some point in the future a portion of the Sanitary Sewer Pipeline may be dedicated to the City of Littleton, for ownership and maintenance.

The rights and responsibilities set forth in this Easement Deed are intended to 21. inure to the benefit of the Parties hereto, and their respective successors and assigns, and as such, shall run with the land encumbered by this Easement Deed until such time as the Easement or Temporary Construction Easement may be abandoned or terminated as provided herein.

SOUTH SUBURBAN PARK AND RECREATION DISTRICT EASEMENT COVENENATS

THE DISTRICT AND THE USER COVENANTS AND AGREES TO THE FOLLOWING STANDARD SET OF EASEMENT COVENANTS:

1. Vehicles allowed on the easement property will only be those reasonably necessary and/or appropriate for the work to be performed. No private vehicle parking will be allowed. Upon completion of the project, all damage will be repaired.

2. Subject to the terms of the agreement to which this Exhibit is attached, all natural materials will be returned to their original conditions after completion of the project. Plant materials shall be replaced on an assessed dollar value, as determined by South Suburban Park and Recreation District. Plant material replacements will be installed according to South Suburban's standard specifications, which will include, but are not limited to, property storage and installation of the natural materials so as to maximize the chance for survival. Any such installations shall be guaranteed for a minimal period of one year after installation.

3. The surface layer of ground will be scraped two (2) inches deep and stockpiled for replacement as top soil before soil preparation.

4. Backfilled trenches shall be compacted to ninety percent (90%) Standard Proctor Density. Physical tampering will be done between eight (8) inch layers (maximum) of backfill.

5. After replacing the stored top soil, the trenched and backfilled surface will be scarified.

6. Excess material shall be removed from the site.

7. The disturbed area shall be reseeded as per specifications of the District.

8. The easement shall be maintained in a clean and sanitary condition and the improvements thereon in good repair at all times.

9. The contemplated improvements are to be completed in a reasonable period of time, and in accordance with the pre-approved schedule.

10. Access onto property shall be according to an approved plan and as much as possible be confined to the shortest feasible route from the nearest street, as pre-approved by the District.

11. All work concerning utilities and services (gas, telephone, water, sewer, cable televisions, and so forth) will be coordinated with the respective companies.

12. The District reserves the right to demand and approve specifications regarding construction in advance of said construction. Such approval in no way creates responsibility in the District for oversight or compliance with the specifications with Colorado law.

Grantee shall

provide the Grantor with copies of said insurance policies and the Grantor shall be named as an additional insured thereon.

7. The Grantee shall at no time interfere with the flow of water through the lakes within the Grantor's property, and the Grantee shall assume all risks incident to the presence, or potential presence, of water within the Grantor's property. Further, the Grantee shall take all reasonable steps necessary to protect the sewer line from surface or ground water damage. Grantee shall prepare and submit an erosion control plan to the grantor for its review and approval prior to any work.

Grantee shall use reasonable means to prevent the discharge or leakage of sewage 8. into or upon and damage to the Grantor's property resulting from the construction, modification, replacement or repair, use, operation and maintenance of the Grantee's sewer line. Any cleanup, repair or replacement of the Grantor's property, or installations on said property, shall be made by Grantee at its sole expense when the same is the result of the negligence of Grantee, its agents, officers, employees, contractors, arising from the construction, modification, operation, maintenance, repair, use or replacement of Grantee's sewer line. With regard to any discharge, leak or spill occurring as a result of the sole negligence of the Grantor or its agents, officers, employees or contractors, clean-up shall be at the sole expense of Grantor. Discharges or leaks of sewage or other damage which is not the result of the negligence of either party shall be allocated between the parties thereto in equal shares. With regard to any discharge, leak or spill occurring as a result of any cause, the parties shall cooperate with each other and use their best efforts to effect necessary clean-up and repair, and/or replacement, in a timely fashion; provided, however, that by performing or causing such clean-up, repair, replacement, neither of the parties shall be deemed to have waived any claim either of them may have against third parties for indemnification or reimbursement.

9. The Grantee shall have and exercise the right of subjacent and lateral support to whatever extent is necessary or desirable for the full, complete and unmolested enjoyment of the rights herein contained; provided, however, that Grantee shall not exercise said right in any manner which would interfere with, modify or change those lakes and ponds adjacent to the Property without the advance written permission of the Grantor. It is expressly agreed between the parties that the Grantor shall take no action which would impair the earth cover over, or the lateral or subjacent support for any sewer pipeline or lines and appurtenances within the Property without the advance written permission of Grantee, the earth cover over any sewer pipeline or lines may be modified, but normally permission will not be granted for a modification resulting in cover of less than 4.5 feet nor greater than 10 feet measured vertically from the top of any sewer pipeline or lines, any modification undertaken by the Grantor shall be upon terms which provide for reimbursement to the Grantee for the cost of any alterations to any pipeline facility made necessary by the change in the earth cover.

10. Except as otherwise provided herein, after construction, reconstruction, repair or maintenance or removal of lines by the Grantee or Grantee's contractor, the general surface of the Property, except as necessarily modified to accommodate appurtenances, shall be restored as

nearly as may reasonably be done, to the grade and condition it was in immediately prior to such construction and maintenance. In addition, any construction debris shall be cleaned from the site to the reasonable satisfaction of Grantor. Grantee's trenches or excavations within the Property shall be backfilled in accordance with Grantor's specifications and with the terms of this Easement Deed.

Grantee shall pay to Grantor the amount of One Hundred Twenty Thousand Dollars (\$120,000) for costs associated with Gantor's revegetation of the property following initial construction of the sewer line. Such costs shall be deemed to include, but shall not be limited to, repair and replacement of any damaged irrigation facilities, replacement of trees, bushes, and shrubs, reseeding grassy areas, construction fence removal, and soil replacement and respreading. Upon payment of the aforementioned \$120,000, Grantee shall have no other obligation to revegetate, including the repair and replacement of damaged irrigation facilities, or to maintain the same, following initial construction but shall be required to revegetate the property thereafter upon reconstruction, repairs, maintenance or removal of sanitary sewer lines as provided above.

To assist in Grantor's revegetation of the property, Grantee shall be required to remove and separately stockpile the excess in-situ material located above the excavation zone of the proposed pipeline facilities approximately every 150 feet along the length of pipeline facilities.. The Grantor will be solely responsible for revegetation of the area above the excavation zone, as well as the remaining affected areas of the Property, once the Grantee has completed backfilling the pipeline trench as provided above. Grantor's revegetation activities shall not generally commence until the Grantee has completed testing and acceptance of the pipeline facilities within the Grantee's easement, unless Grantor's revegetation can otherwise not be completed within the accepted fall or spring seeding season. Grantor's revegetation of the Property shall include spreading any excess in-situ material and scarifying the surface prior to reseeding, all in Grantor's sole discretion. Grantee shall have no obligation to spread excess in-situ material, other than to accomplish backfilling the pipeline trench, and Grantee shall have no obligation to scarify the surface on any portion of the Property.

11. Any construction contemplated or performed under this Easement Deed shall comply with and conform to all Grantor's Engineering and Utilities Division construction standards in effect at the time construction commences and shall be performed and completed in substantial conformance with the plans submitted to and approved by said Division. Grantee shall, if requested by Grantor, place and maintain permanent, visible markers, such as a bollard, of a type and at locations designated by Grantor to define the manhole locations of Grantee's sewer line installation or installations. Grantee shall provide Grantor with "as built" drawings of said construction and improvements. Except for temporary survey stakes during periods of construction, Grantee shall not place any survey monument, monument, manhole marker, marker or any other structure or improvement which projects above the surface of the ground without the advance written approval of the Grantor which approval shall not be unreasonably withheld. 12. Before replacing, enlarging, relocating or adding to its sewer line, Grantee shall advise the Grantor of such proposed change and furnish plans and specifications of the proposed change to Grantor for review and approval.

13. In case Grantee shall abandon its rights herein granted and cease to use the same, all right, title and interest hereunder of the Grantee shall cease and terminate, and the Grantor shall hold said premises as the same may then be, free from the right so abandoned and shall own all material and structures of the Grantee so abandoned, but nothing herein shall be construed as working a forfeiture, or abandonment of any interest derived hereunder and not owned by the Grantee at the time of the abandonment of Grantee's rights. Notwithstanding any such abandonment, Grantee's obligation to indemnify and save harmless the Grantee's sewer line or lines have been removed or plugged to the reasonable satisfaction of Grantor.

14. Grantee may remove the sewer line or lines installed hereunder only after providing Grantor with written notice of Grantee's intent to remove the sewer line or lines. In the event Grantee does remove its sewer line or lines, immediately following such removal Grantee shall restore the property as nearly as may reasonably be done, to the grade and condition it was in immediately prior to such removal.

15. Grantee shall comply with all applicable laws, ordinances, and all rules, regulations and requirements of any governmental authority promulgated there under controlling environmental standards and conditions of the Property and shall obtain all permits or approvals required for such work including Section 404 permits as necessary from the United States government.

16. This non-exclusive easement shall not be assigned or in any other manner transferred or conveyed, by operation of law or otherwise, without the prior written approval of the Grantor through action by the City Council, which approval shall not be unreasonably withheld, unless said assignment is operative as a matter of law, such as in a consolidation or dissolution.

17. The rights and privileges granted in this Easement Deed are subject to prior agreements, easements, licenses and conveyances, recorded or unrecorded; and it shall be the Grantee's sole responsibility to determine the existence of any such rights, uses or installations conflicting with the Grantee's use of the Grantor's Property hereunder and to resolve any conflict.

18. This Easement Deed shall extend to and be binding upon the successors and assigns of the respective parties hereto.

19. This Easement Deed constitutes the complete agreement of the parties hereto with respect to the subject matter hereof, and there are no oral understanding or agreements not contained in this Easement Deed.

20. Grantee agrees that all other public utilities, such as water, storm sewer, gas, electric and telephone utilities, may be installed within the Property as long as they do not interfere with the Grantee's rights herein granted. All public utilities crossing the easement herein granted must cross at approximately right angles and any and all of said utilities which parallel Grantee's sewer line shall not be permitted within fifteen (15) feet of each side of the centerline of the Property. The intent herein is to reserve for Grantee at least thirty (30) feet of the easement width.

21. In addition to the permanent easement described above, Grantor hereby grants to Grantee a temporary construction easement for the purpose of constructing the sewer pipeline described herein. Said temporary construction easement shall encumber Parcel T1, Parcel T2, Parcel T3, and Parcel T4, all as more particularly described on Exhibit B attached hereto and incorporated herein. Said temporary construction easement shall be of no further force or effect eighteen (18) months from the date Grantee commences construction of the pipeline on the Property. Grantee shall provide written notice to Grantor of the date upon which construction commences on the Property to permit calculating the date upon which the temporary construction easement, Grantee shall not erect or construct or allow to be erected or constructed any building or other structures within the temporary construction easement area other than those as may be required by any applicable State or Federal regulation (by way of example, portable restroom facilities).

At any time during Grantee's ownership of this Easement, Grantee reasonably determines that additional temporary construction easements are necessary, Grantor agrees, at no cost, to grant to Grantee a temporary construction easement, on, under, over and across the real property described on Exhibit "B," using a form of temporary construction easement and right-of-way agreement as proscribed by Grantor, provided however, that, in non-emergency situations the granting of the temporary easement may be delayed, modified or conditioned in such manner as will protect the wildlife in the park during critical migration, nesting and birthing periods (generally March 1 through July 31).

22. Following completion of construction on the Property, restoration and revegetation of the temporary construction easement area shall be the responsibility of Grantor, as set forth in Paragraph 10 of this Easement Deed.

23. It is contemplated that the sanitary sewer facilities constructed by Grantee on the Property will be conveyed from Grantee to Grantor at some point in the future. At such time as the sanitary sewer facilities are conveyed to Grantor, this Easement Deed shall be extinguished and Grantee shall deliver to Grantor an instrument, in a form acceptable to Grantor, delivering all of Grantee's right, title, and interest in the Property to Grantor.

PERMANENT SANITARY SEWER EASEMEN

KNOW ALL MEN BY THESE PRESENTS THAT the CITY OF LITTLETON, a

municipal corporation of the State of Colorado, Grantor, for and in consideration of TEN AND NO/100 DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the Grantor, does, for itself and on behalf of its heirs, successors and assigns, hereby grants and conveys to the ROXBOROUGH WATER AND SANITATION DISTRICT (formerly the Roxborough Park Metropolitan District), a quasi-municipal corporation and political subdivision of the State of Colorado, the Grantee, its successors and assigns, a right of entry and permanent sanitary sewer easement on that property described in Exhibit "A", which is attached hereto and incorporated herein by this reference (hereinafter the "Easement Premises"), upon which to construct, reconstruct, operate, remove, repair and maintain sanitary sewer facilities across, on, under and through the Easement Premises, said Easement Premises lying and being in the City of Littleton, County of Arapahoe, State of Colorado. As part of the grant herein contained, the parties agree as follows:

1. Grantor further covenants to and with Grantee that the Grantee's officers, agents or employees may at any or all times when necessary or convenient to do so, go over and upon said Easement Premises, and do and perform any and all acts necessary and convenient to the carrying into effect of the purposes for which this grant is made.

2. Grantor hereby reserves the right to use and enjoy the Easement Premises for any purposes which are not inconsistent with, and do not interfere with, the easement and rights herein granted to Grantee, provided, however, that such reservation by Grantor shall not include the right to erect or cause to be erected any buildings, structures, trees, or other obstructions on the Easement Premises which would preclude, interfere with, injure or make more difficult the exercise by Grantee of the easement and rights granted to Grantee hereunder.

3. Grantee agrees to restore the Easement Premises, as reasonably as possible, to the condition it was in immediately prior to any construction or maintenance activities undertaken herein. Such restoration shall not include the replacement or repair of any structure or landscaping (such as but not limited to trees, signs, walls, etc.) Such restoration shall only include repaving, regrading or reseeding of the Easement Premises.

Grantee shall use reasonable means to prevent the discharge or leakage of sewage into 4. or upon and damage to the Grantor's property resulting from the construction, modification, replacement or repair, use, operation and maintenance of the Grantee's sewer line. Any clean-up, repair or replacement of the Grantor's property, or installations on said property, shall be made by Grantee at its sole expense when the same is the result of the negligence of Grantee, its agents, officers, employees, contractors, arising from the construction, modification, operation, maintenance, repair, use or replacement of Grantee's sewer line. With regard to any discharge, leak or spill occurring as a result of the sole negligence of the Grantor or its agents, officers, employees or contractors, clean-up shall be at the sole expense of Grantor. Discharges or leaks of sewage or other damage which is not the result of the negligence of either party shall be allocated between the parties thereto in equal shares. With regard to any discharge, leak or spill occurring as a result of any cause, the parties shall cooperate with each other and use their best efforts to effect necessary clean-up and repair, and/or replacement, in a timely fashion; provided, however, that by performing or causing such clean-up, repair, replacement, neither of the parties shall be deemed to have waived any claim either of them may have against third parties for indemnification or reimbursement.

5. Any construction contemplated or performed under this Permanent Sanitary Sewer Easement shall comply with and conform to all Grantor's Engineering and Utilities Division construction standards in effect at the time construction commences and shall be performed and

completed in substantial conformance with the plans submitted to and approved by said Division. Grantee shall, if requested by Grantor, place and maintain permanent, visible markers, such as a bollard, of a type and at locations designated by Grantor to define the manhole locations of Grantee's sewer line installation or installations. Grantee shall provide Grantor with "as built" drawings of said construction and improvements. Except for temporary survey stakes during periods of construction, Grantee shall not place any survey monument, monument, manhole marker, marker or any other structure or improvement which projects above the surface of the ground without the advance written approval of the Grantor which approval shall not be unreasonably withheld.

6. If the construction of all or any part of Grantee's sewer line is to be performed by a contractor under contract with Grantee, the Grantee shall notify the Grantor and shall incorporate the applicable stipulations and conditions set forth in paragraphs 4, 5, 10, and 16 of this Permanent Sanitary Sewer Easement into the contract specifications and shall cause said contractor to obtain, prior to commencement of the work, an insurance policy or policies in an amount sufficient to cover the Grantor, its officers, agents and employees, from any losses or damages resulting from the work performed by the contractor. Grantee shall provide the Grantor with copies of said insurance policies and the Grantor shall be named as an additional insured thereon.

7. Before replacing, enlarging, relocating or adding to its sewer line, Grantee shall advise the Grantor of such proposed change and furnish plans and specifications of the proposed change to Grantor for review and approval.

8. In case Grantee shall abandon its rights herein granted and cease to use the same, all right, title and interest hereunder of the Grantee shall cease and terminate, and the Grantor shall hold said premises as the same may then be, free from the right so abandoned and shall own all material and structures of the Grantee so abandoned, but nothing herein shall be construed as working a

forfeiture, or abandonment of any interest derived hereunder and not owned by the Grantee at the time of the abandonment of Grantee's rights. Notwithstanding any such abandonment, Grantee's obligation to indemnify and save harmless the Grantor, its council members, officers, employees and agents, shall not terminate unless Grantee's sewer line or lines have been removed or plugged to the reasonable satisfaction of Grantor.

9. Grantee may remove the sewer line or lines installed hereunder only after providing Grantor with written notice of Grantee's intent to remove the sewer line or lines. In the event Grantee does remove its sewer line or lines, immediately following such removal Grantee shall restore the property as nearly as may reasonably be done, to the grade and condition it was in immediately prior to such removal.

10. Grantee shall comply with all applicable laws, ordinances, and all rules, regulations and requirements of any governmental authority promulgated there under controlling environmental standards and conditions of the Easement Premises and shall obtain all permits or approvals required for such work including Section 404 permits as necessary from the United States government.

11. This non-exclusive easement shall not be assigned or in any other manner transferred or conveyed, by operation of law or otherwise, without the prior written approval of the Grantor through action by the Littleton City Council, which approval shall not be unreasonably withheld, unless said assignment is operative as a matter of law, such as in a consolidation or dissolution.

12. The rights and privileges granted in this Permanent Sanitary Sewer Easement are subject to prior agreements, easements, licenses and conveyances, recorded or unrecorded; and it shall be the Grantee's sole responsibility to determine the existence of any such rights, uses or

installations conflicting with the Grantee's use of the Grantor's property hereunder and to resolve any conflict.

13. This Permanent Sanitary Sewer Easement shall extend to and be binding upon the successors and assigns of the respective parties hereto.

14. This Permanent Sanitary Sewer Easement constitutes the complete agreement of the parties hereto with respect to the subject matter hereof, and there are no oral understanding or agreements not contained in this Permanent Sanitary Sewer Easement.

15. Grantee agrees that all other public utilities, such as water, storm sewer, gas, electric and telephone utilities, may be installed within the Easement Premises as long as they do not interfere with the Grantee's rights herein granted. All public utilities crossing the easement herein granted must cross at approximately right angles and any and all of said utilities which parallel Grantee's sewer line shall not be permitted within fifteen (15) feet of each side of the centerline of Grantee's sewer line. The intent herein is to reserve for Grantee at least thirty (30) feet of the easement width.

16. To the extent permitted by law, Grantee shall indemnify, defend and save harmless the Grantor, its council members, employees and agents, against any and all claims or fees and court costs to which it or they may be subjected by reason of the negligent or intentional tortuous actions or tortuous failures to act of Grantee, its agents, officers or employees arising out of in connection with the construction, use, operation, modification, replacement, maintenance, repair or removal of Grantee's sewer line; provided that Grantee's total obligation to indemnify Grantor, including defense costs, shall not exceed the limits of liability as set forth in the Colorado Governmental Immunity Act, as the same now exists or as amended.

17. It is contemplated that the sanitary sewer facilities constructed by Grantee on the Easement Premises shall be conveyed to Grantor at some point in the future. At such time as the sanitary sewer facilities are conveyed to Grantor, this Permanent Sanitary Sewer Easement shall be extinguished and Grantee shall deliver to Grantor an instrument, in a form acceptable to Grantor, delivering all of Grantee's right, title, and interest in the Easement Premises to Grantor.

ASSIGNMENT OF MAINTENANCE LICENSE

This ASSIGNMENT OF MAINTENANCE LICENSE (the "Assignment") is made and entered into this _____ day of _____, 20___, by and between ROXBOROUGH WATER AND SANITATION DISTRICT, a quasi-municipal corporation and political subdivision of the State of Colorado (the "District" or "Assignor"), and CITY OF LITTLETON, COLORADO, a municipal corporation of the State of Colorado (the "City" or "Assignee") (collectively, the "Parties").

RECITALS

WHEREAS, Columbine Country Club ("Columbine") and the District entered into that certain Interceptor Redesign and Access Agreement, dated October 6, 2006, for the purpose of consolidating all understandings and commitments between the parties relating to the redesign and construction of the District's Pipeline, as such term is defined in the Agreement, away from the thirteenth green, the repair and replacement of any damaged irrigation facilities, and limited access over Columbine's maintenance road to the District's temporary construction access easement (the "Agreement"); and

WHEREAS, pursuant to Paragraph 2.d. of the Agreement, Columbine granted to the District a revocable, non-exclusive license for access across Columbine's maintenance road for the purpose of permitting the District to access the District's Pipeline to inspect and perform maintenance activities on the pipeline ("Maintenance License"); and

WHEREAS, Paragraph 2.d. of the Agreement further provides that Columbine agrees that the District may assign the Maintenance License to the City of Littleton, Colorado; and

WHEREAS, the District has conveyed, or intends to convey, the Pipeline installed and constructed within the Easement area to the City; and

WHEREAS, as part of such conveyance, the District desires to assign and transfer to the City all the District's right, title, obligation, and interest in, to, and under Maintenance License; and

WHEREAS, the City is willing to accept from the District said assignment of all the District's right, title, obligation, and interest in, to, and under the Maintenance License.

NOW, THEREFORE, in consideration of the promises and mutual covenants herein contained, and for other good and valuable consideration, the legal sufficiency and receipt of which are hereby mutually acknowledged, the Parties hereto agree as follows:

1. The District hereby assigns to the City all the District's right, title, obligation, and interest in, to, and under that certain Maintenance License as described in Paragraph 2.d. of the Agreement attached hereto as <u>Exhibit A</u>, provided however, the District reserves the right to utilize the Maintenance License to access and inspect the Pipeline as deemed necessary and appropriate by the District to ensure the integrity of the entire Pipeline.

2. The City hereby accepts from the District the assignment of the District's right, title, obligation, and interest in, to, and under that certain Maintenance License as described in Paragraph 2.d. of the Agreement.

3. Upon execution of this Assignment, the District shall have no further right, title, obligation or interest in, to, and under the Maintenance License except as otherwise provided in Paragraph 1 hereof, and shall provide written notice of this Assignment to Columbine.

4. This Assignment and the provisions hereof shall be governed by, and construed in accordance with, the laws of the State of Colorado.

5. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and assigns.

INTERCEPTOR REDESIGN AND ACCESS AGREEMENT

This INTERCEPTOR REDESIGN AND ACCESS AGREEMENT (the "Agreement"), made and entered into this $\underline{\phi}^{r/t}$ day of $\underline{\partial crotBee}$, 2006, by and between ROXBOROUGH WATER AND SANITATION DISTRICT (formerly the Roxborough Park Metropolitan District), a quasi-municipal corporation and political subdivision of the State of Colorado (the "District"), and the COLUMBINE COUNTRY CLUB, a Colorado non-profit corporation ("Columbine"), collectively referred to herein as the "Parties."

RECITALS

WHEREAS, the District is empowered by §32-1-1004, C.R.S., to provide water and wastewater service within its boundaries; and

WHEREAS, the District is in the process of constructing a regional sanitary sewer pipeline (the "Pipeline") for the purpose of transporting wastewater from the District to the Littleton-Englewood Bi-City Wastewater Treatment Plant; and

WHEREAS, a portion of the District's Pipeline will be located on property owned by the Colorado Water Conservation Board (the "CWCB") and located adjacent to Columbine; and

WHEREAS, the District has obtained a temporary construction easement and permanent easement from the CWCB, both dated March 30, 2006, and recorded in the Arapahoe County Clerk and Recorder's Office on April 7, 2006 at Reception Nos. B6054373 and B6054374, respectively, to permit the District to construct and maintain a portion of the Pipeline on CWCB's property, which property is adjacent to Columbine's golf course (the "Easement"); and


WHEREAS, Columbine has arranged to obtain an easement from CWCB to permit Columbine to put certain golf course improvements within said easement; and

WHEREAS, Columbine has redesigned and constructed a portion of its golf course on property owned by CWCB in or in close proximity to the District's Easement; and

WHEREAS, the Pipeline will be located in certain areas where Columbine recently redesigned and reconstructed the thirteenth green and the seventh hole tee-boxes which are located directly within the District's Easement; and

WHEREAS, if constructed as originally designed, the Pipeline project would require the District to trench portions of the new thirteenth green and portions of 3 of the 5 new tee boxes on the seventh hole, and would require the removal and/or destruction of multiple irrigation facilities located within the Easement area; and

WHEREAS, Columbine has requested that the District redesign and construct the Pipeline away from the thirteenth green and closer to the South Platte River; and



WHEREAS, Columbine has requested that the District mitigate and/or repair any damage to Columbine irrigation facilities; and

WHEREAS, the District is willing to redesign and construct the Pipeline away from the thirteenth green provided that Columbine pays the District's costs associated with such redesign and construction; and

WHEREAS, Columbine owns a maintenance road extending from Driver Lane across Columbine's property to the location of the District's Easement; and

WHEREAS, the District has requested limited access over Columbine's maintenance road during the District's construction of the Pipeline and very limited access on a ongoing basis thereafter to inspect and perform emergency repairs on (where no other access is practically available) the District's Pipeline, insofar as it borders Columbine; and

WHEREAS, the District and Columbine desire to enter into this Agreement for the purpose of consolidating all understandings and commitments between the Parties relating to the redesign and construction of the District's Pipeline away from the thirteenth green, the repair or replacement of any damaged irrigation facilities, and limited access over Columbine's maintenance road to the District's Easement.

NOW THEREFORE, in consideration of the covenants and agreements set forth herein, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

COVENANTS AND AGREEMENTS

1. <u>Redesign and Construction</u>. The District hereby agrees to redesign and construct the District's Pipeline away from the thirteenth green of the Columbine golf course, as more particularly depicted in Exhibit A attached hereto. Columbine agrees to pay to the District the amount of Forty Thousand Dollars (\$40,000) for the cost of the District's reasonable expenses associated with this Agreement, of which \$20,000 shall be paid upon execution of this Agreement and \$20,000 at the completion of the construction activities as described in paragraph 2(a).

2. Access to Maintenance Road.

a. <u>Temporary Construction Access Easement</u>. Columbine hereby grants to the District a non-exclusive temporary construction access easement on and across Columbine's maintenance road extending from Driver Lane across Columbine's property to the location of the District's Easement, as depicted in Exhibit B attached hereto (the "Access Easement"). The term of the Access Easement shall commence immediately upon execution of this Agreement and shall expire on September 30, 2007, or upon written notice from the District to Columbine that the District's construction activities related to use of the Access Easement have been completed, whichever is the first to occur. The District's use of the Access Easement shall be subject to the terms set forth below. Payment by Columbine to the District as provided in paragraph 1 shall be

reduced by \$5,000 per month for each month after May 31, 2007, that the District continues to use the Access Easement, provided however, the District shall be entitled to use the Access Easement after May 31, 2007 until the termination of the Access Easement with no reduction in payment so long as such use is limited to reseeding activities except as needed for reseeding activities continues to use the Access Easement.

b. <u>Traffic Control and Safety</u>. The District shall require its contractor(s) to provide for traffic safety in and around the Access Easement as if the Access Easement was a public thorough fare and shall take all reasonable steps to ensure public safety.

c. <u>Use During Construction</u>. The Parties further acknowledge that during construction of the District's Pipeline, the District and its contractors and subcontractors shall utilize the maintenance road with the minimum number trucks and other equipment, based upon industry standards for projects of similar size and scope, necessary for the construction of a reach of the Pipeline located approximately ¼ mile north of the Columbine property and extending in a southerly direction to Mineral Avenue.

The District's use of the Access Easement shall be limited to normal construction hours. The District shall use its best reasonable efforts to complete construction of the reach of the Pipeline described above and cease use of the Access Easement not later than May 31, 2007. However, in the event construction and use of the Access Easement cannot be completed by said date, the District shall be entitled to use of the Access Easement until the termination date set forth in Paragraph 2(a), above.

The District agrees to use its best reasonable efforts, and to cause its contractor(s) and subcontractors to do likewise, to minimize the amount of dirt removed from the reach of the Pipeline Easement described above via Columbine's maintenance road. Such efforts may include coordinating with Columbine to "lose" the dirt removed from the Pipeline trench in agreed upon areas on or adjacent to Columbine property.

d. Use Post Construction. Columbine hereby grants to the District a revocable, non-exclusive license for access across Columbine's maintenance road for the purpose of permitting the District to access the Pipeline to inspect and perform maintenance activities on the Pipeline (the "Maintenance License"). The term of the Maintenance License shall commence immediately upon termination of the Access Easement granted above. The District shall be permitted use of the maintenance road for purpose of inspecting and repairing the District's Pipeline facilities for so long as Columbine has the maintenance road; provided, however, if Columbine no longer has the maintenance road, Columbine shall allow alternative access to the District's Easement so long as the access does not interfere with Columbine's uses. Barring an emergency, the District does not anticipate heavy use of the maintenance road pursuant to the Maintenance License. The Parties acknowledge that it is difficult to ascertain exactly how many vehicles will utilize the Maintenance License on an annual basis; however, the District agrees to use its best reasonable efforts to minimize the number of vehicles utilizing the Maintenance License. The District shall be allowed to utilize the maintenance road for repair of the Pipeline with the vehicles and equipment necessary in the event of an emergency in which the District has no other practical means of access to resolve the emergency. In the event of such an emergency, the District shall provide notice to Columbine, at the first practical opportunity, of the extent of the emergency and schedule for completing any repairs. In the event of such emergency the Parties shall coordinate the schedule of the repairs, to the extent reasonably practicable, to limit interference with Columbine's uses. Columbine agrees that the District may assign the Maintenance License to the City of Littleton, Colorado.

3. <u>Repair and Replacement of Damaged Irrigation Facilities</u>. The District agrees to repair and replace, at its expense, any Columbine irrigation facilities damaged during construction of the Pipeline. Such irrigation facilities shall be repaired and/or replaced as near as possible to the condition existing prior to commencement of the District's construction activities.

4. <u>Restoration of Maintenance Road</u>. The District agrees to restore at its sole expense, Columbine's maintenance road or other access provided by Columbine, as near as is reasonably possible to the condition the same existed immediately prior to the District's first use of the Access Easement.

5. <u>Indemnification</u>. To the extent permitted by law, the District hereby agrees to indemnify and save harmless Columbine, its successors and assigns, and each of its directors, officers, employees, agents and consultants, from all claims and/or causes of action, including mechanic's liens, arising out of this Agreement, and in that regard agrees to pay any and all costs incurred by Columbine as a result thereof, including settlement amounts, judgments and reasonable attorneys' fees. Nothing in this Agreement shall be construed as a waiver by the District of any of the provisions of the Colorado Governmental Immunity Act, §§24-10-101, *et seq.*, C.R.S. The District shall immediately pay the cost of repair of damage to any Columbine improvements damaged by the District or its contractor(s). The District shall cause its contractor(s) to have reasonable liability insurance.

6. <u>Amendments</u>. This Agreement may be amended only by mutual agreement of the Parties; and shall be evidenced by a written instrument authorized and executed with the same formality as this Agreement is executed.

7. <u>Assignment</u>. Except as set forth herein, neither this Agreement, nor any of the Parties' rights, obligations, duties, or authority hereunder may be assigned or delegated in whole or in part by either Party without the prior written consent of the other Party, which consent shall not be unreasonably withheld. Any improper attempt to assign or delegate the Agreement, in whole or in part shall be deemed void and of no force or effect. Consent to one assignment and/or delegation shall not be deemed to be consent to any subsequent assignment and/or delegation or the waiver of any right to consent to such subsequent assignment and/or delegation.

8. <u>Notice</u>. Any notices, demands, or other communications required or permitted to be given by any provision of this Agreement shall be given in writing, delivered personally, sent by facsimile with a hard copy sent immediately thereafter via First Class U.S. Mail, or sent via First Class U.S. Mail, postage prepaid and return receipt requested, and addressed to the parties at the information set forth below. Notice shall be considered given when delivered personally

and sent by facsimile with a hard copy sent immediately thereafter via First Class U.S. Mail, and shall be considered received on the earlier of the day on which such notice is actually received by the party to whom it is addressed, or the third day after such notice is mailed.

11. <u>Integration</u>. This Agreement represents the entire, integrated agreement between the Parties with respect to the matters set forth herein and supersedes all negotiations, representations or agreements with respect to those matters, either written or oral.

LICENSE AGREEMENT

LICENSE AGREEMENT

THIS LICENSE AGREEMENT, made this__10_th day of October, 2006, between the Nevada Ditch Holding Company herein referred to as the "Company", and Roxborough Water and Sanitation District herein referred to as "Licensee" (whether grammatically singular or plural).

WITHNESSETH That:

The term "Licensee" shall include employees, agents and contractors of Licensee.

The term "property" as used herein refers to real property and includes easements, rightsof-way and other company interest in land and may some times be referred to herein as "Company property".

The Company, by these presents, without warranting title or interest, and subject to the convenants hereinafter set forth does hereby authorize the Licensee, its successors and assigns, to:

- 1. Any construction initiated under this License shall be performed and completed according to the plan and within the tolerance given on the Company's drawing (s) attached hereto and made part hereof.
- 2. The Licensee, at least thirty (30) days prior to the proposed date for commencement of the work hereby authorized, shall submit to the Company for its approval a duplicate set of final detailed plans of the installation Licensee proposes to construct, utilize, modify, repair, replace or maintain hereunder. No construction except for emergency repairs will be permitted on the licensed premises until the Company has approved the plans therefor.
- 3. The Licensee shall notify the Company at least three (3) days prior to commencement of the construction of, modifications or repairs to Licensee's installation, so that the Company may make such inspections as it deems necessary. In the event of emergency repairs required for safety or restoration of service to utility customers, Licensee shall not be required to furnish notice prior to commencing said repairs, but shall notify the Company of the nature and extent of any such emergency work.
- 4. In granting this License, the Company reserves the right to make full use of the property involved as may be necessary or convenient in the operation of the ditch system under the control of the Company and the Company retains all right in operate, maintain, install, repair, remove or relocate any of its facilities located within the Company's property at any time and in such a manner as it deems necessary or convenient. In the event Licensee's installation should interfere with the Company's use or operation of its property, at any time hereafter, the Licensee shall, upon request by the Company and at Licensee's sole expense, immediately relocate or rearrange its installation so as not to interfere with any such company use.

- 5. The Licensee shall complete its installation, clear the area of all construction debris and restore the area to its preexisting condition as nearly as may be possible within 10 days from the date of commencement or initial construction or repairs. In the event clearing and restoration of the area is not completed within the time specified, the Company may complete the work at the sole expense of the Licensee.
- 6. The Licensee shall, if required by the company, place and maintain permanent, visible markers of a type and at locations designated by the company to define the centerline of Licensee's installation. If the placing of the centerline makers is not completed within the time specified, the company may complete the work at the expense of the Licensee.
- 7. Licensee shall be responsible for obtaining any permits that may be required by state or federal laws prior to commencement of the work. Compliance with all state and federal laws and regulations as they apply to work authorized in this License is the sole responsibility of Licensee.
- 8. Unless prohibited or otherwise mandated by state or federal laws and regulations, Licensee, at its expense, may trim or cut down trees, shrubs or brush when necessary for the construction of its facility and shall remove and dispose of the cutting debris to the satisfaction of the Company.
- 9. Guy wires and/or anchors and all structures, including manholes, vaults, junction boxes, etc., shall be installed only at locations specifically authorized herein.
- 10. Unless prohibited or otherwise mandated by state or federal laws and regulations, all trenches and excavations within company property shall be backfilled in the following manner: The trench or excavation shall be backfilled to the original ground line using only suitable soft earth material. The backfill material shall be deposited in layers not to exceed eight- (8) inches loose measure for the full width of the trench. Layers shall be brought up uniformly and compacted with mechanical tampers capable of exerting a blow at least equivalent to 250 pounds per square foot, to 90% of Standard Proctor Maximum Density. The moisture content of the material shall be adjusted as required to secure the above density. The amount of water used shall be sufficient to compaction; the Licensee shall be required to grade, mix or otherwise process wet material proper moisture content or haul in suitable material.
- 11. Underground electric power line installations shall be encased in rigid steel conduit within the Company's property.
- 12. Licensee shall not and will not be permitted to discharge water into or upon any Company property of facility, but shall provide for carriage of any water over or across Company property or facility in a manner satisfactory to the Company at no expense to the Company.
- 13. At no time shall Licensee interfere with the flow of water in Company facilities and Licensee shall assume all risks incident to the presence of water in Company facilities.
- 14. The irrigation season is generally from April 1 until November 1, each year and water may be flowing in the Company's facility during this time. Any construction

Any repair or replacement of any of the Company's installation on its property made necessary, in the opinion of the Company, because of the construction modification, operation, maintenance, repair or replacement of Licensee's installation, shall be made only by the Company and at the sole expense of the Licensee.



This LICENSE AGREEMENT ("License") is made this ______ day of ______ 2015 by and between PUBLIC SERVICE COMPANY OF COLORADO, a Colorado corporation, hereinafter called "Licensor," and, the CITY of LITTLETON, a Colorado municipal corporation hereinafter called "Licensee."

RECITALS

A. Licensor is the owner of **easements or rights-of-way** for utility facilities (the "Premises"), and desires to protect the facilities located thereon and preserve the future use of said easements or rights-of-way, which is more particularly described as follows:

B. Licensee desires to maintain a sanitary sewer line of varying widths, either 36" or 24" ("licensed facility") in, under, or along portions of the Premises as more particularly shown on Exhibit A, attached hereto and made a part hereof, and desires to obtain Licensor's permission therefore.

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Licensor hereby grants to Licensee, with respect to such interest as Licensor may have in the Premises, the authorization to construct, operate, maintain, repair, inspect, remove, and replace the licensed facility in, on, under, or along the Premises, subject to the following:

(1) Licensor is the owner of a limited interest in the Premises. Licensee shall bear the sole obligation of obtaining from the fee title owner of the Premises or others owning proprietary interest in the Premises, such authority or rights as Licensee may need in addition to this license for Licensee's use of the Premises. Licensee agrees that any authorization granted herein is subject to Licensee obtaining such additional authorization.

(2) Licensor intends to use the Premises for the construction, operation, maintenance, repair, replacement, and relocation of its utility facilities, and the rights herein granted to Licensee for the use of the Premises are subject to the rights of Licensor to use the Premises for such purposes, which rights Licensor hereby expressly reserves.

(3) Licensee shall contact the Utility Notification Center of Colorado (1-800-922-1987) for location of any underground utilities, at least two working days prior to the commencement of construction on the Premises. Further, if Licensor has constructed electric transmission facilities on the Premises, Licensee shall contact Licensor's Electric Transmission Lines department at (303) 273-4669 at least four working days prior to the commencement of construction on the Premises. At the discretion of Licensor's Electric Transmission Lines department, construction activities on the Premises shall be performed only when Licensor's representative is present. The instructions of such representative relating to the protection of Licensor's facilities will be followed by Licensee, and will be considered conditions of this authorization.

(4) Licensee shall not do or permit to be done any blasting above, underneath, or near facilities on the Premises without first having received prior written permission from Licensor. Any blasting shall be done in the presence of a representative of Licensor and in accordance with directions such representative may give for the protection or safety of facilities in the area.

(5) Any damage to the Premises, or to Licensor's facilities located on the Premises, as a result of the construction, operation, maintenance, repair, inspection, removal, replacement, or relocation of the licensed facility shall be paid for or repaired at the expense of Licensee.

(6) Licensee agrees and understands that if Licensor has constructed natural gas gathering, storage, transmission, distribution, or related facilities on the Premises, Licensee has been fully advised by Licensor that such natural gas facilities may now transport and may continue to transport natural gas at significant pressures. Licensee shall advise all of its employees, agents, contractors, and other persons who enter upon the Premises, pursuant to the provisions of this license, of the existence and nature of such natural gas facilities and the danger and risk involved.

(7) Licensee agrees and understands that the natural gas facilities of Licensor, if located on the Premises, may be subject to cathodic protection by rectifier and related anode beds, and that Licensor shall not be liable for stray current or interfering signals induced in the licensed facility as a result of the operating of Licensor's cathodic protection system.

(8) Licensee agrees and understands that if Licensor has constructed electric transmission, distribution, or related facilities on the Premises, Licensee has been fully advised by Licensor that such electric facilities may now transmit and may continue to transmit electric current at significant voltages, and that the conductors on electric lines may not be insulated. Licensee shall advise all of its employees, agents, contractors, and other persons who enter upon the Premises, pursuant to the provisions of this license, of the existence and nature of such electric facilities and the potential danger and risk involved.

(9) (a) (i) As used in this license, the term "Claims" means (1) losses, liabilities, and expenses of any sort, including attorneys' fees; (2) fines and penalties; (3) environmental costs, including, but not limited to, investigation, removal, remedial, and restoration costs, and consultant and other fees and expenses; and (4) any and all other costs or expenses.

(ii) As used in this license, the term "Injury" means (1) death, personal injury, or property damage; (2) loss of profits or other economic injury; (3) disease or actual or threatened health effect; and (4) any consequential or other damages.

POLICY QUESTION:

Does city council support a hiring range of \$142,200 to \$184,800 for the city attorney recruitment?

BACKGROUND:

Salary is a key component for potential candidates when deciding whether or not to apply for a position. The city's contract recruiting firm, Waters and Company, has requested guidance in responding to potential candidates for the city attorney position pertaining to the hiring salary range.

Staff has provided a detailed memo on this issue as an attachment.

STAFF ANALYSIS:

Using the most recent Mountain State's Employer's council Denver-Boulder data for public sector attorneys and aging the data for the employment cost index, staff recommends a hiring range minimum of \$142,200 and a hiring range maximum of \$184,800. The recommended hiring range maximum is the aged weighted average for public sector city attorneys in Littleton's market area for 2017.

FISCAL IMPACTS:

The city attorney position is a direct report to city council, where a candidate may fall within the recommended hiring range would be determined by city council commensurate with a candidate's experience.

STAFF RECOMMENDATION:

Staff recommends a hiring range minimum of \$142,200 and a hiring range maximum of \$184,800.

PROPOSED MOTION:

I move to approve the recommended hiring range for the city attorney recruitment.

Candidates for the City Attorney position have been inquiring what the City's hiring rate is for the City Attorney positon. Waters and Company has only been able to tell them that it's negotiable since we have not provided them with any parameters. They have asked us to provide some guidance for answering this question, because as they continue to work with potential candidates, compensation is a key factor in deciding whether they will apply or not?

As this is a Council position, the below is a recommended guideline based on our market and would allow us to provide Waters with a hiring range to use with our candidates.

Below is a table that uses the most recent Mountain States Employer's Council Denver-Boulder market data for PUBLIC SECTOR attorneys. The data identifies the weighted average for City Attorney's in our market was \$181,200 on 1/1/2016. The City's practice has been to use the weighted average at the top of our *hiring range* for any position. Because the data is old, we would recommend aging it for the 1 year period it lags.

When aging compensation, it has been the city's practice to use the ECI or Employment Cost Index. For the 2016 year, it came in at 2%; meaning a weighted average for a Public Sector City Attorney as of 1/1/2017 would be: \$184,800. Using our city's spread for pay ranges the below table represents a recommended hiring range (Minimum – Maximum) that could serve as a guide to Waters and Company. Where a candidate would fall within the hiring range would be determined by Council commensurate with the candidate's experience.

Recommendation: It is recommended that Council support providing Waters and Company with the below 2017 Hiring Range.
