POLICY QUESTION:

Does city council support the proposed offsite roadway safety improvements for Littleton Village?

BACKGROUND:

A Subdivision Improvement Agreement (SIA) was established between the City and the Littleton Village Development in July of 2014, which identified city funding participation for roadway improvements. The design of the external roadway network associated with the Littleton Village Development was approved in March of 2015 prior to the hiring of the current Public Works Director and Transportation Engineering Manager. Upon review of the plans, multiple safety concerns were identified with the previously approved design of the external roadway network.

Supplemental roadway improvements have been identified to be included along Dry Creek Road in order to ensure as safe an environment as possible for all users of the corridor. Dry Creek Road would need some limited reconstruction along the approximately ½-mile segment between Broadway at the west end and Mineral Avenue at the east end as part of the ongoing construction for the Littleton Village Development.

The project could certainly proceed as previously approved, but staff prefers to discuss the pros and cons of addressing these additional issues before the construction is complete. Attached is a more detailed memorandum from Aaron Heumann describing the issues. Staff will present at the Study Session a summary of the issues and simplified graphics describing the possible improvements.

STAFF ANALYSIS:

With the addition of the Littleton Village Development, several safety concerns should be addressed including the location of left turn movements into Littleton Village from eastbound Dry Creek Road, identifying a designated, controlled pedestrian crossing of Dry Creek Road, upgrading pedestrian curb ramps to be ADA accessible, limiting the Bradley Sinclair Gas Station driveway access along Dry Creek Road, clearly identifying the entrance to the eastbound Dry Creek Road horizontal curve to the Mineral Avenue intersection, controlling the Pennsylvania Street access to Littleton Village, and aligning the east end pedestrian crossing of Dry Creek Road.

The reason for this conflict between what was previously approved and what current staff sees as issues lies largely with the fact that the Engineering Division of Public Works does not have a well-established set of adopted standards for projects of this scale. Using more typical, national engineering standards would suggest the additional improvements are necessary.

FISCAL IMPACTS:

The costs associated with the Dry Creek Road improvements would not be covered by the SIA since these modifications were identified subsequent to the approved design. A cost estimate has been drafted by the developer and contractor for the proposed modifications along Dry Creek Road. The total estimated cost for the improvements is \$180,000, which is proposed to be paid from the Street Rehabilitation program. Below is a summary of the 2016 projected expenditures for this program:

STAFF RECOMMENDATION:

Staff recommends approval of the safety improvements outlined in the attached memorandum dated July 19, 2016 and payment of these modifications out of the Street Rehabilitation program.

MEMORANDUM

The purpose of this memo is to summarize the design modifications identified by the city for Dry Creek Road in order to ensure the approximately ½ mile reconstructed segment between Broadway at the west end and Mineral Avenue at the east end as part of the Littleton Village Development provides safe operations for all users upon completion. The following safety concerns were identified with the previously approved design of the Dry Creek Road segment:

- 1. A concentration of left turn movements from eastbound Dry Creek Road into Littleton Village at Logan Street.
- 2. The need for a designated pedestrian crossing between Broadway and Mineral Avenue to connect Littleton Village with the existing residential neighborhood to the south.
- 3. A requirement to upgrade the pedestrian curb ramps along the south side of Dry Creek Road to satisfy ADA accessibility standards.
- 4. The need for a physical obstruction to limit the Bradley Sinclair Gas Station driveway access along Dry Creek Road to a right-in/right-out.
- 5. An improved guidance for eastbound drivers in the form of an extended median entering the curve to the Mineral Avenue intersection coupled with the need to improve the prohibition of access to Pennsylvania Street.
- 6. Modifications to the pedestrian crossing at the east end of the corridor to minimize exposure of pedestrians in the roadway and improve visibility.

This memo describes the safety concerns, the proposed roadway improvements to address the issues, and the funding required to pay for the work.

SAFETY CONCERNS

The following provides a more detailed description of the six safety concerns identified above along Dry Creek Road as part of the Littleton Village Development project.

Eastbound Dry Creek Road Left Turn Movement

A concern arose when the city realized there was a disconnect between the Littleton Village Traffic Impact Study and the planned internal roadway configurations and parcel access within the G:\Projects\Littleton Village\External Roadways\Summary Memo of Roadway Safety Improvements_071916.doc

development. The traffic report identified the only access to the overall development from eastbound Dry Creek Road would be a concentration of left turn movements at Logan Street. Internal circulation would then be required back to the west to access the commercial parcels between Broadway and Sherman Street and the Amli multi-family residential facility, which has the main access along Sherman Street.

Consequently, the City developed and discussed modifications to the current design of Dry Creek Road for the segment between Broadway and Mineral Avenue prior to the final asphalt lift being applied by the development team. In particular, potential options for the Dry Creek Road/Sherman Street intersection were considered to address the current inability to access Littleton Village from eastbound Dry Creek Road at Sherman Street, which would concentrate this left turn movement at Logan Street. Some of the options considered included:

- 1. Leaving the design as currently planned and previously approved by the city, which restricted the left turn movement from eastbound Dry Creek Road to Sherman Street.
- 2. Applying improved pavement markings from a center two-way left turn lane to clearly identified left turn bays, where appropriate.
- 3. Limiting access to the Dry Creek Station west driveway along the south side of Dry Creek Road across from Sherman Street to a right-in/right-out only.
- 4. Providing a center two-way left turn lane along Dry Creek Road through the Sherman Street and Dry Creek Station west access intersection.
- 5. Shifting Sherman Street north of Dry Creek Road to the west approximately 36 feet to align with the existing Dry Creek Station west access.

The latter design alternative was identified as the preferred option as shifting Sherman Street to the west to align with the existing driveway to the south would create a four-legged intersection with no overlapping and conflicting turn movements. The city believes this design would offer the safest option for the general public, while improving access to Littleton Village and maintaining the current access to Dry Creek Station. However, until the Littleton Village development parcel in the northwest corner of the Dry Creek Road/Sherman Street intersection, which is currently planned to be occupied by a medical office building, is more clearly identified, not enough is known about the potential impact a realignment might have on the ability to develop the property. This potential adjustment was previously potentially anticipated in the General Planned Development Plan (GPDP), which includes a provision for the location of the Sherman Street access along Dry Creek Road to be relocated without requiring an amendment to the GPDP.

In the meantime, until the medical office building design has been advanced further, the option the city is recommending is a design that creates a center two-way left turn lane for the approximately 400 foot segment of Dry Creek Road from west of Sherman Street to just west of the Dry Creek Station east access. This option allows eastbound Dry Creek Road access into Littleton Village at Sherman Street without prohibiting or limiting access to the existing Dry Creek Station west access, while having the added benefit of not prohibiting the future realignment of Sherman Street. With the full build-out of Littleton Village there is expected to be a substantial imbalance between the opposing and conflicting left turn movements. However, the center two-way left turn lane allows overlapping left turn movements to Sherman Street and the Dry Creek Station west access. As a

result, this operation will need to be monitored closely for crashes or other safety concerns, potentially requiring a modification to the control and access alignment.

Designated Dry Creek Road Pedestrian Crossing

The previous plan did not provide any designated crossing for pedestrians across Dry Creek over the almost ¹/₂ mile stretch between Broadway and Mineral Avenue for connectivity between the Littleton Village Development and existing residential neighborhoods to the south. The design did not even provide pedestrian curb ramps for crossing Dry Creek Road on the newly constructed north side of the roadway segment. Rather than waiting for the commercial businesses to open in Littleton Village and allowing pedestrians to establish a variety of potential locations to cross Dry Creek Road, the city identified a crossing location at Logan Street. This pedestrian access will be approximately half way between the end intersection crossings, along the primary access to the neighborhood to the south, and provide good orientation to the commercial businesses to the north.

The pedestrian crossing at Logan Street will be marked, signed and include a rectangular rapid flashing beacon (RRFB) system. The RRFB will allow pedestrians to activate flashers on both sides of Dry Creek Road by the push of a button. The activation will provide visible warning to drivers and establish priority to pedestrians crossing.

Pedestrian Curb Ramps

The reconstruction of a roadway requires improvements to, at a minimum, the associated pedestrian curb ramps oriented for crossing the roadway for ADA accessibility. When the Dry Creek Road design was originally prepared, such provisions were not included. However, the city should not only ensure the ramps for crossing Dry Creek Road are accessible for disabled residents and visitors, but also the ramps parallel to the roadway at Logan Street and Grant Street.

Bradley Driveway Right-in/Right-out

Prior to the widening and reconstruction of Dry Creek Road, the driveway access for the Bradley Sinclair Gas Station was signed as a "NO LEFT TURN" out. With the expansion of Dry Creek Road from an undivided two-lane to a divided four-lane section, along with the widening of the Dry Creek Road approach to the Broadway intersection to four westbound lanes (dual left turns, a through, and a right turn), the previous design included the replacement of the "NO LEFT TURN" signs for the Bradley driveway. However, observation of this access during the morning peak hour identified 15 illegal left turn movements out of the gas station driveway onto westbound Dry Creek Road, with 35 violators in one and a half hours during the evening peak period.

The combination of the gas station driveway accessing Dry Creek Road within the westbound dual left turn lanes and the vertical curve to the east limiting sight distance of oncoming vehicles, make the access a safety concern. The fact that numerous vehicles are violating the "NO LEFT TURN" signs necessitates the need to provide a physical obstruction to limit the driveway to a right-in/right-out. This restriction will require some vehicles to find alternative routes to access the gas station. However, when this issue was raised with the Bradley manager, who subsequently discussed the matter with the owners, the response to the city was the business understands the safety concern and is acceptable with the city proceeding with the installation of a raised median.

Extended East Center Median

The horizontal curvature of the eastbound Dry Creek Road approach to Mineral Avenue has proven to be a safety concern based on recent accidents and resident complaints. The extension of the center median will provide an improved physical guidance for drivers in advance of the curve. At the same time, the Pennsylvania Street access to the residential portion of the Littleton Village Development is intended to provide access in from Mineral Avenue and westbound Dry Creek Road, with access out to westbound Dry Creek Road only. While a raised median and signage was included in the design to restrict these movements, the extension of the Dry Creek Road center median will provide an improved enforcement of the turn restrictions rather than relying on signage.

East End Pedestrian Crossing

There previously was and currently is a pedestrian crossing of the westbound Dry Creek Road single lane east of Pennsylvania Street. The pedestrian curb ramps on either side of Dry Creek Road were previously oriented such that the crossing was at an angle across the roadway. In order to improve the safety of this crossing by shortening the distance and time pedestrians are required to be in the roadway and aligning the pedestrians to have improved visibility of oncoming traffic, the design was modified to align the curb ramps.

DRY CREEK ROAD DESIGN IMPROVEMENTS

The proposed modifications to the previous Dry Creek Road design in order to address the six safety concerns previously identified includes the following raised median work, pavement marking revisions, pedestrian access accommodations, and sign alterations. The associated revised design plan sheets are also attached for reference.

Median Work

There are three modifications proposed to the Dry Creek Road center raised median.

- Remove approximately 200 feet of the existing center raised median west of Sherman Street.
- Extend the center raised median from the west end of the current median approximately 250 feet almost to the Broadway intersection.
- Extend the center raised median just west of Pennsylvania Street to the west approximately 50 feet.

Pavement Markings

The following pavement markings have been included to clearly identify and designate left turn movements and pedestrian crossings.

- Stripe an approximately 400 foot center two-way left turn lane from the modified center raised median west of Sherman Street to approximately 50 feet west of the Dry Creek Station east access.
- Stripe a center median at the following three locations: (a) for approximately 50 feet from the center two-way left turn lane to the west approach to the Dry Creek Station east access;
 (b) for approximately 50 feet from west of Grant Street to the end of the westbound left turn

lane to the Dry Creek Station east access; and (c) for approximately 700 feet from the end of the westbound left turn lane to Logan Street to the end of the center raised median just west of Pennsylvania Street.

- Add left turn lanes along Dry Creek Road at the following four locations: (a) an approximately 75 foot westbound left turn lane to the Dry Creek Station east access; (b) an approximately 75 foot westbound left turn lane to Grant Street south; (c) an approximately 150 foot eastbound left turn lane to Logan Street north; and (d) an approximately 75 foot westbound left turn lane to Logan Street south.
- Add right turn arrows where missing along eastbound Dry Creek Road in the designated right turn lanes to driveways and roadways between Broadway Street and Grant Street.
- Add pedestrian crosswalks with 2 foot wide by 6 foot long zebra pattern striping across the Sherman Street, Grant Street and Logan Street north approaches to Dry Creek Road (also described below under Pedestrian Crossings). In addition, add the pavement marking associated with a pedestrian crossing across Dry Creek Road on the east side of Logan Street (described below) and to realign the pedestrian crossing east of Pennsylvania Street (described below).

Pedestrian Access

In order to establish safe pedestrian crossing locations and accessibility, the following modifications are required.

- Provisions for a pedestrian crossing across Dry Creek Road should be included on the east side of Logan Street, including: directional pedestrian curb ramps, rectangular rapid flashing beacons and the associated equipment and signage, and a painted crosswalk with advance shark teeth stop lines.
- Realign the pedestrian crossing across Dry Creek Road east of Pennsylvania Street to be perpendicular to the roadway, including: new directional pedestrian curb ramps and a painted crosswalk.
- Install crosswalk markings across the Sherman Street, Grant Street and Logan Street north approaches to Dry Creek Road.
- Upgrade the pedestrian curb ramps on the south side of Dry Creek Road at Logan Street and Grant Street to accommodate disabled accessibility.

<u>Signage</u>

The following associates signage changes will be required based on the other modifications identified above.

- Remove the "NO LEFT TURN" sign facing west along Dry Creek Road at Sherman Street.
- Add a "KEEP RIGHT" sign facing west along Dry Creek Road at the end of the extended raised center median west of Pennsylvania Street.
- Remove the "DO NOT ENTER" sign facing south at Pennsylvania Street.
- Remove the "NO LEFT TURN" sign facing west along Dry Creek Road at Pennsylvania

Street.

- Change the north facing "STOP" sign to a "YIELD" sign.
- Add a "ONE WAY" sign in the center median across from the Bradley driveway.

FUNDING

A Subdivision Improvement Agreement (SIA) was established between the City and the Littleton Village Development in July of 2014, which identified city funding participation for offsite roadway improvements. An amount of approximately \$920,000 was identified for the SIA to pay for center medians along Broadway and Dry Creek Road, traffic signal work at the Broadway/Dry Creek Road and Broadway/Fremont Avenue intersections, realignment of the Dry Creek Road/Pennsylvania Street intersection, and the widening of Dry Creek Road and associated construction work.

A cost estimate has been put together by the developer and contractor for the proposed modifications described previously in this memo along Dry Creek Road in an amount of \$180,000. This work would be above and beyond the construction previously included in the SIA and, therefore, would need to be paid for by the city separately. With funds still available in 2016 as part of the Street Rehab program budget, funding for the Dry Creek Road improvements are proposed to be paid through the rehab program.

A) Development and Implementation of a Sustainable Practices Program:

Although contemporary environmental practices are increasingly implemented in cities, states and by individuals, and are "the right thing to do", Littleton has no broad program on environmental practices.

We should develop an expanded approach to sustainability for the city and our citizens, often in the form of outreach and education. This can or should include energy use reduction, waste reduction, recycling, pest management (weeds and pesticide use/control/better practices). We should also implement environmentally-oriented city practices, plus business and construction standards.

B) Program to define, identify and maintain Littleton's Community Character

GOAL

Aggressively and actively address what we want Littleton to look like in the future, and put the proper tools in place to achieve that goal.

We have received repeated and increasingly passionate comments from citizens about the desire to preserve Littleton's character; our special spirit.

There's general acknowledgement that with our river, our downtown and special neighborhoods we are well positioned for a strong future.

- Axiom:
 - Change happens. We either benefit from it or are victimized by it.
 - Fact- Layers of change and history build a community's character
 - You can see that in any great community
 - We have to have discussions about how to manage that change.
- Action
 - That means we need to have the community conversation about:
 - what we want to be;
 - how to preserve our special character and spirit and our quality of life
- The axiom of change demands that we be proactive rather than reactive
 - That we define the balance of developments that's best for us, where certain types of developments take place, what character they have and how they fit into the existing community.

• The national development community is increasingly finding that working within community character requirements is better for the developer and for the community. We need to help them understand that.

It's all about planning.

- Mechanisms:
 - Simple step-Fold Design Guidelines into Ordinances. These have been vetted.
 - We have incredible talent on our Boards and Commissions.
 - They need to be actively involved in the study and development of our vision
 - We need to bring out the voices of our citizens in what they want.
 - We need assistance from professionals who can help us interpret our desires and bring real world solutions to our own vision

C) Develop a Work Plan based on our Goals and Objectives

Much of our work is reactionary and/or routine (IGAs, etc.) rather than vision or policy based as an outgrowth of our Goals and Objectives

Through study sessions we should design and develop a work plan based on our Goals and Objectives.

D) Completion of the Housing Study previously authorized and budgeted by council

Develop a long term plan for our housing stock to provide zoning and planning guidance relative to anticipated land uses and developing demographic changes. Included housing stock should be all types, including affordable, multi-family and single-family.

E) Develop and launch a comprehensive, financially responsible plan for repair of the city's infrastructure along with a plan to prevent us from accumulating deferred maintenance over the long term.
