Case #VAR16-0001, variance to the four foot (4') maximum fence height for a front yard fence in the R-3 zone district at 6500 S. Windermere Street, Littleton, CO

Attached is an application for a zoning variance filed by Donna Flaherty, owner of the property located at 6500 South Windermere Street. The applicant is requesting a variance to the four foot (4') maximum height for a front yard fence to construct a six foot (6') fence.

BACKGROUND:

Applicant Donna Flaherty erected a six foot (6') fence along the front property line of her property for the purposes of utilizing the front yard as a dog agility course. Under section 10-4-3 of the zoning code, the maximum height of a fence in the front yard is four feet (4').

The house on this property was built in 1920. The property was annexed into the City of Littleton in 1956. The present R-3 (Single Family Residential) zoning was established as a part of the process of creating a home-rule city in 1960. The applicant purchased the property in 2007.

STAFF ANALYSIS:

The Littleton Zoning Ordinance 10-4-3 requires a maximum fence height of four feet (4') for front yard fences.

Section 10-11-1 (B) gives the Board authority to grant variances where “due to exceptional and extraordinary circumstances, literal enforcement of the provisions of this Title will result in unnecessary hardship.” No variance can be approved unless the Board finds that all of the criteria stated in Section 10-11-1 (B) have been met.

The following is an assessment of the application under the criteria for approval contained in Section 10-11-1 (B):

1. That the variance will not authorize the operation of a use other than those uses specifically listed as primary permitted uses for the zone district in which the affected property is located.

The requested variance would not allow any use other than the uses permitted in the R-3 Single Family Zone District.

2. That the variance will not alter the essential character of the neighborhood or zone in which the property is located or substantially or permanently impair the allowed use or development of adjacent property.

A six foot (6') fence will alter the character of the neighborhood as most of the homes in the general vicinity of this property either don't have a front yard fence, or have a four foot (4') fence in the front yard.

3. That the variance is the minimum that will afford relief and is the least possible modification to the provision in question.

The agility course could be contained in the side yard, where a six foot (6') fence is permitted per the zoning code. Alternatively, the course could be located in both the side yard and front yard if the fence height meets the maximum four foot (4') height limit within the front yard. Neither of these options requires relief from the zoning code.

4. That the variance will not adversely affect the public health, safety and welfare.

The additional height for the fence would provide protection by keeping the dog contained in the yard; however there are other possible solutions to obtain the same result.

5. That the hardship, if any, under which the variance is sought, was not created by the owner, occupant or agent of the owner of the property in question; nor was it suffered as a result of a violation of any provision of this code.

It appears that a case has not made for existing exceptional and extraordinary circumstances on the property that constitutes a hardship. The configuration and topography of the lot together with the location of the existing house and garage allow for a 6 foot (6') fenced area, albeit a smaller area, that meets zoning code requirements.

STAFF RECOMMENDATION:

For the reasons stated above, City Staff concludes that this application for a variance to the four foot (4') maximum fence height does not meet all the conditions for approval as provided in Section 10-11-1 (B). This fence is being requested for a temporary use, but the variance runs with the property and will be in place forever. Staff recommends denial of the variance.

PROPOSED MOTION:

Two suggested motions are provided for the Board's consideration.

PROPOSED MOTION FOR DENIAL

I move to deny Case# VAR16-0001, request for variance to the four foot (4') maximum fence height at 6500 South Windermere Street, in that the request does not meet all of the criteria of Section 10-11-1 (B) of the Littleton City Code that are required to exist for the Board to grant approval. Denial of this application is based on the following findings of fact:

Criterion #2 is not met as the proposed fence will alter the essential character of the neighborhood, because the adjacent properties have four foot (4') front yard fences.

Criterion #3 is not met as there are alternatives that would provide relief without the need for a variance.

Criterion #5 is not met as the hardship under which this variance is sought was created by the owner.

PROPOSED MOTION FOR APPROVAL

I move to approve Case#VAR16-0001, a request for variance to the four foot (4') maximum fence height at 6500 South Windermere Street, be approved in that the request does meet all of the criteria of Section 10-11-1 (B) of the Littleton City Code that are required to exist for the Board to grant approval. Approval of this application is based on the following findings of fact:

1. The requested variance would not allow any use other than the uses permitted in the R-3 Single Family Zone District.
2. The proposed fence will not alter the essential character of the neighborhood because _____.
3. The proposed location of the fence is the minimum that will afford relief and is the least possible modification of the code because _____.
4. The proposed fence will not have any negative effects on the public health, safety or welfare as its location will not create any visibility or safety concerns. The additional height for the fence would provide protection by keeping the dog contained in the yard.
5. The hardship under which this variance is sought was neither created by the owner, occupant or agent of the owner of the property in question, nor the result of a violation of any provision of this code because _____.

At least 10 days prior to the hearing date, a notice must be published in the Littleton Independent newspaper. City Code requires that the public be notified of variance requests through two means, the newspaper and the sign posted on the property for a period of 10 days. As a service to the applicant, the Community Development office will place the newspaper notice for you. The Independent will bill you for the charge of the publication.

Applicant will turn in the completed application and site plan only to Community Development and keep pages 1, 2, and 6 for their use during the variance process prior to the Board of Adjustment public hearing.

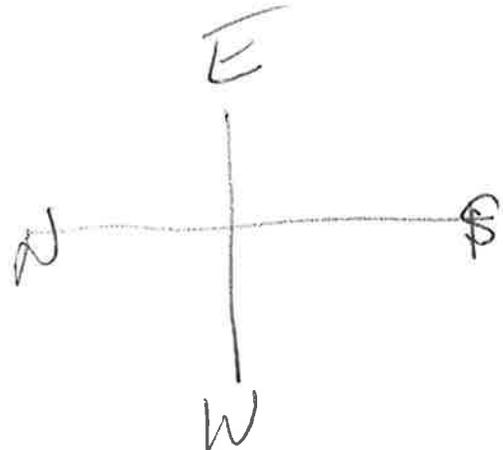

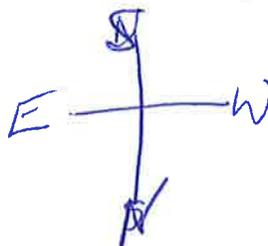

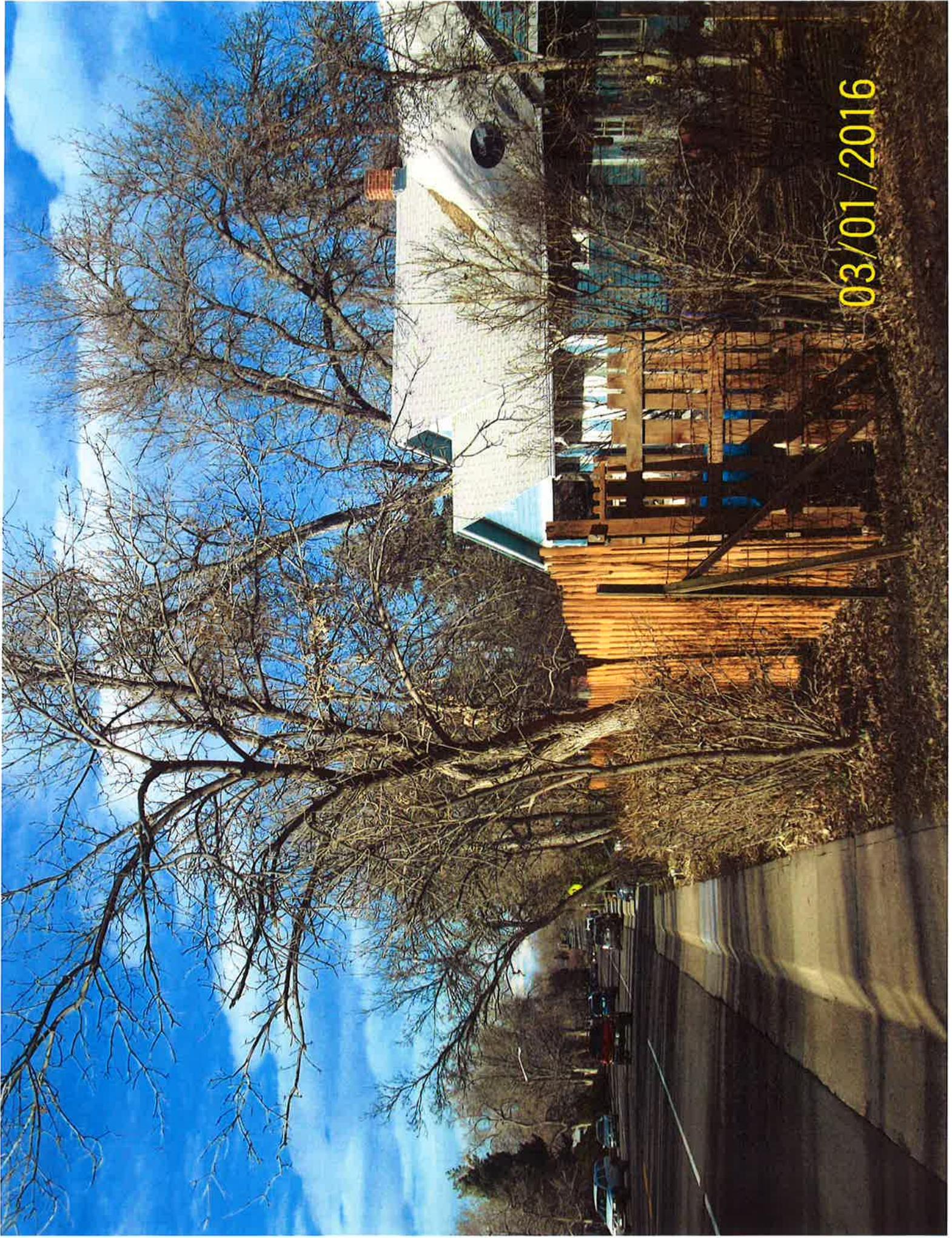
(The traffic on Windermere Street is heavy through out most of the day and though the speed limit is 30 miles per hour it is not consistently adhered to by most drivers.)
