# **Concerned constituent - regarding immigration raids**

Dear city officials,

I am a constituent in district 4 and I am writing to urge the city of Santa Barbara to take a stand to protect those in our community who are most vulnerable to the federal government's harmful immigration raids.

- I encourage the city to inform businesses on what is allowable should ICE show up at their establishment - for instance, ICE may enter a business, but they cannot enter a private space without permission from the owner OR a written judicial warrant. It is essential that our small SB businesses protect our community and the City should help to make this information accessible widely
- I encourage the city to be outspoken against immigration raids/ICE. For example, we cannot celebrate the upcoming Fiesta/Old Spanish Days if we allow the communities who built this city and the culture that we love to partake in to be kidnapped and ripped away from their families. No culture without the people!

• Though I am unsure who has true jurisdiction over SBPD, I know Mayor Rowse has a close relationship with them. I encourage the City Council of Santa Barbara to push the mayor and Santa Barbara Police Department to not cooperate with immigration raids. The SBPD's mission statement is to, "provide for the public safety through the philosophy of community oriented policing." This means protecting our community members, those who live and work here, who make Santa Barbara what it is; not protecting these strangers who come into our city, threaten our neighbors, and hide their faces whilst tearing families apart.

I call the city to end all cooperation between Santa Barbara and Immigration and Customs Enforcement. I urge Santa Barbara to join the ACLU lawsuit that began in Los Angeles against unconstitutional ICE apprehensions. I urge Santa Barbara to create emergency funding to support the local organizations, like 805 Undocufund and La Casa De La Raza, that are providing rapid response, food, immigration resources, emergency family planning services, etc. to our neighbors who are directly impacted by ICE raids.

After witnessing last week's raid in Carpinteria, we must take action now and put in place protections for our community.

#### **Immigration Conversation**

I was born and raised on the Westside of Santa Barbara I have had the privilege of growing up around Oscar Gutierrez and working for Randy Rowse. I know both of them care deeply for our city and wanted to thank them and all the other city council members for holding this meeting today.

I am a direct descendant of one of America's founding fathers, John Jay, and I am deeply troubled by what I have seen happening in our community and across our great nation.

ICE has been racially profiling our community and indiscriminately taking people who look Latino off our streets. ICE continues to detain legal green card holders and even US Citizens. Further, the undocumented members of our community that ICE does take are not hardened criminals or gangbangers, but the backbone of our community. These are hardworking tax paying individuals who are, by and large, trying to work towards legal status. They have been holding down jobs for decades and adding value to our neighborhoods and our community. All while paying taxes into a system which they cannot collect benefits from.

ICE consistently violates the law by not identifying themselves, not presenting proper warrants for arrests, refusing to give reasons for detaining individuals, ignoring legal ID documents (like Real IDs and Passports) when presented, detaining legal green card holders and US citizens without attempting to confirm who they are, detaining US veterans and deporting their parents, keeping individuals in inhumane conditions in their detention centers, denying due process (moving individuals out of state before they can get legal representation), and when ICE finally export individuals the individuals are increasingly not deported to their country of origin. This is unacceptable in America.

United States law enforcement is supposed to protect and serve. Who is protected by ICE's actions? Not our community. No, our community is terrorized and living in a constant state of fear. Our neighbors, coworkers,

family, and friends are terrified to live ordinary law abiding lives because masked men may descend upon them at any moment for no crime other than simply having the wrong color of skin. Who does ICE serve? Not the constitution or the American people. They increasingly violate the constitution which is the bedrock of our democracy and violate the rights of the American people. No, ICE is protecting Donald Trump's ego and serving Donald Trumps every whim. This is UnAmerican and should outrage every patriot who claims to love this country.

We support our local SBPD and appreciate their work protecting our community.

However, right now the community's trust in local law enforcement agencies is waning. They are see first amendment auditors harass our already frightened community with racist and confrontational encounters. Police respond but leave quickly causing the community to endure these vile harassments alone. During these encounters residents were told to "be careful how they exercise their 1st amendment in the future." Meanwhile, when the national guard was deployed against its own citizens in order to protect ICE... we saw footage of local law enforcement clearing traffic for ICE and police staying between peaceful protestors and ICE agents who were trying to break into a hospital. When the community calls local PD to ask what they should do in the event a masked individual takes their neighbor they are told only to call if they are the one being abducted. Our community deserves to feel safe and this response does not reassure the community that they are protected.

When individuals feel like their safety concerns are not heard or valued... some resort to violence. We do not condone the violence. However, we understand that it is a result of individuals feeling like they are out of options to protect themselves and their community.

Santa Barbara can and needs to do better.

Right now we need our city to empower our local law enforcement to protect our community. Order our local police, sheriffs, highway patrol and other local law enforcement agencies to not collaborate with ICE in any way. Including directing traffic for them or standing between them and peaceful protestors. Demand that ICE reveal their agents identities and ranks to our local law enforcement whenever they are in our community. ICE agents need to be held accountable for every law they break while operating in our community.

We didn't choose to be at the epicenter of Trumps war against America, but it came to us all the same. The soul of America hinges on the actions taken by the elected officials in this room. The rest of America looks to our community to find the strength to resist against the persistent attacks against our constitution, in hopes that they can find their own courage. Or ... they may look at our cowardice and likewise continue to allow Trump to trample everything our flag stands for, "liberty and justice for ALL."

ICE's actions are unacceptable, unconstitutional, and UnAmerican.

We are counting on you to stand up for our beloved Santa Barbara and the United States of America. Please, do not fail us.

In Response to Recent ICE Raids in our Community

July 14, 2025

Recent immigration enforcement activities in Carpinteria have generated significant concern among residents, business owners, and local officials, prompting the need for thoughtful dialogue and action. The Chamber encourages policymakers to consider comprehensive approaches that balance legal obligations with community realities, recognizing that local businesses depend on consistent workforce availability and predictable operating conditions as well as community wellbeing.

Clear communication between federal agencies and local officials can help minimize confusion and ensure enforcement activities don't interfere with essential community services and business operations. Equally important, all members of our community, employees, customers, or neighbors, should be able to go about their daily lives with a basic expectation of dignity and due process. Whatever one's views on immigration policy, most of us share common goals of safe neighborhoods, thriving local businesses, and a community where families can plan for their future.
