## **Request and Recommendation**

The Arapahoe County Sheriff's Office (ACSO) requests the Board of County Commissioners to sign an agreement for services with Enforcement Video, LLC dba WatchGuard Video, for the purchase of Watch Guard Vista body worn cameras, accessories and all software and services resulting in the successful and satisfactory installation and configuration of the WatchGuard Video VISTA HD Wearable Camera System and Evidence Library software.

## **Background**

The ACSO 2016 approved budget included a budget package for body worn cameras, accessories and storage.

## Discussion

During the 2016 budget preparation and budget package submittal process, ACSO had to use estimates for cameras accessories and data storage based on the best information available. After a thorough analysis and testing process with ACSO and Arapahoe County Information Technology, the product selected for this project was the Watch Guard Vista camera. The quote provided by Watch Guard for the cameras, accessories and software related expenses came in above the estimate used for the budget package. ACSO will request an additional \$60,000 from the forfeiture fund board for this project.

#### **Alternatives**

The alternative would be to not sign this agreement and renew the search for a different vendor. During the project analysis and testing, ACSO and Information Technology staff were unable to identify a vendor

to provide a quality product for less than the Watch Guard quote. In fact, many vendors would be two to three times higher in price for a comparable product.

## **Fiscal Impact**

The 2016 budget secured \$207,061 for the project. An additional \$60,000 will be requested by the Sheriff's Office from forfeiture funds. Should this request be denied, \$19,200.00 will be funded from 107040995 54402 and the remaining \$40,800 will be transferred from 147040015 54403.

The Sheriff's Office Administration and the Public Safety Bureau are in concurrence with this recommendation.

## AGREEMENT FOR SERVICES

Project Number or Name: Body Worn Camera

THIS AGREEMENT is entered into as of the 11th day of August, 2016 by and between the Board of County Commissioners of the County of Arapahoe, State of Colorado (hereinafter referred to as the "County") and Enforcement Video, LLC dba WatchGuard Video (hereinafter referred to as the "Contractor").

WHEREAS, the County desires to engage the Contractor to provide the services described in Exhibit A.

NOW, THEREFORE, the parties mutually agree as follows:

- 1. Scope of Services. The Contractor agrees to perform the services described in Section 1 of Exhibit A, which document is attached hereto and incorporated herein in its entirety.
- 2. <u>Time of Performance</u>. The services of the Contractor are to commence and be completed (or end) by the dates set forth in Section 2 of Exhibit A, unless this Agreement is sooner terminated pursuant to paragraph 4.A. below. All time limits are of the essence in this Agreement.
- 3. Method of Payment. The County will compensate the Contractor for services rendered in accordance with Section 3 of Exhibit A, subject to the availability of appropriated funds within the annual budget. The Contractor is responsible for paying all applicable income, Federal Insurance Contributions Act (FICA), Federal Unemployment Tax Act, or other taxes owed on compensation paid under this Agreement. The Contractor shall submit requests for payment in a form acceptable to the County and in conformance with the County's policies. The Contractor shall provide such backup information for its payment requests as may be reasonably requested by the County. The County shall have forty-five (45) days from receipt of any payment request to make payment to the Contractor.

## 4. General Terms and Conditions.

- A. Termination of Agreement. The County or the Contractor shall have the right to terminate this Agreement, with or without cause, by giving written notice to the other party of such termination and specifying the effective date thereof, which notice shall be given at least the number of days set forth in Section 4 of Exhibit A prior to the effective date of such termination. In such event, all finished or unfinished documents, data, studies and reports prepared by the Contractor pursuant to this Agreement shall become the property of the County. Unless expressly stated otherwise in the notice, Contractor shall provide no further services in connection with this Agreement after receipt of a notice of termination, and the Contractor shall proceed to cancel all existing orders and contracts that are chargeable to the County under this Agreement. The Contractor shall be entitled to receive compensation in accordance with this Agreement for any satisfactory services completed pursuant to the terms of this Agreement prior to the date of receipt of the notice of termination, or such other stop-work date as may be specified in the notice. Notwithstanding the above, the Contractor shall not be relieved of liability to the County for damages sustained by virtue of any breach of this Agreement by the Contractor.
- B. <u>Changes</u>. The County or Contractor may, from time to time, request changes in the scope of services or compensation of the Contractor. Such changes that are mutually agreed upon between the County and Contractor shall be in writing, and upon execution shall become part of this Agreement. To be effective, all changes must be signed by the Contractor and by the Board of County Commissioners, or by a person authorized by resolution to sign on behalf of the Board.
- C. <u>Assignability or Subcontracting</u>. Any assignment, transfer or subcontracting of this Agreement is prohibited, unless written consent is obtained from the County.
- D. Audit. The County and any of its duly authorized representatives shall have reasonable access to any books, documents, papers and records of the Contractor which are pertinent to the Contractor's performance under this Agreement for the purpose of making an audit, examination, or excerpts. The Contractor shall provide any documentation necessary to prepare all reporting required of or by the County, and shall keep all books, documents, papers and records

which are pertinent to the Contractor's performance for a minimum period of three years, or such longer time as may be set forth in any Special Conditions or addendums to this Agreement.

- E. <u>Equal Employment Opportunity</u>. While performing this Agreement, the Contractor shall not discriminate against any employee, subcontractor, or applicant for employment because of disability, race, creed, color, sex, sexual orientation, religion, age, national origin, or ancestry.
- F. Ownership of Documents. All drawings, specifications, guidelines and other documents prepared or received by the Contractor in connection with this Agreement shall be the property of the County.
- G. <u>Assignment of Copyrights</u>. The Contractor assigns to the County the copyrights to all works prepared, developed, or created pursuant to this Agreement, including the rights to: 1) reproduce the work; 2) prepare derivative works; 3) distribute copies to the public by sale, rental, lease, or lending; 4) perform the works publicly; and 5) to display the work publicly. The Contractor waives its rights to claim authorship of the works, to prevent its name from being used in connection with the works, and to prevent distortion of the works.
- H. <u>Governing Law/Forum/Interpretation</u>. This Agreement has been executed by the parties hereto on the day and year first above written and shall be governed by the laws of the State of Colorado. Venue for any civil action relating to this Agreement shall be in Arapahoe County. Both parties agree that the rule that ambiguities in a contract are to be construed against the drafting party shall not apply to the interpretation of this Agreement. If there is any conflict between the language of this Agreement and any exhibit or attachment, the language of this Agreement shall govern.
- I. <u>Compliance with Laws/Licenses and Permits</u>. The Contractor shall comply with all applicable federal, state and local laws, ordinances, regulations, and resolutions. The Contractor shall be responsible for obtaining all licenses and permits necessary to perform the scope of services, at the Contractor's expense, unless specifically stated otherwise in this Agreement.
- J. No Waiver of Rights. The County's approval or acceptance of, or payment for, services shall not be construed to operate as a waiver of any rights or benefits to be provided under this Agreement. No covenant or term of this Agreement shall be deemed to be waived by the County except in writing signed by the Board of County Commissioners or person authorized to sign by resolution of the Board, and any waiver of a right shall not be construed to be a waiver of any other right or to be a continuing waiver, unless specifically so stated.
- K. Non-appropriation. Pursuant to C.R.S. § 29-1-110, as amended, the financial obligations of the County as set forth herein after the current fiscal year are contingent upon funds for that purpose being appropriated, budgeted and otherwise available. This Agreement is automatically terminated on January 1st of the first fiscal year for which funds are not appropriated. The County shall give the Contractor written notice of such non-appropriation.
- L. <u>Conflict of Interest/Ethics.</u> The Contractor shall refrain from providing services to other persons, firms or entities that would create a conflict of interest for Contractor with regard to providing services pursuant to this Agreement. The Contractor shall not offer or provide anything of benefit to any County official or employee that would place the official or employee in a position of violating the public trust in violation of Colorado Constitution Article XXIX, C.R.S. § 24-18-109, as amended, or the County's Ethical Principles and Guidelines.
- M. Remedies. In addition to any other remedies provided for in this Agreement, and without limiting its remedies available at law, the County may exercise the following remedial actions if the Contractor substantially fails to satisfy the duties and obligations in this Agreement. Substantial failure to satisfy the duties and obligations shall mean significant insufficient, incorrect or improper performance, activities or inactions by the Contractor. These remedial actions are as follows:
- (1) Suspend Contractor's performance pending necessary corrective action as specified by the County without the Contractor's entitlement to an increase in price/cost or a time extension; and/or
- (2) Withhold payment to the Contractor until the necessary services or corrections in performance are satisfactorily completed; and/or

(3) Deny payment for those services which have not been satisfactorily performed, or which, due to circumstances caused by the Contractor, cannot be performed, or if performed would be of no value to the County.

The foregoing remedial actions are cumulative and the County, it its sole discretion, may exercise any or all of them individually or simultaneously. The County shall provide written notice to Contractor of its exercise of any of the foregoing remedial actions.

- N. Force Majeure. Neither the Contractor nor the County shall be liable for any delay in, or failure of performance of, any covenant or promise contained in this Agreement, nor shall any delay or failure constitute default or give rise to any liability for damages if, and only to extent that, such delay or failure is caused by "force majeure." As used in this Agreement, "force majeure" means acts of God, acts of the public enemy, unusually severe weather, fires, floods, epidemics, quarantines, strikes, labor disputes and freight embargoes, to the extent such events were not the result of, or were not aggravated by, the acts or omissions of the non-performing or delayed party.
- O. <u>Third-Party Beneficiaries</u>. It is expressly understood and agreed that the enforcement of this Agreement and all rights of action relating thereto shall be strictly reserved to the County and the named Contractor. Nothing contained in this Agreement shall give or allow any claim or right of action whatsoever by any other third person.
- P. <u>Survival of Terms and Conditions</u>. Notwithstanding anything herein to the contrary, the parties understand and agree that all terms and conditions of the Agreement that anticipate continued performance, compliance, or effect beyond the termination date of the Agreement shall survive such termination date and shall be enforceable in the event of a failure to perform or comply.
  - Q. <u>Illegal Aliens</u>. As required by C.R.S. § 8-17.5-102, the Contractor certifies and agrees as follows:
- (1) The Contractor shall not knowingly employ or contract with an illegal alien (a non-legal resident of the United States) to perform work under this Agreement.
- (2) The Contractor shall not enter into a contract with a subcontractor that fails to certify to the Contractor that the subcontractor shall not knowingly employ or contract with an illegal alien to perform work under this Agreement.
- (3) The Contractor has confirmed the employment eligibility of all employees who are newly hired for employment to perform work under this Agreement through participation in either the employment verification ("e-verify") program administered by the United States Department of Homeland Security and the Social Security Administration, or the employment verification program operated by the Colorado Department of Labor and Employment ("Department").
- (4) The Contractor shall not use the e-verify or Department programs to undertake preemployment screening of job applicants while this Agreement is being performed.
- (5) If the Contractor obtains actual knowledge that a subcontractor performing work under this Agreement knowingly employs or contracts with an illegal alien, then the Contractor shall: (a) notify the subcontractor and the County within three days that the Contractor has actual knowledge that the subcontractor is employing or contracting with an illegal alien; and (b) terminate the subcontract with the subcontractor if within three days of receiving the notice the subcontractor does not stop employing or contracting with the illegal alien; except that Contractor shall not terminate the subcontract if during such three days the subcontractor provides information to establish that the subcontractor has not knowingly employed or contracted with an illegal alien.
- (6) The Contractor shall comply with any reasonable request by the Department made in the course of an investigation that the Department is undertaking pursuant to the authority established by C.R.S. § 8-17.5-101(5).
- (7) If the Contractor violates any of the provisions of this section 4.Q. the County may immediately terminate this Agreement effective upon the receipt by Contractor of written notice of termination from the County, and the Contractor shall be liable for actual and consequential damages to the County.

- (8) Compliance with this subsection Q is not required if the Contractor is a governmental entity.
- R. <u>Abilities, Qualifications, Experience, and Best Efforts.</u> Notwithstanding anything to the contrary contained in this Agreement, the County and Contractor agree and acknowledge that the County enters into this Agreement relying on the special and unique abilities of Contractor to perform the services and accomplish the tasks described. Contractor accepts the relationship of trust and confidence established between Contractor and the County by this Agreement. Contractor covenants with the County to use its best efforts. Contractor shall further the interests of the County according to the County's requirements and procedures, and according to the highest standards and quality prevailing among those who perform work of a similar nature.
- S. <u>Accuracy of Work</u>. The Contractor represents, covenants and agrees that its work will be accurate and free from any material errors.
- 5. <u>Insurance</u>. In part to assure the County that the Contractor is always capable of fulfilling the specified indemnification obligations, the Contractor must purchase and maintain insurance of the kind and in the minimum amounts specified below, unless indicated otherwise in Section 7 of Exhibit A.
- A. The Contractor agrees to procure and maintain, at its own expense, for all services covered by this Agreement, the following policies of insurance:
- (1) Workers' Compensation Insurance: The Contractor will maintain workers' compensation insurance covering the contractor for the performance of all services under this Agreement in accordance with applicable state laws, and employer's liability insurance. (3) Automobile Liability: The Contractor will maintain business auto liability coverage covering liability arising out of any auto (including owned, hired and nonowned autos) used in connection Minimum Limits:

## Coverages:

- Specific Waiver of Subrogation
- MCS 90 for vehicles carrying hazardous materials
- Mobile (for on-going and completed operations) issued to Arapahoe County, Colorado its

The requirements of this provision shall apply to the Contractor and to all subcontractors.

- (4) If indicated in Section 5 of Exhibit A, Errors and Omissions or Professional Liability Insurance with a minimum coverage amount as specified in Section 5 of Exhibit A, and for two years beyond the completion of all services under this Agreement.
- B. The above-mentioned coverages shall be procured and maintained with insurers with an A- or better rating, as determined by Best's Key Rating Guide. All coverages shall be continuously maintained during the term of this Agreement or as noted above to cover all liability, claims, demands, and other obligations assumed by the Contractor.
- C. Additional Insured status required above shall be primary and non-contributory with any insurance or self-insurance carried by the County. The Contractor shall be solely responsible for any deductible losses under any policy required above.
- D. The policies shall provide that the County will receive notice no less than 30 days prior to cancellation, termination or non-renewal of the policies.
- E. The Contractor shall not be relieved of any liability, claims, demands, or other obligations assumed pursuant to this Agreement by reason of its failure to procure or maintain insurance, or by reason of its failure to procure or maintain insurance in sufficient amounts, durations or types.
- F. Failure on the part of the Contractor to procure or maintain policies providing the required coverages, conditions and minimum limits shall constitute a material breach of contract upon which the County may immediately terminate this Agreement.
- G. The County reserves the right to request and receive a certified copy of any policy and any endorsement thereto.

## 6. Insurance Certificates.

- A. The Contractor shall, prior to commencing services, deliver to the County Certificates of Insurance as evidence that policies providing any and all required coverages and limits are in full force and effect.
- B. These certificates will serve as an indication to the County that the Contractor has acquired all necessary insurance; however, the County may require that certified copies of the insurance policies be submitted and may withhold payment for services until the applicable insurance policies are received and found to be in accordance with the Agreement.

- C. Insurance limits must be indicated on each Certificate of Insurance. Each Certificate of Insurance shall be reviewed and approved by the County prior to commencement of services under the Agreement. The certificates shall identify this Agreement and shall state the project number where applicable.
- 7. <u>Indemnification</u>. The Contractor shall indemnify and hold harmless the County and its elected and appointed officials, officers, employees, and agents from and against any and all losses, damages, liabilities, claims, suits, actions, or awards, including costs, expenses and attorney's fees, incurred or occasioned as a result of the acts or omissions of the Contractor, or its principals, employees, agents, or subcontractors arising out of or in any way connected with the performance of services under this Agreement. The Contractor's obligation to indemnify pursuant to this paragraph, and to provide any extended insurance coverage where applicable, shall survive the completion of the scope of services, and shall survive the termination of this Agreement.
- 8. <u>Independent Contractor</u>. The Contractor is an independent contractor. AN INDEPENDENT CONTRACTOR IS NOT ENTITLED TO WORKER'S COMPENSATION BENEFITS AND IS OBLIGATED TO PAY FEDERAL AND STATE INCOME TAX ON ANY MONIES EARNED PURSUANT TO THE CONTRACT RELATIONSHIP. Notwithstanding any provision appearing in this Agreement, all personnel assigned by the Contractor to perform work under the terms of this Agreement shall be and remain at all times employees of the Contractor or employees of their respective employers for all purposes.
- 9. <u>Notices.</u> Notices to be provided under this Agreement shall be given in writing and either delivered by hand or deposited in the United States mail with sufficient postage to the addresses set forth in Section 6 of Exhibit A.
- 10. Extent of Agreement. This Agreement represents the entire and integrated agreement between the County and the Contractor and supersedes all prior negotiations, representations or agreements, either written or oral. Any amendments to this must be in writing and be signed by both the County and the Contractor. If any portion of this Agreement is found by a court of competent jurisdiction to be void and/or unenforceable, it is the intent of the parties that the remaining portions of this Agreement shall be of full force and effect.

This Contract is made and entered into by the Houston-Galveston Area Council of Governments, hereinafter referred to as H-GAC, having its principal place of business at 3555 Timmons Lane, Suite 120, Houston, Texas 77027, AND, Enforcement Video, LLC hereinafter referred to as the CONTRACTOR, having its principal place of business at 415 Century Parkway, Allen, Texas 75013.

## ARTICLE 1: SCOPE OF SERVICES

The parties have entered into a Law Enforcement Speed Detection & Video Equipment Contract to become effective as of April 1, 2015, and to continue through March 31, 2017 (the "Contract"), subject to extension upon mutual agreement of the CONTRACTOR and H-GAC. H-GAC enters into the Contract as Agent for participating governmental agencies, each hereinafter referred to as END USER, for the purchase of Law Enforcement Speed Detection & Video Equipment offered by the CONTRACTOR. The CONTRACTOR agrees to sell Law Enforcement Speed Detection & Video Equipment through the H-GAC Contract to END USERS.

## ARTICLE 2: THE COMPLETE AGREEMENT

The Contract shall consist of the documents identified below in order of precedence:

- 1. The text of this Contract form, including but not limited to, Attachment A
- 2. General Terms and Conditions
- 3. Bid Specifications No:EF04-15, including any relevant suffixes
- 4. CONTRACTOR's Response to Bid No: EF04-15, including but not limited to, prices and options offered

All of which are either attached hereto or incorporated by reference and hereby made a part of this Contract, and shall constitute the complete agreement between the parties hereto. This Contract supersedes any and all oral or written agreements between the parties relating to matters herein. Except as otherwise provided herein, this Contract cannot be modified without the written consent of both parties.

## ARTICLE 3: LEGAL AUTHORITY

CONTRACTOR and H-GAC warrant and represent to each other that they have adequate legal counsel and authority to enter into this Contract. The governing bodies, where applicable, have authorized the signatory officials to enter into this Contract and bind the parties to the terms of this Contract and any subsequent amendments thereto.

## ARTICLE 4: APPLICABLE LAWS

The parties agree to conduct all activities under this Contract in accordance with all applicable rules, regulations, directives, issuances, ordinances, and laws in effect or promulgated during the term of this Contract.

## ARTICLE 5: INDEPENDENT CONTRACTOR

The execution of this Contract and the rendering of services prescribed by this Contract do not change the independent status of H-GAC or CONTRACTOR. No provision of this Contract or act of H-GAC in performance of this Contract shall be construed as making CONTRACTOR the agent, servant or employee of H-GAC, the State of Texas or the United States Government. Employees of CONTRACTOR are subject to the exclusive control and supervision of CONTRACTOR. CONTRACTOR is solely responsible for employee payrolls and claims arising therefrom.

## ARTICLE 6: END USER AGREEMENTS

H-GAC acknowledges that the END USER may choose to enter into an End User Agreement with the CONTRACTOR through this Contract and that the term of said Agreement may exceed the term of the H-GAC Contract. However this acknowledgement is not to be construed as H-GAC's endorsement or approval of the End User Agreement terms and conditions. CONTRACTOR agrees not to offer to, agree to or accept from END USER any terms or conditions that conflict with or contravene those in CONTRACTOR's H-GAC contract. Further, termination of this Contract for any reason shall not result in the termination of the underlying End User Agreements entered into between CONTRACTOR and any END USER which shall, in each instance, continue pursuant to their stated terms and duration. The only effect of termination of this Contract is that CONTRACTOR will no longer be able to enter into any new End User Agreements with END USERS pursuant to this Contract. Applicable H-GAC order processing charges will be due and payable to H-GAC on any End User Agreements surviving termination of this Contract between H-GAC and CONTRACTOR.

## **ARTICLE 7:**

### SUBCONTRACTS & ASSIGNMENTS

CONTRACTOR agrees not to subcontract, assign, transfer, convey, sublet or otherwise dispose of this Contract or any right, title, obligation or interest it may have therein to any third party without prior written notice to H-GAC. H-GAC reserves the right to accept or reject any such change. CONTRACTOR shall continue to remain responsible for all performance under this Contract regardless of any subcontract or assignment. H-GAC shall be liable solely to CONTRACTOR and not to any of its Subcontractors or Assignees.

## ARTICLE 8: EXAMINATION AND RETENTION OF CONTRACTOR'S RECORDS

CONTRACTOR shall maintain during the course of its work, complete and accurate records of items that are chargeable to END USER under this Contract. H-GAC, through its staff or its designated public accounting firm, the State of Texas, or the United States Government shall have the right at any reasonable time to inspect copy and audit those records on or off the premises of CONTRACTOR. Failure to provide access to records may be cause for termination of this Contract. CONTRACTOR shall maintain all records pertinent to this Contract for a period of not less than five (5) calendar years from the date of acceptance of the final contract closeout and until any outstanding litigation, audit or claim has been resolved. The right of access to records is not limited to the required retention period, but shall last as long as the records are retained. CONTRACTOR further agrees to include in all subcontracts under this Contract, a provision to the effect that the subcontractor agrees that H-GAC'S duly authorized representatives, shall, until the expiration of five (5) calendar years after final payment under the subcontract or until all audit findings have been resolved, have access to, and the right to examine and copy any directly pertinent books, documents, papers, invoices and records of such subcontractor involving any transaction relating to the subcontract.

## ARTICLE 9:

## REPORTING REQUIREMENTS

CONTRACTOR agrees to submit reports or other documentation in accordance with the General Terms and Conditions of the Bid Specifications. If CONTRACTOR fails to submit to H-GAC in a timely and satisfactory manner any such report or documentation, or otherwise fails to satisfactorily render performance hereunder, such failure may be considered cause for termination of this Contract.

## ARTICLE 10: MOST FAVORED CUSTOMER CLAUSE

If CONTRACTOR, at any time during this Contract, routinely enters into agreements with other governmental customers within the State of Texas, and offers the same or substantially the same products/services offered to H-GAC on a basis that provides prices, warranties, benefits, and or terms more favorable than those provided to H-GAC, CONTRACTOR shall notify H-GAC within ten (10) business days thereafter of that offering and this Contract shall be deemed to be automatically amended effective retroactively to the effective date of the most favorable contract, wherein CONTRACTOR shall provide the same prices, warranties, benefits, or terms to H-GAC and its END USER. H-GAC shall have the right and option at any time to decline to accept any such change, in which case the amendment shall be deemed null and void. If CONTRACTOR is of the opinion that any apparently more favorable price, warranty, benefit, or term charged and/or offered a customer during the term of this Contract is not in fact most favored treatment, CONTRACTOR shall within ten (10) business days notify H-GAC in writing, setting forth the detailed reasons CONTRACTOR believes aforesaid offer which has been deemed to be a most favored treatment, is not in fact most favored treatment. H-GAC, after due consideration of such written explanation, may decline to accept such explanation and thereupon this Contract between H-GAC and CONTRACTOR shall be automatically amended, effective retroactively, to the effective date of the most favored agreement, to provide the same prices, warranties, benefits, or terms to H-GAC.

The Parties accept the following definition of routine: A prescribed, detailed course of action to be followed regularly; a standard procedure. EXCEPTION: This clause shall not be applicable to prices and price adjustments offered by a bidder, proposer or contractor, which are not within bidder's/ proposer's control [example; a manufacturer's bid concession], or to any prices offered to the Federal Government and its agencies.

## **ARTICLE 11:**

## **SEVERABILITY**

All parties agree that should any provision of this Contract be determined to be invalid or unenforceable, such determination shall not affect any other term of this Contract, which shall continue in full force and effect.

## ARTICLE 12:

## **DISPUTES**

Any and all disputes concerning questions of fact or of law arising under this Contract, which are not disposed of by agreement, shall be decided by the Executive Director of H-GAC or his designee, who shall reduce his decision to writing and provide notice thereof to CONTRACTOR. The decision of the Executive Director or his designee shall be final and conclusive unless, within thirty (30) days from the date of receipt of such notice, CONTRACTOR requests a rehearing from the Executive Director of H-GAC. In connection with any rehearing under this Article, CONTRACTOR shall be afforded an opportunity to be heard and offer evidence in support of its position. The decision of the Executive Director after any such rehearing shall be final and conclusive. CONTRACTOR may, if it elects to do so, appeal the final and conclusive decision of the Executive Director to a court of competent jurisdiction. Pending final decision of a dispute hereunder, CONTRACTOR shall proceed diligently with the performance of this Contract and in accordance with H-GAC'S final decision.

## ARTICLE 13: LIMITATION OF CONTRACTOR'S LIABILITY

Except as specified in any separate writing between the CONTRACTOR and an END USER, CONTRACTOR's total liability under this Contract, whether for breach of contract, warranty, negligence, strict liability, in tort or otherwise, but excluding its obligation to indemnify H-GAC described in Article 14, is limited to the price of the particular products/services sold hereunder, and CONTRACTOR agrees either to refund the purchase price or to repair or replace product(s) that are not as warranted. In no event will CONTRACTOR be liable for any loss of use, loss of time, inconvenience, commercial loss, lost profits or savings or other incidental, special or consequential damages to the full extent such use may be disclaimed by law. CONTRACTOR understands and agrees that it shall be liable to repay and shall repay upon demand to END USER any amounts determined by H-GAC, its independent auditors, or any agency of State or Federal government to have been paid in violation of the terms of this Contract.

## ARTICLE 14: LIMIT OF H-GAC'S LIABILITY AND INDEMNIFICATION OF H-GAC

H-GAC's liability under this Contract, whether for breach of contract, warranty, negligence, strict liability, in tort or otherwise, is limited to its order processing charge. In no event will H-GAC be liable for any loss of use, loss of time, inconvenience, commercial loss, lost profits or savings or other incidental, special or consequential damages to the full extent such use may be disclaimed by law. Contractor agrees, to the extent permitted by law, to defend and hold harmless H-GAC, its board members, officers, agents, officials, employees, and indemnities from any and all claims, costs, expenses (including reasonable attorney fees), actions, causes of action, judgments, and liens arising as a result of CONTRACTOR's negligent act or omission under this Contract. CONTRACTOR shall notify H-GAC of the threat of lawsuit or of any actual suit filed against CONTRACTOR relating to this Contract.

## ARTICLE 15: TERMINATION FOR CAUSE

H-GAC may terminate this Contract for cause based upon the failure of CONTRACTOR to comply with the terms and/or conditions of the Contract; provided that H-GAC shall give CONTRACTOR written notice specifying CONTRACTOR'S failure. If within thirty (30) days after receipt of such notice, CONTRACTOR shall not have either corrected such failure, or thereafter proceeded diligently to complete such correction, then H-GAC may, at its option, place CONTRACTOR in default and the Contract shall terminate on the date specified in such notice. CONTRACTOR shall pay to H-GAC any order processing charges due from CONTRACTOR on that portion of the Contract actually performed by CONTRACTOR and for which compensation was received by CONTRACTOR.

## ARTICLE 16: TERMINATION FOR CONVENIENCE

Either H-GAC or CONTRACTOR may cancel or terminate this Contract at any time by giving thirty (30) days written notice to the other. CONTRACTOR may be entitled to payment from END USER for services actually performed; to the extent said services are satisfactory to END USER. CONTRACTOR shall pay to H-GAC any order processing charges due from CONTRACTOR on that portion of the Contract actually performed by CONTRACTOR and for which compensation is received by CONTRACTOR.

## ARTICLE 17: CIVIL AND CRIMINAL PROVISIONS AND SANCTIONS

CONTRACTOR agrees that it will perform under this Contract in conformance with safeguards against fraud and abuse as set forth by H-GAC, the State of Texas, and the acts and regulations of any funding entity. CONTRACTOR agrees to notify H-GAC of any suspected fraud, abuse or other criminal activity related to this Contract through filing of a written report promptly after it becomes aware of such activity.

## ARTICLE 18: GOVERNING LAW & VENUE

This Contract shall be governed by the laws of the State of Texas. Venue and jurisdiction of any suit or cause of action arising under or in connection with this Contract shall lie exclusively in Harris County, Texas. Disputes between END USER and CONTRACTOR are to be resolved in accord with the law and venue rules of the state of purchase. CONTRACTOR shall immediately notify H-GAC of such disputes.

## ARTICLE 19: PAYMENT OF H-GAC ORDER PROCESSING CHARGE

CONTRACTOR agrees to sell its products to END USERS based on the pricing and other terms of this Contract, including, but not limited to, the payment of the applicable H-GAC order processing charge. On notification from an END USER that an order has been placed with CONTRACTOR, H-GAC will invoice CONTRACTOR for the applicable order processing charge. Upon delivery of any product/service by CONTRACTOR and acceptance by END USER, CONTRACTOR shall, within thirty (30) calendar days or ten (10) business days after receipt of payment, whichever is less, pay H-GAC the full amount of the applicable order processing charge, whether or not CONTRACTOR has received an invoice from H-GAC. For sales made by CONTRACTOR based on this contract, including sales to entities without Interlocal Contracts, CONTRACTOR shall pay the applicable order processing charges to H-GAC. Further, CONTRACTOR agrees to encourage entities who are not members of H-GAC's Cooperative Purchasing Program to execute an H-GAC Interlocal Contract. H-GAC reserves the right to take appropriate actions including, but not limited to, contract termination if CONTRACTOR fails to promptly remit H-GAC's order processing charge. In no event shall H-GAC have any liability to CONTRACTOR for any goods or services an END USER procures from CONTRACTOR.

## **ARTICLE 20:**

## LIQUIDATED DAMAGES

Any liquidated damages terms will be determined between CONTRACTOR and END USER at the time END USER's purchase order is placed.

ARTICLE 21: PERFORMANCE AND PAYMENT BOND FOR INDIVIDUAL ORDERS

H-GAC's contractual requirements DO NOT include a Performance & Payment Bond (PPB), and offered pricing should reflect this cost saving. However, CONTRACTOR must be prepared to offer a PPB to cover any specific order if so requested by END USER. CONTRACTOR shall quote a price to END USER for provision of any requested PPB, and agrees to furnish the PPB within ten business (10) days of receipt of END USER's purchase order.

ARTICLE 22:

## **CHANGE OF CONTRACTOR STATUS**

CONTRACTOR shall immediately notify H-GAC, in writing, of ANY change in ownership, control, dealership/franchisee status, Motor Vehicle license status, or name, and shall also advise whether or not this Contract shall be affected in any way by such change. H-GAC shall have the right to determine whether or not such change is acceptable, and to determine what action shall be warranted, up to and including cancellation of Contract.

ARTICLE 23: LICENSING REQUIRED BY TEXAS MOTOR VEHICLE BOARD [IF APPLICABLE]

CONTRACTOR will for the duration of this Contract maintain current licenses that are required by the Texas Motor Vehicle Commission Code. If at any time during this Contract period, any CONTRACTOR'S license is not renewed, or is denied or revoked, CONTRACTOR shall be deemed to be in default of this Contract unless the Motor Vehicle Board issues a stay or waiver. Contractor shall promptly provide copies of all current applicable Texas Motor Vehicle Board documentation to H-GAC upon request.

# **Request and Recommendation**

The Arapahoe County Sheriff's Office requests and recommends the Board of County Commissioners accept and sign a contract extension letter provided by Correct Care Recovery Solutions (CCRS) regarding the Restoring Individuals Safely and Effectively (RISE) program. This letter will clarify language that is in the expanded program contract signed earlier this year.

#### **Background**

Arapahoe County has partnered with CCRS (previously known as GeoCare) since late 2013 to house the RISE program in the Arapahoe County Sheriff's Office Detention Facility. The program works with justice-involved individuals who have been found incompetent to proceed with their legal case to restore them to a mental state at which time they can participate in the proceedings. RISE has been a success on numerous levels and the program was recently expanded.

During the contract negotiation for the program expansion, the intent of the Sheriff's Office and CCRS was to have the original program and expanded program to run concurrently which would alleviate the need to renegotiate two contracts for what is essentially the same program. During a recent review of the expanded contract, a clause was noted that indicated the contract for the original program would continue until June 30, 2016 and the expanded program would continue until June 30, 2020. The contract extension letter now before the Board extends both programs until October 31, 2018.

### **Links to Align Arapahoe**

Foster Safe Communities and Foster a Healthy and Vibrant County – Continuing to house and expanding the RISE program will help by evaluating and restoring criminal defendants to a state where they can continue in the legal process; overall mental health of program participants is significantly increased; the program provides a service to partnering organizations that is in great demand by restoring these individuals in a much quicker time frame than the sister program at the Colorado Mental Health Institute – Pueblo.

#### Discussion

In an effort to align the dates listed in the expanded contract, Captain Jared Rowlison has discussed this concern with his contact at CCRS. CCRS has two separate contracts with the State of Colorado to provide restoration services in a jail-based setting and thus the two separate dates appeared in the expanded contract between CCRS and Arapahoe County. CCRS has provided a contract extension letter that extends the original program contract through October 31, 2018 which coincides with their contract with the State. At that time, it is anticipated the entities will attempt to renew their respective contracts in an effort to merge the original and expanded program contracts. CCRS has requested that the County sign the extension letter. By doing so, the County will be agreeing that it formally intends to continue with both the original and the expanded program.

#### **Alternatives**

The BoCC could choose to not sign the contract extension letter. Should this happen, the unclear language in the expanded contract would remain potentially causing confusion at a later date.

# **Fiscal Impact**

There is no anticipated fiscal impact to signing the extension letter.

The Sheriff's Office Administration and Detention Services Bureau are in concurrence with this decision.

# **Purpose**

Two civil lawsuits for monetary damages were recently commenced by Torrey Banks, one in Denver District Court, *Torrey Banks v. State of Colorado, et al.*, Case No. 16cv412, and one in U.S. District Court, Case No. 16-cv-01725-GPG, seeking money damages against the County, employees of the Sheriff's Office, and others for violations of civil rights as a result of allegedly being subjected to malicious prosecution and deprived of his right to a fair and speedy trial by the purported use of fabricated, manufactured investigatory notes, and testimony.

# Background

The subject litigation arises from the prosecution of burglary and sexual assault charges filed against Torrey Banks in 2009. Banks was in federal custody at the time of his preliminary hearings and arraignment, and there were issues related to his transfer and availability for hearings. He pled guilty to the charges in 2012 but his pleas were conditional on his ability to challenge speedy trial violations. In his appeal, the Court of Appeals held conditional pleas are not allowed, remanded the case, and Banks ultimately withdrew the pleas. The charges were later dismissed for speedy trial violations.

Banks alleges claims of malicious prosecution and civil conspiracy against ACSO employees and others for allegedly falsifying evidence and contributing to prolonging his incarceration.

#### Discussion

Under the provisions of the Colorado Peace Officers Act and the Governmental Immunity Act, a county is obligated to bear the costs of providing a legal defense for its law enforcement officers when they are sued for acts or omissions allegedly committed by them during the performance of their jobs. The same holds true with respect to non-law enforcement personnel under the terms of the Governmental Immunity Act. Additionally, a county is obligated to indemnify its

officers and civilian employees for judgments or settlements that may enter against them in those suits, excluding punitive damages (unless otherwise authorized). These obligations are generally subject to the following conditions. First, that the conduct of an employee giving rise to the lawsuit occurred within the scope and performance of his or her job and, second, that the conduct of the employee was not wanton or willful, i.e., maliciously motivated or executed or taken in bad faith.

After reviewing the facts and information currently available, the County Attorney's Office has determined that the conduct of the above-referenced ACSO employees relevant to the claims in Mr. Banks' suits was not undertaken wantonly or willfully, or with any intent to injure him or to violate his rights. It is also apparent that the challenged conduct taken by these employees was taken by them within the scope of their job duties.

### Recommendation

The County Attorney's Office recommends that the Board adopt the proposed resolution accompanying this memo and authorize a legal defense and indemnification protection (inclusive of potential punitive damages) as provided under the Colorado Peace Officers Act and the Governmental Immunity Act in the above-noted litigation for the ACSO and these named current ACSO employees. The defense will be conducted by the County Attorney's Office.

John Hickenlooper, et al.*, was recently commenced in the United States District Court for the District of Colorado against the County and several employees for acts and omissions allegedly undertaken by them during the course and scope of their official duties and employment; and

WHEREAS, it appearing from the information presently available that the claims asserted against the several employees did not arise from wanton or willful conduct, and that there exist no disqualifying conflicts of interests between the named current employee defendants and the County; and

WHEREAS, the Board hereby determines that it is in the public interest for Arapahoe County to bear the cost of defending the current employees against the claims for personal liability and damages asserted in the suits against them, and to defend against and/or pay or settle such claims on their behalf subject to the terms and conditions contained in the Colorado Peace Officer Act and Colorado Governmental Immunity Act.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners for the County of Arapahoe, State of Colorado, that the cost of providing a legal defense for Ed Long, Justin Osborn and the ACSO in the case of *Torrey Banks v. John Hickenlooper, et al.*, Case No. 16-cv-01725-GPG, pending in the United States District Court for the District of Colorado, and a lawsuit titled *Torrey Banks v. State of Colorado, et al.*, Case No. 16cv412, pending in Denver District Court, were recently commenced against the County and several employees for acts and omissions allegedly undertaken by them during the course and scope of their official duties and employment and shall be borne by Arapahoe County, and that such representation shall be provided by the Arapahoe County Attorney's Office, except as may

otherwise be determined by the County Attorney, in which case the County Attorney may retain outside legal counsel as may be deemed necessary; and

BE IT FURTHER RESOLVED that Arapahoe County shall, consistent with the terms contained in the Colorado Peace Officers Act and Colorado Governmental Immunity Act, indemnify each of the current employees named as defendants in the suit from any and all judgments or settlements that may enter against them in the above-noted litigation, and that the claims asserted against them may be compromised, settled, and resolved of by Arapahoe County as it may deem appropriate, necessary, or convenient.

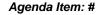

# **Request and Recommendation**

Request the BOCC to authorize the Chair to execute the conveyance of an extension to an existing Easement with CenturyLink Communications Co. located at Wayside Park.

Staff and County Attorney have reviewed the Easement and has determined it meet the County's requirements. Staff recommends said easement be granted by the County.

# Background

Wayside Park is located in the Four Square Mile Neighborhood, adjacent to the High Line Canal and north of East Harvard Ave. It is a small pocket park that was created for the neighbors in 1984. It was recently discovered that Bell Telephone, now CenturyLink, has a utility easement for a "Maxihut": a 200 square foot phone, electronic utility building with underground support utilities under a term limited easement that expired after thirty years, expired on December 31, 2015. CenturyLink still utilizes this structure that houses land line phone components and would like it to remain in place. The original easement terms state that if the easement is needed beyond the original term then the County and CenturyLink: "shall renegotiate the terms of the easement...an extension shall not be unreasonably withheld by the County". They do not foresee the use changing anytime soon and would like to make the easement perpetual so County and CenturyLink do not have to go through the process again.

CenturyLink has agreed to provide the County with another payment for the easement. The payment is the same amount as the original payment only the dollars have been adjusted for inflation to 2016 costs: \$9,060.00.

Approval of the easement and change to a perpetual term was heard before the BoCC on August 8, 2016 at a Drop-In Study Session and the perpetual term change was recommended for approval by all five (5) commissioners in attendance and moved to the Consent Agenda with no changes.

#### Links to Align Arapahoe

<u>Service First</u>: The Easement supports a positive relationship between utility companies who serves the citizens of Arapahoe County.

#### Discussion

Not extending the lease would be detrimental to CenturyLink as the existing underground utilities and building and would need to be removed and relocated at a high cost and according to the original Easement Terms the County cannot unreasonably withhold an extension. There is adequate language in the easement to ensure if the structure and easement are no longer used by CenturyLink then they must pay for the removal and restoration of the area. Discussion on the pro and con of a perpetual vs. term limited easement was discussed during a Drop-In Study Session on August 8, 2016 and was agreed by the BoCC to allow CenturyLink to change the term from a 30 year term to a perpetual easement.

#### **Alternatives**

- 1. Approve the Easement as submitted.
- 2. Deny the request for an Easement.
- 3. Re-negotiate the terms of the Easement.

#### **Fiscal Impact**

Renewal of the easement will provide positive financial impact to Open Spaces with a \$9.060.00 payment for park renovation and maintenance.

# RECORDING INFORMATION ABOVE **EASEMENT AGREEMENT**

This Easement Agreement is made this \_\_\_\_ day of September, 2016, by and between the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ARAPAHOE**, State of Colorado ("Grantor") and **QWEST CORPORATION D/B/A CENTURYLINK QC**, a Colorado corporation ("Grantee"), and its successors, assigns, affiliates, lessees, licensees, and agents.

Grantor maintains a public park facility North of E. Harvard Avenue and West of the High Line Canal (referred to as "Wayside Park").

Grantee desires to maintain an Electronic Equipment Enclosure (a "Maxi-Hut") in an area depicted in Exhibit A (the "Easement Area") within the boundaries of Wayside Park to contain electronic circuitry for communication services in the surrounding area.

WHEREAS, Grantor previously reviewed and approved the Maxi-Hut in Case L85-17 on September 24, 1985; and

WHEREAS, Grantor has no objection to providing Grantee an easement for the Maxi-Hut.

IT IS HEREBY MUTUALLY covenanted and agreed by and between the parties hereto as follows:

- 1. Grantee agrees to pay Grantor nine thousand sixty dollars (\$9060.00) for this easement.
- 2. The size of the Maxi-Hut shall not exceed 10' x 20' and shall not exceed 10' in height.
- 3. The Maxi-Hut may be a metal prefabricated structure or other material approved by Grantor and shall be placed on a concrete foundation.
- 4. The exterior of the Maxi-Hut shall be painted or otherwise architecturally treated in such a way that the design is consistent with, complements and blends in with the design and characteristics of the park setting, as approved by Grantor. Further, the Maxi-Hut shall, if requested by Grantor, be surrounded by a cedar fence.
- 5. Grantee shall maintain the Easement Area together with any improvements constructed or installed thereon by Grantee or associated with Grantee's use of the Easement Area. The operation and maintenance of such improvements and of the Easement Area shall be at Grantee's sole cost and expense.
- 6. The Maxi-Hut shall not contain any hazardous materials and shall have appropriate locks, lock guards and alarms to prevent unauthorized entry.

- 7. Grantee shall have the right of ingress and egress over and across Grantor's lands to and from the Easement Area except there shall be no direct vehicular access to the Maxi-Hut. All Grantee vehicles shall park on adjacent streets unless and until a parking lot is provided within Wayside Park.
- 8. Grantee will indemnify, defend and hold Grantor harmless from and against any and all loss, cost, liability, claim, damage and expense of whatever kind, including reasonable attorneys' fees and court costs (collectively, "Damages") to the extent such Damages arise from Grantee's use of the Easement Area out of or in connection with the maintenance, repair, use and operation of the Maxi-Hut.
- 9. Without limiting the liabilities or indemnification obligations of Grantee, Grantee will, at all times during the easement, carry and maintain at its expense the following insurance from insurers with minimum Best's ratings of "A-VII" authorized to do business in the state where the Easement Area is located: (a) Workers' Compensation insurance in accordance with the law of the state where any work under this easement agreement is being performed including Employer's Liability insurance with limits not less than \$1,000,000 each accident; (b) Commercial General Liability Insurance with an occurrence limit of not less than One Million Dollars (\$1,000,000) and an aggregate limit of not less than Two Million Dollars (\$2,000,000) covering personal injury, bodily injury, death, property damage, products/completed operations and contractual liability; (c) Commercial Automobile Liability with limits not less than \$1,000,000 combined single limit per occurrence covering bodily injury and property damage for all owned, non-owned and hired vehicles used in connection with the performance of this easement agreement; and (d) "All Risk" property insurance covering its Equipment and other personal property in sufficient amounts to cover any loss of such Equipment and personal property.

Grantor, its affiliates, subsidiaries, and parent, as well as the officers, directors, employees and agents of all such entities will be included as additional insureds on the policies described in subsections (b) and (c) above. The coverage described in subsection (b) will be primary and not contributory to insurance which may be maintained by Grantor, subject to the indemnification provisions of this easement agreement. 10. Whenever any notice or other communication (collectively, "Notice") is required or permitted under this easement agreement, Notice must be in writing and sent to the following addresses:

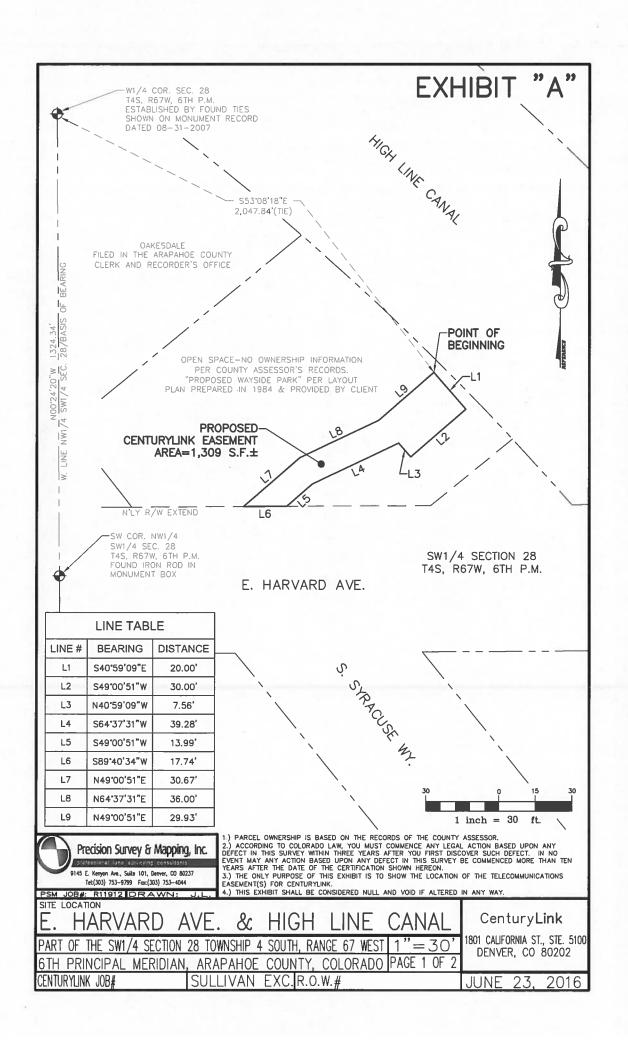

**Subject:** Approval of the ongoing Intergovernmental Agreement (IGA) between the

Douglas County Department of Human Services and Arapahoe County on behalf of Arapahoe/Douglas Works! (A/D Works!) workforce services as part of the

Employment First Program.

#### **Request and Recommendation**

At a Study Session on September 26, 2016, the BOCC considered continuation of the Arapahoe/Douglas Works! Intergovernmental Agreement with Douglas County Human Services to provide employment and training to Employment First SNAP E&T participants. The BOCC directed staff to set the matter on the Consent Agenda of a subsequent public meeting for approval.

**Background:** The Douglas County Department of Human Services requested the continuation of our current Employment First workforce program IGA to reflect the following:

- Employment First Program:
  - The IGA will continue at the same level of funding for the new program year.
  - If additional funding is awarded by the State, these funds will transfer to A/D Works! in an amendment generated by Douglas County.
  - The IGA includes the Earned Enhanced funding component which is generated by A/D Works! as an incentive for placing participants in employment.

#### Links to Align Arapahoe

- Quality of Life: Approval of the Intergovernmental Agreement is needed to serve unemployed and underemployed Douglas County food stamp recipients, enhancing their quality of life and ensuring the highest rate of return on public investment, while contributing to the Counties economic vitality.
- 2. Fiscal Responsibility: The Intergovernmental Agreement is required in order to comply with A/D Works! scope of work to provide workforce development services to participants of the Employment First program. This funding is dedicated to the reduction of poverty in the local community.

3. Service First: Approval of the Intergovernmental Agreement is needed for compliance with the Supplemental Nutritional Assistance Program Employment and Training (SNAP E&T) law, which will ensure services to low income food stamp recipients is received.

**Discussion:** In order to continue providing targeted/intensive job search and job placement services to Douglas County participants, approval of the IGA will need to occur. An approval will ensure funding continues for the targeted populations and services. These funds will cover the programmatic and operational costs incurred by A/D Works! to continue to provide workforce development services to Douglas County participants in accordance with federal rules and regulations.

**Alternatives:** If the IGA is not approved, the current Douglas County program will need to be transferred back to Douglas County Department of Human Services and the funded 1.5 A/D Works! FTE positions would be eliminated as well as service delivery would be impacted.

**Fiscal Impact:** Fiscal Impact to Arapahoe County Government is not anticipated and the contractual fee for service will be utilized to cover operating and customer program expenses.

#### INTERGOVERNMENTAL AGREEMENT

THIS INTERGOVERNMENTAL CONTRACT (hereinafter "this Contract") is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2016, by and between the BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, Colorado ("Douglas"), and the BOARD OF COUNTY COMMISSIONERS OF ARAPAHOE COUNTY, Colorado ("Arapahoe"). Both Counties hereinafter referred to as the "Parties".

#### **RECITALS**

- **WHEREAS,** the Parties are authorized under Article XIV, Section 18 of the Colorado Constitution, and by C.R.S. 29-1-203 et seq. to Contract with one another to provide any function or service lawfully authorized to each of them; and
- **WHEREAS**, Arapahoe, in its capacity as a County Human Services Agency, is responsible for the administration of various human services programs including the Supplemental Nutrition Assistance Program (SNAP) and its corresponding Employment First component; and
- **WHEREAS**, Douglas, in its capacity as a County Human Services agency, is responsible for the administration of various human services programs including the Supplemental Nutrition Assistance Program (SNAP) and its corresponding Employment First component; and
- WHEREAS, Arapahoe/Douglas Workforce Board has designated the Arapahoe/Douglas Workforce Center as the one-stop for the federally designated regions of Arapahoe County and Douglas County; and
- **WHEREAS**, Arapahoe, through its Arapahoe/Douglas Works Division ("ADW") of the Arapahoe County Community Resources Department, provides training, counseling, assessment and job referral services for individuals seeking employment, including SNAP/Employment First recipients; and
- **WHEREAS**, Arapahoe, through its Arapahoe/Douglas Works Division ("ADW") of the Arapahoe County Community Resources Department responded to the "Employment First Program" Request for Proposal #031-15, and
- **WHEREAS**, authority exists in the law and funds have been budgeted, appropriated and otherwise made available and a sufficient uncommitted balance thereof remains available for encumbering and subsequent payment under this Contract,
- **NOW, THEREFORE,** for and in consideration of the premises and other good and valuable consideration, the parties agree as follows:
- 1. Arapahoe, ADW, will provide Employment First case management services for Douglas Employment First program participants referred to ADW by Douglas County Human

Services as more particularly described in the Scope of Work attached hereto as "Exhibit A" and incorporated herein.

- 2. The term of this IGA shall be from October 1, 2016 through September 30, 2017, unless sooner terminated or otherwise extended. Douglas was not previously required to have an Employment First program.
- 3. Douglas agrees to pay Arapahoe an amount not to exceed \$210,524.44 (Two Hundred Ten Thousand Five Hundred Twenty Four Dollars and Forty Four Cents) as reimbursement for services provided herein. Arapahoe shall invoice Douglas on a monthly basis for services provided. Douglas shall pay said invoice within 30 days of receipt. All expenditures are subject to appropriation of funds. Douglas County may terminate without penalty by providing thirty (30) days' written notice to Arapahoe.
  - 4. Facility fees will be waived for Arapahoe County under this Contract.
- 5. The Director of Douglas County Human Services is designated as the authorized representative of Douglas for the purpose of administering, coordinating and approving work performed pursuant to this Contract.
- 6. Arapahoe agrees that no official, officer or employee of Arapahoe County shall have any personal or beneficial interest in the services described herein.
- 7. To the extent authorized by law, Arapahoe shall defend, indemnify, and hold harmless Douglas County, its elected officials, officers, directors and employees from any and all claims, demands, suits, actions or proceedings arising from or resulting from services provided by Arapahoe in relation to this IGA. To the extent authorized by law, Douglas shall defend, indemnify, and hold harmless Arapahoe County, its elected officials, officers, directors and employees from any and all claims, demands, suits, actions or proceedings arising from or resulting from the actions of Douglas in relation to this IGA.
- 8. Arapahoe and Douglas understand and agree that each party is relying on, and does not waive or intend to waive, any provision, right, immunity or protection provided by the Colorado Governmental Immunity Act, §§ C.R.S. 24-10-101 et seq.
- 9. In connection with the services provided pursuant to this Contract, Arapahoe shall not discriminate against any Douglas Employment First participant because of race, creed, color, national origin, religion, sex, mental or physical disability, or age.
- 10. All records remain the property of the Douglas County Department of Human Services. Any and all assets purchased by Douglas and assigned to a non-Douglas County/Department location remain the property of Douglas. Douglas may upgrade assets as needed at no expense to Arapahoe. Arapahoe must permit the County or Department reasonable access to all assets and will report the loss or damage of any asset to the Director's designee within one (1) business day. Arapahoe shall reimburse, at replacement value, the cost of any

equipment destroyed or otherwise rendered un-useful, for which Arapahoe bears responsibility for the destruction.

Documents, data compilations, and other client-based information prepared and maintained by Arapahoe in connection with this Contract shall be confidential. All such documents shall remain confidential and shall not be made available by Arapahoe to any individual or entity without the consent of the Douglas County Representative. Confidential records (whether paper, electronic or some other format) must be maintained in a secure environment that ensures confidentiality. Arapahoe will notify Douglas immediately of any breaches of security or confidentiality as they pertain to client data.

- 11. The Parties shall have the right to terminate this IGA, without cause, by giving not less than thirty days' written notice to the other party of such termination and specifying the effective date of such termination. Arapahoe shall be entitled to receive compensation in accordance with this Contract for services completed pursuant to this Contract prior to the date of receipt of the notice of termination or such other stop-work date as may be specified in said notice.
- 12. Notices to be provided under this IGA shall be given in writing and either delivered by hand or deposited in the U.S. mail with sufficient postage to the following addressees:

14. Pursuant to CRS 29-1-110, the financial obligations of Douglas as set forth herein after the current fiscal year are contingent upon funds for the purpose being budgeted, appropriated and otherwise available.

- 15. COMPLIANCE WITH ALL LAWS AND REGULATIONS: All of the activities conducted under this Contract by Arapahoe shall comply with all applicable laws, rules, regulations and codes of the United States and the State of Colorado.
- 16. ILLEGAL ALIENS: Arapahoe shall comply with §§ 8-17.5-101, et seq., C.R.S., regarding Illegal Aliens Public Contracts for Services, and this Contract. By execution of this Contract, Arapahoe certifies that it does not knowingly employ or Contract with an illegal alien who will perform work under this Contract and that Arapahoe will participate in either the E-Verify Program or Department Program in order to confirm the eligibility of all employees who are newly hired for employment to perform work under this Contract.

# A. Arapahoe shall not:

- (i) Knowingly employ or Contract with an illegal alien to perform work under this Contract; or
- (ii) Enter into a Contract with a subcontractor that fails to certify to Arapahoe that the subcontractor shall not knowingly employ or Contract with an illegal alien to perform work under this Contract.
- B. Arapahoe has confirmed the employment eligibility of all employees who are newly hired for employment to perform work under this Contract through participation in either the E-Verify Program or Department Program.
- C. Arapahoe shall not use either the E-Verify Program or Department Program to undertake pre-employment screening of job applicants while this Contract is in effect.
- D. If Arapahoe obtains actual knowledge that a subcontractor performing work under this Contract knowingly employs or Contracts with an illegal alien, Arapahoe shall:
  - (i) Notify the subcontractor and the County within three (3) days that the City has actual knowledge that the subcontractor is employing or Contracting with an illegal alien; and
  - (ii) Terminate the subcontract with the subcontractor if within three (3) days of receiving the notice required pursuant to the preceding subsubparagraph of this subparagraph, the subcontractor does not stop employing or Contracting with the illegal alien; except that the City shall not terminate the Contract with the subcontractor if during such three (3) days the subcontractor provides information to establish that the subcontractor has not knowingly employed or Contracted with an illegal alien.
- E. Arapahoe shall comply with any reasonable request by the Department of Labor and Employment made in the course of an investigation that the Department is undertaking pursuant to the authority established in § 8-17.5-102(5), C.R.S.

- F. If Arapahoe violates this provision of this Contract, Douglas may terminate the Contract for a breach of Contract. If the Contract is so terminated, Arapahoe shall be liable for actual and consequential damages to Douglas as required by law.
- G. Douglas will notify the Office of the Secretary of State if Arapahoe violates this provision of this Contract and Douglas terminates the Contract for such breach.
- 17. SEVERABILITY: In the event any of the provisions of this Contract are held to be unenforceable or invalid by any court of competent jurisdiction, the validity of the remaining provisions shall not be affected. Should either party fail to enforce a specific term of this Contract, it shall not be a waiver of a subsequent right of enforcement, nor shall it be deemed a modification or alteration of the terms and conditions contained herein.
- 18. NO THIRD PARTY BENEFICIARIES: The enforcement of the terms and conditions of this Contract and all rights of action relating to such enforcement, shall be strictly reserved to the parties, and nothing contained in this Contract shall give or allow any such claim or right of action by any other or third person under such Contract.
- 19. BREACH OF CONTRACT: Failure to perform according to the specifications of this Contract will be considered a breach of Contract and may be subjected to legal action, including immediate termination of Contract and/or any additional applicable legal remedies available to the County.

# Exhibit A SCOPE OF SERVICES

ADW submitted a response to the "Employment First Program" Request for Proposal #031-15 and was selected as the Contractor. Contractor will provide specific services related to the Employment First program for all Douglas County Department of Human Services (Department) referrals and participants. For the Employment First program, the Contractor shall:

# **Conducting Business**

- 1. Conduct business in accordance with the Department's Vision, Mission, and Values. (See Attachment 1.)
- 2. Maintain hours of operation that correspond to the Department's, i.e., Monday through Friday 8 a.m. to 5 p.m. Reasonable holiday and weather closures are permitted. During business hours Contractor will accept referrals; answer client and worksite questions and address concerns; and respond to customer calls and requests within 24 hours.
- 3. Retain confidentiality of all referrals and client information. This includes all verbal and written communication, and all service delivery information. Unless prior written approval is provided from the County, the Contractor may not release any information about the program and its participants.
- 4. Sign the Nondisclosure Agreement prior to any work being performed under this contract. (See Attachment 2.)
- 5. Complete and submit the required monthly expense report and attach all documentation that is sufficiently detailed as outlined by the Department to substantiate expenses and support service provision. Maintain all documentation (staff records and expense back-up) in an organized and auditable manner for four (4) years.
- 6. Have adequate space and technology, trained staff and general administration in place and prepared to begin this work by the start date of the Contract. Contractor must maintain these adequate levels throughout the Contract. Administrative support includes, but not be limited to, accounting, internal audit, purchasing, human resources, customer service, and staff development. All new technology and equipment purchases for this contract must be approved in advance by the Department to determine if Contractor or Department will make such purchase. Reasonable technology and equipment includes, but may not be limited to:
  - a. Phone lines, telephones and related gear, e.g., headsets
  - b. Scanners, copiers and printers (If any of this hardware is purchased by the Department and placed at ADW facilities, no other such equipment expenses may be charged to the Department.)
  - c. Computers and related peripherals, and consistent internet access (If any of this hardware is purchased by the Department and placed at ADW facilities, no other such equipment expenses may be charged to the Department.)
  - d. All necessary office furniture and reasonable office supplies
- 7. Maintain Department-approved detailed written operating procedures throughout this contract. These include, but may not be limited to, client case processing expectations; volunteer and employer site development and management; client supportive services;

- case reviews; confidentiality; system access and security; and the storage and distribution of any gift cards, vouchers, bus passes/tokens or similar items of cash value. These procedures must be approved by the Department (and be in place) by the  $10^{th}$  day prior to the start date of the Contract. All staff assigned to this contract must acknowledge receipt of these procedures prior to the start date of this contract, or if hired throughout the course of this contract within the first week of employment.
- 8. Meet with Department staff as requested to review overall performance and specific case or employer concerns as they arise. Reports on case work and reviews, customer service concerns, volunteer and employer site updates, and any related activities. Reports shall accompany the monthly invoicing, and may be additionally discussed in contract meetings.
- 9. Collaborate with community partners, employers, participants and Department staff as reasonable and appropriate to achieve program requirements and quality customer service.
- 10. Provide trained line staff, appropriately skilled supervision of staff, and appropriate overall management.
- 11. Notify the County and Department in writing of any change in the persons authorized to bind the Contractor.
- 12. Not subcontract this work to any other entity.
- 13. Complete reference and background checks before assigning line staff to perform work under this contract. (Line staff is defined as anyone who has client contact.)

  Background checks shall include a finger print check completed by a law enforcement agency. Contractor will provide copy of the completed check for all line staff assigned to this contract. The Department may refuse line staff placement depending on the background check results.
- 14. Contractor will notify the Department if/when any traffic or criminal charges occur that could impact assigned line staff's fitness or ability to execute the work assigned in this contract, or that violate a law, e.g., Adam Walsh Act, or program requirement.
- 15. Not speak with any member of the media without express consent by a County Commissioner, County Manager, Deputy County Manager, or Department Director. Not present to any entity that they make policy or funding decisions (including the use of earned incentives) on behalf of the County or Department. Contractor shall not engage in any form of lobbying on behalf of the County.
- 16. Work according to generally accepted accounting practices in accordance with established Federal and State laws, rules and regulations. Contractor shall retain an external independent auditor, and complete a Single Audit if Contractor is required to obtain one.

#### Compliance with Laws, Rules, and Policies

- 1. Immediately report suspected child and adult abuse, neglect and exploitation.
- 2. Abide by all applicable Federal, e.g., HIPAA and Adam Walsh Act, and State laws, rules, and regulations; and Douglas County program policies and procedures.
- 3. Annually related to civil rights either: 1) attend the Department's training, 2) provide their own training that covers the applicable laws, policies and procedures, or 3) submit an attestation acknowledging full awareness of and compliance with these laws,

- policies and procedures, and an understanding of how to contact the Department's Civil Rights Coordinator.
- 4. Report all known conflicts of interest consistent with the spirit of the County's and Department's Conflict of Interest policies. (See Attachment 3.)
- 5. Ensure staff are appropriately trained on all program rules, and use the required State computer system to determine participation, process all case-related actions, and note any employer-related information. Access additional State, County or third party systems as needed for client-related work only. Contractor shall comply with the State and County system access, use and confidentiality requirements. Contractor shall notify the Department immediately, when employees no longer have authorization to access any State or County system.

# **Program Services**

- 1. Use the Department's master client index (Human Services Client and Reporting Enterprise System or HSCARES) and electronic content management (ECM) system for all client and some provider documentation. No alternate or additional paper or electronic client files may be created or maintained by the Contractor. Initial training by Department staff will be provided for HSCARES and ECM with periodic refreshers as needed.
- 2. Develop and provide all of the following for new and ongoing participants:
  - Assessment of job history, skills, and readiness, and overall barriers to obtaining and retraining employment,
  - Program orientation (that includes a review of the "ticket" and "sanction" processes),
  - Services that focus on job search, referral and placement,
  - Interview skills and resume writing,
  - Soft skills training to include appropriate workplace conduct and communication
  - Time management and planning.
- 3. Identify an adequate number and type of workfare sites with a reasonable number or percent that are within Douglas County or within a reasonable commute for people who must use public transportation. Develop these relationships and ensure any required paperwork is completed and maintained.
- 4. Coordinate between the Food Assistance and Colorado Works eligibility staff as needed. Enter transportation reimbursement into the State system as approved by the Department. Provide other reimbursable supportive services consistent with Department approved procedures. (Client expenses that are not adequately documented or are not reimbursable per State rule will not be reimbursed to the Contractor. The amount budgeted for client transportation and supportive services are noted in Exhibit B, and are part of the overall Contract maximum.)
- 5. Address and resolve all participant program appeals and worksite grievances.
- 6. Create and maintain <u>participant</u> files that adequately address Department, County, State, and Federal program requirements and that meet reasonable audit standards. Participant files include, but may not be limited to:
  - Signed and dated releases and work plans,
  - Job search hours,

- Requests and approvals for supportive services (which may require the collection of receipts), and
- Volunteer and employer site records
- 7. Create and maintain <u>program</u> files that adequately address Department, County, State, and Federal program requirements and that meet reasonable audit standards. Contractor shall maintain documentation for four (4) years. Program files include, but may not be limited to:
  - Signed and dated staff confidentiality statements,
  - Signed policies and procedures required by the Department or State,
  - Staff training and development records,
  - Employer site development records, and
  - All fiscal records.
- 8. Determine the type of participation in accordance with all rules and regulations, and enter "tickets" or "sanctions" as appropriate.
- 9. Complete an investigation referral should there be any concerns about this or any other program or service provided by the Department.
- 10. Work reports timely and accurately to ensure correct program participation and enhanced funding.
- 11. Complete all State-required CBMS training, remain current with all changes, and correctly use the system.
- 12. Provide all the services outlined in their RFP response noted on "Programming for Douglas County Employment First Program".

### **Quality Assurance**

- 1. Attend program-related State and Department meetings and trainings, and ensure that program delivery is consistent with requirements and best practice.
- 2. Participate in any Federal, State or County audits or performance reviews, and allow access to all related records and systems. Contractor shall provide its own internal audit and quality assurance function, and maintain reasonable documentation. If an audit or review by a Federal, State or County auditor results in a corrective action plan, the Contractor shall develop such plan, obtain Department approval and implement by the defined deadline.
- 3. Participate in any Department Customer Satisfaction initiatives.
- 4. Maintain a processing timeliness standard of 100% and a case quality standard of 95% or better. Manual HSCARES entries, if required, must be 100% accurate, and all ECM document management must be 100% accurate.

# For the Employment First program, the Department shall:

1. Promptly notify the Contractor of all pertinent changes in this program including but not limited to changes in applicable law or regulations; changes in the eligibility requirements; staffing changes; availability of funds and use of incentives; changes in computer system access and use requirements; and changes in data collection requirements.

- 2. Provide the Contractor with access to needed State, County or third party computer systems as necessary.
- 3. Provide Workers' Compensation for Employment First participants at a volunteer or workfare site.
- 4. Monitor the Contractor's performance. Such monitoring includes, but may not be limited to:
  - customer service with both clients and work sites
  - evaluation of work via reports from the system
  - review of billing processes
  - evaluation of complaints and complaint resolution
  - ad hoc review of case work as deemed necessary by the Department.
  - use of HSCARES and ECM
  - quality of communication and collaboration with Department staff in addressing case questions and concerns
  - review overall program performance, e.g., timeliness and quality of contact with referred participants; client engagement; number of contacts made with potential and existing volunteer and workfare sites; number and type of client and worksite complaints received and how resolved; timeliness of reports worked; and other program outcome measures as may be mutually agreed upon.
- 5. Quality and timeliness of the services outlined in Contractor's RFP response noted on "Programming for Douglas County Employment First Program".
- 6. Be able to request that a specific individual be removed from working on Douglas County cases should their performance or customer service standards warrant it, or in the event of a conflict of interest.
- 7. Coordinate with Contractor to ensure client supportive services are made timely and with appropriate back-up documentation.
- 8. Coordinate with Contractor on all appeals, and participate in any complaints when appropriate. Manage all civil rights complaints.
- 9. Submit the Employment First Plan each year with input from the Contractor.

# Exhibit B METHOD OF PAYMENT

For services outlined in Exhibit A, Contractor shall generate documentation monthly that is sufficiently detailed as outlined by the Department to substantiate expenses and support service provision, and maintain all documentation in an organized and auditable manner for four (4) years.

- 1. Payments under this Contract shall not exceed the maximum contract expenditure for the term. Contractor shall bill monthly for services rendered. No pre-payments or advances will be made.

Any requested changes by either of the Parties must be approved in writing in advance of being applied. Back-up documentation used to calculate the applicable percentage will be provided by Arapahoe quarterly.
- 5. Arapahoe will use the invoice template provided by Douglas.
- 6. Any client expense which is not claimable under any of the above categories will not be paid unless prior written approval is obtained from Douglas. This item would be specifically highlighted in the invoice as such and include the prior written approval.
- 7. No computer hardware or software may be purchased under this contract.
- 8. In the event that any costs are shared by multiple clients or a cost is shared across two or more contracts with Douglas County, the Contractor must prorate the expense(s). The Department will only reimburse for the portion of the expense incurred for the execution of this Contract. Contractor may not bill the Department for any cost, fee or expense not outlined above.
- 9. If Contractor elects to simultaneously use any of the same staff people on this contract as another contract with the Department, Contractor must provide documentation that clearly identifies that the Contractor is not receiving more reimbursement for that expense than the appropriate share for each contract.
- 10. Invoices must be submitted by the 15<sup>th</sup> of each month subsequent to the month services were provided except September 2016 must be received by 12:00 noon October 6, 2016. This insurance will apply as primary insurance. The policy will be applicable to all premises and operations. The policy will include coverage for bodily injury, broad form property damage (including completed operations), personal injury (including coverage for Contractual and employee acts), blanket Contractual, independent Contractors, products, and completed operations. The policy will contain a severability of interests provision.
- (c) <u>Commercial Automobile Liability</u> insurance with minimum combined single limits for bodily injury and property damage of not less than ONE MILLION DOLLARS (\$1,000,000.00) each occurrence with respect to each of Consultant's owned, hired and nonowned vehicles assigned to or used in performance of the services. The policy will contain a severability of interests provision.
- (d) <u>Professional Liability/Errors and Omissions Insurance</u> coverage for any negligent act, error, or omission arising out of the performance of professional services under this Contract in an amount not less than ONE MILLION DOLLARS (\$1,000,000.00). Consultant shall maintain such coverage for at least two (2) years from the termination of this Contract.
- 2. <u>Certificates of Insurance</u>. The required Commercial General Liability and Commercial Automobile Liability policies will name Douglas County, its officers and employees as additional insured and provide for a waiver of subrogation in favor of Douglas County Colorado. The required Workers' Compensation and Professional Liability Insurance policies will name Douglas County as a Certificate Holder. The certificate(s) of insurance will be attached to this Contract as evidence that policies providing the required coverage, conditions, and minimum limits are in full force and effect. Any notices, within 20 days of cancellation, termination, or material change will be sent to:

- 3. **Right to Review, Revise and Reject**. Douglas County reserves the right to request and receive a certified copy of any policy and any endorsement(s) thereto. Douglas County reserves the right, but not the obligation, to review and revise any insurance requirement, not limited to limits, coverage, and endorsements. Additionally, Douglas County reserves the right, but not the obligation, to review and reject any insurance policies failing to meet the criteria stated herein or any insurer providing coverage due to its poor financial condition or failure to operate legally. Failure on the part of the Consultant to provide insurance policies within ten (10) working days of receipt of the written request will constitute a material breach of Contract upon which Douglas County may immediately terminate this Contract.
- 4. **Failure to Procure or Maintain Insurance**. The Consultant will not be relieved of any liability, claims, demands, or other obligations assumed by its failure to procure or maintain insurance, or its failure to procure or maintain insurance in sufficient amounts, durations, or types. Failure on the part of the Consultant to procure or maintain policies providing the required coverage, conditions and minimum limits will constitute a material breach of Contract upon which Douglas County may immediately terminate this Contract.
  - 5. **Deductibles and Coinsurance**. The Consultant agrees to be fully and solely responsible for any costs or expenses as a result of a coverage deductible, coinsurance penalty, or self-insured retention. The Consultant will indemnify Douglas County, in full, for any amounts related to the above.
- 6. **Governmental Immunity**. The parties hereto understand and agree that Douglas County is relying on, and does not waive or intend to waive by any provision of this Contract, the monetary limitations (presently \$300,000 per person and \$990,000 per occurrence) or any other rights, immunities, and protections provided by the Colorado Governmental Immunity Act, Sections 24-10-101 et seq., C.R.S., as from time to time amended, or otherwise available to Douglas County, its officers, or its employees.

- 1. <u>Definition of Confidential Information</u>. For purposes of this Agreement, "Confidential Information" shall include all information or material that has or could have commercial value or other utility in the business in which Disclosing Party is engaged. If Confidential Information is in written form, the Disclosing Party shall label or stamp the materials with the word "Confidential" or some similar warning. If Confidential Information is transmitted orally, the Disclosing Party shall promptly provide a written notice indicating that such oral communication constituted Confidential Information.
- 2. Exclusions from Confidential Information. Receiving Party's obligations under this Agreement do not extend to information that is: (a) publicly known at the time of disclosure or subsequently becomes publicly known through no fault of the Receiving Party; (b) discovered or created by the Receiving Party before disclosure by Disclosing Party; (c) learned by the Receiving Party through legitimate means other than from the Disclosing Party or Disclosing Party's representatives; (d) is disclosed by Receiving Party with Disclosing Party's prior written approval; or (e) when the County is subject to a Court Order to release the confidential information pursuant to the Colorado Open Records Act (CORA).
- 3. Obligations of Receiving Party. Receiving Party shall hold and maintain the Confidential Information in strictest confidence for the sole and exclusive benefit of the Disclosing Party. Receiving Party shall carefully restrict access to Confidential Information to employees, contractors and third parties as is reasonably required and shall require those persons to sign nondisclosure restrictions at least as protective as those in this Agreement. Receiving Party shall not, without prior written approval of Disclosing Party, use for Receiving Party's own benefit, publish, copy, or otherwise disclose to others, or permit the use by others for their benefit or to the detriment of Disclosing Party, any Confidential Information. Receiving Party shall return to

Disclosing Party any and all records, notes, and other written, printed, or tangible materials in its possession pertaining to Confidential Information immediately if Disclosing Party requests it in writing.

- 4. <u>Time Periods.</u> The nondisclosure provisions of this Agreement shall survive the termination of this Agreement and Receiving Party's duty to hold Confidential Information in confidence shall remain in effect until the Confidential Information no longer qualifies as a trade secret or until Disclosing Party sends Receiving Party written notice releasing Receiving Party from this Agreement, whichever occurs first.
- 5. <u>Relationships.</u> Nothing contained in this Agreement shall be deemed to constitute either party a partner, joint venture or employee of the other party for any purpose.
- 6. <u>Severability</u>. If a court finds any provision of this Agreement invalid or unenforceable, the remainder of this Agreement shall be interpreted so as best to effect the intent of the parties.
- 7. <u>Integration</u>. This Agreement expresses the complete understanding of the parties with respect to the subject matter and supersedes all prior proposals, agreements, representations and understandings. This Agreement may not be amended except in a writing signed by both parties.
- 8. <u>Waiver</u>. The failure to exercise any right provided in this Agreement shall not be a waiver of prior or subsequent rights.

This Agreement and each party's obligations shall be binding on the representatives, assigns and successors of such party. Each party has <u>signed</u> this Agreement through its authorized representative.

# Attachment 3 CONFLICT OF INTEREST

### **County Policy**

County employees may not use privileged information or exert any undue influence as a result of his/her relationship with the County for personal gain or benefit or to benefit relatives, friends, and other acquaintances.

If an employee or employee's family has any interest (including, but not limited to, serving as partner, stockholder, manager or employee) in any business that sells products or services to the County or if an employee has access to County information that may be used for private gain, the employee shall advise his/her Department Official in writing of such interest. The Department Official shall determine whether a conflict of interest exists and shall then advise the employee, employee's supervisor and Human Resources. If such a conflict is found to exist, the employee shall be given the option of terminating either employment with the County or interest in the business.

### **Department Policy**

### 1.0 Policy Statement

The Department administers various programs and services funded with federal, state, local and private funds. The delivery of these services often involves sensitive and confidential information, and may also include the receipt or distribution of funds/payments. Some of the programs/services provided may be for individuals/families known to one or more of the Department's employees. It is furthermore possible that Department employees or their family members are program/service recipients, e.g., apply for benefits, have a child support order or have a child protection referral/case.

Due to the nature of the Department's involvement in the processing and management of benefits/services and our commitment to work within the County's expectations of ethical behavior, Department staff will not participate in the processing and/or ongoing management of any case for which there is a conflict of interest. This procedure applies to all pending, open and closed cases.

#### 2.0 Definitions

Conflict of interest cases include, but may not be limited to, any referral, application or case for the Department employee's:

- 1.) self,
- 2.) immediate and extended family (including biological or adoptive, in-laws, ex-spouses or ex-step children),
- 3.) God children, foster children, or children with legal guardianship,
- 4.) boyfriend/girlfriend or roommate (and their children or family),
- 5.) friends or acquaintances or

6.) any other individual/family deemed to be in conflict by the Division Manager, Department Director, County Manager, Deputy County Manager or any of the County Commissioners.

A referral/application/case for any Department or County employee may be deemed to be "sensitive" (e.g., a unique relationship or set of circumstances exists) and as such treated as a conflict of interest case. The term "system" includes any electronic system/device used by the Department or County, including computer, email, fax or phone. The term "file" includes any documentation or information (whether verbal or written and regardless both paper and electronic/digital) related to the referral, application, processing, and ongoing maintenance of the case.

### 3.0 Department Employee Applications

If a Department employee wishes to apply for benefits/services provided by the Department, he/she must submit the application to his/her supervisor, manager, or director. The application will be assigned and processed as appropriate. All application/case related activity, including interviews and/or follow-up, must be done on the employee's time.

### 4.0 Employee Case Maintenance

If a Department employee is approved for/receives any benefit/service provided by the Department, the ongoing case file will be maintained by the employee's supervisor, manager, or director. All ongoing communications will be through that person or the individual designated by the supervisor, manager, or director. All application/case related activity, including interviews and/or follow-up, must be done on the employee's time.

### 5.0 Employee Responsibility

If an identified conflict of interest case is known to the Department, it will be assigned to an appropriate individual. Since it is impossible for the Department to be aware of all existing or possible conflict of interest cases, it is each Department employees' responsibility to immediately identify such cases for his/her supervisor, manager, or director. Failure to report a conflict of interest case may result in disciplinary action, up to an including termination.

### 6.0 Information or System Access

For any conflict of interest case, no Department employee, except for the individual(s) expressly authorized by the supervisor, manager, or director, may:

- 1.) access, edit or amend in any way any document or information related to or contained within the case paper file or electronic system, or
- 2.) discuss or otherwise participate in the application or ongoing maintenance of the case, or
- 3.) research or give program/policy related advise on the case, or
- 4.) print off system notices, forms or documents or otherwise obtain system information, or
- 5.) return phone calls, emails or other communication from individuals with a conflict of interest case.

Engaging in any of the above will result in disciplinary action, up to and including termination.

### 7.0 Other County Involvement

The Department may elect to have another county Department process the referral or application and maintain the case if approved/appropriate.

### 8.0 Appeals and Complaints

All appeals and complaints will be forwarded to the Administrative Services Division Manager. If the referral/application/case represents a conflict of interest for that individual, the referral/application/case may be forwarded to a supervisor, manager, or director. The director may ask that the appeal be managed by the County Attorney's Office or another county.

### 9.0 File Storage

The paper file for all conflict of interest case will be maintained by the supervisor, manager or director as appropriate.

### 10.0 Cash and Electronic Benefits Transfer (EBT) Cards

No employee may accept or handle in any manner cash or a cash equivalent, e.g., EBT card, for anyone with whom they have a conflict of interest.

### 11.0 Reporting Fraud

Anyone may report concerns about possible fraud to any of the following:

**Subject:** Adoption of the County's 2016 Updated ADA Transition Plan

### **Purpose and Recommendation**

Adopt the County's 2016 Updated ADA Transition Plan to ensure continued compliance with federally mandated regulations governing accessibility of County programs, services, facilities, and rights-of-way to citizens with disabilities.

### **Background/Discussion**

The Americans with Disabilities Act (ADA) of 1990 created an affirmative obligation on public entities, including counties, to create a plan of action to bring all public buildings, facilities, programs, services, and rights-of-way into compliance with new federal standards of accessibility to persons with disabilities. Over the course of the 25 years since the ADA was enacted, those standards have been refined and modified in response to evolving information concerning appropriate accessibility standards. The ADA built into its mandate a "safe harbor" provision permitting public entities, which have limited available funds, to set priorities and schedules to bring their programs, services, facilities, policies, and rights-of-way into compliance over time. The purpose of the "Transition Plan" is to set forth a public entity's plan to address its known deficiencies after a meaningful self-evaluative period, and to establish a record demonstrating its compliance efforts.

Under these conditions, since the passage of the ADA, the County has undertaken to implement a number of measures designed to bring its facilities, programs, services, policies, and rights-of-way into compliance with then-existing standards of accessibility. Because of changing standards, available County funds, and other considerations, the County has, from time-to-time, needed to reexamine its plan for accessibility, and to make changes to the estimates, priorities, and timetables.

In 2012, the federal government instituted significant changes to the implementing regulations governing ADA accessibility requirements. As a result, the County undertook the services of Meeting the Challenge, a disability rights advocacy and consulting group, which assisted the County in re-examining its then-current ADA compliance, with an eye toward adopting an Updated ADA Transition Plan. After considerable assessment, analyzation of results, and review of the County's short and long-term budgeting processes, the County has now put together an Updated ADA Transition Plan.

The updated plan is not a significant departure from the County's previous ADA compliance efforts; however, it does plan for some much-needed additions to the County's policies that affect disabled citizens. In addition, the Plan incorporates the most recent renovation, construction, and building plans for the County's Public Works, Fleet and Facilities, and Open Spaces departments. The Plan further provides a means for addressing recent minor accessibility issues raised by the State of Colorado at some Arapahoe County polling places ahead of the 2016 election season. The Plan also sets forth the County's intent to provide interpretive services for hearing impaired citizens through the Relay Colorado program. Finally, the Plan standardizes ADA accessibility and reasonable accommodation complaint procedures among the various County offices, such as the Sheriff's Office, the Human Services building in Aurora, and the County's other offices.

The Plan is not meant to be a rigid, inflexible schedule for compliance with the most recent changes to the ADA and implementing regulations; however, it is a general guideline to be used by County to set priorities for the expenditure of public money and to identify the areas where public money can be used to create the greatest positive impact on accessibility for disabled residents in the most cost-effective manner.

### **Executive Summary**

Arapahoe County has prepared this Updated ADA/Section 504 Transition Plan based upon the County's prior efforts to comply with its Americans with Disability Act Title II obligations, review and assessment of past and current regulations and statutory provisions pertaining to accessibility of programs, services, and facilities, a selfreevaluation (and its findings), public outreach and solicitation of public comment, and collaboration with citizens, stakeholders, and partners located throughout the County. The Plan sets forth a guide for improving the County's commitment to accessibility of all County programs, services, facilities, and transportation systems for the County's disabled citizens and ensures that the County will continue to strive for complete equality of accessibility in accordance with federal law. The County's continued success in improving accessibility in all aspects of the County's programs, services, and facilities will require continued monitoring and adjustment of the Plan particulars and a coordinated effort by County officials, partners, citizens, and other interested parties to apply the guidelines set forth in this Plan. The County encourages citizens, businesses, private and government officials, and other stakeholders to get involved in the continuing efforts to improve the County's efforts to meet its obligations under the ADA and Section 504.

# Updated ADA/Section 504 Transition Plan

Year 2016

### Introduction

The Americans with Disabilities Act (ADA), as amended, is a comprehensive civil rights law that requires equal opportunity for individuals with disabilities. It supplements and supports the federal government's prior disability rights law, Section 504 of the Rehabilitation Act of 1973 (Section 504). The ADA and Section 504 prohibit discrimination in, among other things, access to jobs, government services and communication. In setting its original transition plan, Arapahoe County engaged in an extensive self-evaluation to ensure that persons with disabilities have access to its employment opportunities, programs, services, facilities and benefits in compliance with Title II of the ADA and Section 504. Periodically, the County has reassessed its compliance with the obligations imposed by Title II of the ADA and Section 504, and has adjusted its focus to better serve the County's disabled citizens.

The County is obligated to observe all requirements of Title I in its employment practices and Title II in its policies, programs, and/or services and any parts of Title IV and Title V that apply to the County and its programs, services, and/or facilities.

In accordance with the ADA and with Section 504, this document shall serve as the Updated ADA/Section 504 Transition Plan for Arapahoe County (hereafter "the Plan"). Included in this document is consideration of the results of assessments that address compliance with the ADA and Section 504 within Arapahoe County's programs, services, facilities, roads and streets, and pedestrian rights of way. The ADA and Section 504 state that a public entity must reasonably modify its policies, practices, and/or procedures to avoid discrimination against people with disabilities. This Plan will assist the County in identifying current policy, program, and physical barriers to accessibility and in developing barrier removal solutions that will facilitate the opportunity of access to all individuals.

The development of this Plan has occurred with the assistance of several individuals and departments, and with Meeting the Challenge, Inc., which has evaluated the programs, services, roads, and streets of Arapahoe County. Any comments, additions, or suggestions about this Plan may be directed to the ADA/Section 504 Coordinator (hereinafter "ADA Coordinator").

Arapahoe County has three ADA Coordinators. Their contact information is included with this Plan at Appendix A.

The Plan will be reviewed periodically and updated further as needed. A public hearing regarding this Plan will be held prior to the Board's formal adoption of the Plan, and the Plan may be further updated based on comments received from the public. Notice of a public hearing will be made at least two (2) weeks in advance of the hearing. Any other comments, suggestions, and/or additions to the Plan may be addressed to the County's

ADA Coordinator. This Plan may be amended by decision of the Board of County Commissioners for Arapahoe County.

### Statement of Intent

#### Plan Mission Statement:

Through this Plan, Arapahoe County seeks to improve upon its provision of accessible services, programs, and facilities in a professional and effective manner to all citizens, facilitate economic growth and enhance the quality of life, public safety, and recreational and cultural activities.

### Goals for the Plan

- <u>Safety</u> To continue to provide, and where identified, improve upon the provision
  of a safe environment for all individuals who visit Arapahoe County facilities, use
  Arapahoe County vehicle and pedestrian travel ways, receive a service from the
  County, or who participate in any program or activity offered by or through
  Arapahoe County.
- <u>Accessibility</u> To continue to ensure, and where identified, improve upon the assurance that all persons accessing County programs, facilities and services are reasonably accommodated regardless of disability.
- <u>Functionality</u> To continue to ensure that reasonable accommodations provided by the County meet the requirements of local, state, and federal laws and regulations, as well as the needs of the public.
- <u>Efficiency</u> To continue to provide, and where identified, improve upon the
  provision of the most beneficial services at a reasonable cost, without
  compromising the safety of the public and/or the functionality of the
  accommodations.

### **Purpose**

The purpose of this Plan is to continue to ensure that all individuals are provided reasonable access to all Arapahoe County facilities, programs, services, and activities, and to update the County's current plan to identify next steps to ensure that County facilities, programs, services, and activities remain reasonably free from obstacles (whether physical or otherwise) to those individuals having one or more disabilities.

Title II of the Americans with Disabilities Act requires that local governments maintain a transition plan. A more complete articulation of the background of ADA transition plan requirements is set forth in Appendix B.

#### **Focus**

The Arapahoe County Board of County Commissioners believes that the ability to accommodate all individuals reasonably, regardless of disability, is essential to the County's provision of services directly to, and on behalf of its residents. Accordingly, as funds become available, and in accordance with obligations under the law, Arapahoe

County will continue to make reasonable modifications to facilities, programs, services, and activities, which modifications do not fundamentally alter the nature of the service, program or activity provided. Priorities will be given to the following:

- County offices
- County facilities
- County roads, sidewalks, paths, and other rights of way
- County programs and services
- County employees
- Places of public accommodation

### **Review and Development Process**

This Plan is implemented pursuant to the requirements set forth in Title II of the ADA, and will assist the County in identifying any necessary policies and programs, any remaining physical barriers to accessibility, and any barrier removal solutions that will facilitate continued and improved access opportunities for everyone.

There are two types of accessibility: physical accessibility and program accessibility; both types of accessibility are required by law. The ADA Accessibility Guidelines (ADAAG) cover a wide range of facilities (including buildings, outdoor recreation areas and curb ramps) and establish minimum accessibility requirements for new outdoor recreation areas and for new construction, as well as alterations to these facilities.

Accessibility includes more than physical access; it also includes all policies, procedures and practices that permit people with disabilities to participate in programs and to access important information. The County may provide program accessibility by a number of methods, both structural and nonstructural.

This Plan will guide the planning and implementation of necessary program and facility modifications over the next several years in accordance with the ADA and the ADAAG. This Plan reflects the County's ongoing commitment to the development and maintenance of policies, programs, and facilities that include everyone.

To be effective, this Plan needs to be utilized in the annual planning of projects and funding decisions, and also needs to be reviewed for compliance and validity. Any remedies suggested in this document are subject to further investigation and are not binding. However, deficiencies should be addressed in a manner that results in compliance. Regular updates to the Plan will also result in monitoring compliance and the effectiveness of any priorities in the Plan itself. The County desires to make the most effective accommodations as efficiently as possible.

The County will determine a list of priorities for providing accommodations, improving services and benefits, and modifying facilities and pedestrian rights of way. The highest priority will be given to any barriers identified by members of the public. Data from the self-evaluation did not specifically identify physical barriers; however, this conclusion may change as input from the community is received through surveys or other monitoring methods.

To assist in the setting of priorities for coming years, the County engaged the services of Meeting the Challenge, an organization that assists local government entities in performing and interpreting self-analyses and goal-setting. Meeting the Challenge performed an audit of the County's infrastructure and buildings in 2013, and produced a report on October 31, 2013.

### Citizen Input and Survey

The County also solicited input from County residents via an online survey. The survey was conducted over the course of six (6) weeks from April 4, 2016 through May 13, 2016. The survey solicited feedback from citizens concerning their experiences with County rights-of-way, pedestrian walkways, building access, parking measures, programs, services, internet presence, and other County initiatives. During the six-week survey process, the County received 83 separate responses, which provide significant insight into the issues of present concern to its disabled residents.

The results of the survey are included with this Plan as Appendix C.

In addition, before this Plan is fully and finally adopted and implemented, the County will accept input from the public, including interested residents and advocacy groups, at the meeting of the Board of County Commissioners at which the Plan is presented for adoption.

### Recommendations

### **Recommended Actions:**

<u>Customer Service</u> – In-person interaction with the public is one of the primary functions of many County departments and offices. The County has been developing policies to establish procedures for determining reasonable modifications to programs and customer services.

- Departments and offices may not charge any additional fees to persons with disabilities for modifying programs. As an example, the County may not charge for interpretive services for hard of hearing or deaf persons.
- The County will continue to provide accessible services such as parking (including van accessible parking), path of travel entry doors, signage and transaction counters at all customer service locations. The County should continue to evaluate these areas on a complaint-received and annual basis.
- The County will strive to ensure that modifications are provided in the most integrated setting without stigmatizing the user.
- The County will provide standard equipment at each customer service site to facilitate basic communication access using alternative formats. Equipment may include, but not be limited to, paper and pencil, hearing devices, access to the Relay Colorado 711 service technology, and a list of interpretive services.
- The County will ensure that access to interpretive services is readily available to persons who request such service.
- The County will continue to assess departmental policies to ensure they are updated and in full compliance with ADA Title II regulations.

- The County will allow the use of service animals to assist persons in accessing programs and facilities. Customer service personnel will be trained in the requirements for service animals. A draft of a proposed County service animal policy is located in Appendix D.
- The County will provide regular training for employees in the County who have contact with the public.
- The County will ensure that Relay Colorado 711 functionality is accessible and that staff is knowledgeable about the use of the service. Some TDD and TTY functionality will still be used by the Sheriff's Office and the County will ensure that such information is available and accessible to citizens who need it.
- The County has provided information regarding its obligation to make reasonable accommodations and the methods for requesting accommodations on its website and in pamphlets located in the Administration Building and at the Human Services Department.
- The County will ensure that educational materials regarding the ADA and Section 504 and explaining the means to require an accommodation are available in all of the County's courthouses and other County buildings accessible to the public.

#### Other Recommendations:

The updated assessment performed in 2013 identified examples of areas within County facilities and the public rights-of-way that are not in strict compliance with the 2010 standards and the 2005 Public Rights of Way Accessibility Guide (PROWAG). Noncompliant findings are to be expected because many of these facilities and rights-of-way were constructed prior to the adoption of the current (2010) ADA guidelines, changes to the ADA standards, and the anticipated adoption of the 2005 PROWAG standards, and are not required to be in compliance with the newest standards at this time.

The County has reviewed the survey results and examined the measures that were put in place as part of the initial transition plan. There was not a finding that those who are disabled have been prevented from accessing programs and benefits offered by the County, including benefits and programs offered by the Arapahoe County Department of Human Services, or access to information from the Clerk and Recorder's Office, the Treasurer's Office or Human Resources. Measures that have been implemented previously still provide adequate access to County programs and services for persons with disabilities at County facilities and public rights-of-way. As an example, improvements completed at the Arapahoe County main administration building as part of the initial transition plan, which included the main entrance ramp, automatic entry doors, and other improvements or accommodations, provide access for persons with disabilities to all of the public services offered at the facility. Therefore, even though there are areas in our facilities that are not in strict compliance with the 2010 ADA standards and guidelines, there are no known barriers to County services and programs for persons with disabilities. These areas, all of which were constructed prior to the 2010 ADA revisions can be altered when they are remodeled or otherwise subject to construction, which is when they will have to meet the 2010 (or any subsequent) standards.

Pedestrian facilities also provide adequate access to County programs and services which is evident by the absence of complaints and the instituted policies within the Concrete Repair Manual, dated December 2000. The manual details how an ADA/Section 504 accessibility issue is resolved in and out of the construction seasons. A copy of

the County's Concrete Repair Manual is included with this plan as Exhibit E. The County is still required by the 2010 ADA standard to address non-compliant pedestrian facilities when alterations are performed on public streets. The definition of an alteration is clearly defined by the Department of Justice and those alterations are performed mostly by Public Works and Development Department (PWD) with the majority of alteration projects occurring during the annual street maintenance projects. The alterations that PWD performs in the annual street maintenance project are asphalt overlays and roadway reconstructs. In addition, Capital Improvement Projects and private developers are required to design and construct all projects within the County to comply with current (2010) ADA guidelines.

The Facilities Department also will be required to meet the 2010 ADA requirements as it overlays or reconstructs parking lots and renovates or replaces County structures.

### **Training**

The County will ensure that all appropriate employees are trained and knowledgeable about the Relay Colorado 711 system and that such training is provided on a regular basis. Further, appropriate County employees at the Sheriff's Office will be trained and knowledgeable about the limited TDD/TTY services provided by that office.

The County has previously contracted with Rocky Mountain Disabilities, Inc. to provide training on the ADA and Section 504 to all employees of the County who have contact with the public and to all supervisors and managers, and will consider renewing such training in the coming years. Such training is mandatory for employees and the Human Resources Department will keep records of the training. Training was provided to employees at the Human Services Department in 2014, and is scheduled to be repeated in 2016.

The County will strive to ensure that training is repeated every two years.

A list of the proposed training curriculum is attached as Appendix F.

# **Existing Facilities and Public Rights-of-Way Constructed Prior to 2010**

Elements that have not been altered in existing facilities on or after March 15, 2012 and that comply with the corresponding technical and scoping specifications for those elements in either the 1991 Standards or in the Uniform Federal Accessibility Standards (UFAS) Appendix A to 41 CFR part 101-19.6 (July 2, 2001 ed.), 49 FR 31528. P A (Aug. 7, 1984) are not required to be modified in order to comply with the requirements of the 2010 standards.

The ADAAG, UFAS and the 2010 ADA Standards apply to "newly designed and newly constructed buildings and facilities and to altered portions of existing buildings and facilities," but not specifically to pedestrian infrastructure in the public right of way.

Compliance with the 2010 ADA standards will be accomplished in accordance with the provisions of the ADA, as amended, as part of major improvements or new construction funded through the Capital Improvements Projects.

In addition, pedestrian facilities located along roads in the annual street maintenance program that receive an alteration treatment, may have non-compliant items per the 2010 ADA standard that need to be addressed. Upgrades will be made when possible so that when the 2005 PROWAG is finally adopted by the federal government, the newest ramp and sidewalk installations will be in compliance. Further, Capital Improvement Projects and projects by private developers in the County will be constructed using the 2005 PROWAG guidelines.

Since all of these options are dependent upon the alteration budget, there could be unintended consequences to using the disproportionality rule to determine the amount of money spent on compliance with the ADA and Section 504. The County will be careful not to artificially restrict the alteration budget to minimize the amount of money required for compliance and will not adjust its maintenance treatments to avoid improvements that implicate ADA and Section 504 considerations, as that may not be the best pavement management practice. PWD is committed to maintaining roads in the most cost effective and efficient manner with a pavement preservation approach. This approach works to keep roads good by applying the right treatment at the right time. As a result of this approach, alteration-type treatments are used sparingly to maintain pavements.

In each option listed, issues that are not compliant with the ADA and Section 504 will need to be prioritized. This prioritization will need to be further developed and will be based on several variables which will include the following: non-compliant issue type, severity, location of issue, and road classification. Included with this Plan at Appendix G is the current year (2016) intended Curb Ramp Replacement Schedule, which addresses the most pressing alterations to the public rights-of-way in 2016. Similar replacement schedules are being planned for subsequent years.

### **New Construction, Alterations and Physical Changes to Facilities**

The County will ensure that all buildings and facilities constructed by or on behalf of the County and any alterations made to County Facilities are constructed in full compliance with the requirements of the ADA, as amended, and its implementing regulations.

- From September 15, 2010 to March 15, 2012, state and local governments had the option of choosing to follow the 1991 Standards, the UFAS, or the 2010 Standards when making architectural changes to achieve program accessibility and for all new construction and alterations.
- On or after March 15, 2012, public entities must comply with the 2010 Standards in making architectural changes to achieve program accessibility and for all new construction and alteration.

# **Parks and Outdoor Spaces**

The County will work to ensure that outdoor structures and facilities, recreational facilities, including, but not limited to multi-use trails, playgrounds, ball fields, and all other such facilities, are made accessible in compliance with the applicable provisions of the ADA, as amended, and its implementing regulations. The County will work to address specific citizen and advocacy group concerns as appropriate. Further, the County will monitor parks and outdoor spaces, as well as attendant parking and restroom facilities, to ensure that they comply with the applicable requirements under the ADA, as amended, and its implementing regulations.

A list of the current Arapahoe County Open Spaces Projects for the 2016 calendar year is attached to this Plan as Appendix H.

# **Voting and Election Locations**

Voting is one of our nation's most fundamental rights and a hallmark of our democracy. Several federal laws, including the ADA, protect the rights of voters with disabilities. The County is committed to complying with its obligations under these federal laws to ensure that all citizens eligible to vote have the opportunity to do so, and are not prevented or hindered in any aspect of the voting process because of a disability.

The County has made accessible all aspects of the voter registration process, and provides assistance in the registration process to disabled citizens upon request. No otherwise eligible citizen will be disqualified from registering to vote on the basis of a mental health, intellectual, or physical disability.

The County has ensured that all polling places are accessible to citizens with disabilities, and will provide reasonable accommodations at polling places upon request. The County is also reassessing the ramp access to its polling locations to ensure either that any ramps not compliant with applicable standards are replaced or modified, or that alternative access meeting all election accessibility requirements is provided for all local, county, state, and federal elections. Any new or additional polling locations election-to-election will comply with current regulations for accessibility. In the event an otherwise eligible voter with a disability cannot be accommodated reasonably at a polling location without undue burden, the County will make arrangements to ensure that the citizen is permitted to vote at an alternative location that can accommodate that person's disabling condition.

The County has ensured that voting systems are accessible to voters with disabilities, including citizens who are blind or visually impaired. Furthermore, the County will provide assistance or alternative methods of voting in the rare circumstance that the voting methods adopted by the County cannot accommodate a voter's disability.

Equal communication by County election officials with voters with disabilities will be ensured by the use of auxiliary aids and services where necessary, and where the use of such auxiliary aids or services would not result in a fundamental alteration or undue financial and administrative burden to the County. Poll workers and other election officials will be provided instruction in addressing requests for accommodations, auxiliary aids and services, and other issues that may arise during County elections.

# **ADA/Section 504 Complaint Procedure**

The ADA requires the County to implement a complaint procedure to assist the County in becoming aware of and resolving disability-related issues on County property, in County buildings, and involving County programs and services. The County and the Sheriff's Office maintained have complaint resolution policies implemented; however, policies requirement was those have not been standardized. The Complaint Procedures listed in this Plan are intended to standardize the procedure across the County offices and ensure that citizens have one easy-to-understand set of rules to follow when bringing an ADA-related issue to the County's attention.

The County's amended ADA Complaint Procedure is enclosed at Appendix I, along with a reproduction of the current complaint policy implemented by the Arapahoe County Sheriff's Office. The language has been standardized as much as possible and the procedures for submitting a complaint or appealing decisions have been made consistent between the County and the Sheriff's Office.

### APPENDIX B - ADA/Section 504 Background

### **Disability Access Laws**

Title VI of the landmark Civil Rights Act of 1964 prohibits government agencies from discriminating on the grounds of race, color or national origin. The rights of persons with disabilities are protected under Section 504 of the Rehabilitation Act of 1973, and even further under the Americans with Disabilities Act of 1990.

Title II of the ADA requires state and local governments to provide persons with disabilities an equal opportunity to benefit from government programs, services and activities.

Title II dictates that state and local governments with 50 or more employees must develop self-evaluation and transition plans to make their programs, services, and facilities accessible.

### **Regulatory Agencies and Resources**

The United States Congress has given the United States Department of Justice the authority to enforce Title II of the ADA and to coordinate other federal agencies' enforcement activities under Title II. In 1973, the United States Congress established the United States Architectural and Transportation Barriers Compliance Board as an independent federal agency tasked with preparing guidelines to standardize physical accessibility requirements. The United States Architectural and Transportation Barriers Compliance Board prepared the 1984 Uniform Federal Accessibility Standards and the 2004 Americans with Disabilities Act Accessibility Guidelines.

In 2010, the United States Department of Justice published a revision of accessibility requirements incorporating updates of Titles II and III of the ADA, and the 2004 update of the Americans with Disabilities Act Accessibility Guidelines. Together, the updated ADA and 2004 Americans with Disabilities Act Accessibility Guidelines comprise the United States Department of Justice's "2010 ADA Standards for Accessible Design."

The United States Department of Transportation is the agency responsible for overseeing state and local governments' compliance with Title II of the ADA regarding transportation systems including highway, railroad, transit, maritime and aviation. The Federal Highway Administration, a division of the United States Department of Transportation, is responsible for implementation of pedestrian access requirements in the public road right-of-way.

### **Disability Defined**

Under the ADA, a qualified individual with a disability is defined as a person who has a physical or mental impairment that substantially limits one or more major life activities. The two primary areas of disabilities that are typically accommodated in pedestrian facility design are mobility and visual impairments, but hearing and mental impairments can also be accommodated.

### **Technical Requirements**

Minimum design criteria for accessible pedestrian facilities has been established and published by federal and state regulatory agencies. It should be noted that the ADA has no effect on any state or local regulations that provide protection for individuals with disabilities at a level greater than that provided by the ADA.

### **Required Improvements and Exceptions**

The United States Department of Justice has made a distinction between the accessibility requirements that apply to new construction, altered construction, and maintenance activities. The United States Department of Justice has also recognized that exceptions to the design standards are allowed when applying the standards may be technically infeasible, structurally impracticable, or threatens historically significant features of a qualified historic facility.

### **Undue Burden**

Arapahoe County is committed to ensuring that everyone has access to its programs, benefits, services, and facilities. The County is not required to take action, however, when it can demonstrate that the action would result in a fundamental alteration in the nature of a program or activity, or would create a hazardous condition for other people or would represent an undue financial and administrative burden.

The determination that an undue financial burden would result must be based on annual evaluation of all resources available for use in a program. For example, if a barrier removal action is determined to be unduly burdensome, the County may consider other options for providing access.

Many do not use the crossing provided, and create a huge hazard for themselves and traffic. When is that project going to be done that is planned for Yale from Syracuse to Dahlia??!!
- Our Street has been plowed in 8 years. Today is 3/24/2016 it is 3:45 pm. Yesterday we received over a foot of snow. South Andes Cir in Sienna subdivision has yet to be plowed. We have a couple of autistic kids that live in our neighborhood, mine included.
- 1 Riverwalk paths seem to have been taken over by bikers and some are rude. Put up signs to remind bikers to tell those walking that the biker is near. Walking should always have the right of way.
- Snow clearance of sidewalk intersections is poor.
- Snow removal may be county or subdivision. Along Arapahoe Road from Holly to Broadway and Holly from Arapahoe to County Line sidewalks are impassible for anyone. Bus customers cannot get to bus stops, and disabled people are totally without ability to use sidewalks. We noticed people walking in the street on Holly dangerous for both pedestrian and drivers trying to avoid them.
- The sidewalks along Orchard Road between Cherry Creek Drive and Havana are impossible for anyone in a wheelchair to navigate after a snow storm. The plows dump the snow on the sidewalks, no one maintains/shovels these sidewalks and even if someone did shovel them the curb cuts are clogged with snow. This is totally unacceptable. My daughter uses a power wheelchair to get around and she is unable to be independent for weeks after a snow storm and must rely on her parents to help her get places. This is very frustrating for her and us. Something need to be done.
- The sidewalks are seldom, if ever, cleared of snow and ice on major streets like Buckley. Combined with the slope, it is dangerous, if not impossible, for people with disabilities and others. Homeowners are generally good at getting sidewalks in front of their homes cleared, but the city does a terrible job. For those of us unable to drive for medical reasons, this presents a major obstacle to walking for groceries or to the pharmacy. Also, with absolutely NO snowplow service to residential streets, crossing the street is a problem for those with disability. Again, inches of slush, snow and ice present a dangerous situation when crossing the street.
- The snow and ice never seem to be removed from the public sidewalks. The sidewalks on Buckley between Orchard and Smoky Hill are covered in ice and snow for days after any winter storm. Never cleared, and no ice melt!! Further, since the side streets are never plowed, it is virtually impossible to get across the street to get to the sidewalks cleared by the good citizens of Centennial in front of
- 1 The snowplows push all the snow from the street in front of the curb ramps. They are inaccessible until the snow melts.

# APPENDIX D – Proposed Policy on Service Animals in County Buildings

**Arapahoe County Service Animal Policy** 

**Approved by County Attorney's Office:** 

## **Approved by the BOCC:**

**Purpose:** The purpose of this policy is to confirm Arapahoe County's commitment to providing access to our facilities, programs and services to all citizens and to provide guidance to Arapahoe County employees encountering citizens with service animals.

#### **Definitions:**

"Service animal" is defined as a dog individually trained to do work or perform tasks for the benefit of an individual with a disability. Dogs whose sole function is to provide comfort or emotional support do not qualify as service animals under the Americans with Disabilities Act ("ADA"). Miniature horses qualify as service animals if (1) it is individually trained as a service animal, (2) is of the type, size and weight that can be accommodated in the facility, (3) its handler has it under sufficient control, (4) it does not urinate or defecate in the facility, and (5) it does not cause a fundamental alteration to a program or constitute a direct threat.

"Direct threat" to the health and safety of others may be present if the service animal is snapping, growling, biting, urinating, defecating, blocking egress, and presenting other similar behaviors.

#### Scope:

This policy applies to all Arapahoe County facilities, programs and services.

#### General Policy:

Service animals are allowed in all Arapahoe County facilities where the public is normally allowed to go unless the service animal poses a direct threat, a fundamental alteration, is not housebroken or is not under the control of the individual with a disability.

#### **Policies and Procedures:**

#### **Identifying service animals**

The County does not require documentation or certification that a dog or miniature horse is a service animal. If a dog or miniature horse appears to be a service animal, no inquiry is permitted. Should it not be readily apparent that a dog or miniature horse is a service animal, the employee may:

- 1. Politely stop the patron and notify him/her that animals are not allowed in County buildings.
- 2. If the patron says the dog or miniature horse is his/her service animal, the patron should be allowed to enter/remain in the building with the animal.
- 3. If the employee has questions or concerns about an animal, they should contact their supervisor and the ADA Coordinator.

Alternatively, an employee is permitted to ask the following two questions:

- 1. If the animal is required because of a disability?; and
- 2. What work or task has the animal been trained to perform?

#### Control over the service animal

Service animals must be harnessed, leashed or tethered, unless these devices interfere with the service animal's work or the individual's disability prevents using these devices. In that case, the individual must maintain control of the service animal through voice, signal or other effective controls.

If an employee feels that a service animal poses a direct threat, fundamental alteration, is not under control or housebroken, they should:

- 1. Notify their supervisor.
- 2. The supervisor will then ask the patron/visitor to correct the situation and bring the service animal under his/her control. If the handler does not take effective action to correct the situation, the supervisor will ask the handler to remove the service animal from the premises with the understanding that the handler is welcome to return without the service animal. The handler must be allowed to return without the service animal if he/she desires.
- 3. Employees will report any aggression, injuries, or damages caused by a service animal to the ADA Coordinator and Risk Management and designated staff will report them to animal control. Animal Control determines whether the service animal was "at fault."

## **CONCRETE REPAIR POLICY STATEMENTS**

- It is the policy of Arapahoe County Department of Development Services and Infrastructure Management
  ("DSIM") to immediately make safe any hazardous condition developing within County right-of-way. A
  hazardous condition would include a significant tripping hazard located in a high traffic pedestrian area. In
  some instances temporary repairs, such as an asphalt patch, may be performed until more permanent repairs
  can be scheduled. Permanent repairs occur as allowed by annual repair budget amounts.
- County contractors, County Road and Bridge crews and private contractors may repair damaged concrete in
  the public right-of-way. Property owners may have repairs made by private contractors at the property
  owner's expense. Work performed by private contractors must conform to current Arapahoe County
  Standards and Specifications, and requires a County permit. Further information regarding the permitting
  process may be obtained by calling 303-795-4640.
- 3. DSIM believes that good drainage extends pavement life. For this reason concrete replacements are generally scheduled in advance of County roadway reconstruction and maintenance projects. Additional repairs are prioritized from throughout the urbanized areas of unincorporated Arapahoe County from the County's Concrete Repair Database. Distress type, distress severity, incidence of Maintenance Request Forms ("MRF"), and annual budget amounts help to define concrete replacement priorities. When possible, alternative maintenance techniques may be scheduled to bring existing concrete structures up to an acceptable level of service.
- 4. Concrete repairs can be requested through the Engineering Division (303-795-4640) or Road & Bridge (303-792-5016) offices. After MRFs are received they are assigned to a member of the DSIM Maintenance Team who will then evaluate the complaint. The DSIM Maintenance Team consists of staff members from both the Engineering and County Road and Bridge Sections of DSIM. The team members shall utilize the "Condition Classification Chart for Concrete Improvements" in the evaluation process, which follows in this document. Engineering attempts to evaluate concrete conditions for the entire roadway segment listed on each MRF and enter this data into the Concrete Repair Database.
- 5. A Maintenance Team supervisor shall select the most economical approved repair method. The minimum repair or replacement section (five feet in length for curb and gutter and combination curb and gutter) required to alleviate unsafe or highly distressed conditions may be the only work scheduled for completion.
- 6. Repairs are generally scheduled during the fall and winter months prior to the beginning of the annual construction season. DSIM will complete as much work on an annual basis as allowed by the budget. Work that is not completed in the year it was originally scheduled will be re-prioritized and re-scheduled.
- 7. Sections that have had temporary repairs to correct hazardous conditions may be given priority over other repairs.
  - 8. Contract concrete replacement crews are generally scheduled to work in as many areas of the County as required to accomplish the County's concrete repair goals in any given year. Road & Bridge ("R&B") concrete replacement crews perform high-priority repairs and routinely complete maintenance request repairs and repairs in other locations and instances that may not be feasible for completion by outside contractors.
  - 9. It is the policy of DSIM to fully comply with all provisions of the Americans with Disabilities Act of 1992 ("A.D.A."). Arapahoe County will install new handicap ramps according to the procedures and policies established within this document. (See American's with Disabilities Act Section following).
  - The County's Concrete Replacement Program is prepared on an annual basis and is generally available for review at the DSIM offices after April 15. Please call 303-795-4640 for more information on the plan.

## INTRODUCTION

This document establishes the criteria for concrete repair and replacements by Arapahoe County DSIM. It is intended to be a guide for evaluating and determining repair priorities for many of the concrete features maintained by Arapahoe County, including sidewalks, curb and gutter and other concrete features. This manual is not intended to apply to structural concrete such as concrete pavement, bridge decks or hydraulic structures.

Policies are included for performing emergency repairs of potentially hazardous conditions; for citizen requests for repairs; for ADA compliance; and for DSIM's Concrete Repair Plan. Descriptions of the most common defects, or distresses, found in concrete features maintained by the County and definitions of the distress rating system utilized for them are also included. In addition, guidelines for repairing and replacing these concrete features are detailed. Finally, Appendix A contains miscellaneous policies and procedures and Appendix B follows with a variety of standard forms and letters used by DSIM.

# COMMON TYPES OF CONCRETE DISTRESS

Arapahoe County maintains a variety of concrete structures including sidewalk; curb and gutter; combination curb, gutter, and sidewalk; crosspans; handicap ramps; sidewalk chase drains and inlets. This manual does not apply to the relatively small amount of concrete pavement maintained by The County. This manual covers the most commonly-occurring defects appearing in the structures above, which include displacement, cracking, spalling or scaling, buckling, chipping and gouging, and "ponding" conditions.

This document contains a complete description of each type of distress with explanations of the most common causes of the defect. Severity ratings are defined for each type of defect, along with a brief discussion of potential repair methods. Photographs have been included for a variety of defects and condition ratings. More photographs will be added, as they become available.

# **DISTRESS SEVERITY LEVELS**

A member of the DSIM Maintenance Team shall rate each type of concrete distress according to the severity of the distress, as defined within this manual. The Condition Classification Chart for Concrete Improvements contained in this document defines a one-to-five rating system, with a Condition 1 being an excellent condition and a Condition 5 being a very poor condition having little or no service life remaining. Depending on severity, a distress may require a specific type of repair in order to bring it up to an acceptable level of service, or may only require monitoring to determine its rate of deterioration and the appropriate maintenance activity required.

This Concrete Repair Policy Manual, including the "Condition Classification Chart for Concrete Improvements," is utilized as an aid for DSIM staff to evaluate and schedule repairs in a consistent manner for many of the concrete assets maintained by the County.

Common distresses include the following:

- displacement
- 2) cracking
- 3) spalling/scaling
- 4) buckling
- 5) chipping/gouging
- 6) ponding

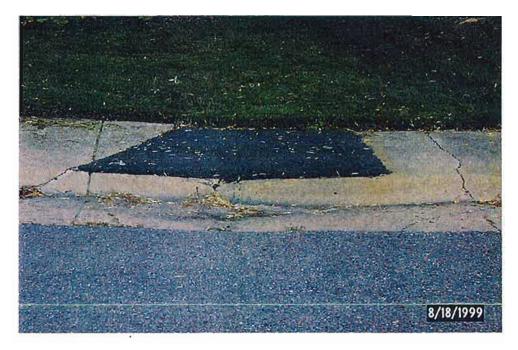
DSIM utilizes a 1-5 rating system to classify concrete conditions. (See "Concrete Distress Rating System," page 10).

# **EMERGENCY REPAIRS**

A significant pedestrian tripping hazard or a gouge within a motor vehicle travel lane severe enough to effect traffic (typically condition 5) may present a hazardous situation to citizens. In these instances, emergency repairs of the concrete shall be made. An emergency repair is typically temporary in nature. Emergency repairs may involve use of temporary barricades, removal of concrete sections, or simply covering hazardous sections with asphalt to eliminate the hazard, until permanent repairs can be scheduled.

Emergency repairs have priority, Emergency repairs have priority over all other concrete work performed by Arapahoe County. If a crew is not immediately available to perform the emergency repair, County Road and Bridge crews shall barricade the location to warn the public of the hazard, until the emergency repair can be made.

# **CITIZEN REQUESTS FOR REPAIRS**

DSIM utilizes the MRF process to allow citizens to make their maintenance requests known to the County. An MRF can be initiated by telephone or in person (see MRF PROCESS, p. 35). A member of the DSIM Maintenance Team typically evaluates concrete conditions for an entire roadway along with an individually requested location. This evaluation data is then entered into the Engineering Concrete Repair Database, where records for the concrete features maintained by DSIM are kept. When fully populated, the database will contain condition ratings for most of the concrete features maintained by Arapahoe County and can be used as a planning tool to ensure that County funds are efficiently utilized.

After the County has processed the MRF, citizens will receive a notification by mail, including a brief inspection report and comments explaining any actions taken by DSIM to resolve the request. An example MRF form, along with a flow chart showing the sequences in the County's MRF process has been included in Appendix A.

Concrete repairs are not scheduled on a "first come first served" basis. Rather, repairs are scheduled as previously noted in "Concrete Repair Policy Statement No. 3" (p. 4). Scheduling repairs and replacements in this manner allows DSIM to maximize County maintenance program budgets.

County Road and Bridge crews as well as private contractors perform annual roadway rehabilitation and maintenance. Prior to pavement rehabilitation, DSIM issues contracts to replace deteriorated concrete on the roadways selected in any given year. The extent of contracting is determined by the extent of repairs needed, the available time frame for making the repairs, and the budget allocated for the Concrete Replacement Program. Private contractors replace the majority of deteriorated concrete in Arapahoe County.

All contracted repairs shall conform to Arapahoe County Construction Standards, as well as to the Special Conditions of individual County contracts, if applicable. Permits are required for all work performed by contractors in County right-of-way.

# **AMERICANS WITH DISABILITIES ACT (ADA)**

It is the policy of Arapahoe County to fully comply with all provisions of the American's With Disabilities Act.

Routes near schools, medical care facilities and other high pedestrian traffic areas generally have priority for new handicap ramp installations.

New handicap ramps are installed annually by County Road & Bridge crews, and by County contractors.

It is the policy of Arapahoe County to fully comply with all provisions of the American's With Disabilities Act. DSIM utilizes three primary strategies to achieve this goal.

- 1) Depending on the availability of the Community Development Block Grant (CDBG) funds typically awarded to the County, DSIM prepares and administers an annual Handicap Ramp Installation Program. This program typically issues one contract each year to install new handicap ramps in locations throughout the urbanized areas of unincorporated Arapahoe County. High pedestrian traffic areas and access to activity centers have priority ahead of lower traffic areas. Pedestrian access to bus routes and pedestrian routes in the proximity of elderly care centers, medical facilities and routes near public buildings would generally have the highest priority.
- 2) Secondly, whenever concrete repairs are scheduled for an intersection radius which does not have a handicap ramp, crews will be directed to install a standard handicap ramp as a part of performing the normal work at that location. Routine concrete repairs are performed annually and may be performed by the County's Road and Bridge Division, or by County contractors as part of the Concrete Replacement Program and/or Roadway Rehabilitation Program. Handicap ramps are generally installed at all designated locations, however there are certain locations within Arapahoe County involving non-standard intersections, or non-standard structures, which may prevent or delay the installation of standard handicap ramps. In addition, handicap ramps would generally not be installed at locations otherwise indicated, if sidewalks do not exist. In these instances no architectural barrier exists to an accessible pedestrian route.
- 3) Thirdly, DSIM encourages open communication with other governmental agencies, advisory groups and citizens to determine critical locations for new handicap ramps. Individuals may request new handicap ramp installations at specific locations by calling 303-795-4640. It is DSIM's goal to have new handicap ramps installed within 60 days of receipt of the request, providing the request is received while weather conditions allow time for the work to be done and sufficient funds remain in DSIM project accounts. If handicap ramp requests are received after a construction season has ended, or after project budgets have been committed for the year, handicap ramp installations will be scheduled for the next construction season.

DSIM prepares a Concrete Repair Plan on an annual basis. This plan typically includes the following strategies:

- 1) Concrete Replacement Program
- 2) Handicap Ramp Installation Program (If Funded)
- 3) County Road & Bridge Concrete Repair Program (In House)
- 4) Alternative Program(s) (a mudjacking contract or other maintenance contracts will be prepared as needed.)

The contracts and strategies of the overall Concrete Repair Plan achieve several objectives. First, DSIM believes that pavements must be managed effectively and maintaining effective drainage on roadways is a primary factor in realizing their designed lifespan. For this reason, a primary purpose of the Concrete Repair Plan is to perform concrete replacements on roadways prior to them being sealed, resurfaced or reconstructed. In this way original drainage designs can be restored or improved and intended pavement designed lifespan can be fully realized, maximizing County taxpayer's maintenance dollars.

Another purpose of the Concrete Repair Plan is to maintain concrete structures in a safe, highly functional condition by performing routine repairs and replacements of deteriorated concrete features throughout the urbanized areas of unincorporated Arapahoe County. Routine replacements are prioritized from the County's Concrete Repair and MRF databases and will be included in the Concrete Replacement Program, as budget levels allow. In addition performing routine concrete repairs, County Road and Bridge concrete crews regularly perform emergency repairs and other replacements in areas where County contractors have not been scheduled to work as a part of their program.

A final purpose of the Concrete Repair Plan is to improve pedestrian accessibility and safety for County residents by assisting Arapahoe County meet ADA provisions. Many deteriorated curb ramps are replaced and new ones installed as a part of the County's overall Concrete Repair Plan.

## CONCRETE DISTRESS RATING SYSTEM

DSIM has established a 1-5 rating system for the basic concrete features maintained by Arapahoe County. Conditions are rated for sidewalks; curb and gutters; combination curb, gutter, and sidewalks; crosspans; handicap ramps; sidewalk chase drains and inlets. Condition ratings range from a condition 1, which is an excellent condition, to a condition 5, which is an extremely deteriorated condition with little or no service life remaining. In general, conditions 4 and 5 are replaced anytime a crew is scheduled to work on a particular roadway. Condition 3 (fair) may also be replaced; depending on the nature of the defect, the type of maintenance scheduled for the roadway, if any, budget amount and the incidence of MRFs received for the roadway.

# CONDITION CLASSIFICATION CHART FOR CONCRETE IMPROVEMENTS

Six common defects are rated with the County's "Concrete Condition Classification Chart" and prioritized for repairs and replacements.

Six of the most common distresses appearing in County-maintained concrete structures are identified and rated by severity according to the "Concrete Condition Classification Chart" included on the following page. Common distresses include the following:

- 1) displacement
- 2) cracking
- 3) spalling or scaling
- 4) buckling
- 5) chipping or gouging
- 6) sunken or "ponding" conditions.

In order to develop an orderty procedure for maintenance and replacement of concrete public improvements, the condition of the concrete improvement can be classified according to the criteria listed above. Concrete improvements to be classified under this system are crosspans, trickle channels, curb and gutter, sidewalks, and combination curb/gutter/sidewalk. Trickle channels shall be classified under crosspan criteria. The condition of the sidewalk shall generally govern when classifying combination curb/gutter/sidewalk. This classification is not to be used for assessing the condition of structural concrete, such as concrete paving, bridge decks headwalls, hydraulic structures, etc.

This classification chart is utilized to rate each of the commonly occurring defects in Arapahoe County's concrete features. A brief discussion of the of the individual defects follows and includes a description, typical causes of the defects, how the defects are rated and which conditions are typically replaced.

## CONCRETE DISTRESS IDENTIFICATION

#### DISPLACEMENT

#### **DESCRIPTION AND CAUSES**

Settled or displaced concrete creates a tripping hazard for pedestrians and cyclists. The associated crack also allows surface run-off to infiltrate into the subgrade soils. Water entering the subgrade soils generally leads to more widespread concrete damage and may precipitate street failures.

Differential settlement is normally a result of one or more of the following conditions: poor sub-grade preparation, trench failure, frost heave or tree root growth. The severity rating is determined by the amount of displacement between sections. The range will be defined in inches. Photos of various condition ratings for this defect have been attached.

#### **REPAIR METHODS**

A slow rate of settlement, combined with a low condition rating, is generally a stable condition that warrants a future evaluation. Crack sealing may be warranted, to slow the rate of water infiltration and subsequent concrete settlement. If settlement has occurred in a high pedestrian traffic area, and/or is significantly displaced, mud jacking, where possible, grinding, or removal and replacement would be necessary. Condition 4 and 5 displacement ratings generally require removal and replacement and may be temporarily patched with asphalt until permanent repairs can be scheduled.

#### CRACKING

#### **DESCRIPTION AND CAUSES**

Cracking may create a tripping hazard for pedestrians and cyclists and the associated crack also allows surface run-off to infiltrate into the subgrade soils. Cracks tend to widen over time and water entering the subgrade soils generally leads to more widespread concrete damage and street failures.

Concrete cracking is normally a result of one or more of the following conditions: poor subgrade preparation, trench failure, improper loading, poor curing practices, or inadequate slab thickness. The severity rating is determined by both the size and the amount of cracks occurring within a section. The standard section length for curb and gutter is generally 10 feet. Photos of various condition ratings for this defect have been attached.

#### REPAIR METHODS

A slow rate of movement and associated cracking, combined with a low condition rating, may warrant a future evaluation. In addition, crack sealing may be warranted to slow the rate of water infiltration and subsequent concrete cracking and settlement. If cracking has occurred in a high pedestrian traffic area, the cracked section may warrant removal and replacement. Cracked sections having condition ratings of 4 and 5 will generally warrant removal and replacement and may be temporarily patched with asphalt until permanent repairs can be scheduled.

#### **SPALLING / SCALING**

#### **DESCRIPTION AND CAUSES**

Spalling or scaling is characterized by the loss of mortar and/or aggregate from the surface of the concrete. Spalling reduces the load carrying capabilities of the concrete, due to a thinning of the section, and results in a concrete sections that are more susceptible to damage caused by freeze/thaw cycles and erosion. This type of distress can be pedestrian and cyclist hazard, as well as an unsightly visual condition.

The causes of spalled concrete are most often attributed to either defects in workmanship during concrete placement or improper curing of the product. Over-working of the surface or the addition of water after placement can also lead to spalling, as can improper cold weather protection during curing. Photos of various condition ratings for this defect have been attached.

#### **REPAIR METHODS**

Spalled sections of concrete should be monitored to determine the rate of deterioration. Deterioration rates may be highly variable. There are no approved long-term intermediate repair methods for spalling, so rapidly deteriorating sections should be scheduled for replacement. Condition 4 and 5 spalling sections are generally scheduled for removal and replacement and may be temporarily patched with asphalt until permanent repairs can be scheduled.

#### BUCKLING

#### DESCRIPTION AND CAUSES

Buckling may create a tripping hazard for pedestrians and cyclists and the associated crack allows surface run-off to infiltrate into the subgrade soils. Associated cracks tend to widen over time and water entering the subgrade soils generally leads to more widespread concrete damage and street failures.

Concrete buckling is normally a result of one or more of the following conditions: poor sub-grade preparation, trench failure, improper loading, poor curing practices, or inadequate slab thickness. The severity rating is determined by the amount of warp or distortion occurring within a section. Standard sections for curb and gutter are generally ten feet. Photos showing various condition ratings for this defect have been attached.

#### **REPAIR METHODS**

Buckled sections of concrete should be monitored to determine the rate of deterioration. Deterioration rates may be highly variable. Rapidly deteriorating sections should be scheduled for replacement. Condition 4 and 5 buckling sections are generally scheduled for removal and replacement and may be temporarily patched with asphalt until permanent repairs can be scheduled. Condition 3 may be replaced depending on current scope of work, location and repair budget amount.

#### CHIPPING / GOUGING

#### **DESCRIPTION AND CAUSES**

Chipped concrete can be a pedestrian and cyclist hazard, as well as an unsightly visual condition. Chips that hold water can make the concrete section more susceptible to damage from freeze/thaw cycles.

Gouged or chipped concrete is most often the result of either external damage by snow and ice removal and construction equipment, or excessive sub-grade pressures. Chipping adjacent to contraction joints is normally a result of poor workmanship or inadequate tooling practices. Photos showing various condition ratings for this defect have been attached.

Note: a distinction has been made above between concrete sections subject to pedestrian traffic (sidewalks) and other concrete features. In this way pedestrian safety can be maintained without unnecessarily replacing other concrete features that have not lost significant functionality.

#### REPAIR METHODS

Chipped or gouged sections meeting condition-ratings 1, 2 and 3 generally do not warrant removal and replacement. Condition 3 chipping in sections may be scheduled for removal and replacement, depending on the location of the concrete section, pedestrian traffic levels and the type of maintenance scheduled for the roadway. Chipped sections meeting condition 4 and 5 are generally scheduled for removal and replacement and may be temporarily patched with asphalt, or grout, until permanent repairs can be scheduled.

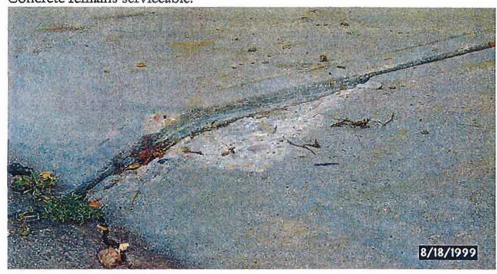

#### **PONDING**

#### **DESCRIPTION AND CAUSES**

Sunken areas create ponds of water in the concrete. These ponds may allow water to penetrate into the subgrade soils at the interface, or joint, between the concrete and the asphalt. Water ponds may also create potentially hazardous roadway conditions due to splashing and cold weather icing problems.

Sunken concrete is normally the result of one or more of the following items: poor sub-grade preparation, trench failure, street related sub-grade failures or excessive loading. The severity levels will be determined by the ability to maintain adequate flow, as compared to the original design criteria.

#### **REPAIR METHODS**

Ponding conditions 1 and 2 deviate from the original line and grade which cause minor ponding of runoff water, yet still allow the majority of the flow to escape. Ponding of this classification is generally not a significant problem and is not scheduled for removal and replacement. Ponding condition 3 deviates in line and grade and inhibits the flow of runoff water and does not permit the concrete structure to function according to design. Ponding of this classification is generally contained within the limits of the concrete structure and is generally not scheduled for removal and replacement. This condition needs to be monitored to determine the rate of deterioration. If joint sealing or crack sealing will reduce the rate of deterioration of a section, it should be scheduled as soon as possible. Sunken sections, which contribute to localized traffic or pedestrian problems, should be scheduled for replacement. Ponding conditions 4 and 5 deviate in line and grade causing excessive ponding, which will generally exceed the limits of the slab. Ponding of this classification is generally prioritized for removal and replacement.

#### Ponding Condition 1. Excellent.

#### APPENDIX A MISCELLANEOUS

#### SIDEWALK CHASES

DSIM shall maintain chase structures that have been permitted and installed according to Arapahoe County Construction Standards. DSIM shall not be responsible for maintaining the integrity of unapproved discharge pipes/drainage structures placed through County curbs and sidewalks by private parties.



#### SIDEWALK CHASE INSTALLATION USING COUNTY FUNDS

"DSIM will only authorize the installation of new sidewalk chase sections with public funds if surface storm water runoff is being conveyed to the street from greater than 4 lots."

DSIM has established a policy for installation of sidewalk chase sections through curb/gutter/sidewalk within public right-of-way. DSIM will only authorize the installation of sidewalk chase sections with County funds if surface storm water runoff is being conveyed to the street from greater than 4 lots (as determined by DSIM).



Side yard swales between two homes are not considered to be multi-lot drainage facilities. DSIM will not authorize expenditures of County funds to install chase sections for water accumulations resulting from landscape over-watering, sump pump discharge, side yard swales, down spouts from residences or landscaping under-drains, etc.

DSIM will conduct a site inspection when the County is requested to install sidewalk chases and may review County drainage maps and/or studies to determine if the location meets County chase installation criteria. If these requirements are met, DSIM will add the sidewalk chase request into the County's overall Concrete Repair Plan and prioritize for construction. Construction will be prioritized and scheduled, as allowed by annual repair budget amounts and overall repair priorities.

#### ALTERNATIVES TO SIDEWALK CHASE INSTALLATION WITH PUBLIC FUNDS

If the DSIM inspection shows the location does <u>not</u> meet County installation criteria, property owners will be asked to choose one of two options listed below (also see Standard Letter, Appendix B):

OPTION 1: The property owner wishes to keep the pipe running from their property through, or across County-maintained curb/gutter/sidewalk, and chooses to have a sidewalk chase drain installed, at their expense, in the curb/gutter/sidewalk to replace the pipe which currently passes through it or discharges across it.

Providing the chase section meets Arapahoe County's Construction Standards, the County will assume future maintenance of this structure. DSIM may be able to facilitate the installation of the chase by referring the property owner to a County contractor, depending on the nature and scope of the County's project, and contract time. DSIM will not authorize payment for initial chase installation, unless the existing pipe is utilized for multi-lot (greater that 4 lots) surface storm water drainage (as determined by Arapahoe County Engineering Division).

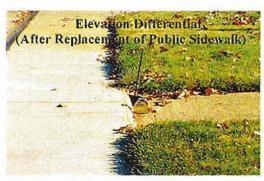

OPTION 2: The pipe does not meet County installation criteria (convey surface storm water drainage from greater that 4 lots, as determined by Arapahoe County Engineering Division) and the property owner does not wish to pay for the installation of a County-approved sidewalk chase. County representatives will replace the deteriorated concrete feature and terminate the pipe running from the property through the County's curb/gutter/sidewalk.

The property owner shall be responsible for the pipe remaining on private property and for disconnecting the pipe and re-routing its flow to another County-approved discharge point on their property.

#### REPLACEMENT OF PRIVATE CONCRETE IMPROVEMENTS

Over time, overwatering of landscaping and poor subgrade soil conditions may lead to settlement of concrete sidewalks and curb and gutter. In many instances County-maintained concrete structures settle at the same rate as adjacent private sidewalks and driveways. These conditions present problems when County crews and contractors replace County-maintained curbs and sidewalks and restore or improve the original design grades. The resulting differential in



elevations between concrete sections can present safety hazards in areas subject to pedestrian traffic. It is not the policy of DSIM to authorize the expenditure of public funds for replacing concrete improvements located on private property, however, DSIM attempts to avoid hazards resulting from County concrete replacements as follows:

- 1) When original drainage designs are *improved*, DSIM will assume responsibility for resulting differential elevations in adjacent driveways and sidewalks to avoid hazards.
- Where original drainage designs are restored, DSIM will not assume responsibility for maintaining or replacing private concrete features located behind the sidewalk, such as private sidewalks and driveways. However, DSIM may take some of the following actions to mitigate impact to private improvements in specific cases:
  - a) When replacements are made, efforts will be made to match existing private improvements, within reasonable conformance with Arapahoe County Roadway Design and Construction Standards.
  - b) DSIM may make temporary repairs, including concrete overlay or patching, to temporarily alleviate tripping hazards (County Condition 3, > 5/8") resulting from County work.
  - c) DSIM may elect to replace portions of private improvements located on County right-of-way at County expense to avoid safety hazards.
  - d) DSIM staff shall attempt to advise property owners of potential problems that may result from County work and attempt to obtain property owner's participation to resolve the problem.

#### **DRIVEWAY FILLETS**

"Driveway fillets" typically consist of concrete or asphalt slabs placed in the flow line of sections of curb and gutter to provide smoother access to driveways. Filling in the gutter with these materials may allow easier access to private driveways, but fillets invariably become flow-line obstructions resulting in accumulations



of dirt and ice, restricted drainage, accelerated damage to pavements and potential safety hazards. For these reasons, driveway fillets are in violation of Arapahoe County Roadway Standards, federal safety standards adopted by the American Association of State Highway and Transportation Officials (AASHTO), The Manual on Uniform Traffic Control Devices (MUTCD) and Colorado Revised Statutes.

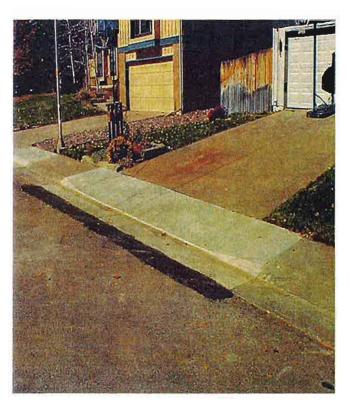


DSIM utilizes the following strategies to minimize the potential problems associated with driveway fillets:

- 1) DSIM requests that property owners remove driveway fillets (See Appendix B) on a complaint basis. Residents frequently complain due to fillets' tendency to accumulation of water and sediments in adjacent gutters.
- 2) Driveway fillets may be removed with annual rehabilitation projects when County crews or contractors replace concrete or resurface pavements.
- 3) Engineering staff may notify property owners to remove fillets on streets scheduled for pavement overlay or reconstruction where fillets are expected to significantly decrease the lifespan of new pavements (i.e., water accumulations into street).

Estimates of the quantity of fillets existing in unincorporated Arapahoe County has been performed recently, however DSIM believes that 500 or more fillets may exist throughout the County.

As an alternative to placing fillets in gutters, property owners may contract privately for the installation of a curb depression or "curb cut," (see photo at right and detail in Appendix B). Curb cuts are a County-approved method of obtaining relatively smooth driveway access, while avoiding the problems typically associated with driveway fillets. A County permit is required to have this work performed. Permit information can be obtained by calling 303-795-4640. A permit is not required if residents contract directly with the County's annual Concrete Replacement Program contractor(s). County residents may contact Engineering for contractor phone numbers and may realize savings in cases where the County is replacing portions of the concrete in front of a driveway necessary for curb cut installation.



#### **CURB CUT INSTALLATION BY COUNTY**

DSIM has established a policy for expenditure of County funds for installation of curb cuts, or depressed driveway approaches when County representatives are replacing curb/gutter/sidewalk within public right-of-way. DSIM will only authorize curb cut installation utilizing County funds if 100% of the driveway width (measured to the nearest foot) meets the County's replacement criteria, as determined by Arapahoe County DSIM, and has been scheduled for replacement. Concrete that does not meet the County's replacement criteria will not be replaced with County funds for the convenience of property owners.



If the Count's requirements are met, DSIM representatives will install a curb cut, including the necessary transition lengths on either side of the driveway, at no cost to the property owner.

#### INSTALLATION OF NEW SIDEWALKS

Pedestrian facilities are the responsibility of both the private and public sectors. The private sector, by development statutes and regulations, is typically responsible for pedestrian facilities within developments. The public sector is typically responsible for community-wide pedestrian facility planning and the design of facilities along major roadways. However, when private landowners are responsible for providing sidewalks, continuous sidewalk systems are frequently disrupted by missing links in the system where individual parcels are awaiting development or redevelopment. The following factors have been weighted for use as aids for the County to prioritize construction of new sidewalks. A score of 105 would be the maximum number of points any location or project could score.

#### **MRF PROCESS**

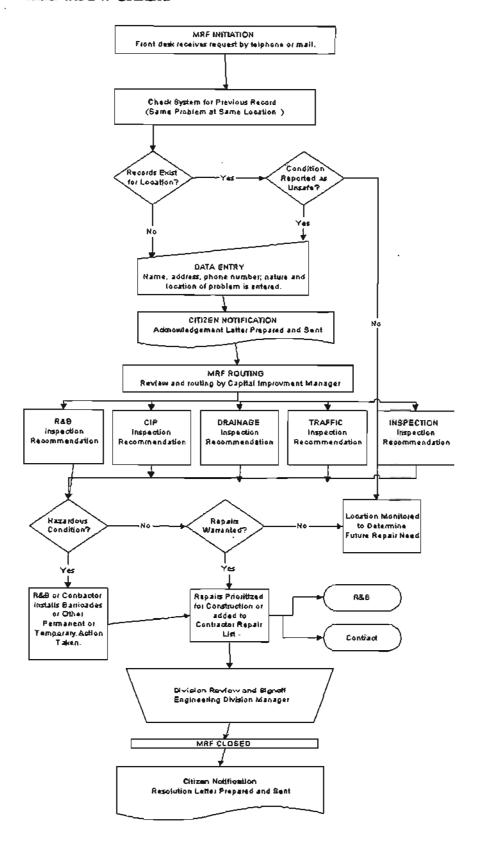
At this time Arapahoe County is in the process of implementing changes in our MRF process. Permits Plus<sup>TM</sup> client server software has recently been implemented to improve in-house accessibility and use of various County databases. This system is expected to provide one-stop access to information including building permits, planning cases, engineering projects, MRFs as well as other information. Sharing of information between departments should increase and overall County response time to customers both inside and outside of Arapahoe County should decrease as a result of this system.

#### MRF FLOW SEQUENCE

In general MRFs received by DSIM are processed by the following actions:

- 1. MRF Initiation. Information received by DSIM office by telephone or in person. Information is entered into MRF database.
- 2. Citizen Notification. Citizen is sent a letter acknowledging the County's receipt of the request and anticipated time for response (see MRF Acknowledgement Letter, Appendix B).
- 3. MRF Routing. MRF is reviewed by the designated manager and routed to appropriate Section/inspector, staff member.
- MRF Inspection. Inspector evaluates location and suggests repair or action necessary to resolve request. Inspection may be performed for entire roadway segment, depending on staff resource availability.
- 5. Division Review and Sign-Off. Completed MRFs will be forwarded to Division Manager for QC review and sign-off.
- 6. Citizen Notification. If MRF has been completed, a resolution letter will be sent to citizen.
- 7. MRF Closed. (Note: MRF may be closed prior to final resolution of complaint. MRF records will be maintained in database until final resolution).

#### **ROAD & BRIDGE MRFs**

On this date, limitations in the computer network linkage between Engineering and Road and Bridge offices require the following additional actions by Engineering. After MRFs have been initiated at DSIM, Engineering Section, and assigned to the Road & Bridge Section, a hard copy will be sent to R&B offices via interoffice mail. R&B staff will then evaluate the location and suggest repairs or actions necessary to resolve the requests. The MRF will then be returned to Engineering where R&B staff comments will be entered into the County's database and the MRF will be finalized in the normal manner.

Arapahoe County, as the owner of the public roadway and sidewalk adjacent to your property at [Address], has identified a flow-line obstruction located in the curb and gutter, in front of the driveway at the above address. The obstruction consists of a driveway approach slab, or "driveway fillet."

While filling in the gutter with concrete or other materials may provide smoother access to your driveway, flow-line obstructions typically cause accumulations of dirt and ice to build up, restrict drainage, accelerate damage to pavements and may present safety hazards. For these reasons, driveway fillets are in violation of Arapahoe County Roadway Standards, federal safety standards adopted by the American Association of State Highway and Transportation Officials (AASHTO), The Manual on Uniform Traffic Control Devices (MUTCD) and Colorado Revised Statutes.

Therefore, Arapahoe County requests that this obstruction be removed. The obstruction must be removed within thirty (30) days from the receipt of this letter. If you do not remove the obstruction, Arapahoe County representatives will clear the obstruction and bill you for the associated costs. If you wish to avoid this assessment, please remove the obstruction prior to the expiration of the 30-day period.

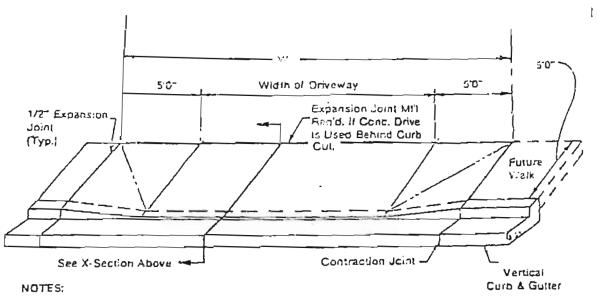

Arapahoe County Department of Development Services and Infrastructure Management ("DSIM") has established a policy for expenditure of County funds for installation of sidewalk chase sections placed within public right-of-way. Arapahoe County will only install chase sections through County-maintained curbs, gutters and sidewalks, if surface storm water runoff is being conveyed to the street from greater than 4 lots (as determined by Arapahoe County DSIM). Side yard swales between two homes are not considered to be multi-lot drainage facilities. Arapahoe County will not expend County funds to install chase sections for sump pump discharge, side yard swales, down spouts, landscaping under-drains, etc.

Arapahoe County shall main sidewalk chase sections that have been properly permitted and constructed in accordance with Arapahoe County Design and Construction Standards. The County will not maintain unauthorized, substandard sidewalk chase installations or concrete sections having discharge pipes placed through sidewalks. Damage to curb and sidewalks resulting from unauthorized drainage conveyance shall be the responsibility of the property owner, who shall be responsible for replacing or repairing the concrete sufficiently to bring the concrete structure up to an acceptable level of service.

County representatives have inspected the location identified below and have provided this notice and inspection report to the adjacent property owner(s). No action is required on your part if the pipe described below does not belong to, or effect your property. In this case, County representatives will be directed to terminate the pipe and replace the deteriorated concrete as described in Option 1 below. If the pipe is associated with your property, please choose either Option 1 or Option 2 listed below and respond to Arapahoe County DSIM within ten (10) days of the receipt of this letter. If you do not respond with ten (10) days, County representatives will be directed to terminate the pipe and replace the deteriorated concrete as described in Option 1 below.

#### OPTION 1: REMOVAL OF PIPE

The County will terminate the pipe, which is running from the above property through Arapahoe County's curb/gutter/sidewalk, and replace the deteriorated concrete. The resident will be responsible for the pipe to remain on private property and for disconnecting the pipe and re-routing its flow to another County approved discharge point on their property.

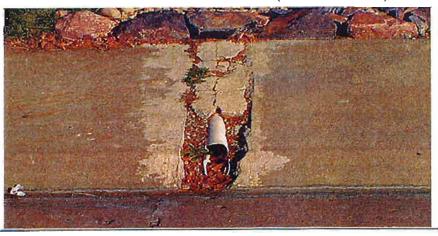

If the property owner desires they may elect to have a chase drain installed, at their expense, in the curb/gutter/sidewalk to replace the pipe that currently passes through it or discharges across it. Providing the chase section meets Arapahoe County's Construction Standards, the County will assume future maintenance of this structure. DSIM will assist property owners with chase installations by County contractors, if possible, however, individual property owners are

responsible for paying for the initial chase installation. As noted above, Arapahoe County will not pay for installation, unless the existing pipe is utilized for multi-lot (greater that 4 lots) surface storm water drainage, as determined by DSIM. Training will encompass the requirements of the settlement including:

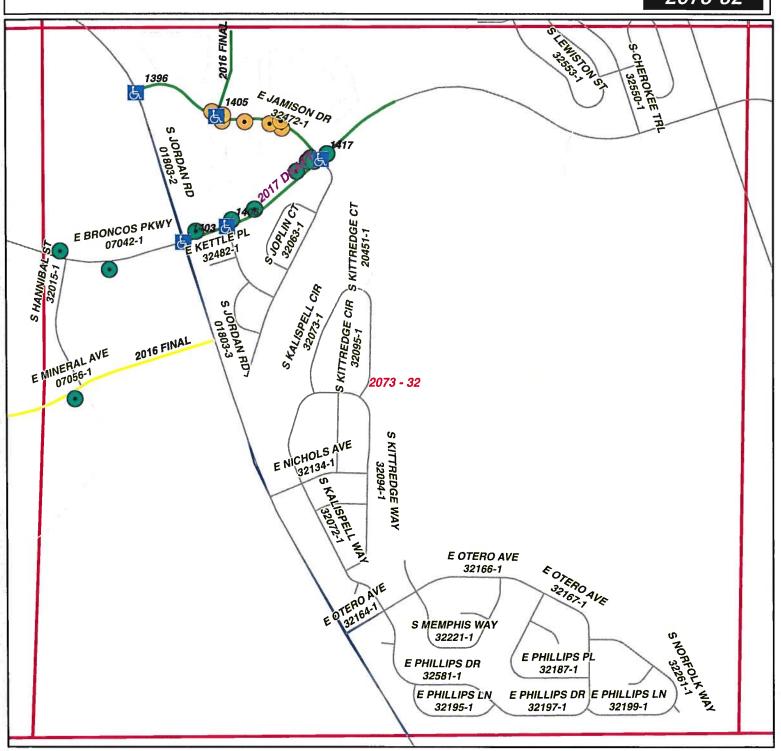

  - d. Companion rights to Effective Communication under the ADA
  - e. Defining "timely manner" when procuring effective communication for a person with a sensory disability
  - f. Common requests for auxiliary aids and services
  - g. Telephone equipment requirements and concerns
  - h. Common concerns when providing effective communications and best practices
- 3. Tips for interacting with persons with sensory disabilities including individuals that are deaf, hard of hearing, deaf and blind, blind or have low vision.
- 4. Information on cultural differences between Deaf and hearing communities

#### **APPENDIX I – Proposed ADA/Section 504 Complaint Procedure**

The Complaint Procedure is established to meet the requirements of the Americans with Disabilities Act of 1990. The procedures can be found in pamphlets available to the public and distributed in the Administration Building at 5334 S. Prince Street, Littleton, Colorado 80120 and the Human Services building at 14980 E. Alameda, Aurora, Colorado 80012. It is also available from any of the ADA Coordinators, from the Human Resources Department, and can be found online at the Arapahoe County website at <a href="http://www.arapahoegov.com">http://www.arapahoegov.com</a>.

This procedure may be used by any person who wishes to file a complaint alleging discrimination in the provision of services, activities, programs, or benefits by Arapahoe County. The County's Human Resources Guidelines govern employment-related complaints of disability discrimination.

#### **Informal Resolution of Complaints**

Any complaint may be informally resolved by the ADA Coordinator absent the submission of a formal written complaint. A written report of all informal resolutions, inclusive of the complainant's name and contact information, and the nature and dates of the complaint and resolution, if any, shall be prepared and maintained by the ADA Coordinator.

#### **Formal Complaints**

If a complaint cannot be resolved informally to the satisfaction of the complainant, it shall be formally submitted in writing on a Citizen Complaint Form which shall include the name, address, and telephone number of the complainant, a reasonable description of the matter complained of, the date of the complaint, and the accommodation, if any, the complainant believes is appropriate.

Written complaints shall be sent to the appropriate ADA Coordinator:

- Complaints involving the <u>Sheriff's Office</u> shall be sent to Arapahoe County Sheriff's Office ADA Coordinator, Human Resources Section, 13101 E. Broncos Parkway, Centennial, CO 80112;
- Complaints involving the <u>Department of Human Services</u> shall be sent to Arapahoe County Department of Human Services ADA Coordinator, 14980 E. Alameda Aurora, Colorado 80017;
- Complaints concerning <u>all other departments and offices</u> shall be sent to Arapahoe County ADA Coordinator, 5334 S. Prince Street, Littleton, Colorado 80120.

#### Time Limitations

All written complaints must be filed within thirty (30) days after the complainant becomes aware of, or should have been aware of, the condition and/or denial of the service or access complained of.

#### Review and Consideration of Complaints

Written complaints shall be promptly reviewed by the ADA Coordinator who may undertake such investigation and gather such information as deemed necessary to adequately address the matter. The ADA Coordinator may be assisted in an investigation by other Arapahoe County employees (including, but not limited to Sheriff's Office and/or Human Services employees, as appropriate) or, as appropriate, an outside entity. Investigation files associated with all formal complaints will be maintained in the ADA Coordinator's office.

A complainant may be required to submit or make available medical information from his or her healthcare provider, including a fully executed "Authorization to Disclose Medical Information," in order to confirm a qualifying disability and/or to fully and fairly evaluate the need for, nature, and scope of a proposed accommodation.

#### Notice of Determination

The ADA Coordinator, or authorized designee, shall issue a written notice of determination to the complainant within forty-five (45) days from the date the complaint was submitted. The notice shall inform the complainant of his or her right to appeal the determination, including the manner and time period for doing so, and the name, address, and contact information of the appropriate Appellate Authority.

#### Appeal of Determination

If a complainant is not satisfied with a determination by the ADA Coordinator, he or she may appeal the matter by submitting a written statement within ten (10) days from the date of the determination to the appropriate Appellate Authority (see below). Appeals will be forwarded by the ADA Coordinator to the appropriate Appellate Authority. The appeal shall contain a reasonable description of the grounds upon which the appeal is based, along with any requested relief.

#### Appellate Authority

- Appeals of decisions by the Sheriff's Office ADA Coordinator will be considered by the Undersheriff, or his or her designee.
- Appeals of decisions by the Human Services ADA Coordinator will be considered by <u>[undetermined]</u>, or his or her designee.
- Appeals of all decisions by the Arapahoe County ADA Coordinator will be considered by <u>[undetermined]</u>, or his or her designee

The Appellate Authority, or his or her designee, shall review the matter and issue an opinion within thirty (30) days. The decision of the Appellate Authority or designee shall be final.
