Andrew Shearer, president of the District, reviewed the history of the area and why the land was not conveyed to the District.

Mr. Mielke further explained that there is existing bond financing; this could be an issue in the future.

Commissioner Sharpe asked if there is a way for the developer to fix this issue at no cost.

Mr. Mielke said there was nothing done illegally, but it is not practical for the District to maintain a property that the HOA owns, and going back to the developer is not an option.

Commissioner Sharpe proposed charging only the planning review fee, which is \$1,500.00.

The motion was made by Commissioner Sharpe and duly seconded by Commissioner Doty in the case of WVR16-021, Arapahoe Lakes Parks District - Request for Waiver of Fees associated with a Subdivision Exemption, that the Board has read the Board Summary Report and received testimony at the regularly scheduled public meeting of the Board on October 18, 2016. The Board approves a partial fee waiver of \$2,000.00, with a total fee of \$1,500.00. Commissioner Jackson explained why she does not support the motion to approve the approve the fee waiver.

Approval of a resolution authorizing legal representation and indemnification in pending litigation filed against Sheriff David Walcher and the Arapahoe County Sheriff's Office.

### Purpose

A civil lawsuit for monetary damages was recently commenced in the Arapahoe County District Court, *Michael Cummings v. Arapahoe County Sheriff Office, et al.*, Civ. No. 16-cv-32444, seeking money damages against the County and the Sheriff, individually, for wrongful discharge in violation of public policy and breach of contract. This memo and the accompanying resolution seek the Board's formal authorization to provide legal defense services and indemnification coverage for the individual current and former employees who have been named as co-defendants along with the County.

### Background

The subject litigation arises from the discharge of former ACSO sergeant Michael Cummings for untruthfulness during an Internal Affairs investigation and hearing concerning his conduct as an instructor for certain training classes at the Sheriff's Office. Mr. Cummings began the 2015 calendar year with a written corrective action memorandum from his lieutenant to address certain performance deficiencies. In late April 2015, Mr. Cummings incurred a work-related injury and notified the SO the next day. In early May, Mr. Cummings' lieutenant placed him on a performance improvement plan because his performance deficiencies noted earlier in the year had not substantially improved. In mid-May 2015, Mr. Cummings was placed on restricted duty by his physician and reassigned to a non-physical job.

Despite his restricted duty, Mr. Cummings was set to instruct a defensive tactics driving course at the ACSO drive track in late June 2015. He approached his lieutenant in early June to request that he be allowed to teach the course. His lieutenant informed Mr. Cummings that he could continue to instruct the course, so long as he did not perform any duties inconsistent with his restricted duty, meaning no driving and no shooting. Despite these instructions, Mr. Cummings engaged in driving during the course instruction.

During the course, Mr. Cummings and his co-instructor, a deputy from Jefferson County, drove Mr. Cummings' car onto the drive track and placed it on the course with the hood up. Mr. Cummings' co-instructor then stood beside the car, using it as cover, while firing "Less Lethal" ammunition rounds (blanks) at student drivers during an exercise. The ACSO maintains a policy prohibiting students, instructors, and others from driving their personally owned vehicles onto the ACSO drive track. As a result of this conduct and several other irregularities during the class, the ACSO training supervisor, Shannon Lofland, filed an Internal Affairs complaint against Mr. Cummings. The complaint was investigated by Internal Affairs and the evidence presented to Lieutenant Stephanie Spain-Madrigal for initial recommendation. Lt. Spain-Madrigal found that Mr. Cummings had violated several ACSO policies and recommended that he be demoted to Deputy. Mr. Cummings appealed the decision and presented his case before a disciplinary panel under established ACSO procedures. The panel heard testimony from Mr. Cummings and several other witnesses. It then sought out additional information after the close of the hearing. Some of that evidence was unfavorable to Mr. Cummings, who had not been permitted to address it during the actual hearing. Upon recommendation from the County Attorney's Office, the Sheriff's Office re-convened the disciplinary panel to permit Mr. Cummings to address the newly-acquired evidence. Subsequently, the panel determined that Mr. Cummings had given inexplicably conflicting statements to the IA investigator, Lt. Spain-Madrigal, and the panel itself. The panel then declined to accept Lt. Spain-Madrigal's recommendation and instead recommended that Mr. Cummings be discharged for untruthfulness. Per ACSO policy, Sheriff Walcher met with Mr. Cummings and his attorney several weeks later to hear any additional information Mr. Cummings wished to provide. After that meeting, the Sheriff accepted the disciplinary panel's recommendation and discharged Mr. Cummings.

Mr. Cummings filed the instant lawsuit on Monday, October 10, 2016, alleging that the "untruthfulness" reason was a pretext and that he was really discharged because he had filed a worker's compensation claim. He also alleges that his discharge violated numerous ACSO policies, which he believes constituted a contract of employment. Therefore, he alleges that his discharge in violation of those policies is a breach of that employment contract. The suit seeks compensatory and exemplary money damages against both the Sheriff's Office and the Sheriff, individually.

## Discussion

Under the provisions of the Colorado Peace Officers Act and the Governmental Immunity Act, a county is obligated to bear the costs of providing a legal defense for its law enforcement officers when they are sued for acts or omissions allegedly committed by them during the performance of their jobs. The same holds true with respect to non-law enforcement personnel under the terms of the Governmental Immunity Act. Additionally, a county is obligated to indemnify its officers and civilian employees for judgments or settlements that may enter against them in those suits, excluding punitive/exemplary damages (unless otherwise authorized). These obligations are generally subject to the following conditions. First, that the conduct of an employee giving rise to the lawsuit occurred within the scope and performance of his or her job and, second, that the conduct of the employee was not wanton or willful, i.e., maliciously motivated or executed or taken in bad faith.

After reviewing the facts and information currently available, the County Attorney's Office has determined that the conduct of the Sheriff and the ACSO employees involved in the recommendation and decision to discharge Mr. Cummings was not undertaken willfully or wantonly, or with any intent to injure Mr. Cummings or to violate his rights. It is also apparent that the conduct taken by the ACSO and its employees, including the Sheriff's decision to discharge Mr. Cummings, was taken within the scope of their job duties.

## Recommendation

The County Attorney's Office recommends that the Board adopt the proposed resolution accompanying this memo and authorize a legal defense and indemnification protection (inclusive of potential punitive/exemplary damages) as provided under the Colorado Peace Officers Act and the Governmental Immunity Act in the above-noted litigation for the Sheriff. The defense will be conducted by the County Attorney's Office.

WHEREAS, it is common for plaintiffs, without a factual basis to do so, to allege that government officials and employees acted outside the scope and course of their employment, or acted willfully and wantonly; and

WHEREAS, a lawsuit titled *Michael Cummings v. Arapahoe County Sheriff Office, et al*, was recently commenced in the Arapahoe County District Court against the Arapahoe County Sheriff's Office and Sheriff David Walcher for acts and omissions allegedly undertaken by them during the course and scope of their official duties and employment; and

WHEREAS, it appearing from the information presently available that the claims asserted against them did not arise from wanton or willful conduct, and that there exist no disqualifying conflicts of interests between the several named defendants and the County; and

WHEREAS, the Board hereby determines that it is in the public interest for Arapahoe County to bear the cost of defending the current and former employees against the claims for personal liability and damages asserted in the suit against them, and to defend against and/or pay or settle such claims on their behalf subject to the terms and conditions contained in the Colorado Peace Officer Act and Colorado Governmental Immunity Act.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners for the County of Arapahoe, State of Colorado, that the cost of providing a legal defense for Sheriff David Walcher and the Arapahoe County Sheriff's Office in the matter of *Michael Cummings v*. *Arapahoe County Sheriff Office, et al.*, Case No. 2016-cv-32444, pending in the Arapahoe County District Court, shall be borne by Arapahoe County and that such representation shall be provided by the Arapahoe County Attorney's Office, except as may otherwise be determined by the County Attorney, in which case the County Attorney may retain outside legal counsel as may be deemed necessary; and

BE IT FURTHER RESOLVED that Arapahoe County shall, consistent with the terms contained in the Colorado Peace Officers Act and Colorado Governmental Immunity Act, indemnify each of the current and former employees named as defendants in the suit from any and all judgments or settlements that may enter against them in the above-noted litigation, and

that the claims asserted against them may be compromised, settled, and resolved by Arapahoe County as it may deem appropriate, necessary, or convenient.

### **Request and Recommendation**

The Public Works and Development (PWD) staff request approval from the Board of County Commissioners (BOCC) on an easement for Right of Way for a stilling basin/flow diffuser located on Cherry Creek Lake project with the U.S. Army Corps of Engineers (USACE). Staff also request authorization for the Chair to sign easement and authorization for the Clerk to the Board to sign the Certificate of Authority document. PWD recommends that the BoCC excute this easement extension agreement.

### Background

Easement No. DACW45-2-88-6123 was acquired from the USACE in the late 1980's concurrent with development of The Hills at Cherry Creek East Subdivision. The easement expired on July 24, 2014 and requires an extension. The storm sewer from the Cherry Creek East Subdivion storm sewer outfalls onto the USACE property.

### Links to Align Arapahoe

Increasing community and regional partnerships and intergovernmental cooperation

### Discussion

The PWD staff has determined that the easement is still necessary for the functioning of the subdivision drainage system and hence the easement will require an extension. The USACE supports that the improvement remain in place and have prepared the new easement agreement (attached).

### Alternatives

PWD staff sees no viable option to extending this easement with the USACE.

### **Fiscal Impact**

The USACE has determined that the fair market value for the easement area to by \$6,275.00 and are assessing an additional \$1,750.00 for the Government's administrative costs. The Southeast Metro Stormwater Authority (SEMSWA) has agreed to fund the \$8,025.00 fee for processing this easement. Therefore, there is no fiscal impact to the County.

THE SECRETARY OF THE ARMY under and by virtue of the authority vested in the Secretary by Title 10 United States Code, Section 2668, having found that the granting of this easement will be in the public interest, hereby grants to, ARAPAHOE COUNTY, a political subdivision, under and by virtue of the laws of the State of Colorado, with its principal office at 5334 South Prince Street, Littleton, Colorado 80120 hereinafter referred to as the grantee, an easement for the operation, and maintenance of a stilling basin / flow diffuser, and access hereinafter referred to as the facilities, over, across, in and upon lands of the United States consisting of approximately 3.64 acres, hereinafter referred to as the premises, as identified in Exhibits "A", "B", all being attached hereto and made a part hereof.

**THIS EASEMENT** is granted subject to the following conditions.

### 3. NOTICES

All correspondence and notices to be given pursuant to this easement shall be addressed, if to the grantee, **Arapahoe County, ATTN: Public Works and Development Director, 5334 South Prince Street, Littleton, Colorado 80120** and, if to the United States, to the District Engineer, Attention: Chief, Real Estate Division, 1616 Capitol Avenue, Omaha, Nebraska 68102-1618, or as may from time to time otherwise be directed by the parties. Notice shall be deemed to have been duly given if and when enclosed in a properly sealed envelope or wrapper addressed as

### 4. AUTHORIZED REPRESENTATIVES

Except as otherwise specifically provided, any reference herein to "Secretary", "District Engineer", "Installation Commander", or "said officer" shall include their duly authorized representatives. Any reference to "grantee" shall include assignees, transferees and their duly authorized representatives.

### 5. SUPERVISION BY THE DISTRICT ENGINEER

The construction, operation, maintenance, repair or replacement of said facilities, including culverts and other drainage facilities, shall be performed at no cost or expense to the United States and subject to the approval of the **District Engineer of the Omaha District**, hereinafter referred to as said officer. Upon the completion of any of the above activities, the Grantee shall immediately restore the premises to the satisfaction of said officer. The use and occupation of the premises for the purposes herein granted shall be subject to such rules and regulations as said officer prescribes in writing from time to time.

### 6. APPLICABLE LAWS AND REGULATIONS

The grantee shall comply with all applicable Federal, state, county and municipal laws, ordinances and regulations wherein the premises are located.

### 7. CONDITION OF PREMISES

The grantee acknowledges that it has inspected the premises, knows the condition, and understands that the same is granted without any representation or warranties whatsoever and without any obligation on the part of the United States.

### 8. INSPECTION AND REPAIRS

The grantee shall inspect the facilities at reasonable intervals and immediately repair any defects found by such inspection or when required by said officer to repair any such defects.

### 9. PROTECTION OF GOVERNMENT PROPERTY

The grantee shall be responsible for any damage that may be caused to the property of the United States by the activities of the grantee under this easement and shall exercise due diligence in the protection of all property located on the premises against fire or damage from any and all other causes. Any property of the United States damaged or destroyed by the grantee incident to the exercise of the privileges herein granted shall be promptly repaired or replaced by the grantee to a condition satisfactory to said officer, or at the election of said officer, reimbursement made therefor by the grantee in an amount necessary to restore or replace the property to a condition satisfactory to said officer.

### **10. RIGHT TO ENTER**

The right is reserved to the United States, its officers, agents, and employees to enter upon the premises at any time and for any purpose necessary or convenient in connection with government purposes; to make inspections; to remove timber or other material, except property of the grantee; to flood the premises; to manipulate the level of the lake or pool in any manner whatsoever; and/or to make any other use of the lands as may be necessary in connection with government purposes, and the grantee shall have no claim for damages on account thereof against the United States or any officer, agent, or employee thereof.

### 11. TRANSFERS AND ASSIGNMENTS

Without prior written approval by said District Engineer, the grantee shall neither transfer nor assign this easement or any part thereof nor grant any interest, privilege or license whatsoever in connection with this easement. The provisions and conditions of this easement shall extend to and be binding upon and shall inure to the benefit of the representatives, successors and assigns of the grantee.

### **12. INDEMNITY**

The United States shall not be responsible for damages to property or injuries to persons which may arise from or be incident to the exercise of the privileges herein granted, or for damages to the property or injuries to the person of the grantee's officers, agents, or employees or others who may be on the premises at their invitation or the invitation of any one of them, and the grantee shall hold the United States harmless from any and all such claims not including damages due to the fault or negligence of the United States or its contractors.

### **13. SUBJECT TO EASEMENTS**

This easement is subject to all other existing easements, or those subsequently granted as well as established access routes for roadways and utilities located, or to be located, on the premises, provided that the proposed grant of any new easement or route will be coordinated with the grantee, and easements will not be granted which will, in the opinion of said officer, interfere with the use of the premises by the grantee.

### **14. REQUIRED SERVICES**

The grantee shall furnish through said facilities such services as may be required from time to time for governmental purposes, provided that payment for such service will be made by the United States at rates which shall be mutually agreeable but which shall never exceed the most favorable rates granted by the grantee for similar service.

### **15. RELOCATION OF FACILITIES**

In the event all or any portion of the premises occupied by the said facilities shall be needed by the United States, or in the event the existence of said facilities is determined to be detrimental to governmental activities, the grantee shall from time to time, upon notice to do so, and as often as so notified, remove said facilities to such other location on the premises as may be designated by said officer. In the event said facilities shall not be removed or relocated within ninety (90) days after such notice, the United States may cause such relocation at the sole expense of the grantee.

### **16. TERMINATION**

This easement may be terminated by the Secretary upon 30 days written notice to the grantee if the Secretary shall determine that the right-of-way hereby granted interferes with the use or disposal of said land by the United States, or it may be revoked by the Secretary for failure of the grantee to comply with any or all of the conditions of this easement, or for non-use for a period of two (2) years, or for abandonment.

### 17. SOIL AND WATER CONSERVATION

The grantee shall maintain, in a manner satisfactory to said officer, all soil and water conservation structures that may be in existence upon said premises at the beginning of or that may be constructed by the grantee during the term of this easement, and the grantee shall take appropriate measures to prevent or control soil erosion within the right-of-way herein granted. Any soil erosion occurring outside the premises resulting from the activities of the grantee shall be corrected by the grantee as directed by said officer.

### **18. ENVIRONMENTAL PROTECTION**

**a**. Within the limits of their respective legal powers, the parties hereto shall protect the premises against pollution of its air, ground, and water. The grantee shall promptly comply with any laws, regulations, conditions or instructions affecting the activity hereby authorized if and when issued by the Environmental Protection Agency, or any Federal, state, interstate or local governmental agency having jurisdiction to abate or prevent pollution. The disposal of any toxic or hazardous materials within the premises is strictly prohibited. Such regulations, conditions, or instructions in effect or prescribed by the said Environmental Protection Agency or any Federal, state, interstate or local governmental agency are hereby made a condition of this easement. The grantee shall not discharge waste or effluent from the premises in such a manner that the discharge will contaminate streams or other bodies of water or otherwise become a public nuisance.

The grantee shall not remove or disturb, or cause or permit to be removed or disturbed, any historical, archeological, architectural or other cultural artifacts, relics, remains or objects of antiquity. In the event such items are discovered on the premises, the grantee shall immediately notify said officer and protect the site and material from further disturbance until said officer gives clearance to proceed.

### **20. NON-DISCRIMINATION**

The grantee shall not discriminate against any person or persons because of race, color, age, sex, handicap, national origin, or religion in the conduct of operations on the premises.

### 21. **RESTORATION**

On or before the expiration or termination of this easement, the grantee shall, without expense to the United States, and within such time as said officer may indicate, remove said facilities and restore the premises to the satisfaction of said officer. In the event the grantee shall fail to remove said facilities and restore the premises, the United States shall have the option to take over said facilities without compensation, or to remove said facilities and perform the restoration at the expense of the grantee, and the grantee shall have no claim for damages against the United States or its officers or agents for such action.

### 22. DISCLAIMER

This instrument is effective only insofar as the rights of the United States in the property are concerned, and the grantee shall obtain such permission as may be required on account of any other existing rights. It is understood that the granting of this easement does not eliminate the necessity of obtaining any Department of the Army permit which may be required pursuant to the provisions of Section 10 of the Rivers and Harbors Act of 3 March 1899 (30 Stat. 1151; 33 U.S.C. §403), Section 404 of the Clean Water Act (33 U.S.C. §1344) or any other permit or license which may be required by Federal, state or local statute in connection with use of the premises.

Prior to the execution of this easement the following site specific Condition No. 23 was added hereto and made a part hereof:

23. REPLACEMENT EASEMENT

This easement supersedes and replaces Department of the Army Easement No. DACW45-2-88-6123, between the Arapahoe County, Colorado and the Department of the Army for the construction, operation, and maintenance of a stilling basin / flow diffuser, which expired on July 24, 2014. The grantee hereby acknowledges that it has been in continuous possession of said facilities since the expiration of said easement.







### **Request and Recommendation**

We are requesting approval of the Community Services Block Grant 2017 budget. At a study session on November 1, 2016 the Board of County Commissioners expressed support for the recommendation and directed staff to set the 2017 Community Services Block Grant Plan on the Consent Agenda for approval.

### Background

Arapahoe County receives CSBG funds annually through the Department of Local Affairs. These funds have traditionally been utilized to support the Homemaker Program operated through the Senior Resources Division. Recent statewide funding formula changes have resulted in increased funding to Arapahoe County providing us with the opportunity to offer additional assistance to low income individuals and families.

### Links to Align Arapahoe

Utilizing CSBG funds to improve the living situations of low income individuals and families links to Quality of Life.

### Discussion

Arapahoe County will be receiving \$487,824 in CSBG funds for 2017 representing an increase of \$52,461 from our 2016 allocation. We propose to utilize the CSBG funds as follows.

\$383,147 will be utilized to support the Homemaker Program including staff salaries and fringe benefits, program supervision, program management, administrative and payroll support, central services and IT, mileage, training, and supplies and equipment.

\$77,177 will be utilized for emergency services including \$25,772 for Integrated Family and Community Services to continue providing emergency rent, mortgage, utilities, and propane to low income individuals and families living in the Eastern Plains area of Arapahoe County; \$46,391 to be utilized by our Housing Specialist to assist with security deposits, rent, or utilities payments to assist in preventing loss of housing or securing new housing for individuals and families who are impacted by the housing crisis; and \$5,006 covering 10% of the cost allocated salary and fringe benefits of the Housing Specialist while working on this project.

Additionally, we are targeting \$27,500 to meet the new CSBG Organizational Standards which include the requirement of a three year Community Assessment and Needs Plan which will require extensive focus groups throughout Arapahoe County and documentation of communication with schools, faith based organizations, non-profits, housing authorities, etc. to determine the needs in the community. We propose to hire a consultant for this process as we do not have sufficient staff time available to meet this additional requirement. Another added requirement for submission of our 2018 plan is that our plan be reviewed by a certified Results Oriented Management and Accountability (ROMA) trainer. Arapahoe County does not have a Certified ROMA trainer on staff which will require hiring someone to complete this CSBG requirement.

### Alternatives

The alternative would be to not utilize the funds as outlined above and to recommend alternative ways to use these funds.

### **Fiscal Impact**

CSBG funds are allocated to Arapahoe County based on a formula. There is no match required so there is no fiscal impact to Arapahoe County.

### Concurrence

The CSBG Advisory Board has approved the use of these funds as outline. The BOCC reviewed the budget at a Study Session on 11/1/16 and recommended moving on to the Consent Agenda.

### Direction/Information:

On November 1, 2016, Housing and Community Development Services (HCDS) staff requested to increase the Family Promise Tenant Based Rental Assistance (TBRA) program by \$47,970, to continue operating their TBRA program. At the study session on November 1, 2016 the BoCC expressed support for this project and directed staff to set the matter for an upcoming consent agenda.

### Family Promise of Greater Denver TBRA Funding Increase Request

In 2015 Family Promise was awarded \$65,280 in HOME funds to operate a TBRA program. They have housed 5 families to date. They are requesting an additional \$47,970 in HOME funds to continue to support the 5 existing families and to add two new families into the program. At a Study Session, held on November 1, 2016, the BoCC unanimously approved the full funding increase (\$47,970) for Family Promises TBRA Program, they directed the item to be set for Consent Agenda.

### Links to Align Arapahoe

- 1. Enhance Quality of Life. Citizens' lives may be enhanced by utilizing federal HOME funds for housing activities that will benefit lower-income families.
- 2. Service First. Using HOME funds to help residents of Arapahoe County obtain stable housing will reduce the number of homeless persons and persons with inadequate housing.

### Discussion

The current rental market in Arapahoe County is very tight. The vacancy rates are very low (average of 4%) which is driving rental prices up significantly. It is estimated that renters need to make \$35 an hour in order to afford housing in the Denver Metro area. With the low vacancy rates and high rents, it is difficult for families to find, and maintain, decent, safe, and affordable housing. This TBRA program is a useful tool to get families housed, making life more stable for the families. **Alternatives** 

The BOCC may choose to not to increase the funding, or to increase it at a lower amount.

### **Fiscal Impact**

HOME funds are allocated by the U.S. Department of Housing and Urban Development. No County funds are affected.

Subject:	Incentive Payment Agreement – Charter Communications Holding Company LLC

### Purpose and Recommendation

Charter Communications Holding Company LLC is requesting the Board to authorize the Chair to sign an Incentive Payment Agreement for refunds of 100% of the personal property taxes associated with the new business facilities and the expanded business facilities located at the 6360 South Fiddler's Green Circle, Greenwood Village, Colorado 80111. This Agreement is for 5 years and involves tax years 2017 – 2021, with an option to extend the Agreement for one additional 5 year term involving the tax years 2022- 2026.

### **Background and Discussion**

Pursuant to Section 30-11-123, CRS, the Board of County Commissioners has the authority to enter into agreements for refunds of personal property taxes levied for County purposes associated with new business facilities in the County or associated with existing business facilities that expand such that they qualify as "new" business facilities. The Board met with representatives of the Aurora Economic Development Council and Charter Communications Holding Company LLC at a study session on July 19, 2016, and generally agreed to the concept of an incentive payment agreement, subject to negotiating an acceptable contract. This agreement is a "standard" incentive payment agreement relating to new business facilities and expanded business facilities, is for a term of five (5) years, with an option to extend the Agreement for one additional 5 year term, and involves a refund of 100% of the personal property taxes levied by the County.

### Alternatives

This is one of the few economic "incentives" available to a County.

### **Fiscal Impact**

Obviously, this is a refund of taxes received by the County and it reduces the funds available for other County expenditures. The statute allows for the County to adjust its tax levy to recoup the total of all incentive payments; however, the Board has not made such an adjustment in previous years.

### **INCENTIVE PAYMENT AGREEMENT**

This Incentive Payment Agreement ("Agreement") is entered into as of \_\_\_\_\_\_, 2016, by and between the Board of County Commissioners of the County of Arapahoe, State of Colorado (the "County") and Charter Communications Holding Company, LLC (the "Taxpayer").

WHEREAS, pursuant to the provisions of Sec. 30-11-123, C.R.S., the County has the authority to negotiate for incentive payments or credits with taxpayers who establish new business facilities or who expand existing business facilities; and

WHEREAS, pursuant to this legislation, a county and a taxpayer may negotiate a contract for an incentive payment or a credit from a county to a taxpayer relating to the new or expanded business facilities; and

WHEREAS, the County and the Taxpayer desire to negotiate a contract regarding a new business facility as well as an expanded business facility.

NOW, THEREFORE, IT IS AGREED by the County and the Taxpayer as follows:

1. The Taxpayer will establish new business facilities as defined in Section 39-30-105(7)(e), C.R.S. in the City of Greenwood Village, a municipality in Arapahoe County, Colorado. This new business facility is/will be located at 6360 S Fiddler's Green Circle, Greenwood Village, Colorado 80111. The purposes and functions of this new business facility include Charter's regional offices and functions such as product design, portfolio planning and other backoffice functions to help facilitate the regional office, and as further described in Exhibit A.

The Taxpayer will expand its business facilities as defined in Section 39-30-105(7)(c), C.R.S. in the City of Greenwood Village, a municipality in Arapahoe County, Colorado. This expanded business facility is/will be located at 6363 S Fiddler's Green Circle, Greenwood Village, Colorado 80111. The purposes and functions of this expanded business facility include network operations, information technology professionals, network engineers, and other backoffice functions, and as further described in Exhibit A.

2. The Taxpayer shall comply with all of the provisions of Sections 39-5-107 and 39-5-108, C.R.S., concerning the filing of personal property schedules associated with the taxable personal property located at or within such new business facility and used in connection with the operation of such new business facility and associated with the taxable personal property located at or within such expanded business facility and used in connection with the operation of such expanded business facility and used in connection with the operation of such expanded business facility.

3. Prior to any payment from the County, the Taxpayer shall invoice the County by June 15<sup>th</sup>, beginning in the year 2018, for the incentive payment and provide the County with the Taxpayer's tax statement, appropriate documentation of proof of payment of the County business

personal property tax and a description of the Taxpayer's progress towards fulfillment of the expectations represented by the Taxpayer in Exhibit A.

4. Upon completion of Paragraph 3 above, the County shall make an annual incentive payment, to the Taxpayer, which payment shall equal one-hundred percent (100%) of the amount of taxes levied by the County for the County mill levy upon the <u>taxable personal property</u> directly attributable to such new business located at or within such new business facility and used in connection with the operation of such new business facility and directly attributable to such expanded business located at or within such expanded business facility and used in connection with the operation of such expanded business facility. This incentive payment relates to the tax levied only by the Board of County Commissioners of Arapahoe County for county government and not to any other tax levied by another taxing entity.

5. These incentive payments to the Taxpayer shall be made by the County on or about September 1 of each year for five (5) years, beginning in September, 2018, as set forth in Exhibit B, , provided the Taxpayer has paid, and is therefore not delinquent in the payment of, its property taxes, and the Taxpayer has complied with the provisions of this Agreement.

6. The County shall inform the school district and the municipality, in which the Taxpayer's new business facility and the expanded business facility are located, of this Agreement. The Taxpayer shall be responsible for negotiating separate incentive payment agreements with the affected school district and the affected municipality (if any).

7. The term of this Agreement shall commence as of the date written above for tax year 2017 collected in 2018, and shall expire five (5) years later, after the 2021 tax year with taxes collected in 2022. After written request from the Taxpayer, this Agreement may be extended for additional five (5) year increments, not to exceed a total term of ten (10) years, at the County's sole discretion.

8. Pursuant to Section 29-1-110, C.R.S., financial obligations of the County payable as set forth herein after the current fiscal year are contingent upon funds for that purpose being appropriated, budgeted and otherwise made available. This Agreement may be terminated on January 1 as to any fiscal year for which funds are not appropriated. The County shall give the Taxpayer written notice of such nonappropriation.

9. The Taxpayer shall not assign or transfer its interest in this Agreement without the written consent of the County, which consent shall not be unreasonably withheld. Any unauthorized assignment or transfer shall render this Agreement null, void and of no effect as to the County.

10. This Agreement may not be modified, amended or otherwise altered unless mutually agreed upon in writing by the parties hereto.

11. In the event of default of any provision of this Agreement by the Taxpayer, the County will provide 30 days written notice to the Taxpayer to cure said default. If said default is not so cured within the 30-day period, this Agreement may be terminated by the County without

further notice. In the event of termination by the County, no damages, liquidated or otherwise, shall inure to the benefit of the Taxpayer.

12. Unless otherwise agreed in writing, this Agreement and the interpretation thereof shall be governed by the laws of the State of Colorado.

13. Should any provision of this Agreement be determined by a court of competent jurisdiction to be unconstitutional or otherwise null and void, it is the intent of the parties hereto that the remaining provisions of this Agreement shall be of full force and effect.

14. Notices to be provided under this Agreement shall be given in writing either by hand delivery, or deposited in the United States mail, certified mail, return receipt requested, with sufficient postage, to the following persons:

15. This Agreement represents the entire and integrated agreement between the parties and supersedes all prior negotiations and representations whether written or oral. Nothing herein shall be deemed to create any contractual relationship, either express or implied, between the Taxpayer and any other consultant or contractor or material supplier to Arapahoe County. Nothing herein shall be deemed to give anyone not a party to this Agreement any right of action against a party which does not otherwise exist without regard to this Agreement.

### INCENTIVE PAYMENT AGREEMENT PROJECT DESCRIPTION AND REPRESENTATIONS

In an effort to further advance the Company's telecommunication operations (i.e., telephone, wireless, optical, and media), Charter is considering the renovation of the Fiddler's Green complex's 179,500 square feet as well as constructing a new 306,500 square foot facility on the premises of Fiddler's Green. The existing Fiddler's Green complex houses network operations professionals, IT professionals, network engineers, and other Charter back office functions while the new Fiddler's Green facility will largely be a new regional headquarter space for Charter.

The project is expected to create up to 797 new jobs at Fiddler's Green over the first four years of operations with an average wage of \$93,374. New jobs would be comprised largely of professionals working within the information technology, network operations and software engineering sectors.

The total capital investment for the Fiddler's Green expansion and new construction is projected to be approximately \$61,850,000. Construction at Fiddler's Green is expected to begin in the third quarter of 2016, and the newly constructed facility is scheduled to be operational in 2018.

### **Request and Recommendation**

We are seeking direction from the Board of County Commissioners (BOCC) regarding our continued management of the Senior Transportation Program funded through Older American's Act and/or State Funding for Seniors funds.

Senior Resources staff recommend continued involvement with the Senior Transportation Program to ensure that Arapahoe County seniors have a voice and an advocate.

At a study session on November 1, 2016 the BOCC expressed support for our involvement with the Older American's Act/State funding for Seniors Transportation Program and directed staff to set the matter on an upcoming consent agenda.

### Background

The Senior Resources Division has managed the Senior Transportation Program in Arapahoe County since 2006. The funding for this program comes through the Denver Regional Council of Governments (DRCOG) and utilizes Older American's Act and/or State Funding for Seniors in any given year. Additionally, Arapahoe County is required to contribute 10% in matching funds which in 2016 is \$41,363. With that match we are able to leverage an additional \$372,000 in Funds from DRCOG.

From 2007 through 2014 we utilized First Transit as our subcontractor to deliver transportation services. This program was developed in conjunction with the City and County of Denver and served both Denver and Arapahoe Counties and had a client satisfaction rating of 96% or higher each year.

In 2015 DRCOG awarded the Denver contract to Seniors' Resource Center (SRC) which left First Transit unable to serve Arapahoe County as our funding is not sufficient for a stand-alone operation. Arapahoe County was left in the position of contracting with SRC as DRCOG's decision was made five weeks before the end of the 2014/15 contract and it was the only option for maintaining uninterrupted transportation services to vulnerable seniors in Arapahoe County.

During transition discussions with DRCOG in June 2015 it was suggested by DRCOG that perhaps Arapahoe County should no longer manage the transportation funds. At that time, with direction from the Board of County Commissioners, we elected to stay involved and manage the grant funds for the current two year cycle because we had concerns about SRC's capacity to deliver services in Arapahoe County, and we felt that it would be the best way to ensure seniors had a voice during the transition. DRCOG agreed with this decision and we agreed with DRCOG that we would revisit the topic before the next round of proposals.

### Links to Align Arapahoe

Continuing to be involved with senior transportation meets the Quality of Life initiative under Align Arapahoe as seniors are given the opportunity to maintain their independence while utilizing transportation to attend medical appointments, dialysis, grocery shopping, food banks, and meals programs.

### Discussion

The next two year request for proposals will be released by DRCOG in the next 2 months. On September 30, 2016 in a meeting with DRCOG, Jayla Sanchez-Warren, Director of the Area Agency on Aging said that she was willing for Arapahoe County to stay involved in managing the transportation funds for Arapahoe County.

Community Resources staff feel that it would be in the best interests of Arapahoe County seniors for us to stay involved with managing the funds. The transition to SRC as a provider has not been a smooth one, although services are improving, and the number of trips being delivered is slowly increasing. If we are not involved in the process, seniors in Arapahoe County will not have a voice to advocate for them as we will lose our leverage. We have also initiated regular transportation meetings involving Arapahoe County, Adams County, SRC, and DRCOG to discuss issues and develop solutions. Senior Resources staff believes this work group can provide better solutions with everyone being involved.

### Alternatives

The alternative would be for Arapahoe County to choose not to manage the transportation program funded through DRCOG. Should this option be chosen, it would be staff's recommendation that we also not provide the \$41,363 in required match for the program.

### **Fiscal Impact**

Arapahoe Count is required to provide a 10% match which in 2016 is \$41,363 to leverage the \$372,000 in transportation funds. The match utilized is part of the Senior Resources General Fund budget. Staff time used to manage the program is charged to this match.

### **Request and Recommendation:**

The recommendation from Open Spaces staff to the Board of County Commissioners is to approve the transfer of the West Bijou Property. This topic was heard and approved by the Board of County Commissioners at a study session on October 31, 2016.

### **Background:**

In 2012, Arapahoe County awarded \$95,000 of "joint project funding" from the Open Space Acquisition and Development Fund to the Plains Conservation Center, a Colorado non-profit, to help support its acquisition of property in the eastern part of Arapahoe County. Arapahoe County only contributed funds towards 128 acres, but the overall project was 1,083 acres (with 955 acres being in Elbert County). The PCC already owned 7,000 acres at the time, so the acquisition brought the total acreage of the ranch up to approximately 8,000 acres.

As a condition of using Open Space funds, Arapahoe County and Great Outdoors Colorado, the other principal funder, required that the property be placed under conservation easement. The conservation easement is held by Colorado Open Lands, but Arapahoe County maintained certain rights in the easement. One of those rights is that Arapahoe County must approve any property transfer. The PCC would like to transfer the property to the Savory Institute, another Colorado nonprofit, and now seeks Arapahoe County's permission.

### Discussion:

The PCC and Savory Institute, two Colorado based nonprofits focused on grasslands conservation, wish to combine their assets and expertise to accelerate the restoration of grasslands worldwide. The PCC's history in soil conservation and advancing regenerative agriculture dates back to its beginnings with the West Arapahoe Conservation District established in 1949 to help prevent the disasters of the Dust Bowl from happening again. Since the late 1960's, the Savory Institute has been developing and implementing

Holistic Management ("HM") with pastoralists and ranchers worldwide to achieve positive financial outcomes and reverse the effects of desertification.

The Savory Institute and PCC recognize an aligned mission to promote large-scale restoration of the world's grasslands through HM. In the emerging spirit of these cooperative missions, and in the interest of practicing economies of scale by efficient utilization of scarce resources, both parties aim to leverage their respective assets of expertise, networks, legacy, real estate and equipment to enhance their shared visibility, growth and impact.

Specifically, the Savory Institute and PCC wish to utilize the West Bijou Property as a world center of excellence, showcasing HM and serving as a central demonstration of the Savory Network's mission to restore 1/5 of the world's grasslands by 2025. Furthermore, PCC's cash and investment assets (value of approximately \$2M) will be used to launch the effort that will leverage West Bijou's ecological, cultural, and educational assets.

We believe that the combined organizations will be in a stronger position to fully realize the original conservation goals established at the time of purchase of the West Bijou Property and preserve and enhance the Property's conservation values.

In addition, the following stakeholders have also been notified of the transfer and are in full support of the motivation and intentions of the transfer:

- West Arapahoe Conservation District
- Great Outdoors Colorado
- Colorado Open Lands

### **Request and Recommendation**

Staff requests approval of a resolution for an amendment to the Land Development Code to provide an administrative process for review and approval of small-scale solar facilities land development applications. Staff has revised Section 12-1900 of the Land Development Code to include small-scale solar facilities in addition to oil and gas facilities. The new Section 12-1900 will be titled "Energy Facilities."

The concept of a Memorandum of Understanding (MOU) for small-scale solar facilities was considered by the BOCC during a study session held June 27, 2016. The BOCC directed staff to proceed with development of an administrative process for small-scale solar facilities, to be used within unincorporated Arapahoe County, for further consideration through the public hearing process. The MOU is an administrative document that will be used in conjunction with this process; the Board of County Commissioners would be delegating to staff the authority to revise the MOU as appropriate to a specific application.

<u>Planning Commission Recommendation</u>: Following a public hearing on October 18, 2016, the Planning Commission recommended **approval** of the proposed Land Development Code Amendment based on staff findings and **with the conditions of approval recommended by staff**. The vote was 4 in favor, 1 opposed (2 absent).

Planning Commissioner Rieck opposed the motion. She felt that, although there was no public comment at the time of the proposed code, there may still be public concern on a project-specific basis. She felt an administrative process does not allow for sufficient public input on individual projects and that this new process allows for an almost automatic approval. She noted that the shorter process requested for meeting Xcel timing requirements could be addressed by Xcel's practices and requirements. Comment from two industry representatives in attendance was

favorable to the proposed MOU and new administrative process. A summary of referral comments received prior to the hearing is provided in this Board Summary Report.

### **Background Information**

Small-scale solar facilities, also known as Community Solar Gardens, are centrally-located solar photovoltaic (PV) systems that sell electricity to utilities, while providing benefits to participating subscribers. Solar gardens have a capacity of 2 megawatts or less. Typically a site of approximately 15-20 acres is needed; this helps to account for parcels that may not be the ideal shape to meet setbacks and other requirements of the project.

Small-scale solar facility land development applications received to date have gone through the typical Use by Special Review (USR) process with BOCC review. Representatives for two solar companies are seeking to shorten the application process by modelling the administrative process for oil and gas development applications.

The funding process for solar facilities is very dependent on predictable and relatively short application review timelines, and so the existing County USR process that takes five to eight months for approval for these relatively low-impact development applications endangers their project funding.

An administrative process would entail the same level of staff scrutiny, for a process that would be complete in five to six weeks, without the two public hearings. It is also important to note that the Director of Public Works would retain the option of moving an application to a full USR process, with hearings, for applications with potential heightened impacts.

### Align Arapahoe Links

This matter links to the Align Arapahoe goals for **Service First** and **Fiscal Responsibility** because the amendment would reduce the time required from Planning and Engineering Services case managers to review and approve applications, as well as advancing the goal for **Quality of Life**, by providing renewable energy options for residents.

### **Comprehensive Plan**

Providing Community Solar Gardens also fits with the Arapahoe County Comprehensive Plan strategy NCR 4.2(a): The County will support programs and education to reduce energy consumption, to support solar energy research and other clean energy programs, and energy-efficient building design and solar-oriented site planning.

### Discussion

While the solar companies would get an expedited permit review process under the Solar MOU and an administrative USR, similar to Oil and Gas applications, the County would require increased buffering for aesthetics and should review typical application and permit fees for any needed adjustments to cover the County's review costs. The proposed fee structure will be presented to the BOCC at a future date for consideration and adoption into the fee schedule. The fee would apply to the review and approval processes for the land development application, GESC permit, access permits, and fence permits necessary for a project.

The review process for small-scale solar facilities would be shortened from the current timeframe of five to eight months to a significantly shorter timeframe of five to six weeks, while adhering to the same level of scrutiny through use of a voluntary MOU to qualify for the administrative process. Solar companies have communicated that they expect five or six applications to Arapahoe County over the next nine months. The proposed amendment and Solar MOU would provide the County with significant savings in both staff time and labor as well as benefitting solar energy projects.

Having an administrative process for small-scale solar facilities would "level the playing field" in the County for these low-impact, renewable energy projects.

### Staff Findings

The following findings are consistent with the recommendation of the Planning Commission.

Staff has reviewed the proposal and supporting documentation as well as referral comments, as detailed in this report. Based on review of applicable goals and policies as stated in the Comprehensive Plan, staff finds:

- 1. The proposed changes to Section 12-1900 within the Land Development Code appears to be in conformance with the Arapahoe County Comprehensive Plan.
- 2. Arapahoe County has the authority to amend provisions of the Land Development Code as proposed by this revision.
- Modifications proposed comply with the applicable Land Development Code Amendment policies and procedures as set forth in the Land Development Code including public notification requirements. Notice was provided in both the Villager and the I-70 Scout newspapers.
- 4. The proposed changes promote the public health, safety, and welfare of the citizens of unincorporated Arapahoe County.

For the last several months SunShare has been working alongside Arapahoe County Public Works and Development with the idea of implementing a Memorandum of Understanding (MOU) to streamline USR permit submittals for solar gardens. The idea originated after successfully developing two solar gardens in Arapahoe County and successfully completing the USR process. With each project we received either positive comments or no comments from referral parties, the projects themselves are very low impact, and everybody seems to be in favor of them. As long as we established pre-defined design and site selection criteria than solar gardens could go through a less cumbersome review process.

SunShare has worked in dozens of jurisdictions in CO and MN and have found Arapahoe County's current USR review process to be one of the longest and most cumbersome. All planning and engineering staff is very helpful and receptive to our projects, the process is just unnecessarily long and complicated. Approving the MOU would put Arapahoe County in a position of efficiency which will help with staffing resources and additionally would attract additional solar development to the county. We think this will be a win for all parties involved without any compromise in design criteria.

SunShare has a pipeline of several more Arapahoe County solar gardens in plans to develop in the coming years. We plan to actually submit a new project located on East Quincy known as Quincy II Solar Garden. We will also likely submit 2-3 more projects in early 2017. From what I hear, several other solar developers are also targeting Arapahoe County for small solar garden projects as well. The timing is good to approve the MOU as the rush of solar development seems to be imminent.

WHEREAS, Sections 30-28-113, -116 and -133, C.R.S., provide that the Board of County Commissioners has the power to adopt and amend the Land Development Code from time to time, after notice to the Planning Commission and published notice of the Board's intention to consider amendments, all as set forth in Sections 30-28-116 and -133, C.R.S.; and

WHEREAS, staff recommendations for amendments to the Land Development Code, concerning the addition of an administrative process for Small Scale Solar Facilities (Case No. W16-001) were forwarded to the County Planning Commission for review and comment, along with the changes recommended in the periodic review process; and

WHEREAS, the Planning Commission held a public meeting on October 18, 2016 and reviewed the recommended changes to the Land Development Code to amend Chapter 12, "Specific Regulations" by adding language to Section 12-1900 and changing the title of the section to "Energy Facilities" to allow for an administrative process for small scale solar facilities; and voted to recommend that the changes be made to the Land Development Code, with certain conditions; and

WHEREAS, public notice has been properly given of such proposed regulations by publication on October 27, 2016 in The Villager, and on October 25, 2016 in the I-70 Scout, both newspapers of general circulation in the County; and

WHEREAS, on November 15, 2016 at 9:30 a.m., the Board of County Commissioners held a Public Hearing concerning proposed amendments to the Land Development Code; and

WHEREAS, evidence was received showing that the notice, publication and referral procedures required by law for amending the zoning resolution were followed; and

WHEREAS, no objection was raised by the public or the Planning Commission relating to the adequacy of the notice, publication or referral procedures followed; and

WHEREAS, at the public hearing County Planning and Legal staff presented and explained the proposed changes, and were questioned about the particulars by the members of the Board of County Commissioners; and

WHEREAS, the record for this action contains extensive documentation of the factual basis for the proposed regulations; and

WHEREAS, following the summary presentation by County staff, the Chairman asked members of the public for comments about the proposed changes; and

WHEREAS, following the opportunity for public comment, the Board of County Commissioners made the following findings:

- A. The Board of County Commissioners finds and determines that the statutory jurisdictional requirements have been met and that the Board has jurisdiction to consider and act upon the proposed amendments to the Land Development Code.
  - 1. That adequate opportunity for public input and comment has been provided.
  - 2. That the Board has –authority under Title 29 and 30 to hear, consider and act upon the proposed changes to the -Land Development Code.
  - 3. Staff has reviewed the proposal and supporting documentation as well as referral comments as detailed in this report. Based upon this review, staff finds:
    - a. The proposed changes to the Land Development Code appear to be in conformance with the Arapahoe County Comprehensive Plan by supporting rural development and character.
    - b. Arapahoe County has the authority to amend provisions of the Land Development Code Regulations as proposed by this revision.
    - c. Modifications to Chapter 12 and 19 comply with the applicable Amendment policies and procedures, including public notification requirements, as set forth in the Land Development Code.
- B. The Board of County Commissioners hereby concludes that changing conditions clearly require adoption of the following amendment to the Zoning Regulations in the Arapahoe County Land Development Code, that the changes will not adversely affect the community's interest in reasonable stability in the zoning regulations and subdivision regulations, and that the changes are in the public interest and for the public good.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Arapahoe County, Colorado to adopt the revisions to the Zoning Regulations and/or the Subdivision Regulations, in the Land Development Code, concerning the addition of an administrative process for small scale solar facilities (Case No. W16-001), as presented in the staff report, with the addition of a new Section 12-1900, to read as shown in Appendix A.

The following terms shall be added to Chapter 19 (Definitions) of the Land Development Code:

ENERGY FACILITY OR FACILITIES. Includes Oil and Gas and Solar Facilities:

OIL and GAS FACILITY or FACILITIES. Includes oil and gas wellsites, flowlines, tank batteries, compressor stations, pits/ponds, below-grade tanks, dehydration units, vapor recovery units (VRUs), and associated roads. Pipelines and gathering systems, other than flowlines, as well as salt water disposal wells and injection wells are excluded. Locations

with more than one of the above mentioned types of equipment will be considered to be one facility.

SOLAR FACILITY OR FACILITIES. Is a facility or facilities that use solar energy to generate electricity through the use of solar panels, racking structures, inverters, transformers, overhead or underground wiring, and associated roads intended to generate power for a utility. A solar facility or facilities does not include any facility or facilities that exceed two megawatts (2 MW) in power generation or twenty (20) acres in size.

BE IT FURTHER RESOLVED by the Board of County Commissioners of Arapahoe County, Colorado that the above action shall be effective immediately and shall be included in the next printing of the Land Development Code.

We find ourselves in agreement with Staff findings one (1) through four (4) set forth in the Board Summary Report dated October 26, 2016, and with the Code amendment to establish an administrative Use by Special Review Process as proposed, with modifications, and hereby **approve the amendment to 12-1900 with the following changes** and with the following two (2) conditions of approval:

#### Changes to the proposed text:

- Changes to the text should be read as part of the motion to approve. <u>The Board</u> of County Commissioners may note the nature of the change to be made and direct staff to finalize text prior to integration of the new section into the Land <u>Development Code</u>.
- 2. ....

# Conditions of Approval:

1. Minor modifications to the text identified as necessary are required prior to incorporation of this Amendment into the existing Land Development Code. Staff, in conjunction with the County Attorney's Office, is hereby authorized to make necessary modifications to the text.

2. Modifications to Section 12-1900 of the Land Development Code will be effective and integrated into the existing Code upon approval by the Board of County Commissioners.

# C. Motion for <u>Denial</u>:

In the case of W16-001 – Land Development Code Amendment, Chapter 12 Specific Regulations, modification of Section 12-1900, Oil and Gas Facilities, to rename the Section to Energy Facilities and to incorporate new regulations for small-scale solar facilities, the Board of County Commissioners has read the proposed code amendment and the Board Summary Report and has considered additional information presented during the public hearing. We do not find ourselves in agreement with Staff findings set forth in the Staff report dated October 26, 2016, and therefore <u>deny</u> the application **based on the following findings:**

# SECTION 12-1900 ENERGY FACILITIES

# 12-1901 INTENT and APPLICABILITY

- A. The intent of this Section 12-1900 is to describe the Use by Special Review process and approval criteria for Energy Facilities. Notwithstanding any other language in the Land Development Code to the contrary, an Energy Facility or related site preparation or development, including any such Facility that requires a Colorado Oil and Gas Conservation Commission ("COGCC") permit, may not commence without first obtaining Use by Special Review approval, regardless of the zone district or category in which the operation will be located. Energy Facilities are specifically allowed in all zone districts, including Planned Unit Developments, subject to Use by Special Review approval and subject to obtaining other required permits and approvals, unless and to the extent otherwise stated in these regulations.
- B. The administrative Use by Special Review and the Memorandum of Understanding process available as provided under this Section of the Land Development Code shall apply only to an Oil and Gas Facility or Facilities as defined in Chapter 19 of this Land Development Code and to Solar Facility or Facilities as defined in Chapter 19 of this land Development Code.
- C. Nothing in this Section of the Land Development Code is intended to waive or modify any applicable provision of the Arapahoe County Regulations Governing Areas and Activities of State Interest (1041 Regulations).

# 12-1902 RELATIONSHIP TO SECTION 13-900

This Section provides an Administrative Use by Special Review approval process for Energy Facilities where an applicant has executed an acceptable Memorandum of Understanding ("MOU") with the County and meets other administrative approval criteria, as set forth in further detail below. An Administrative USR is not available for any Solar Facility or Facilities that exceed two megawatts (2 MW) in power generation or twenty (20) acres in size. In the event that an applicant has executed an MOU and obtains approval for an Administrative Use by Special Review for a particular Energy Facility, compliance with the procedures and criteria in Section 13-900 (Use by Special Review) is not required. In other situations, in order to obtain Use by Special Review approval, the applicant must comply with the provisions of Section 13-900 (Use by Special Review), except to the extent modified in 12-1912 of this Section or waived by the Public Works and Development Department ("PWD") Director or the Board of County Commissioners ("Board") in accordance with the authority provided in this Land Development Code.

# 12-1903 ADMINSTRATIVE APPROVAL CRITERIA

In order to obtain Administrative Use by Special Review approval, an Energy Facility shall first satisfy the following criteria, except to the extent waived by the PWD Director or by the Board:

# 12-1903.01 Memorandum of Understanding

An MOU acceptable to the County must have been executed by the applicant and the County and currently be in full force and effect, and the Energy Facility as proposed must be in compliance with the provisions of the MOU.

# 12-1903.02 Satisfy Submittal Requirements

The application and exhibits for the Administrative Use by Special Review must satisfy all applicable submittal requirements in this Section.

## 12-1903.03 Environmental/Public Health and Safety Impacts

The Energy Facility as proposed for approval shall not involve any site specific conditions that present significant and material impacts to public health, safety or welfare, or the environment, that cannot be adequately mitigated through conditions agreed to by the applicant in the MOU or by conditions imposed upon the Administrative Use by Special Review approval.

## 12-1903.04 Emergency Service Providers

The Energy Facility applicant must provide a commitment to serve ("will serve") letter from the authority having jurisdiction for providing emergency services (fire protection and emergency medical services) for that facility, or, where no authority has jurisdiction, from an emergency services provider with the ability to provide such emergency services.

# 12-1904 ADMINISTRATIVE PROCESS

## 12-1904.01 Pre-Submittal Meeting

Prior to submitting an application for an Administrative Use by Special Review for an Energy Facility, the applicant is required to attend a pre-submittal meeting with representatives of the PWD, unless waived. At the pre-submittal meeting the applicant will receive direction from County staff that will assist in preparing a complete application for submittal to the County. The applicant will need to obtain a list of applicable referral entities that will be sent a referral packet.

#### 12-1904.02 Review for Completeness

Upon receipt of an Energy Use by Special Review application and fee, referral packets and associated application materials, the Planning Division staff of the PWD shall review the materials submitted to determine if the application is complete and consistent with the standards set forth in this Section.

#### 12-1904.03 Concurrent Referral and Review

County staff will refer the complete application for a fourteen (14) working day review by the various divisions of the PWD and the County Attorney's Office, as deemed appropriate. An application may require review by outside agencies such as the U. S. Army Corps of Engineers, if the project impacts a floodplain, and may also be referred to any life-safety providers, adjacent jurisdictions, local public health department, and others as may be deemed appropriate.

#### 12-1904.04 Address Deficiencies

The applicant will be notified of any outstanding issues in connection with application materials upon completion of this review and will be required to address any issues or deficiencies in connection with the application materials. If necessary, a meeting will be held to discuss any issues that need to be resolved. If necessary, the applicant will then submit an amended application, plan or other submittals, as appropriate, to the County for verification that deficiencies have been addressed by the

applicant. If the above described outstanding issues cannot be resolved, the PWD Director may refer the case to the Board for its consideration.

#### 12-1904.05 Final Review

Upon acceptance of the final copy of the application and exhibits by the PWD, the application materials will be forwarded for final review by the PWD Director.

# 12-1905 ADMINISTRATIVE SUBMITTAL REQUIREMENTS

A Submittal Requirements Matrix is available from the Planning Division outlining the complete list of submittal items and the proper number of documents. Other submittal requirements may be required based on Planning Division review. The following items are required as part of an Energy Facility application submittal:

## 12-1905.01 Pre-Submittal Notes or Waiver

Notes from the pre-submittal meeting pertaining to the application, or signed waiver of pre-submittal meeting form.

## 12-1905.02 Application Form

A completed Energy Facility application form. Application forms are available from the PWD.

## 12-1905.03 Application Fees

Application Fee Schedules are available from the PWD.

#### 12-1905.04 Plan

An Energy Facility Plan drafted in accordance with 12-1906 of this Section.

#### 12-1905.05 Engineering Documents

The following Technical Engineering documents are required by the Engineering Services Division of the PWD unless otherwise waived by the Engineering Services Division staff:

#### 12-1905.05.01 Construction Plans

If applicable, Construction Plans for the proposed Energy Facility public improvements including road plan and profile sheets, storm drainage improvements plans and other public improvements, prepared in accordance with the latest version of the Arapahoe County Infrastructure Design and Construction Standards and Stormwater Management Manual.

#### 12-1905.05.02 Pavement Design Report

If applicable, a Pavement Design Report prepared in accordance with the latest version of the Arapahoe County Infrastructure Design and Construction Standards.

#### 12-1905.05.03 Grading Erosion and Sediment Control

If applicable, a Grading, Erosion, Sediment Control Report and Plan as defined in the latest version of the Arapahoe County Grading, Erosion, and Sediment Control ("GESC") Manual.

#### 12-1905.05.04 Truck Traffic Report

A Truck Traffic Report prepared in accordance with the latest version of the Arapahoe County Infrastructure Design and Construction Standards for Traffic Impact Studies. Such report shall also identify the source and location of any water to be used by the Energy Facility.

## 12-1905.05.05 Drainage Study/Technical Drainage Letter/Plan

If applicable, a Drainage Study/Technical Drainage Letter/Plan prepared in accordance with the latest version of the Arapahoe County Stormwater Management Manual.

#### 12-1905.05.06 Floodplain Modification Study

A Floodplain Modification Study prepared in accordance with the latest version of the Arapahoe County Stormwater Management Manual, if the proposed Energy Facility construction disturbance, operation or access encroaches into a 100-year floodplain or major drainageway as defined by the latest version of the Arapahoe County Stormwater Management Manual

#### 12-1905.06 Surface Owner Documentation

Documentation, if any, as to whether the surface owner has authorized the proposed Energy Facility. Applicants for a Solar Facility or Facilities where the owner of the proposed facility or facilities is not the owner of the underlying real estate shall provide a copy of the lease or other legal documentation from the owner authorizing the Facility or Facilities on the property.

#### 12-1905.07 Additional Information

Additional information may be requested by the PWD Department as deemed appropriate to process the application and the PWD Director may also waive the submittal of any information required above as deemed appropriate.

# 12-1906 ENERGY OPERATIONS PLAN

#### 12-1906.01 Plan Format

All plans will be 11" x 17" (for areas less than one acre) or 24" x 36" (for areas greater than one acre) format. No plans shall contain copyright restrictions or public use restrictions.

#### 12-1906.02 Cover Sheet

The cover sheet shall have a title block with the reference to an Administrative Use by Special Review, project name, and location by section, township and range. The cover sheet shall also include a legal description of the area, date of the drawing, existing zoning of the site, a sheet key, a vicinity map with north arrow (scale of  $1^{"} = 2,000'$  preferred) with an emphasis on the major roadway network within two (2) miles of the proposal, and all applicable County notes, an approval signature block and a block to insert the State of Colorado permit number when approved and when applicable. Upon approval, the first sheet will be signed by the PWD Director.

#### 12-1906.03 Impact Area Map

The second sheet shall contain an Impact Area Map that shows the proposed location of the Energy Facility, locations of all existing energy facilities or equipment within the one-mile impact area, locations of all water wells within ½ mile of the proposed Energy Facility, and all existing and proposed roads within the one-mile impact area. For purposes of this paragraph, energy facilities or equipment shall include, but not be limited to, other oil and gas facilities, other solar facilities, power transmission lines, electric substations, natural gas transmission lines, and other similar such energy facility equipment or energy production sites.

#### 12-1906.04a Operation Plan for Oil & Gas Facilities

The third sheet shall provide a site plan of drilling ) operations and drilling equipment with existing and proposed finished-grade topography at two-foot (2') contours or less tied to a datum acceptable to the County. The applicant shall verify current information regarding what datum is acceptable to the County, prior to submitting the application for the Administrative Use by Special Review. The layout

of the equipment may be shown as a typical plan, if the County deems it appropriate for the extent of development of the proposed Oil and Gas Facility.

# 12-1906.04b Operation Plan for Solar Facilities

The third sheet shall provide a site plan of operations and equipment with existing and proposed finished-grade topography at two-foot (2') contours or less tied to a datum acceptable to the County. The applicant shall verify current information regarding what datum is acceptable to the County, prior to submitting the application for the Administrative Use by Special Review. The layout of the equipment may be shown as a typical plan, if the County deems it appropriate for the extent of development of the proposed Solar Facility.

## 12-1906.05a Production Plan for Oil & Gas Facilities

The fourth sheet shall provide a site plan of production operations with production equipment (stays in) with existing and proposed finished-grade topography at two-foot (2') contours or less tied to a datum acceptable to the County. A seed mix shall be provided for reseeding the project area Equipment layout may be a typical plan appropriate to the degree of development for the Energy Facility submitted for approval.

## 12-1906.05b Production Plan for Solar Facilities

A production plan for Solar Facilities is not applicable; however, a seed mix shall be provided on the Operation Plan for reseeding the project area upon decommissioning the facility.

## 12-1906.06 Signage Plan/Sign Detail

A dimensioned Signage Plan or Sign Detail shall be included on one of the sheets describing and illustrating the appearance, size, location, type, color, material, and illumination of all signs. Directional signs for emergency responders and inspectors shall be included, along with a 24-hour, 7-days per week contact information to deal with all noise, traffic, or other complaints.

#### 12-1906.07 Approved Plan

Once the review process is complete and staff has determined that all outstanding issues have been resolved, staff will request a final copy of the Energy Operations Plan for the Oil and Gas Facility or Solar Facility, as applicable. The final copy of the Approved Energy Operations Plan shall be on paper (as opposed to Mylar). The drawing shall contain the information listed above unless otherwise specified by the County staff.

# 12-1907 NOTICE OF APPLICATION REQUIREMENTS

The applicant shall provide written notification by U.S. Mail to owners of parcels adjacent to the parcel on which the Energy Facility is proposed that an application for an Administrative Use by Special Review for an Energy Facility has been filed with the County. The Notice of Application shall meet the format prescribed by the County and shall be mailed at or no more than 30 days before the time of filing the application with the County. The property owner of record, as identified in the County Assessor's property records, shall provide the basis for notifications.

# 12-1908 APPROVAL/DENIAL OF ADMINISTRATIVE USE BY SPECIAL REVIEW

# 12-1908.01 Action to Approve, Conditionally Approve or Deny

Unless there are any issues that have not been resolved by the applicant, the County will exercise its best efforts to process the Administrative Use by Special Review for an Energy Facility within thirty (30) working days from the date of complete submittal by the applicant, or at such time as proof of any applicable State of Colorado permit approval is provided, whichever is later. The Administrative Use by Special Review can be administratively approved, approved with conditions or denied. Written notice of the decision shall promptly be provided to the applicant, and, if denied, the notice shall include a statement of the reason(s) for denial. The thirty (30) working day timeframe counts only as the County's processing time and does not include the applicant's response time.

# 12-1908.02 PWD Director's Discretion to Refer to the Board

In lieu of the PWD Director making a decision on an application, the Director has the discretion to refer any application for Administrative Use by Special Review or amendment thereto to the Board for its consideration and decision at a public hearing. In such event, the Board shall make its determination based upon the requirements of this Section; however, unless waived by the Board, compliance with the notice requirements set forth in Sections 13-905.02 A. and 13-905.03 B. is required prior to the Board hearing. At such public hearing, the Board may approve, approve with conditions, or deny the application.

# 12-1908.03 Expiration of Approval

An approval of the Administrative Use by Special Review for Energy Facilities shall only be valid for five (5) years unless the Energy Facility is substantially commenced prior to the expiration of such timeframe.

## 12-1908.04 Permits Required Prior to Commencement of Operations

If applicable, an Access Permit, GESC Permit, and Oversize/Overweight Vehicle Permit shall be required prior to the development of an Energy Facility. A Floodplain Development Permit shall be required prior to any work within a floodplain. A Building Permit may be required prior to construction of certain structures within the Energy Facility.

# 12-1909 APPEAL OF DECISION ON APPLICATION FOR ADMINSTRATIVE USE BY SPECIAL REVIEW

An applicant may appeal the PWD Director's denial of an application for an Administrative Use by Special Review for an Energy Facility, or any conditions of approval, to the Board of County Commissioners for a *de novo* hearing. The applicant must file the appeal within fourteen (14) calendar days of the date of the Director's decision by submitting a letter of appeal to the Planning Division Manager. Thereafter, the matter will be scheduled on the next available agenda of the Board. At such hearing, the Board may affirm, reverse or modify the decision of the PWD Director, based upon the criteria set forth in Section 12-1903.

# 12-1910 MOU PROVISIONS AS CONDITIONS OF APPROVAL

An approval of an Administrative Use by Special Review for an Energy Facility shall automatically include as conditions of approval all provisions of the MOU executed by the applicant, except to the extent waived by the PWD Director or the Board.

# 12-1911 ADMINISTRATIVE AMENDMENT

If the applicant or operator proposes changes from the plans approved through the Administrative Use by Special Review, including and not limited to any changes in the source or location of water to be used by

the Energy Facility, the applicant or operator is required to submit an amendment to the application showing the changes, unless such requirement has been waived by the PWD Director. The proposed amendment will be reviewed by PWD staff and, if applicable, PWD Staff may require additional information. The amended application will need to meet all requirements of this Section and be approved in writing by the PWD Director, or the Board (if the Board approved the original application), prior to implementation.

# 12-1912 NON-ADMINISTRATIVE APPROVAL PROCESS

Use by Special Review approval for an Energy Facility may also be requested through the process described in Section 13-900 of this Code, subject to the following modifications:

# 12-1912.01 Plan Format

The site plan shall comply with the requirements of Section 12-1904 above in lieu of the provisions of Section 13-904. In addition, the final document shall be submitted in paper form instead of Mylar, notwithstanding the language of Section 13-905.06.

# 12-1912.02 Other

The applicant shall not be required to submit a letter from a water and sanitation district, notwithstanding the language of Section 13-903.07, and shall not be required to comply with Section 13-903.08.

**12-1912.03 Expiration of Approval** An approval of a Use by Special Review shall only be valid for five (5) years unless the Energy Facility is substantially commenced prior to the expiration of such timeframe.

# 12-1913 STATE AND COUNTY APPROVALS REQUIRED

Development of the Energy Facility shall not commence until and unless any required permits from the state, and a Use by Special Review (administrative or non-administrative) from the County, have both been approved.

# MEMORANDUM OF UNDERSTANDING

# **For Solar Energy Facilities**

This Memorandum of Understanding ("MOU") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2016, by and between Arapahoe County, a Colorado County ("County") with an address of 5334 S. Prince St., Littleton, Colorado 80120 and ("Operator"), with an address of . The Operator and the County may be referred to individually as a "Party" or collectively as the "Parties."

# BACKGROUND

**A.** Operator is the owner and/or developer of Solar Energy Facilities ("Facilities") within unincorporated parts of the County, and, as of the time of the execution of this MOU, has the right and intent to further develop its community solar projects within unincorporated portions of the County.

**B.** The intent of this MOU is to provide the conditions under which Operator will develop and operate future community solar projects or newly expanded Facilities in the unincorporated portions of the County, in order to foster the efficient and economic production of renewable energy resources, to protect human health, safety and welfare and to protect the environment and wildlife resources, while at the same time providing for a predictable and expeditious administrative process for obtaining County land use approvals and permits for Solar Energy Facilities. The terms Solar Energy "Facility" or "Facilities" are defined here as including solar panels, racking structures, inverters, transformers, overhead or underground wiring, and associated roads for electrical energy production of up to two (2) megawatts (MW). The construction of any new transmission lines or the relocation of existing lines required for connection to the Facility is not authorized by this MOU or the administrative USR process, and will be subject to review under County 1041 and/or other applicable laws and regulations.

NOW, THEREFORE, the Parties agree as follows:

**1. Intent to Supplement County Rules and Regulations.** The Parties recognize that pursuant to the Arapahoe County Land Development Code Section 13-900 as well as criteria set forth in the 1041 Regulations ("Code") the County regulates the development of Solar Energy Facilities. The provisions of this MOU are intended to supplement and add to the County's rules and regulations. To the extent that any of the provisions of this MOU are in conflict with the Code rules and regulations, the stricter standards shall govern.

**2.** Land Rights, Permits and Approvals. Prior to any commencement of construction, Operator will obtain all necessary property rights and obtain utility award and interconnection agreement, in addition to any Arapahoe County Planning Division and/or Engineering Division approvals.

**3. Regular Meetings to Monitor and Discuss MOU Issues.** The County and Operator agree to meet as necessary, or at least once a year, to monitor and discuss any pertinent issues associated with Solar Energy Facilities within the County.

**4. Water Quality.** Operator will consider all relevant Federal and State water quality plans in Facility design and operation.

**5. Weed Control and Management**. Operator will be responsible for noxious weed control on any Facility, or disturbed area, from the construction phase to the decommissioning of the Facility. Operator will observe and enforce all applicable County noxious weed control ordinances throughout the operational cycle of the Facility.

**6.** Noise. The operator will follow all applicable State laws, County noise ordinances or resolutions during construction and operation of the Facility.

**7. Emergency Response Plan**. Operator will provide the County with an Emergency Response Plan (ERP) to address all potential emergencies that may be associated with a solar Facility. Operator shall also provide a copy of such plan to all emergency service providers that would respond to such emergencies. A "will-serve" letter must be obtained from the appropriate emergency provider(s).

**8. Engineering Services Division Requirements.** All Engineering Services Division requirements must be fully met. This MOU does not eliminate any Engineering Services requirements including but not limited to all of the following, as applicable:

- **a**. Drainage Arapahoe County Stormwater Management Manual (SWMM)
- **b**. Stormwater Detention SWMM Chapter 13
- c. Stormwater Quality SWMM Chapter 14
- **d**. Floodplain SWMM Chapter 5
- e. Public Roads Arapahoe County Infrastructure Design & Construction Standards (IDCS) Chapter 4
- **f**. Private Roads IDCS Section 4.11
- g. Grading, Erosion and Sediment Control (GESC) Arapahoe County Grading, Erosion and Sediment Control Manual
- h. Traffic Impact Study (TIS) IDCS Appendix B
- i. Right of Way Access IDCS Chapter 11
- j. Rural Roadways Arapahoe County Rural Engineering Standards
- **k**. Pavement Design IDCS Chapter 5

**9. Height.** Solar equipment required for the project will not exceed twelve (12) feet above surface grade. This does not include electrical interconnection equipment and pole lines that may be required by the public utility to interconnect to the electrical grid.

**10**. **Screening and Buffering.** The Operator must choose one of the following four screening or buffering options when the facility abuts a residentially zoned district, residential property, rural residential zoned property or County arterial roadway or collector.

1. Setback from the property line to the edge of the solar modules. The minimum distance of the any required setback from the property line shall be determined on a case by case

basis as appropriate and shall approved by the Director of Public Works and Development.

- 2. Screen fence such as cedar fence, chain link fence with interwoven slats, or other fence solution approved by the Director of Public Works and Development that will screen visual impact of solar equipment.
- 3. A landscape buffer to mitigate visual impact of solar equipment.
- 4. A raised berm, with xeriscape features, that is a minimum of fifty (50) percent of the height of solar equipment.

If the facility is located in a rural area that does not abut a residential zoned district, arterial roadway or collector, or any other land use that may be impacted, screening will not be required.

**11. Biological Resources.** The operator shall avoid any Federal and/or State Threatened and Endangered Species habitat, as well as State Species of Concern that exist in areas where the Facility will be constructed. If any Federal and/or State Threatened and Endangered Species or any State Species of Concern, is found to exist in areas where the Facility will be constructed, then the operator will collaborate with Colorado Parks and Wildlife (CPW) to mitigate and minimize any potential impact to these species. Arrangements with CPW will be completed prior to application with the County.

**12.** Wetlands, Army Corps of Engineers and 404 Requirements. The operator will adhere to all permits and obligations required by the Army Corps of Engineers for wetlands and Waters of the United States if applicable.

**13. Historical and Cultural Resources.** The operator will avoid any areas identified as being of paleontological, historic, or archaeological importance. If avoidance is not possible, further testing will be conducted with landowner's permission to determine the site's eligibility for historic status and a treatment plan will be developed that will be followed to protect eligible sites.

**14. Lighting.** All permanent lighting of shall be directed downward and internally.

**15. Fencing.** Standard fencing around the Facility will be a maximum of eight (8) foot, meet the safety requirements of the National Electric Code, and will comply with Arapahoe County Fence Regulations.

**16. Decommissioning**. Once the Facility is no longer operational, the operator will remove all ground equipment and foundations, at the operator's expense, and leave the site in a similar condition that it was prior to the installation of the Facility. Removal will be complete within one year of ceasing operations. Reestablishment of all disturbed areas, including the construction access, shall maintain the historic drainage patterns and ground cover. The County will determine if decommissioning, including revegetation, has been completed sufficiently.

**17. County Inspections.** Operator agrees to allow County access to all Facilities for inspection, provided County personnel are equipped with all appropriate personal protection equipment (PPE), the personnel comply with the Operator's other and customary safety rules, and, except to the extent allowed by law, the County is responsible for all costs and expenses of such inspections. The County shall use its best efforts to provide advance notice to the Operator prior

to an inspection; however, the County reserves the right in its discretion to make spot inspections or to inspect without notice in the event of an issue potentially involving an immediate risk to public safety, health or welfare or damage to the property of another.

**18. County Land Use Approvals.** The Operator understands and agrees that prior to the development or operation of any solar Facility in unincorporated portions of the County, that Operator must first obtain approval from the County pursuant to any validly adopted provisions in the Land Development Code. As part of the process and approval, Operator will request a pre-application meeting with the County and notify neighboring property owners within one-quarter (1/4) mile of the boundary of the parcel on which the Facility is located by letter, before or within five (5) days of having submitted a land use application with Arapahoe County. The Operator agrees and consents that the provisions of this MOU are to be included among any conditions for the issuance of any land use approval or permit issued by the County under its Land Use Development Code (LDC), unless, and to the extent, waived or modified in writing by the Director of the Arapahoe County Public Works and Development Department, or waived or modified on the record at a public hearing before the Arapahoe County Board of County Commissioners; further, the Operator understands and agrees that the provisions of this MOU shall remain conditions of such land use approval or permit regardless of the subsequent sale or other transfer of any solar Facilities, or interest therein, by the Operator.

**19. Applicability.** This MOU shall only apply to Solar Energy Facilities under two (2) megawatts (MW) alternating current. This MOU shall not be construed to apply to solar Facilities for which another operator applies for a permit even though the Operator may have an interest but is not the Operator. Additional Facilities may be exempted from some or all of the terms of this MOU, but only if approved in writing by the Director of the Arapahoe County Public Works and Development Department or approved on the record at a public hearing before the Arapahoe County Board of County Commissioners.

20. Compliance with Applicable Federal, State, and Local Laws and Regulations. The Operator shall operate the Facility in compliance with all applicable federal, state, and local laws and regulations.

**21. Term.** This MOU is effective upon the execution by both Parties and shall remain in effect so long as Operator, its subsidiaries, successors or assigns, are engaged in the development or operation of solar Facilities within the unincorporated portions of the County; provided, however, this MOU may be terminated by either Party with thirty (30) days prior written notice to the other Party. If there is a new development in state law, rules or judicial decisions that substantially affect any provision of this MOU, the Parties agree to negotiate in an attempt to update this MOU in light of same by a written amendment executed by both Parties. In the event this MOU expires or is otherwise terminated, the substantive requirements stated in this MOU shall survive and remain enforceable against the owner or operator of any solar Facilities that were permitted or otherwise approved during the term of this MOU, except to the extent waived or modified pursuant to the provisions of this MOU.

**22. Obligation of Funds.** Nothing in this MOU shall commit either Party to obligate or transfer any funds to the other.

**23.** Force Majeure. Neither Party will be liable for any delay or failure in performing under this MOU in the event and to the extent that the delay or failure arises out of causes beyond a Party's reasonable control, including, without limitation, war, civil commotion, act of God, strike or other stoppage (whether partial or total) of labor, or any law, decree, regulation or order of any government or governmental body (including any court or tribunal).

**24.** Authority to Execute MOU. Each Party represents that it has the full right and authority to enter into this MOU.

**25.** Governing Law. This MOU shall be governed and construed in accordance with the laws of the State of Colorado and the Arapahoe County Land Development Code without reference to its conflict of law provisions.

26. Entire Agreement. Except as expressly set forth herein, this MOU embodies the complete agreement between the Parties hereto with respect to the subject matter hereof and supersedes and preempts any prior understandings, agreements, or representations by or between the Parties, written or oral, which may have related to the subject matter hereof. No amendment to this MOU shall be effective unless in writing, signed by the Parties.

**27.** Third Party Beneficiaries. Except as specifically stated herein, this MOU is not intended to, and does not, create any right, benefit, responsibility or obligation that may be enforced by any non-party.

**28.** Notices. All notices and other correspondence related to this MOU shall be in writing and shall be delivered by: (i) certified mail with return receipt, (ii) hand delivery with signature or delivery receipt provided by a third party courier service (such as FedEx, UPS, etc.), (iii) fax transmission if verification of receipt is obtained, or (iv) email with return receipt, to the designated representative of the Party as indicated below. A Party may change its designated representative for notice purposes at any time by written notice to the other Party. The initial representatives of the Parties are as follows:

**29.** Subsidiaries/Successors. The provisions of this MOU shall apply to all subsidiaries and successors-in-interest of the Operator with respect to any solar Facilities permitted or otherwise approved during the term of this MOU.

**30**. **Default.** If a Party defaults in the performance of an obligation under this MOU, the defaulting Party shall have ten (10) days to cure the default after receipt of written notice of such default from the non-defaulting Party, provided the defaulting Party shall be entitled to a longer cure period if the default cannot reasonably be cured within thirty (30) days and the defaulting Party commences the cure within such ten (10) day period and diligently pursues its completion; however, in the event that the default involves an issue that could have an immediate impact on public health, safety or welfare, or cause damage to property of another, the defaulting party shall immediately begin action to cure the default. Each alleged default shall be treated separately under this paragraph and notice of an alleged default shall not affect the processing of permit applications while the notice is being evaluated, contested or corrected. In the event of a default, the Parties shall be entitled to seek specific performance as well as any other available remedies.

**31.** Jurisdiction: Waiver of Rights. The parties acknowledge, understand and agree that this agreement shall not be used as evidence that either party has waived any rights to assert its claims concerning the validity or extent of the County's land use jurisdiction. Nothing in this agreement shall be construed as an admission regarding the existence of proper jurisdictional authority or waiver by either party of any legal right or obligation, nor shall anything be construed as a bar to either party to seek any legal remedy available to it. The Operator agrees, however, that it will not exert jurisdictional or preemption arguments with respect to the specific performance obligations contained in this MOU.
